Restaurant to remain closed until issues addressed and state re-inspection

CECIL — Two significant violations found during a Jan. 3 inspection of the Washington Inn Supper Club in Cecil were responsible for temporarily closing the restaurant down until those issues are addressed.

In all, the inspection by a field agent with the Wisconsin Department of Agriculture, Trade and Consumer Protection (DATCP), Bureau of Food and Recreational Businesses found 24 violations.

Most of those were minor and many were corrected while the agent was still on the premises making the inspection.

A review of other restaurants inspected on the DATCP web site shows that minor violations are not uncommon.

The violation in this case that has gotten the most attention — and has become a topic on social media — is a pest control problem.

According to the DATCP web site, “Cockroaches and cockroach feces

were found in the basement near the dishwasher, in the back room near the soda box dispensing rack, in the open wall area and in the room near the meat cooler.”

There have been claims on social media that plates of food containing cockroaches were actually served at the restaurant, but there is nothing in the state’s findings as reported on its web site to indicate that.

The Leader reached out to the state for more information and was referred to DATCP’s public records office, which has asked that an open records request be submitted before answering any questions.

The Leader has submitted that open records request and has been told it could take up to 10 days to receive a response.

The DATCP web site lists its Jan. 3 review of the Washington Inn as a “routine inspection.”

However, Washington Inn owner Darwin Olsen confirmed Friday that the inspection was the result of a complaint made to DATCP.

“They got a complaint online that

someone had seen a bug,” Olsen said.

Olsen said claims on social media that the cockroach was on a plate of food that was served to a customer are not true.

“It wasn’t on a plate,” he said. “It was over by the salad bar in the dining room.”

Olsen said he has had an exterminator on the premises once a month for the past year and a half, as required by state code.

“And all of a sudden a bug came out,” Olsen said. “It probably got ahead of her and she didn’t keep up with it.”

Olsen said he has since hired a new pest control company.

The incident that prompted the complaint to DATCP and the Jan. 3 inspection took place on Dec. 27, Olsen said, a night when he was not working at the restaurant.

“I’m not blaming anybody,” Olsen said. “I take 100% responsibility for this, 100% responsibility to take care of the problem.”

Olsen said he does not know how the cockroach got into the restaurant.

"It's hard to say how they come in. I can't pinpoint it," he said.

DATCP listed two related pest control problems including a window in the basement sealed with duct tape and not fully closed, which could allow the entry of insects or rodents, and unnecessary items stored in the basement such as clothes, boxes, crates, personal items, buckets, PVC pipes, and other items that could provide a harbor for insects and rodents.

Olsen said both of those issues were easy fixes that have already been addressed.

"All the clutter has been cleaned out," he said. "Everything is totally gutted out down there."

DATCP lists the pest control problem as a repeat violation. During a January 2017 inspection, the last one done at the Washington Inn until this month, mouse droppings were found, according to the DATCP web site.

"Mouse droppings were found under the server station and on top of the 1st floor dishwasher. Several flies were found in the kitchen," according to the 2017 report.

The state recommended that the restaurant inspect facilities for insects and rodents, remove all droppings and exterminate as needed.

Olsen said he removed the mouse

droppings and never saw a rodent.

There was no re-inspection required. DATCP's policy, according to its web site, is that all violations not requiring a re-inspection must be corrected by the next routine inspection.

The Jan. 3 inspection also uncovered two plumbing issues needing to be addressed before the Washington Inn can reopen.

According to the DATCP report, "the sump pump system is not hard plumbed and is discharging into the basement kitchen where food is processed" and "a direct connection exists between the sewage system and a drain from food prep sink."

Neither of these issues were cited in DATCP's 2017 inspection.

The Washington Inn was given instructions to repair the plumbing system to conform to the State Uniform Plumbing Code.

"Facility must provide the name and license number of the plumber, inspection report, and report of any repairs completed to the department before reopening. Referral will be made to the department of safety and professional services for follow up," DATCP wrote in its report.

Also, DATCP wrote, Washington Inn must "design the sewage system in a manner that would preclude a

direct connection between the sewage system and the drain from which food is placed."

Olsen said the restaurant has already had a plumber on the premises who has begun addressing the problems.

The Washington Inn was initially given until the end of January to address its violations.

"It's going to take us a little longer than that to do the stuff we've got to get done," Olsen said.

Olsen said he was granted an extension until June 30, when it comes time to renew his license with the village, but, he said, he doesn't expect the fixes to take that long.

"We only have two issues," he said. "The water issue, which is getting a hard-plumbed pipe into the wall, and of course the bug issue, to get rid of that. Those are the only two things I need to open, but we are doing a lot of other things here, updating, remodeling."

Olsen, who said he has been in the food service business for 38 years, purchased the Washington Inn in 1997.

"I never had an issue until this came about," he said.

Olsen said he feels the state handled the situation fairly and had praise for DATCP field agent who

conducted the inspection.

"She worked with us for about two hours and said there's no problem we can't fix," Olsen said. "She helped us out in doing a lot of different things. She was honest and sincere with me about how to handle things. Very informative."

Olsen also thanked his employees for their support during this situation.

"I thank all my help, all my employees for putting in their time," Olsen said. "I've always had great help. I can't say enough about them. They're honest and hard-working. Unfortunate things happen, but we want to take care of business in the right way and move forward."

Olsen said he does not believe it will be a problem regaining the trust of his customers.

"I have good, loyal clientele here," he said. "They've been stopping in here and giving me advice and offering help."

Olsen said he invites everyone to come back to the Washington Inn after it has addressed its violations and he thanked all of his past customers.

"I apologize for this," he said. "I do take 100% of this on me and it's a hard thing to go through but things happen. It will be taken care of."

Keshena man gets 6 months in prison

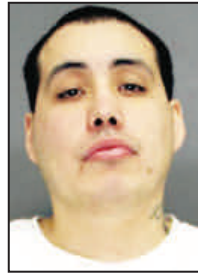
Blackowl hit woman, who needed reconstructive surgery

GREEN BAY — A Keshena was sentenced Friday in federal court to six months in prison and placed on three years' supervised release for physically assaulting a woman that resulted in a facial injury requiring surgery.

A woman identified only as "Jane Doe," told authorities on Feb. 17, 2019, that Brad L. Blackowl struck her with a closed fist. The blow landed on her nose resulting in nasal injuries requiring reconstructive surgery.

According to the Oct. 4 plea agreement, Menominee Tribal Police responded to Doe's address in Keshena where Doe said that Blackowl had assaulted her at a different address in

and she was in a lot of pain.

Doe later had surgery for nasal and septum fractures. The chipped front tooth is an obvious disfigurement and likely to be permanent.

Authorities collected screen shots of Facebook messages Doe received from Blackowl apologizing for hitting her.

Blackowl told a FBI agent and a tribal detective that he had hit Doe, sent her messages apologizing for what he had done, and had learned

the Menominee Indian Reservation.

The responding officer noted that Doe's nose was bloody and looked "crooked." Doe also said the punch had chipped a tooth

that Doe required surgery for the injuries he had caused.

Court documents don't indicate Blackowl's motivation for the offense or the nature of the relationship between him and his victim.

Efforts to obtain this information from the U.S. Attorney's office Friday were unsuccessful.

At sentencing, Blackowl faced maximum penalties of 10 years in prison, a \$250,000 fine, restitution and three years' supervised release.

However, Blackowl faced far less severe penalties under the advisory federal sentencing guidelines that factor in the seriousness of the offense, any prior convictions, sentences imposed in similar cases and any other relevant conduct.

Assistant U.S. Attorney Andrew Maier requested a sentence within the advisory guidelines but the calculated guideline range wasn't men-

tioned on online court records.

His attorney, Thomas Phillip, asked for a 90- to 120-day sentence with treatment and counseling while on supervised release.

District Judge William Griesbach could have ordered Blackowl pay restitution for expenses Doe incurred related to the offense, but no restitution was requested.

Griesbach did order Blackowl into the custody of U.S. Marshal Service to begin his prison sentence.

Blackowl's Facebook account contains many posts about boxing and boxers and this message posted on the day he hit Doe: "Had a chance 2 fight tonight but wouldnt of been a good idea havnt been able 2 do much working out or training prolly get my (expletive) kicked dont feel like getting beat up in front of bunch of people i know lmao sounded tempting tho 2 get in the ring."

Corn, Waukau, Kakkak elected to Menominee legislature

KESHENA — One incumbent and two newcomers wound up on top in the Jan. 15-16 election for the Menominee Tribal Legislature.

Incumbent Ronald Corn Sr.,

who is completing his first term on the legislature, was the top vote getter with 337. Ronald Waukau Sr. received 279 votes, while Gena Kakkak received 226 votes. The three newly elected legislators will be sworn into office on Feb. 9 at

the legislature's reorganizational meeting. The legislators will serve three-year terms.

Also in the running were Randal Chevalier, who received 203 votes; Karl Peters, 182 votes; and Vincent Grignon St., 141 votes.

Besides Corn, the seats for Eugene Caldwell and Craig Corn were available. Caldwell opted not to seek reelection, while Craig Corn had to step down because of term limits. Legislators are limited to three consecutive terms in office.

SHAWANO COMMON COUNCIL HIGHLIGHTS

Engel Drive apartments get approval

The Shawano Common Council last week approved a development agreement for an apartment complex to be located in the industrial park on Engel Drive.

SC Swiderski, of Mosinee, is planning an apartment development that would include 160 up to 224 units that would be completed in stages over the next five years.

The development agreement calls for SC Swiderski to purchase the 18.6 acres from the city for \$450,000.

When Swiderski has completed and gotten occupancy permits for 160 units, the city will reimburse the developer for the purchase price of the land.

The 160-unit figure is being used as a "bare minimum" in the proposed development agreement, even though Swiderski is planning as many as 224 units, according to City Administrator Eddie Sheppard.

Plans call for 12 apartment units per acre in three building styles, including

two-bedroom, two-bathroom apartments with attached garages; one- and two-bedroom apartments with detached garages; and two- and three-bedroom apartments with attached two-car garages.

Council OKs canoe/kayak launches

Two docks with canoe and kayak launches were approved by the Shawano Common Council at its Jan. 15 meeting. One dock will go in at Huckleberry Harbor. The other will be located at Kleeman Park.

The docks are expected to cost a total of about \$41,000.

The money will come out of the roughly \$60,000 left over from the park improvements referendum that included the splash pad at Memorial Park and improvements to Franklin and Smalley parks.

Additional docks specifically with canoe/kayak launches was discussed as part of the referendum plan.

The city will seek to get back

some of the cost of the docks after the fact by applying for a state DNR recreational boating fund grant, which could cover up to 35% of the cost.

City helps with business improvements

Two Shawano businesses will get assistance with the cost of improvements from the Shawano Redevelopment Authority under development agreements approved Jan. 15 by the Common Council.

R. Franklin Clothing at 109 S. Main St. plans to update its facility by renovating the interior and eliminating blighted conditions at a cost of \$60,000.

The RDA will provide a grant of \$12,500 toward the project.

RBNEZ LLC, which rents the building at 414 S. Main St. to Edward Jones Financial Advisors, is planning a remodeling and renovation of that property and elimination of blighted conditions at an estimated cost of \$114,000.

Improvements include a new ADA accessible ramp and entrance, new windows, a paved parking area and landscaping.

The RDA will provide a grant of \$6,000 toward the project.

Change wanted in dark store loophole

The city of Shawano is asking the state to eliminate the so-called dark store loophole that allows big box stores to claim property values significantly lower than the assessments set by municipalities for those properties.

The stores claim those properties can't be used for anything else once they're vacated and should be assessed as if they were vacant when taxes come due.

That forces other property owners to pay more in taxes to make up the difference.

The Common Council passed a resolution that will be forwarded to the governor and the Legislature calling for an end to the loophole.

Setting goals will help when gardening time returns

The new year is upon us and with it, already, gardener's dreams are becoming more and more enticing as catalogs begin to arrive and seeds begin to show up on the shelves of local garden centers.

January is a time to set goals for the gardening year, as well as a time to indulge in a little bit of a fantasy as we explore new plant varieties and botanical temptations that bloom on each and every page of our favorite garden catalogs.

Do you have goals in mind for

your goal is to try to grow food and become more self-sufficient.

the coming growing season? Are there new plants you wish to try? Are there plants that you have seen in botanical gardens or other gardens that you wish to try at home? Maybe

Whatever your garden dreams are for the coming year, you can make them happen.

One of my immediate suggestions is, of course, to simply spend more time in the garden. We all get so busy with “things” and “activities” that we often forget to spend some time in the garden each and every day.

Ideally, the time spent in the garden should vary by day. Don't fall into the habit of only going into the garden at certain times of the

day, because you have no idea what you will miss. Different things in bloom, different creatures visiting the garden, different lighting that often transforms the garden into a whole new perspective.

Spend some time in your garden after dark, as well. This may sound silly at first thought, but when you walk into your garden beneath the moonlight and begin to let your eyes adjust, your garden plants take on a whole new life after the sun goes down. Some colors seem

to glow, almost neon, in the night garden. Plants in silver, white, pale yellow, pale blue and other colors take on a whole new life after the sun sets.

After dark, you may notice a whole new fragrance in the garden, as well. Many annuals and perennials put forth their strongest fragrance at night to attract night-flying pollinators such as moths and other insects.

Another suggestion for a garden goal for the coming year, if you haven't already done so, is to start your own compost pile or compost bin in your backyard. Nothing beats treasured garden gold as a top dressing and soil amendment in just about any garden bed or border. The best part is it's free. You don't need to spend a ton of money to start your own compost pile for composting.

Along the same lines, another resolution is to install a rain barrel or a rain garden planting. Both are excellent ways to conserve rainwater and prevent harmful runoff directly into our precious waterways.

With a rain barrel, rainwater can be stored for long periods of time to be used to water your garden plants. A rain garden filters rainwater naturally and slowly into the water table and provides a source of stunning beauty, using native wildflowers and grasses.

Many gardeners have a goal each year to grow more food at

home but end up frustrated or not meeting this goal. Try making it more fun by growing unusual varieties of fruits, vegetables and root crops that you may not find anywhere else. If you have children, grow fun and exciting plants to keep the kids excited as the growing season matures.

Try growing food in a different way. There are many fun and exciting ways to grow crops that go beyond traditional rows. Try companion planting or vertical gardening; try some of the fun and unusual ways to grow potatoes and onions, such as in containers or raised beds or straw bales.

Another simple resolution that comes as a surprise to many gardeners is to grow more houseplants. For some reason, outdoor gardeners are often intimidated at the thought of growing indoor plants. There is a misconception out there that houseplants are so much harder to take care of.

Give a few a try this winter season. Many are extremely tolerant of poor conditions and will do well. Easy-to-grow plants such as snake plants, ZZ plants, philodendron, succulents and even herbs make the gardening season even more enjoyable.

Photographs were judged on the basis of creativity, photographic quality, composition and how an image expresses the theme of the selected category.

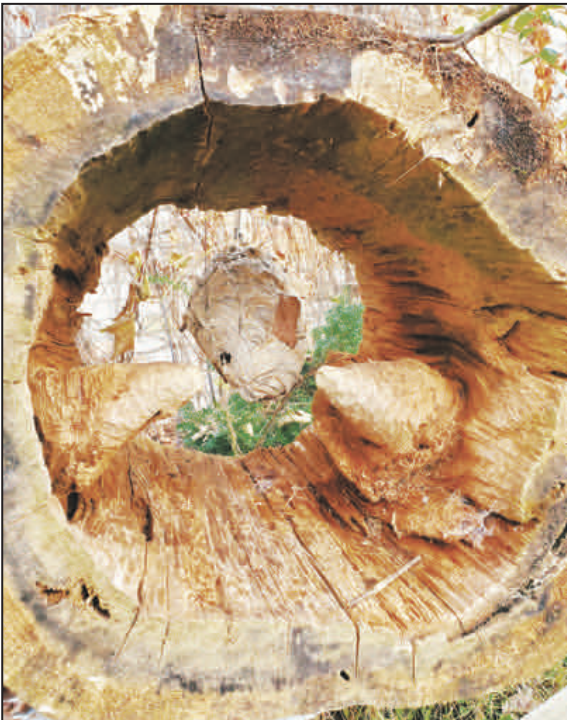

Packers come up short in NFC Championship Game

Green Bay can't slow San Fran running game

SANTA CLARA, CALIF. — Raheem Mostert rushed for 220 yards and four touchdowns to make quarterback Jimmy Garoppolo mostly a spectator, Nick Bosa harassed Aaron Rodgers from the start and the San Francisco 49ers beat the Green Bay Packers 37-20 for the NFC championship Sunday.

The 49ers advanced to their first Super Bowl in seven years and will play the Kansas City Chiefs in two weeks in Miami for the championship.

It's been a remarkable turnaround for a team that won just 10 games in the first two seasons under coach Kyle Shanahan and general manager John Lynch and had the No. 2 pick in the most recent draft.

Now, San Francisco is one of two teams left standing after delivering a second thorough beating of the season to Rodgers and the Packers. The Niners are the third team to make it to the Super Bowl a year after winning four or fewer games, joining Cincinnati (1988) and the Rams (1999).

Bosa, the prize for last year's rough season as the No. 2 overall pick, helped set the tone when he ended Green Bay's second drive of the game with a 13-yard sack of Rodgers.

Mostert, a former special teams standout, did much of the rest in a remarkable redemption story for a former surfer who was cut seven times and carried the ball only eight times in his first three seasons in the NFL.

But he has become a key part of the NFC's top team this year, leading the Niners with 772 yards rushing in the regular season and delivering a performance for the ages in the NFC title game.

He had the second-most yards

rushing in a playoff game to Eric Dickerson's 248 for the Rams on Jan. 4, 1986, and was the first player to rush for at least four TDs and 200 yards in a playoff game.

He got started when he burst 36 yards on a third-and-8 trap play to open the scoring on San Francisco's second drive and kept ripping off long runs behind impressive blocking.

He added TD runs of 9 and 18 yards in the second quarter and had 160 yards rushing at the half, becoming the only player in NFL history to rush for at least 150 yards and three TDs in the first half of a playoff game.

Mostert added a 22-yard TD run in the third quarter.

Rodgers and the Packers were unable to match that performance as they got overwhelmed by San Francisco's dominant front for a second

time this season.

Rodgers had a career-low 3.15 yards per attempt in a 37-8 loss here back in November and wasn't much better in the first half of the rematch.

He lost a snap from center Corey Linsley to end Green Bay's only promising drive of the half, threw an interception to Emmanuel Moseley late in the half and didn't convert his first third down of the season against the Niners until connecting on a 6-yard pass to Aaron Jones on the opening drive of the second quarter for his first third-down conversion in 18 attempts this season against the Niners.

Rodgers capped that drive with a 9-yard TD pass to Jones, but the game was too far out of hand by that point.

He led Green Bay to two more TDs and finished with 326 yards passing,

but it wasn't nearly enough as the Packers lost the NFC title game for the third time since their last Super Bowl trip following the 2010 season.

Quiet day

The Niners asked very little of Garoppolo, who threw only eight passes thanks to the big-play running game and lopsided score.

He went 24 minutes of game time between his sixth and seventh passes and finished with six completions for 77 yards.

Passing Favre

Rodgers' two TD passes gave him 40 in his playoff career, breaking Brett Favre's franchise record of 39.

Rodgers also has seven straight playoff games with at least two TD throws, one shy of Joe Flacco's record.

Chargers take control of Central Wisconsin Conference

Wittenberg-Birnamwood edges Bonduel in dual

WITTENBERG — The Wittenberg-Birnamwood High School wrestling team earned a 39-36 dual win over Bonduel on Thursday, taking control of the Central Wisconsin Conference in the process.

Thursday's matchup had all the makings of a classic, with both teams boasting perfect conference dual records coming in. Despite Witt-Birn only winning one of the six non-forfeited weight classes, it was enough to edge Bonduel.

"I told the boys, 'This could be for the conference title.' We do host a multi-dual next Saturday and there's a couple teams we can't look past but like I told them, 'If we can beat Bonduel, we have a good chance at beating most of the teams in the conference,'" said Witt-Birn coach Troy Ostrowski. "We just keep getting better every week. We haven't won anything yet. We beat a good team but haven't won anything yet.

The host's lone non-forfeit came from Will Urquhart in the 160-pound weight class. The senior claimed a 4-0 decision win over Bonduel senior Moises Lagunes.

After a scoreless first period, Urquhart pulled a reversal to take a 2-0 lead. Urquhart then took down Lagunes in the third period to seal up his win.

"I knew I had to go out big and go win it for the team. If I won for the team, I knew we'd have probably the best chance to win conference so I had to put it all on the line," said Urquhart. "I had to take him down and dominate the whole match and I think I dominated the whole match because he didn't score."

After Bonduel won the first three weight classes of the night to go up 15-0, senior Allen Uttecht (285) and sophomores Damien Wudtke (106) and Pierson Potrykus (113) all won by forfeit to put the hosts up 18-15.

The Bears took the lead again after a pin, but the Chargers pulled back ahead after earning forfeit wins at 126 and 132 pounds. Junior Austin Worzalla won at 126, while senior Chad Moegenburg earned the win at 132.

Bonduel responded with wins in the next two weight classes to tie

things up, but Witt-Birn junior Wyatt Esker was awarded a forfeit win at 152 to make it 36-30 and give Urquhart a chance to seal a victory.

Working with only eight wrestlers, Bonduel coach Chris Rank was pleased with how his guys battled despite the long odds.

"It was a great dual," said Rank. "We did some things that I don't normally do — I don't like forfeiting to some of their better wrestlers but with the type of dual meet this was and what was on the line, I was trying to go into the conference tournament with a title. I was trying to slow down momentum and take the crowd out of it. We knew the eight guys we were putting out on the mat probably needed to win, and we just came up short."

The night started at 182 pounds, with Bonduel junior Kaden Bergsbaken taking on Witt-Birn sophomore Kyle Linke.

Bergsbaken took down Linke in the opening period and took that 2-0 lead into the second. Bergsbaken was able to finish off a pin at the 2:40 mark of the match.

Bonduel junior Isaac Banker and Witt-Birn freshman David Gauderman then took the mat for the 195 class.

After a scoreless first period, Bank-

er pulled a reversal early in the second and took that lead into the final period. Banker got a takedown to go up 4-0, but Gauderman pulled a reversal of his own, then got a stall point to trim the deficit to one. Banker was able to hang on for the 4-3 decision win.

Bonduel senior Alex Garside was awarded a forfeit win at 220 to give the team its 15-0 lead.

Clintonville boys ride 2nd-half run to road win

Polzin, Morse, Mauel lead Truckers

OCONTO FALLS — The Clintonville High School boys basketball team carried the momentum from a late first-half spurt into the second half, going on an 18-2 run that eventually helped the team to a 67-55 North Eastern Conference win over Oconto Falls on Friday.

After getting down 18-9 to a hot-shooting Oconto Falls, Clintonville was able to go on a 7-0 run to tighten the game up. Just when it looked like the Truckers might surge ahead, senior Aiden Polzin — the team's leading scorer who had seven of the team's point at that juncture of the game — was tagged with his second personal foul with 7 minutes, 2 seconds to go until halftime.

"When Aiden went out with his second foul, I pulled him out and started wondering when I might have to put him back in," said Clintonville coach Ryan Mattson. "But our players really got it together with him on the bench. They cut it to one (30-29) by halftime, which was great because then we had a really fresh Aiden Polzin to come in and help us in the second half."

Clintonville juniors Cameron Mauel and Nathan Morse carried the team with Polzin on the bench, combining to score the team's next eight points. With the Truckers down six with under two minutes to play in the half, sophomore Jesse Wilson knocked down a big 3-pointer before junior Klay Barkow added a field goal to make it a one-point game at halftime.

With Polzin rested and momentum on its side, Clintonville dominated the first seven minutes of the second half to break open a tight game.

Oconto Falls had the first basket of the second half, but Clintonville got a triple from Polzin, a fastbreak basket from Morse and a 3-pointer from Morse in about a minute-and-a-half span to go up 37-32 and force Oconto Falls to burn a timeout.

The hosts knocked down a pair of free throws after the quick break,

but the Truckers responded with a Polzin bucket, triples from senior Presley Rosenow and Mauel before two free throws from Polzin to make it 47-34 with 11:39 to play.

"(Coach Keary Mattson) really got on our butts about that (a strong start to the second half) and told us to just come out and play like a team and play how we are," said Polzin. "We just came out and did it."

Oconto Falls was able to trim its deficit to single digits a few times over the rest of the game, but Clintonville always had an answer.

Polzin converted a field goal, and-one and 3-pointer that kept Clintonville's lead at 10, 55-45, with 4:25 to play.

The Truckers pushed the lead back up to 13 points, but the Panthers made it an eight-point game with 1:47 to play. Clintonville sealed up the win with clutch free-throw shooting, with sophomore Cole Rosenow, Mauel and Morse all making two free throws on one-and-one opportunities.

The NEC win was the Truckers second of the week, upping the team's conference mark to 5-3.

"It's huge," said Morse of the conference road win. "We're trying to get on a winning streak here and get us back up top in the conference. We got a couple more games coming up that we think we can win — we just got to keep playing hard."

Polzin finished with 16 second-half points to finish with 23 for the game. He knocked down two 3-pointers and seven of the team's 15 free throws.

Morse connected on three triples and tallied 19 points, while Mauel added 15.

Clintonville schools discuss adding day care center

New facility could be housed at Dellwood

CLINTONVILLE — The Clintonville School Board and district administrators are investigating the need for and feasibility of operating a community child care center.

After listening last week to a presentation by business manager Holly Burris, the board felt it was not ready to make a decision on the matter and put it on the agenda for its next board meeting Monday.

There is limited day care available in the community, Burris said. She listed some of the reasons why a center is needed — including declining enrollment, a declining workforce in the community and the need to attract families to the Clintonville area.

Dr. David Dyb, district superintendent, said 13 students left the district

last year due to the lack of a licensed day care in the community. It was noted that once a student is enrolled outside the district in 4K, there is a slim chance they will come back.

“For each student in the district, it means \$10,000 in revenue,” Burris said. “And if 10 of them go out of the district, it means \$100,000 lost.”

A committee has looked at day care centers in school districts in Marion, Shiocton and Tigerton, Burris said. She recommended locating the day care center at the Dellwood Early Learning Center; a new facility or one not in a school district location would not be cost effective, Burris said.

Dyb said the district looked at other properties in Clintonville for a day care, and there are none available. Additionally, the Rexford-Longfellow Elementary School would need too much renovation for a center.

Matt McGreger, senior project manager with Hoffman Planning, Design and Construction, said that a lot of what is needed for a day care is already in place at Dellwood, which

would help keep the cost low.

Burris recommended using five rooms to host a day care center that could accommodate 50 children; additional space would be needed for a director’s office and other services.

“The current (70) 4K students would need to move to Rexford-Longfellow to make the room needed to open a community day care,” Dyb said. “The CAP Services-1 classroom and Birth-3 home visitor program would remain in the space they currently lease from the district.”

Board Member Jim Schultz asked Burris why she had suggested a center for 50 kids.

“I thought it was a good number to accommodate for getting our feet on the ground without a lot of disruption,” said Burris.

“We were told that was a good place to start,” Dyb added. “There are different licensing requirements. It is big enough, but we would not be overwhelming ourselves.”

Dyb said hiring and keeping qualified staff members would likely be their biggest issue. Hiring a director and caregivers who would need training and licensing is difficult,

Burris added. They would also need to acquire licensing, buy supplies and promote the day care center, and a director would need to be hired before the center would see any revenue coming in.

Burris thought that it would be at least eight or nine months from the time the board approves a day care center to the opening of its doors. The facility would need to meet the building codes and address playground, parking and traffic needs. She recommended a startup budget of \$100,000.

“It could assist the community, but it would be nonprofit,” said Burris.

Clintonville resident Jessica Schroeder said she planned to open a day care outside the city in May, and she would have concerns about the district opening a day care.

Dyb said there is no other entity like it in Clintonville.

“This is a progressive idea to help the community grow,” he said. “It is good for industry, and the city wants to grow.”

“This (day care) would be nice for the community, and it is much needed,” said Mark Zachow, board member.

Clintonville animal shelter under scrutiny

City administrator finds several issues with operations, donations

CLINTONVILLE — The Clintonville Common Council learned this month that the position for the keeper of its animal shelter was under the sole authority of the Clintonville Police and Fire Commission and not the council.

When a group of citizens attended a council meeting Dec. 10, several spoke in opposition to a proposed contract with Clintonville Veterinary Hospital for stray animal boarding services, while others spoke in support of Liz Sorenson, who currently operates the pound in Clintonville. The council took no action at the time.

After the meeting, the city reviewed the operations of the Clintonville Pound, and a number of concerns came up that needed to be addressed, according to City Administrator Sharon Eveland.

One of the concerns was that neither Eveland or Police Chief Craig Frietag could locate a job

description for the keeper. Frietag put together a job description to be submitted to the Clintonville Police and Fire Commission.

Another concern was the haphazard way donations were being tracked and accounted for. Eveland said there was quite a bit of food that has expired dates and as a result, the pound keeper was directed to dispose of all expired food.

"The city appreciates all donations. However, they cannot feed expired food," said Eveland.

Eveland said that there also seems to be equipment that does not belong to the city, but that was donated directly to the pound

keeper. Because of insurance and liability concerns, the pound keeper was directed to remove anything that did not belong to the city.

Monetary donations for any services or equipment as well as in-kind donations must be brought to the police department, according to Eveland.

Eveland said the city is not rejecting donation offers; they are simply requiring they be done in a formalized manner.

Eveland also reported that she and Frietag are currently looking into the possibility of setting up a special arrangement with the local

vet clinics to allow monetary donations go directly to the vets for the spay and neuter services the city authorizes and any necessary medical care, excluding euthanasia service.

The presence of volunteers will be more closely monitored, according to Eveland. All city volunteers must have approved background checks before being allowed to volunteer.

Eveland said the changes being made are being made so the pound can operate in an efficient and proper manner that also takes into account the personnel policies and liability concerns.
