Dr. Wiley excited to practice at restored Tigerton Clinic

ThedaCare clinic reopened Jan. 18

Dr. Jasmine Wiley can't wait to return to her practice at the restored ThedaCare Family Medicine - Tigerton after what she called the "ultimate fixer-up, clinic edition."

"Our patients are so excited to have us back, and we are, too," she said. The clinic has seven employees.

The clinic, 110 Cedar St., Tigerton, reopened Jan. 18. It will again offer family medicine, laboratory services, X-rays, obstetrics care and minor surgical procedures.

Wiley feels the mansion's recently completed restoration not only brought back the character of the historic structure but also added to the life of the building.

As she is devoted to family practice, she sees all ages in her one day a week each at the Tigerton and Clintonville clinics and two days at the Shawano Clinic.

ThedaCare leases the clinic space on the first floor of the mansion from Tigerton Clinic Inc., a nonprofit organization. The organization was formed more than 70 years ago as the Tigerton Cooperative Hospital with the goal of ensuring that health care services are provided in the community. The organization has contributed about \$60,000 to the recent remodeling project. The corporation was not identified as the owner in an earlier edition of the Wittenberg Enterprise-Birnamwood News.

Wiley hopes to have a reopening celebration later in the year. In the meantime, she said videos of the clinic are available on the ThedaCare website.

Patients will see the original cork flooring, windows in doors with the paint removed, woodwork restored and original tile flooring revealed — some of it for the first time in

decades.

Wiley, a 2006 Clintonville High School graduate, traces her commitment to medical practice in the area to her undergraduate studies that included time at the Shawano and Tigerton clinics.

During that time, she came to feel the "character, the charisma" of the

Tigerton building, built in 1920 by Herman Swanke, Tigerton Lumber Company owner, as his home. The hospital operated from 1950 to 1978.

"I always thought it would be really neat if it were restored to its original glory," she said.

She likes to think that not just Swanke but all of the people who

were born or worked in the building when it was a hospital would be pleased with the restoration.

What started out as a much-needed upgrade to the electrical system became a much larger restoration. Wiley said the building is now more accessible for disabled patients and features a more accessible lab area, among other improvements.

Wiley, a University of Wisconsin-Madison medical school graduate, always planned to come home to practice medicine. But she also chose to do her residency at Aurora St. Luke's in Milwaukee because she wanted to see the greatest variety of situations and medical conditions.

Wiley said she appreciates what the building means to the community — not just as a clinic but as a historical asset.

"That's part of the reason I split my time at the clinics. Each one is so special to its community," Wiley said. She added a rural area like Tigerton is fortunate to have this level of health care available.

"It's been their medical home for a long time," she added, observing it's difficult for many elderly patients

to get to Clintonville or Shawano.

Margaret Anderson, nurse-practitioner, is available 3.5 days a week at the clinic as well, Wiley said.

The closure of the clinic due to COVID-19 concerns matched Wi-

ley's planned sabbatical, so she "dug in" to restoration tasks.

While Wiley declined to be called an expert after her days of restoring tile, matching paint and scraping carpet glue, she said she was an "expert in consulting the experts."

"It's so fun to see everyone get so excited about the restoration," Wiley said. She gave a huge shout-out to all of the volunteers and tradespeople, including retired clinic employees, who worked on the project.

She added it was a "unique, small-town thing to have people pitch in," even if only to drop off cleaning supplies or provide snacks.

Wiley said she thinks the staff is even more excited than she is with the reopening, although some insist the mansion is haunted.

The doctor said that if there are ghosts, they're friendly. What isn't spooky is seeing the relics of hospital and clinic equipment that have been unearthed during the restoration — a reminder of how far the technology in medicine has come in the past years, she said.

Bonduel seeking \$12.5M school referendum

Renovating aging classrooms, building new gym among list of projects

The Bonduel School District will be asking voters to approve \$12.5 million in bonds to allow for some needed improvements and renovations to its facilities.

The Bonduel School Board voted earlier this month to proceed with the referendum. If voters approve the referendum in an April 6 election, property owners can expect to pay 16 cents per \$1,000 of equalized valuation, which means the owner of a \$100,000 home will be paying an additional \$16.

Many of the classrooms at Bonduel High School were built in the 1950s and are in need of improvements, according to Superintendent Joe Dawidziak. Floor and ceiling replacement, new windows, a fresh coat of paint and replacing the original doors and frames are part of the work planned to modernize those classrooms.

“We started out with a discussion of wants versus needs and trying to come up with a plan that limited tax impact to taxpayers,” Dawidziak said. “We went through a study with Miron Construction and Blue Design (Architects), and what you see in the plan is a result of talking with various stakeholders.”

The district also plans to build a two-court gymnasium with locker rooms near the current front entrance of the high school. A new entrance would be created on the school’s west side, adding a canopy and building signage.

The existing high school gymnasium would also be remodeled, as Dawidziak noted that it and the current middle school gymnasium would continue to see voracious use by both the school and the community. Refinishing the hardwood floors and replacing the scoreboards, goal posts and ceiling fans would be part of the remodel.

“We’re convinced those facilities are going to be used all day and all night,” Dawidziak said.

The upgrades would also include making sure the high school is compliant with the Americans With Disabilities Act. Also, air conditioning framework would be installed in the classrooms and at Sousa Hall, where the school district holds

concert and theater events.

Although most of the work is at the middle and high school, there would be some work done at Bonduel Elementary School. The school’s main entry would be remodeled to create a secure foyer with an electronic system in place when visitors come to the school. Also, aging exterior doors and frames would be replaced.

“If you walk through the building, it’s fairly obvious where the oldest parts are in the (high school) building,” Dawidziak said. “The elementary building is the newest in our district.”

These items need to be addressed, regardless of what the current enrollment is, according to Dawidziak. The district believes the financial situation is optimal to pursue the referendum

now, as the pandemic has financial institutions cutting interest rates.

“We had originally talked about doing this (referendum) in November, but with the state of the economy and COVID, the timing was very inappropriate,” Dawidziak said. “We’re in a very different place that way (now).”

He noted that the district had sent out a community survey in 2020, and about 75% of the respondents were in favor of the \$12.5 million plan. That could be a good indicator in a community with a spotty history when it comes to passing referenda.

“I don’t know how accurate that (survey) is in terms of everyone who would actually vote, but it’s at least a good place to start,” Dawidziak said. “We believe we’re kind of on the right track.”

The district plans to execute an aggressive education campaign to make sure voters are aware of what they’re voting for. Dawidziak noted he plans to do a “road show” in several areas where he would explain what the district will do with the \$12.5 million. In-person and virtual meetings are planned.

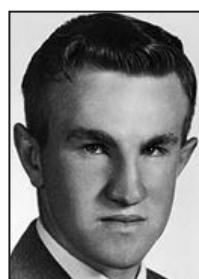
Dale 'Stan' Dickman

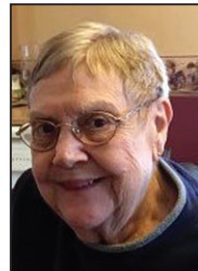

Wisconsin Farm Center hosts farm support groups on Zoom

Wisconsin Public Radio

Wisconsin farmers will have the opportunity to connect with each other online through a new program from the Department of Agriculture, Trade and Consumer Protection (DATCP).

DATCP's Wisconsin Farm Center will be hosting support groups for farmers and farm couples on Zoom starting in February. With each session led by a farmer and a licensed mental health counselor, the conversations are meant to allow producers to encourage each other and share ideas to get through a challenging time in the agriculture industry.

"With all of the extra stress and anxiety going on on farms in recent years, we thought it was a good venue for them to kind of know they're not alone and have a chance to talk about some of the struggles they deal with on a daily basis," said Jayne Krull, director of the Wisconsin Farm Center.

Krull said the agency planned to host the support groups in person before the coronavirus pandemic because of the financial stress felt by many farmers over the last few years. But she said the online format has presented new opportunities to reach farmers who may not have had time for an in-person meeting.

The center has already gotten positive feedback from producers who are using the agency's new telecounseling services, Krull said, especially because of the convenience.

"Farmers are liking that they don't have to clean up and leave the farm because they don't have enough time to do all that," Krull said. "And so this is a quick way to jump online and not have to go through all that."

She said the online format also provides a level of anonymity to farmers who may feel uncomfortable telling neighbors or friends that they're struggling.

"You don't have to show your picture, you can just use your first name. Even if you don't actually speak and participate, just to hear other people are struggling with the same thing you are," Krull said. "Farming is such an isolating occupation that it's good for them to know they're not alone."

Joy Kirkpatrick is an outreach specialist for the University of Wisconsin-Madison's Center for Dairy Profitability who meets with farmers to help them navigate farm succession planning.

Kirkpatrick said she thinks the opportunity for anonymity online could make some farmers feel more comfortable sharing tough realities.

But she said she has noticed in her own work that meeting with people online is not exactly the same as in person.

While reliable broadband access can be a challenge in rural areas, Kirkpatrick said she has been able to get around that obstacle by having people call into a virtual meeting.

She said the biggest benefit of the new program will likely be the fact that the conversation is exclusive to farmers. The pandemic has interrupted the way people in the agriculture community connect, Kirkpatrick said, whether it's sharing a cup of coffee at the local feed mill or through their child's extracurricular activities.

But she said these connections between farmers were already starting to fray before the coronavirus changed day-to-day life.

"It used to be that any sort of county road might have maybe five, 10 farms on it and that would be that neighborhood community of farmers, who all are experiencing a lot of the same things at the same time," Kirkpatrick said. "With people exiting the business, maybe that land is being purchased by a bigger farm rather than a new family coming into that particular area. We have fewer farms, and so the fabric of that community looks different now."

VOTING BY ABSENTEE BALLOT

Any qualified elector who is unable or unwilling to appear at the polling place on Election Day may submit a request to vote an absentee ballot to their municipal clerk. A qualified elector is any U.S. citizen, who will be 18 years of age or older on Election Day, who has resided in the ward or municipality where he or she wishes to vote for at least 10 consecutive days before the election. The elector must also be registered in order to receive an absentee ballot. Proof of identification must be provided before an absentee ballot may be issued.

You must make a request for an absentee ballot in writing or online at MyVote.wi.gov.

Contact your municipal clerk and request that an application for an absentee ballot be sent to you for the primary or election or both. You may also submit a written request in the form of a letter or you may apply for an absentee ballot online at myVote.wi.gov. Your written request must list your voting address within the municipality where you wish to vote, the address where the absentee ballot should be sent, if different, and your signature. You may make application for an absentee ballot in person, by mail, by fax, by email or at MyVote.wi.gov.

Making application to receive an absentee ballot by mail

The deadline for making application to receive an absentee ballot by mail is:

5 pm on the fifth day before the election, Thursday, February 11, 2021.

Note: Special absentee voting application provisions apply to electors who are indefinitely confined to home or a care facility, in the military, hospitalized, or serving as a sequestered juror. If this applies to you, contact the municipal clerk regarding deadlines for requesting and submitting an absentee ballot.

Voting an absentee ballot in person

You may also request and vote an absentee ballot in the clerk's office or other specified location during the days and hours specified for casting an absentee ballot in person.

NOTICE OF SNOW AND ICE REMOVAL VILLAGE OF WITTENBERG

MUNICIPAL CODE 8.05 SNOW AND ICE REMOVAL. (1) SIDEWALKS TO BE KEPT CLEAR. The owner, occupant or person in charge of each and every building or structure or unoccupied lot in the Village fronting or abutting any street shall clean, or cause to be cleaned, the sidewalk in front of or adjoining each such building or unoccupied lot of snow or ice to the width of such sidewalk and to the street surface within 24 hours after the cessation of a snowstorm. When the ice has formed on any sidewalk so that it cannot be immediately removed, the persons herein referred to shall keep the same sprinkled with salt, ashes, sawdust or sand. (2) DEPOSIT IN STREET PROHIBITED. No person shall deposit, or cause to be deposited, any snow or ice taken and removed from his premises or elsewhere upon any sidewalk, alley, parkway, public place or street in the Village. Snow shall not be piled at or near intersections so as to obstruct the view of pedestrians or operators of motor vehicles. (3) REMOVAL BY VILLAGE. The failure to remove or the deposit of any snow or ice upon any sidewalk, alley or street of the Village contrary to the provisions of this section shall be and is declared to be a nuisance and, in addition to the penalty provided for violation of this section, the Village may summarily remove any snow so deposited and cause the cost of said removal to be charged to the owner of the property from which said snow or ice has been removed. If not paid within 30 days, such charge shall be extended upon the current or next tax roll as a charge for current services, as provided in §66.0627, Wis. Stats.
