Retzlaff says charges are 'fraud' in hearing

Defendant fails to get requested bond hearing due to Marsy's Law

Ann Retzlaff continued to be defiant in court May 9, claiming the staff at the Shawano County Jail continued to hamper her ability to retain counsel to represent her, as well as continuing to claim the court had no jurisdiction over her and that she was trying to be silenced.

Retzlaff is facing felony charges dating back to May 2021 of fleeing and eluding officers and two counts of second-degree recklessly endangering safety, as well as a misdemeanor count of resisting or obstructing an officer. She also faces misdemeanor charges through Menominee County for resisting and failing to stop. Bail jumping and disorderly conduct charges were added in April after she missed two court appearances in late 2021, and deputies arrested her in Wittenberg.

Once again claiming she was making "a special appearance under duress" from the jail, Retzlaff told Marathon County Circuit Court Judge Mark Moran during a status conference, when asked if she had found an attorney, that she "had not been afforded the opportunity" while being held on a \$25,000 bond from Shawano County and a \$1,000 bond from Menominee County.

"The deputy went and told the desk sergeant, to no success," Retzlaff said. "I would like to have that right. I will not waive any of my rights."

According to Ethan Schmidt, Shawano County clerk of courts, she has been allowed to use a telephone and the internet. He said he emailed the jail to "remedy the situation" and learned she had made 226 calls in her time in jail as of May 5, as well as that she had the funds in her account to make calls.

"Some calls did not go through, but looking at the records the jail

has, the majority of the calls have gone through," Schmidt said. "Their policy states they need to allow access to a phone. The phone is in her housing unit, and she has been making calls. They have not had any requests in writing for her to use a different phone due to the inability to contact an attorney."

Retzlaff continued to claim that the whole case should have been dropped due a lawsuit filed in federal court against Shawano-Menominee County Circuit Court Judge William Kussel Jr., who has recused himself from the case, along with District Attorney Greg Parker and Corporation Counsel Larenda Maulson.

"It's irrelevant," Retzlaff said. "It's nonsense that this case is even moving. It's a federal lawsuit, and Greg Parker's name is on that lawsuit. So why is he even sitting at the desk today?"

Moran pointed out that there can be cases running simultaneously at the state and federal levels.

"They're not mutually exclusive, ma'am," he said.

Retzlaff claimed she couldn't make a call to talk with an attorney because the jail calls cost her 20 cents per minute. She claimed it would be easier if her bond could be reduced so she could make her calls from home and work, which wouldn't cost her extra.

"It takes several days, and you're on the phone all the time," Retzlaff said. "I am not made of money. I have to have people drive money here so I can make phone calls. If I were to do this from my home office, this would cost me nothing."

She also claimed she has called friends that include a retired judge

and a retired lawyer, but because the caller ID indicates her call is coming from the jail, her calls are rejected.

Retzlaff wanted to discuss a bond modification at the status conference, but Moran pointed out that there had been no notice posted about a bond hearing as required under Marsy's Law — which sent the defendant into a rambling tirade, claiming that Marsy's Law did not apply and that the court was a "corporation."

"The court has no jurisdiction to determine its own jurisdiction," Retzlaff said. "I am not a federal citizen of the District of Columbia. I am a state national and claim my nationality as such."

Moran responded that Retzlaff's statement makes it clear that the current bond amount is reasonable, as she indicates she does not respect the court's authority.

Retzlaff claimed that the "real crime" was supposed sex trafficking going on in the area. She said that she "inadvertently" came across a sex trafficking house in Menominee County and had rescued somebody from that place when law enforcement tried to pull her over.

"This is why all these charges are being brought up," Retzlaff said. "They are trying to target me and trying to silence me. What is Shawano County doing about all the sex trafficking and child trafficking and drug trafficking in Shawano County? That is the real crime! Not me!"

Retzlaff continued to portray her as a victim of a corrupt system who should be freed.

"I am just a traveler going from point A to point B," Retzlaff said. "All of these traffic violations are fraud."

The bond hearing and a new status conference is scheduled for 10:30 a.m. May 19.

Anglers head out for inland fishing opener

Even smaller waterways filled with rods and reels

Shawano Lake and the Wolf River come to mind as two of Shawano County's popular fishing destinations.

Gunnar Kvistad had something else in mind, however.

The 12-year-old Marion Elementary School sixth grader got up early May 7 for the first day of Wisconsin's inland fishing season, grabbed his fishing rod and a handful of minnows that he had caught in a creek near his home and headed to the boat landing at the Pella Pond.

The pond is a 49-acre lake created by a dam on the Embarrass River in the Shawano County community of Pella, halfway between Marion and Shawano.

While boat landings at Shawano Lake were filled with vehicles, boats and trailers, Kvistad had a section of the pond in Old Mill Park all to himself.

"It's quiet, and I can just relax," he said. "I was here at 6:30."

He returned to the boat landing after fishing after school the previous day.

"Yesterday, I caught a northern on a minnow," he said. "I was here just by myself, but sometimes, I come out on our boat with my dad and my mom. We catch bass, sunfish."

Mark Schraufnagel, a DNR conservation warden based in Shawano, showed up at the landing to see how Kvistad was doing.

"I'm checking sturgeon sites; I'm checking trout spots," he said. "There's a lot going on. There's going to be a lot of people out today because we finally got some good weather."

Activity near the dam began to pick up around 8 a.m. as several people stopped along the road to see spawning lake sturgeon in the river below the dam.

Shawano County is home to a number of small-town ponds on the Embarrass River and its branches, including ponds in Caroline, Leopold and Tilleda.

"These are actually pretty productive fisheries, and these little millponds mean a lot to these local communities," Schraufnagel said. "There's a little bit of everything.

You have your panfish, you have your gamefish — a nice variety.

"Pella did a nice job with this," he continued. "They have a pier here you can fish off of, and they have a fishing platform over there. (The Embarrass) isn't listed as trout water below the dam, but there are trout in there that people will catch. Right now, it's kind of neat because you can see the sturgeon. Suckers will be

moving in, and there will be a lot of guys fishing for them as well."

The pond's water level was recently dropped for dam repairs, according to Schraufnagel.

"They did drop the water here, so we'll see how this goes," he said. "They try to do that slowly so the fish can sense that and go upstream."

Kvistad headed home at 10 a.m. without any fish to show for his ef-

fort, but said he'd be back later.

About 20 miles northwest of Pella, Luke Schmidt, of Kaukauna, and his friends fished for trout on Homme Pond — an impoundment of the Middle Branch of the Embarrass River, just north of Wittenberg.

"A bunch of friends and I get together every opening day for the last five years or so," he said. "We've always called it Trout Club. We'll fish a bunch of local streams and grill out later in the day."

The group had several rainbow trout and one brook trout on ice before noon.

"It's been pretty good," Schmidt said. "You keep moving and work your way around. We've been on a number of streams this morning."

The inland fishing opener isn't as big as opening weekend of the state's nine-day gun deer season, but Schmidt said the first Saturday in May is still a big deal.

"We look forward to it for sure," he said. "Winter gets long."

"Opening weekend has that tradition for a lot of families, whether it be trout fishing, walleye fishing or whatever," Schraufnagel said. "It's not quite the same as the nine-day, but it's up there."

Fredenburgh given 25 years for child sex abuse

Former Suring trustee groomed girl, 12, for sex

U.S. District Judge William Griesbach had a blunt message to friends and family of John Fredenburgh before sentencing him to 25 years in federal prison.

"No one pleads guilty to a 15- to 20-year crime if they didn't do it," Griesbach said during the May 5 sentencing hearing. "If you think she's making it up, get a life. Use your head. This is what he did, and he lied to you."

Fredenburgh, 37, a former Suring village trustee, pleaded guilty in December to traveling in interstate commerce for the purpose of having sex with a minor, and one count of attempting to entice a minor to engage in sexual conduct, in connection with an eight-year relationship with a girl, now 18, that turned sexual when she was 12.

She confided the affair to her mother when she was 17, and Oconto County authorities charged him in March 2021 with 24 felony counts stemming from the long-term abuse. Federal investigators got involved when they learned Fredenburgh had crossed the state line into Michigan for at least one of the sexual encounters with the girl.

Noting that letters he received from some supporters indicated they still believed Fredenburgh's early denials, Griesbach said any one of the acts he has admitted would result in a conviction and prison time.

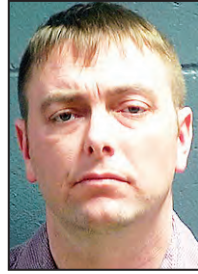
"This is hundreds of acts over eight years," he said.

Before the sentence was imposed, the victim and several family members and friends asked Griesbach to impose the maximum allowed by law, which could have been as much as 40 years.

Fredenburgh was a coach, and the victim was a friend of his daughter.

The girl's uncle said she was groomed by Fredenburgh, who built a great amount of trust with her and her family.

"He took away her childhood, he took away all of her adolescence, there were threats made with a gun, and she's got to live with all of

this," the uncle said. "She did not deserve this horror."

Her mother said Fredenburgh came forward after the girl's beloved grandmother died, and the family was grateful to "let an adult bond with her, not realizing she was being preyed on."

When the mom reported Fredenburgh to the police, her daughter was angry and said she hated her. It took weeks for the girl to understand what he had done to her, the mother said. In their small town, they have had to endure community reaction with comments to the mother like "How could you not have known?" and comments to the girl that she was making up the allegations.

The girl's father said Fredenburgh came across as a friendly person who always had a smile on his face and an encouraging word, even convincing the community to elect him to the village board, all of it masking the dark reality.

"No young girl or family ever has to go through what this man did to her. I feel guilty every day that I didn't see the evil in this man," the father said. "I hope everybody in this room from both sides will understand what's happened to my little girl."

With her mother and aunt standing at her side, the victim read a four-page statement describing the abuse and its impact on her life.

"I don't know how old I will be when I finally feel I have my life back again," she said.

She described Fredenburgh giving her compliments about how pretty she was as early as when she was 10. When she was 11, he planted the idea that when she turned 18 they would get married and move to California.

Then he started suggesting sex, and during a sleepover one night when she was 12 he texted her to meet him upstairs, saying, "It's now or never ... otherwise you can't come over or be friends with my daughter anymore."

It was not the first threat that occurred during the secret relationship. She said he held a gun on

her several times, including one incident in a hotel room when she was 17 when he held a gun on her and threatened to kill her and then himself.

She was overcome by emotion several times as she spoke, and at one point Griesbach stopped her, pointed out that he had read her statement before the hearing, and told her she did not have to continue.

"No," she replied. "I have to do this, to help myself heal."

Assistant U.S. Attorney Daniel Humble recommended a prison term of 320 months, or nearly 27 years.

"This court doesn't see many cases more serious and horrific as this," Humble said.

Fredenburgh abused the girl sexually and emotionally for years, he said, and yet "he still purports to be a pillar of the community," citing a statement in the pre-sentence report.

A 320-month sentence would be slightly above federal sentencing guidelines but would be a fair and just term, Humble said.

Defense attorney Krista Halla-Valdez argued for a 15- to 20-year term, citing that her client signed a plea agreement with a range of 188-285 months, or about 16 to 23 years.

"That is serious punishment, and he was willing to do that," he said. "At no point is Mr. Fredenburgh excusing or rationalizing his behavior ... Nobody is trying to downplay this as not a serious crime ... he's not doing that either."

Halla-Valdez pointed out that Fredenburgh had no previous criminal record, sustained a traumatic brain injury while serving in the military, and wants to go to a

prison where he can obtain needed mental health and substance abuse treatment.

Given a chance to make a statement, Fredenburgh said he was sorry.

"I've let many people down in my community, in my family, (the victim) and her family," he said. "I'm devastated by what I've done to (her) mental health."

Fredenburgh said he wanted people to know that while his actions were "deplorable, they were not malicious."

Before imposing sentence Griesbach said Fredenburgh preyed on people's innocence and gained the trust of the community, portrayed himself as an upstanding leader.

"He could have been that person," the judge said, but instead committed "a horrible crime" over a long period of time. "This is not a one-time mistake of judgment. This is a lifestyle."

To the victim, who had said she feared she might never recover from the trauma, Griesbach said, "You can see in the letters of support that this is not irreparable damage. Don't throw in the towel. You've already helped a lot of people by coming forward. Your life is still of great value."

Fredenburgh himself is still salvageable if he uses his time in prison to "reflect on what he's done and make amends," Griesbach said.

The judge gave Fredenburgh credit for pleading guilty and sparing the victim the ordeal of testifying in an open trial, but added, "He also spared himself the complete airing of everything he did."

Cecil man charged in vehicle standoff

Snowplows used to eventually trap driver, end incident

A chase involving a historic military vehicle with a standoff sandwiched in between kept state Highway 29 closed for hours on the evening of May 8, and a Cecil man has been arrested and charged in the incident.

The Shawano County Sheriff's Department responded around 5:15 p.m. to reports of a heavy truck-type military vehicle on the highway in western Shawano County travelling down the roadway with a flat tire, thus causing a traffic hazard, according to Lt. Jesse Sperberg.

Deputies located and attempted to stop the vehicle, according to Sperberg, but the driver, identified

in court records as Aaron Renel, led them on a short chase, coming to a stop in about a half-mile on the eastbound lane median of Highway 29 near County Road G in the Town of Seneca. The eastbound highway was shut down due to the incident.

Renel, 39, allegedly would not cooperate and would not exit the vehicle. Because of comments allegedly made by Renel and the conditions of this incident, the Shawano County Special Response Team responded to this scene, Sperberg said. Deputies, including trained negotiators, communicated with Renel for about four hours, and during this time, arrangements were made with the Shawano County Highway Department for the use of snowplows in case the driver

tried to flee the scene.

About 9:30 p.m. Renel allegedly did just that, heading eastbound on Highway 29. Deputies tried to stop the suspect vehicle, using the snowplows in an attempt to perform a moving roadblock. The vehicle then crossed the median and began heading eastbound in the westbound lanes of the highway, according to Sperberg.

Renel allegedly came back to the eastbound lanes but then against crossed the median and was driving the wrong way down the highway. At one point, Renel allegedly drove into the median and a deputy operating a snowplow was able to pin the truck into the median, immobilizing it. Renel allegedly would not exit his vehicle and had to be removed with force. No serious injuries were reported to any law enforcement or this suspect, Sperberg said.

Renel made his appearance in Shawano-Menominee County Circuit Court on May 9 and is being charged

with felony count of fleeing and eluding an officer in a vehicle and second-degree recklessly endangering safety, along with a misdemeanor count of resisting or obstructing an officer.

Shawano-Menominee County Circuit Court Judge William Kussel Jr. set a \$10,000 cash bond for Renel and scheduled an adjourned initial appearance for 1:30 p.m. May 18 in Branch 2 at the Shawano County Courthouse. At that appearance, Kussel will also address charges filed April 29 against Renel that include intentionally pointing a firearm at a person, disorderly conduct with the use of a dangerous weapon, possession of THC and possession of drug paraphernalia.

Other conditions of the bond include absolute sobriety and no illegal drugs, with prescription medication permitted. Renel is also not allowed to operate a motor vehicle.

Kussel also ordered a competency exam for Renel.

Musolff named new Shawano School Board president

Musolff's election generated applause from the audience of about 40 people.

Jamie Beyer, who was just elected to the board in 2021, was named vice president by unanimous consent. Another newer face, James Davel, was named the board's clerk, also by unanimous consent.

Chuck Dallas was reelected as treasurer for a second term, getting five votes and beating out Alysia Pillsbury and Mart Grams, who each received two votes.

The leadership positions are for one year, after which time the board will cast new votes at its reorganizational meeting in May.

Event planned to aid youth fighting leukemia

Celebration and fundraiser will take place May 21 at Doc's Harley Davidson in Bonduel

Doc's Harley-Davidson in Bonduel will be hosting a celebration and fundraiser for a 2-year-old who is battling leukemia.

Amira Rynish, of Green Bay, was diagnosed with leukemia last June, said her aunt, Ashley Pearce.

"She was diagnosed about a week after her second birthday," said Pearce. "The recovery for leukemia is about 2½ years of active chemotherapy treatment, in addition to steroids and other chemotherapy drugs."

Pearce added that Rynish is being treated at the Children's Hospital in Milwaukee.

"That is about a two-hour drive one-way for her family to get there," said Pearce. "How many times a week she is down there really depends on what part of treatment she is in."

To assist her sister and brother-in-law in covering financial costs, Pearce helped to organize the benefit at Doc's, which will be May 21 from 3-8 p.m.

"We are going to be close to the zoo area, so families can go and look at the animals," said Pearce. "We are going to also have a kids' game zone, which will feature face painting."

She added that raffles will also be included, with beef, guns, booze and a mystery box being raffled off, as well as pulled pork and sloppy Joes being supplied for food.

"It is kind of going to be a celebration for how far she has come in her treatment, but also an effort for us to cover as many of her financial expenses as possible," said Pearce.

Pearce said that, throughout the process, the family has met a lot of people in similar situations.

"I want people to leave this event knowing that this is more common than they think," said Pearce. "It is heartbreaking to know that so many families are hearing the news that we heard last June."

Pearce said that Rynish noticed this and is showing support for people in the same situation as her.

"You see how much she cares and loves for others around her — she is very receptive of others' emotions, I think, because she has

gone through so many emotions herself," said Pearce. "Amira has a really good outlook on life, so I think it helps to relieve some of the hard days."

She noted that the family has heard support from the Shawano

and Bonduel communities for Amira.

"The support that we have had from people looking to donate and volunteer, it is amazing," said Pearce. "To see how close a family and a community can come to-

gether when someone is affected by cancer is amazing."

Pearce added that the Rynish family is also donating to other families who are in similar situations.

"Amira has a little brother, Atlas, who just turned 1, so some of his clothes that he has out grown are getting passed forward to another family," said Pearce. "They are also looking for ways to ease the burden that leukemia brings on a family."

She also noted that although hearing the diagnosis was heartbreaking, the silver lining has been that the family has become much closer.

"We have always been a super close family, but this has brought us together in a way that can't be replicated," said Pearce. "To use humor and celebrating the good days has helped to handle the rough days."

In addition to organizing the event, Pearce mentioned that she and the rest of the committee are partnering with the Community Benefit Tree.

"They are a nonprofit organization that helps to plan benefits and help with families who are going through medical and financial situations," said Pearce. "All of the money that is raised in this benefit gets put into a special fund, and they will help to manage the money — including paying Amira's medical bills."

To sum up what visitors can expect at the event, Pearce said that it should be an afternoon and evening of family fun.

"Families should not be afraid to bring their kids," said Pearce. "There are multiple raffles. There is a full slew of things that will be available."

Pearce added that Rynish recently learned about celebrations and parties and is excited for this upcoming celebration.

"I don't know if she knows it's about her," said Pearce. "We are planning on having a birthday card stand, where visitors can give her card for her birthday in June. She loves dinosaurs, so she excited to see all of the different dinosaur decorations."

Ask lawmakers for the records they delete

If a legislator deletes an email, is it truly gone? Not necessarily.

On March 10, Dane County Circuit Judge Valerie Bailey-Rihn ordered Assembly Speaker Robin Vos to search for deleted emails that should have been preserved after an open records request from American Oversight, a watchdog group.

Weeks later, Vos' team surrendered an astounding 20,000 emails recovered from the "deleted items" folders of government email accounts.

Obtaining records from state lawmakers can be especially difficult. Decades ago, the Wisconsin Legislature exempted itself from the state's records retention statute. The smallest township in Wisconsin is required to keep some records for years, but the legislators and their staff can destroy records at will.

The state's open records law states that, once a record has been requested, destroying it is illegal. If you make an open records request, even legislators

Steve Fawcett, Vos's staff counsel, waited up to 13 days before he notified staff to stop deleting records that may have been responsive to American Oversight's requests. On March 30, Bailey-Rihn found Vos in contempt of court in a different case, saying he and the Assembly had shown "a collective and abject disregard" of a prior order to produce the records.

Former Wisconsin Supreme Court Justice Michael Gableman, who was hired by Vos at taxpayer expense to search for evidence of fraud in the 2020 election, was also ordered by a

need to pause their deletions to properly respond to your request.

Bailey-Rihn took this further, ordering Vos to search for records that had been deleted but were still retrievable.

judge to stop deleting records.

The Wisconsin Legislative Council, the nonpartisan agency that gives legal and policy advice to the Legislature, concluded last year that Gableman's Office of Special Counsel is subject to the records retention statutes, and yet it was continuing to delete records it decided were "irrelevant or useless" to its investigation.

As the Wisconsin Examiner recently reported, the ability to request records that have been deleted opens up a new avenue for reporters and others seeking to hold public officials accountable — and perhaps provides an end-run around lawmakers' ability to delete records.

"I've already changed my request template," Amanda St. Hilaire, an investigative reporter at Fox6 WITI in Milwaukee who makes hundreds of records requests a year, told the news outlet. "I've never thought to request specifically deleted records because based on the way the law works, I al-

ways was under the impression that if they could retrieve those records, that would be responsive to my request."

Jeff Ylvisaker, director of the Legislative Technology Services Bureau, declined to answer my questions regarding its retention policies that might explain how much email is in their archives and perhaps still accessible.

That's unfortunate, because lawmakers shouldn't be deciding which records to keep and which to destroy, a power that could be used to hide misconduct. Lawmakers' exemption from the retention rules in place for everyone else should be eliminated.

Until then, citizens seeking to know what lawmakers are up to should be asking them to search the trash cans, too.

As Roe v. Wade in limbo, is it 1849 or 2022?

On May 2, a leaked draft opinion of the U.S. Supreme Court showed that our nation's highest court intends to overturn Roe v. Wade, our constitutional right to abortion.

The leaked opinion from the Supreme Court is an unacceptable roll back of our constitutional rights. It's evidence of a frenzied effort from politicians and judges to restrict our freedom to choose, and continues a long-running war on women, health care and reproductive rights.

Right now, Roe v. Wade is the only thing standing between us and a 173-year backslide in Wisconsin's health care system. If the highest court's draft opinion becomes final, Wisconsin would revert back to a criminal abortion ban written into law in 1849.

The 1849 law makes abortion illegal, even in cases of rape or incest, and would also threaten doctors who provide or facilitate abortions in Wisconsin with felonies. It could force local clinics to close their doors for good, barring millions of Americans from access to essential medical care.

This statute has not been enforceable since the U.S. Supreme Court ruled abortion was legal in the 1973 Roe v. Wade decision, but it was never repealed and remains on the

By punishing not only those who are in critical need of reproductive health care but also the medical professionals giving them a safe choice, politicians and supreme court justices against Roe v. Wade are telling Wisconsin one thing: your body, their choice.

Twenty-six states would lose access to safe abortions if this draft opinion were to become final. That means 36 million women could be stripped of their right to make decisions about their own bodies. Those 36 million women aren't strangers — they're our neighbors, our friends, our children and people who make our communities what they are.

For now, abortion is still legal. The draft opinion that was leaked has no

current legal authority, but attacks on reproductive freedom are real and significant. The high court is opening the door for politicians to impose new restrictions on people's freedom to control their own bodies.

This is a wake-up call to come together to protect and support our friends and family members' ability to decide if or when they become a parent.

No judge, no politician, no elected or partisan-appointed official should be able to take away our right to make personal medical decisions for ourselves, or take away our ability to decide if we want to start a family.

These funds will be distributed

over two years of programming to initiate a revisiting of the theoretical model of sustainability and SDI as an institution.

Tom Kenote Jr., SDI director, is excited to use the Bay and Paul Foundation's support to develop a new era of SDI focus and work.

"We are excited for this next iteration of the Menominee Theoretical Model of Sustainability," Kenote

said. "We plan to host community dialogue sessions to reimagine what sustainable development looks like in today's context. We also plan to use the funding to support operations here at the institute."

The funds provided cover SDI staff costs to plan, implement, analyze and present community workshops and convening. Work has already begun.

Holt and Bascom Logging Camp Museum to reopen

The Holt and Balcom Logging Camp Museum in Lakewood will reopen on Memorial Day weekend. Maintenance and cleaning has been done by volunteer staff to ready the site for visitors.

A recoating of the camp is expected to be completed this summer by Mountain Log Homes, and Camp Manager Dave Zuleger's to-do list also includes repairing two windows. The recoating is an expensive procedure, and donations are needed to cover the cost.

"We are so happy these schools will be able to join us this year," said Bob Brown, school tours coordinator. "The staff always enjoys seeing the excitement build as the children enjoy a unique hands-on interactive experience at the logging camp."

Camp Director Kathleen Marsh reported that the museum lost one of its best school tour guides this past winter.

"Don Seifert was a loyal volunteer staffer at Holt and Balcom. Each spring for the past decade, he was part of our team of school tour guides. Don's face would light up as

he watched fourth graders from area elementary schools bound off the bus and run across the lawn to enjoy a morning of living like a lumberjack."

Seifert's favorite part was patiently teaching the kids how to use a two-man saw — repeating over and over that the key to success in sawing a log efficiently is to pull, not push, the saw, and to work as a team, Marsh said.

"To help them remember, Don

would lead the kids in chants of 'Pull! Pull! Pull!' she said. "When the cut was almost made, he would have the kids yell out 'Timber!' — always aware that he would have to play the referee, as the wanna-be lumberjacks fought over who would be able to take home the cut piece as a souvenir."

One of his proudest moments was being named Oconto County History

Society Volunteer of the Year, she said.

"That award, which meant so much to him and to his wife, Barb, has never been given to a more deserving person," Marsh said. "Just a few weeks ago, I saw him at a funeral and asked if he would help us out again this year. Without hesitation and wearing a big smile, he said, 'Of course.' Some people cannot be spared. Don was one of them for us. It will not be the same out at the camp this spring without him."

As in the past, the Logging Museum will be open 10 a.m. to 3 p.m. Saturdays, Memorial Day through Labor Day. Special tours can also be arranged by calling Brown at 715-276-3505 or Marsh at 715-276-6515.

The museum is grateful for donations from those who want to help keep the area's logging heritage alive at the oldest logging camp in America still sitting where it was built, Marsh said. USDA seeks proposals for wildlife enhancement initiative

The U.S. Department of Agriculture is welcoming new and modified proposals from conservation partners for the State Acres for Wildlife Enhancement initiative, a part of the Conservation Reserve Program focused on effectively managing wildlife habitat.

USDA's Farm Service Agency has expanded available practices under this initiative in response to feedback from partners.

"We are committed to offering a strong suite of voluntary conservation options through the Conservation Reserve Program," said FSA Admin-

istrator Zach Ducheneaux. "In 2021, we made several updates to CRP to improve program participation and strengthen its climate benefits. As we work to build on those efforts, we're now encouraging producers to help us strengthen the wildlife benefits of CRP through our SAWE initiative."

Through SAWE, producers and landowners restore vital habitat in alignment with high-priority state wildlife conservation goals. Specifically, landowners establish wetlands, grasses, and trees. These practices are designed to enhance important wildlife populations by creating criti-

cal habitat and food sources. They also protect soil and water health by working as a barrier to sediment and nutrient run-off before they reach waterways.

To help improve the planning and implementation of the SAWE initiative, FSA is adding two new practices with the assistance of USDA's Natural Resources Conservation Service, FSA's sister agency. In partnership with FSA, NRCS employees across the country provide CRP participants with critical conservation planning assistance, which will now include managing for early successional habi-

tat cover establishment or management, and wildlife habitat planting.

These additional eligible practices will enable SAWE partners to better target a wide variety of wildlife species, such as the Northern bobwhite, lesser prairie-chicken, and the New England cottontail.

As part of this year's SAWE sign-up, FSA will also authorize cost-share assistance for producers who would like to re-enroll acres in CRP but need assistance updating their vegetative cover to align with NRCS practice standards for early successional habitat or wildlife planting.

If any owner or occupant of real estate in the Village of Bonduel fails to cut or otherwise properly destroy in due season any such weeds or rank growth of vegetation, the Village Weed Commissioner shall, as provided in Chapter 24-9(c) of the Bonduel Municipal Code, cause a written notice to be served upon the owner or occupant as to this fact, notifying such owner or occupant that unless such weeds are cut or otherwise properly destroyed within five days of service of said notice, the Village Weed Commissioner will cause such weeds to be cut or otherwise destroyed and the actual cost thereof, together with an administrative fee equal to ten percent of the actual cost, shall be charged to the property owner. If such charges are not paid by November 15 of the year in which they are billed, such charges, together with an additional administrative fee for collection equal to ten percent of the total of such charges and fees, shall be extended on the next succeeding tax roll as a tax charged against the property affected and collected in the same manner as are other taxes, pursuant to Wis. Stats. § 66.0517.

The board of review may not hear an objection to the amount or valuation of property unless, at least 48 hours before the board's first scheduled meeting, the objector provides to the board's clerk written or oral notice of an intent to file an objection, except that upon a showing of good cause and the submission of a written objection, the board shall waive that requirement during the first 2 hours of the board's first scheduled meeting, and the board may waive that requirement up to the end of the 5th day of the session or up to the end of the final day of the session if the session is less than 5 days with proof of extraordinary circumstances for failure to meet the 48-hour notice requirement and failure to appear before the board of review during the first 2 hours of the first scheduled meeting.
3. Objections to the amount or valuation of property shall first be made in writing and filed with the clerk of the board of review within the first 2 hours of the board's first scheduled meeting, except that, upon evidence of extraordinary circumstances, the board may waive that requirement up to the end of the 5th day of the session or up to the end of the final day of the session if the session is less than 5 days. The board may require objections to the amount or valuation of property to be submitted on forms approved by the Department of Revenue, and the board shall require that any forms include stated valuations of the property in question. Persons who own land and improvements to that land may object to the aggregate valuation of that land and improvements to that land, but no person who owns land and improvements to that land may object only to the valuation of that land or only to the valuation of improvements to that land. No person may be allowed in any action or proceedings to question the amount or valuation of property unless the written objection has been filed and that person in good faith presented evidence to the board in support of the objections and made full disclosure before the board, under oath, of all of that person's property liable to assessment in the district and the value of that property. The information that is provided under this paragraph, unless a court determined that it is inaccurate, is not subject to the right of inspection and copying under s. 19.35 (1), Wis. stats.

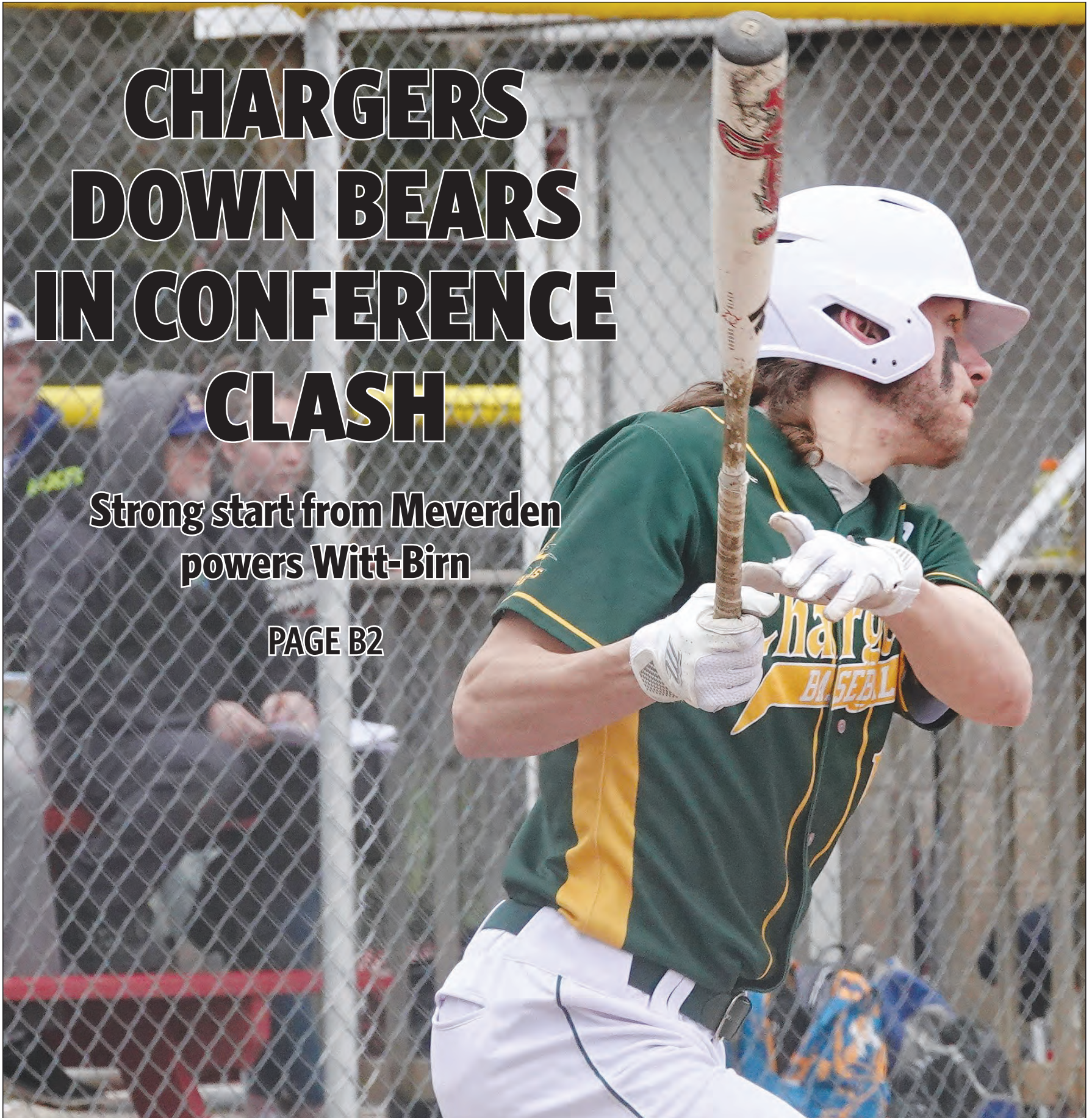

Witt-Birn blanks Bonduel

Mason Meverden pitched a gem to guide the Wittenberg-Birnamwood High School baseball team to a 5-0 Central Wisconsin Conference-East Division victory over Bonduel on May 2 in Bonduel.

"Just trusting the coaches and the pitches that they call, and then just executing the pitch," said Meverden on what made him successful. "To go all the way through the whole game, you gotta be efficient and not walk people, and that's what I tried to do, just throw strikes."

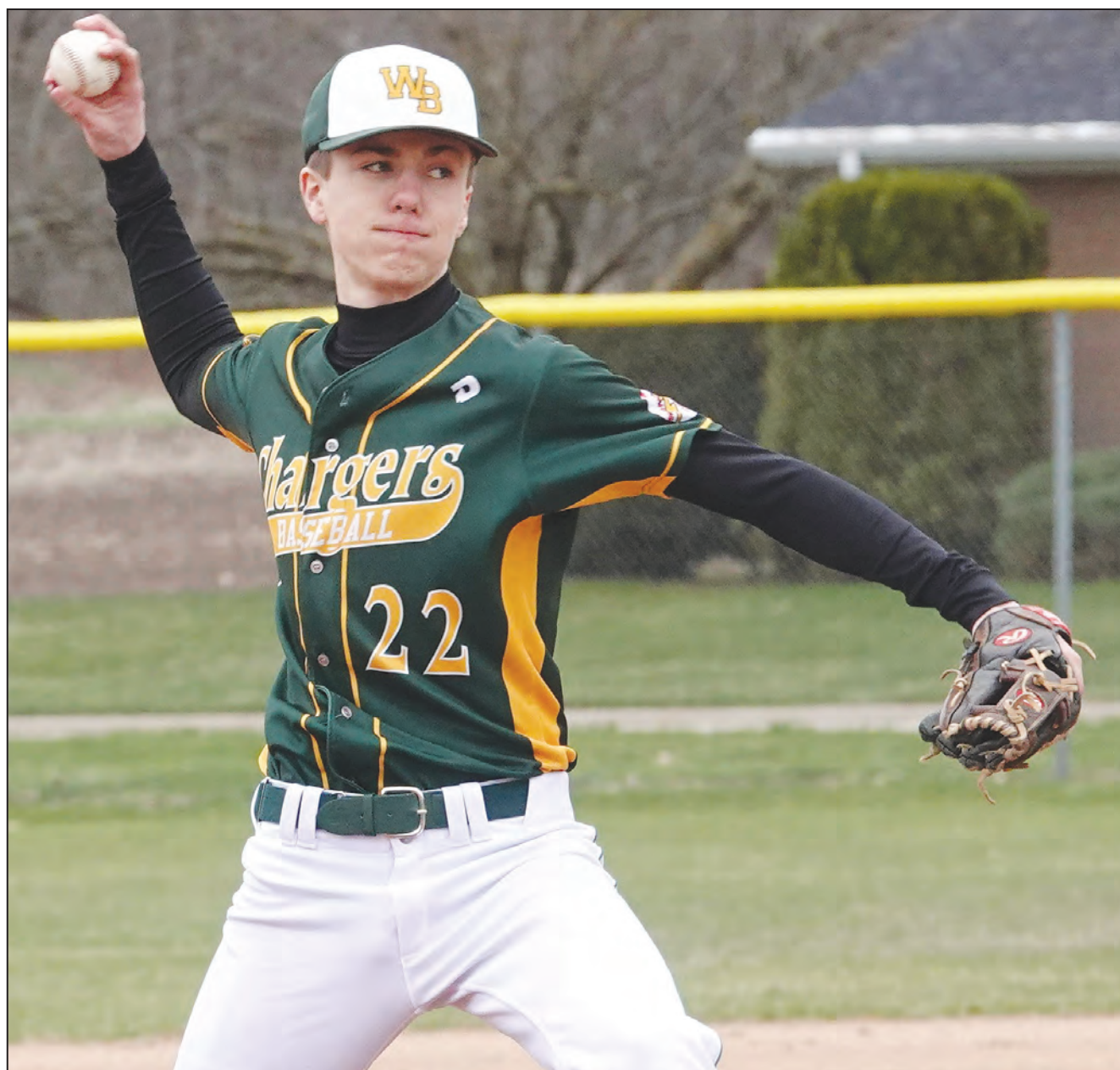
He got some timely defensive plays behind him and the team's offense was eventually able to get him some run support.

The first inning was one of Bonduel's best scoring chances after a leadoff double from Noah Weier. The Bears tried to bunt him to third, but the Chargers pounced on the ball and eventually got Weier out after a rundown. Later in the frame, Meverden got a flyout to strand runners at first and third.

Bonduel's Karson Stoss singled to open the third inning, but he never moved off the base as Meverden got a strikeout and two flyouts to escape the frame. Reece Stoltenow walked and Adam Beilfuss singled in the fourth inning for Bonduel, but Meverden was able to pick off a runner at second base to end the threat.

Charlie Tauchen and Colin Margelofsky each singled in the fifth for Bonduel, but Meverden escaped the inning with a strikeout. Bennett Engel and Stoltenow singled to open the sixth, but a forceout followed by a double play ended the scoring chance.

Tauchen and Weier each tallied hits in the seventh against Meverden, and he eventually went over 100 pitches. Ben Wesolowski came on in relief and needed just two pitches to induce a game-ending groundout.

"We've been really consistent all year, not many errors," said Meverden. "So I pitched to contact — let them put it in play because I'm confident every single time that we can get them out. Our outfielders are great, they cover so much ground out there. It calms you down a lot."

After stranding the bases loaded in the first two innings, Witt-Birn was able to push across the game's first run in the third.

Max Fraaza and Evan Meverden were hit by pitches and Chase Krull walked to load the bases for the Chargers. Kaden Schmidt then walked to plate Fraaza.

While it ended up being the only run against Bonduel starting pitcher Mason Bohm, the visitors drove his

pitch count up in a hurry and forced a pitching change in the third.

The Bears ended up using three pitchers in the contest in an effort to preserve some pitching for later games in the week.

"So they really made me throw strikes. They were really patient in the box," said Bohm, who ended up getting the first seven outs. He walked four batters and hit three others while striking out three. "We were battling a tight zone all day — and they were too. I thought it was a pretty good zone, I just couldn't hit it."

In all, Witt-Birn drew nine walks, with Quinton Sippl having four of them.

Witt-Birn added two runs in the

fourth, with Sippl walking and Ian Salvesen and Ben Wesolowski singling to load the bases at the start of the frame. Fraaza came through with a sacrifice flyout to plate Sippl, and then Pierson Potrykus grounded out to plate Salvesen.

In the sixth, a misplayed flyball and error on a grounder helped the Chargers score their final two runs. Wesolowski scored when Fraaza reached on the error. Fraaza later scored on a balk.

"This kept us in the running for first and second in conference, so we just have to play it that way I guess," said Fraaza on what the win meant to the team.

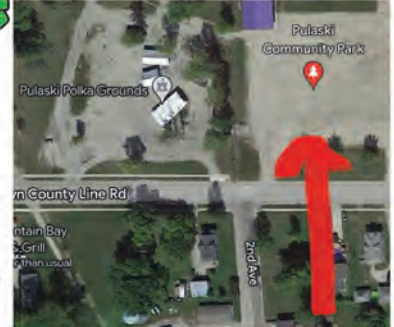

Artist draws on wood, wildlife for inspiration

White brings nature of Oconto County alive from old Baptist church

A vivid imagination, an eye for detail and a love of wildlife have added up to a successful career for Lakewood's Joan White.

She has owned and operated Nicolet Studio out of a former church building in the northern Oconto County community for nearly 40 years.

"The idea was when I graduated from art school, I wanted to be an artist," White said on a recent Saturday afternoon in her studio.

"I guess I didn't realize how unusual that is, to make a living as an artist. When I moved up here, I needed a studio space, and this place was sitting vacant. It's an old Baptist church. I got it for a song, fixed it up and have been here ever since. That was 38 years ago."

White is no stranger to the Lakewood area.

"I'm from Appleton, but my folks had a cottage up here on the Oconto River," she said. "That's what started me coming up here as a kid. I just fell in love with the area. It's peaceful."

With a lot of help from her husband, Ken, a retired carpenter, White's speciality is paintings on carefully selected slices of wood.

"I'm drawn to the forest — always have been," she said. "I always liked wood. I started painting on a couple boards and realized I had a feel for it. Sometimes, I have an idea in my head of what I want to paint, and then I have to look for the right piece of wood. Normally, I stare at the wood, I see something and I go from there."

White's original plan was to come up with unique pieces of art.

"Initially, it was trying to sell something and put food on the table," she said. "I was doing landscapes, a whole smattering of things for the first few years. I started painting on boards and then my husband starting finding some more unusual wood."

"I wanted to paint something that no one else was doing or couldn't do. Instead of just putting a bird on a branch, I really studied the wood, tried to see what was in it and let it tell a story to me. The knots, the grain, the color, the shape, I took it all in. I sketch out what I see and paint from there."

Ken cuts the wood, cures it for a year or more, kiln-dries the wood and planes and sands every piece until they are glassy smooth. The final painting is finished with several coats of wood sealer.

White prefers burl wood, but she also uses wood from birch, maple, cherry, black walnut, oak and ash trees.

She sells much of her work through a website — joanwhite.com — and the studio's Facebook page, facebook.com/JoanWhiteWoodPaintings.

"We traveled around the country and did log home shows," she said. "Usually, I was the only artist at the show because nobody had thought of it. I formed a relationship with collectors all over the country."

Many of White's pieces feature endangered or threatened animals.

"Probably 80% are bears and deer, the usual thing, but then I have to break away from that," she said. "We travel a lot, so I have a lot of subject photos from different places that I can use."

White said she has painted thousands of pieces over the years and usually works on one at a time.

Most of her work are reproductions.

"Mostly everything in here are reproductions of wood pieces," she said. "They look like wood, but they're a print. My printer laminates a lithograph to a composite and then cuts it out so they look like wood. They've really been selling well. People like them for their cabins, and they're a fraction of what an original costs."

"I have a really good printer in Green Bay," she said. "She's a photographer. I take her the original piece, she does a really high-res photo of it and she has a really fancy printer and makes the prints. I sign and number them on the back so they're a limited edition."

Customers who wander into Nicolet Studio, located at 15346 Gage St., a block off of state Highway 32, usually purchase the reproductions.

"The online sales are more the original pieces because those are true collectors that are looking for my original work," White said. "Once people started liking my work and word got around, I formed close relationships with my collectors. When I would paint a piece and think, 'Oh, Karen would like this piece,' I'd contact her."

Some of those collectors have dozens of White's original pieces.

"One time, Ken and I did a show in Chicago and one of our collectors invited us over for dinner," she said. "It was up and down the halls and everywhere. He and I hadn't seen some of these pieces in quite awhile, so it was fun to revisit them."

White has kept only one piece for herself.

"The one thing I took away from going to art school is I remember one instructor said, 'If you're going to make a living at it, you can't get attached to your own work,'" she said. "I've kept one piece for myself out of all of them. It was after a trip to Africa. When I got back, I did a collage of the trip and it was meaningful, so I kept it."

White knows the day she stops painting will eventually come, but that won't be anytime soon.

"I get days where I'm not feeling creative, but it doesn't happen very often," she said. "I just go sit in the woods or go trout fishing and it re-inspires me. I am working a little less now because I feel like I've earned it. I used to work every single day in the summer. I try to be here from 10 to 4:30, but if we want to take off and go camping, we do. I probably worked too hard, but that's how you get good at it."

Fashion show provides more than dapper attire

Event helps Shawano Woman's Club provide things for the community

The fashion was in the 1920s, but the atmosphere was in the 1920s as the Shawano Woman's Club held its first fashion show since the coronavirus pandemic ground everything to a halt two years ago.

Even though the event, which started 16 years ago, gave female volunteers a chance to show off modern fashions from local retailers May 5 at The Gathering, the main purpose for the show was to raise money for the club to help nonprofit organizations and provide scholarships for secondary education.

"We do this for our philanthropy," said Cindy Holewinski, the chairwoman for the fashion show. "This is to benefit our community."

The 1920s were known as the Roaring Twenties and, with COVID-19 sidelining the woman's club's main fundraiser, Holewinski said it made sense to commemorate such a liberating time for women.

"We had the suffrage (movement)," Holewinski said. "It was so fitting to

use the 'Women Roaring Back' theme, because it meant we were back generating the money for our philanthropy. The second reason we chose to do this type of event is to bring women together. They become partners and sisters in our mission."

Many in attendance decided to don 1920s attire, wearing sequin fringe dresses and other items that looked like they came out of "The Great Gatsby."

More than \$16,000 in items were donated by local businesses and organizations for raffles and auctions, and over 250 people packed the dining hall to check out the goodies and watch their fellow women strut the runway. "We are what we imagine," Kiowa author N. Scott Momaday wrote. "Our very existence consists in our imagination of ourselves. Our best destiny is to imagine, at least, completely, who and what, and that we are. The greatest tragedy that can befall us is to go unimagined."

While Momaday's message affirms the views of optimists who see

life's proverbial glass half-full, as well as those dreaming lofty dreams for themselves and their loved ones, I've found it resonates loudest in the output of artists. The asser-

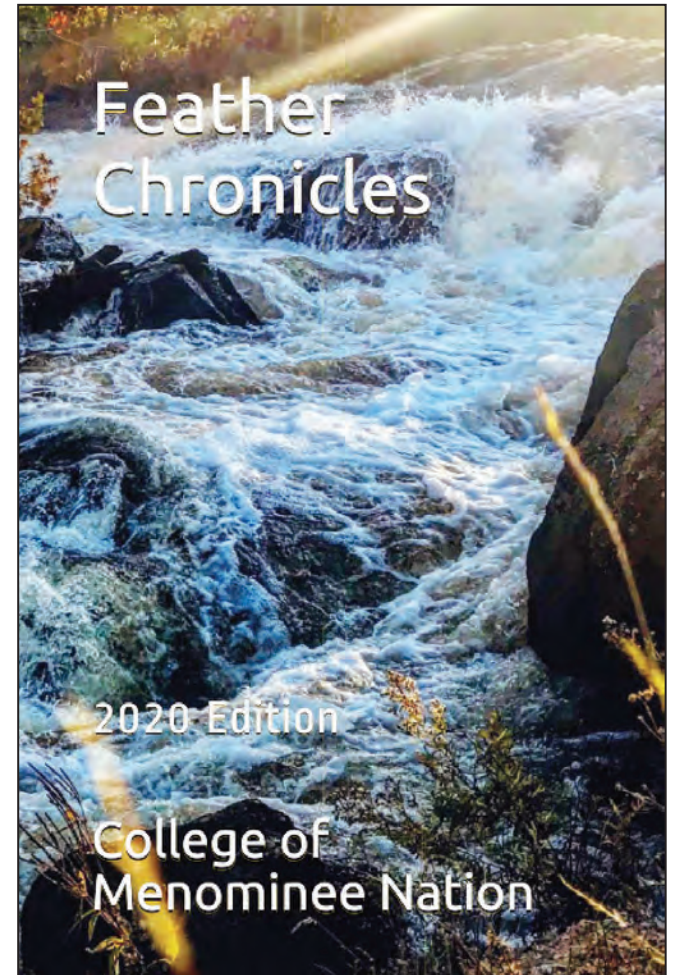
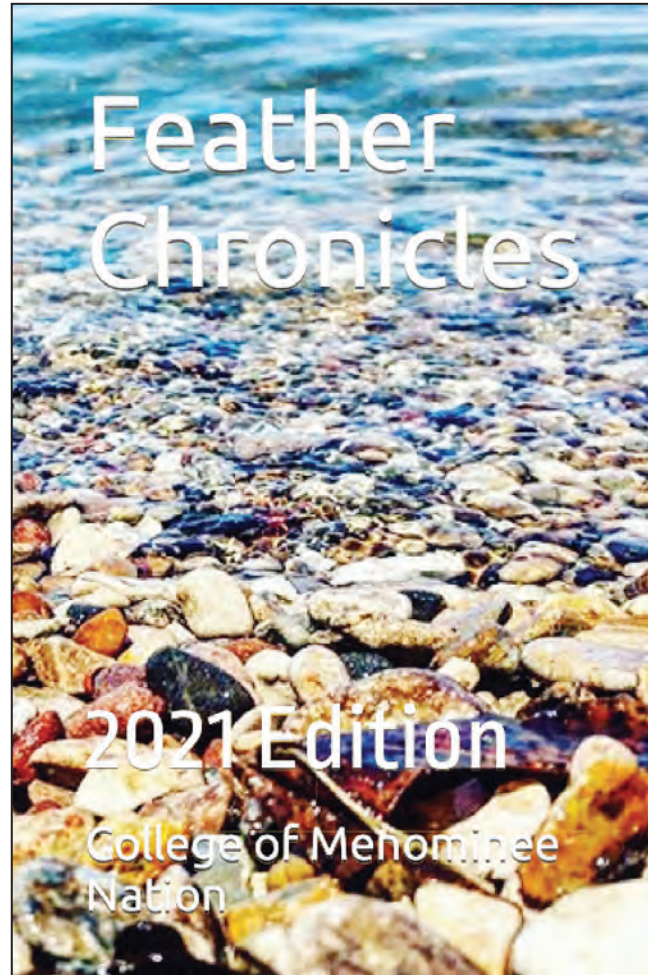
tion is perhaps most apparent in the works of emerging talent.

Since 2008, College of Menominee Nation has produced an annual journal dedicated to showcasing the art of the college community titled, "Feather Chronicles." Spearheaded by faculty emeritus Dr. Dennis Vickers, the text features the work of people affiliated with CMN.

"It began as a writing campus club where students workshopped their stories," Vickers said. The periodical evolved out of those gatherings, as "the principal objective for the journal was to provide a place for students to publish their work." With Vickers' editorial guidance it became more — a creative hub where art could be both shared and enjoyed.

Available in both print and electronic versions, the issues circulate widely and are often offered as gifts to visitors at either the college's Keshena or Green Bay campus. Yet, Vickers noted what pleased him was contributors' desire to "share the journal with their family and list the accomplishment on their resumes." The success of the publication was evident from the get-go, and soon CMN employees and community artists were adding their voices to the fold.

Flipping through the pages, one finds lines examining the natural world, humanity and personal identity. There are verses on both love and loss and all of the cathartic emotions that accompany them, as

well as some celebrating humor, friendship and wonder about what has been and what will come next.

The presentation is noteworthy in its own right, as the images on the covers as well as those shuffled within the pages showcase contributors' photographic eye for moments worth savoring. Upon reviewing an issue for yourself, it's easy to recognize why the announcement of each new entry is eagerly anticipated.

In 2012, CMN's founding president, Dr. Verna Fowler, wrote the introduction to that year's issue which spoke to a sentiment that faithful readers share: "In many ways each year, our students, faculty and staff, and friends of the College generously express their thoughts and insights on American Indian and other cultures. Their work in the visual and theatre arts, and through music, poetry and prose, makes our College a more lively, spiritual and satisfying place for all.

'Feather Chronicles' is one of our most enduring channels for sharing the creative writing and art of the College."

This spring's production of the 2021 issue marks a turning point in the journal, as Vickers is handing over the editor's keyboard. Although he has only been officially retired from teaching since the fall, a cancer diagnosis and its subsequent care has sidelined Vickers' vigor the past few years. Still, he continued to serve CMN and its students with strength and determination. Joining our department meeting last week, Vickers stated that ensuring the continuation of "Feather Chronicles" was "the last thing on my to-do list."

Having begun my own teaching at CMN the same day as Vickers in the fall of 2005, I can attest that his engagement with our students has been extraordinary to witness. Vickers' kindness, humility and tact has

amazed me time and time again, and that includes hearing him share the ins-and-outs of the campus publication that will forever be a part of his legacy.

Using the disarming humor that endears him to so many, Vickers explained the truth about inclusive, affirming publications: "It doesn't have to turn into 'The New Yorker' to be successful. It is successful as it is."

"Art is affirmation," is another line that Momaday wrote, but it's the showcasing of that art that allows it to reverberate. "Feather Chronicles" reverberates.

Saving today's youth from Nature-Deficit Disorder

I once took a birding class when I was an English major at Southern Illinois University in Carbondale. On the first day, my jaw sank when the professor explained that this class would not be a field course as I had hoped. Instead, we would study the skins of dead birds for a semester.

You'll never see a Cassin's auklet

or an Antarctic petrel in Shawano County, but I held their preserved skins in my hand. I needed a certain number of science credits and it served a purpose, but it was probably one of

the dumber classes I ever took.

We were given a 10-bird quiz on the first day to test our knowledge. I think I got them all right. At the end, we were given the same quiz.

One girl from Chicago (Carbondale attracts many Chicago-area students because of its natural beauty and a direct train line there) confided on our last day of class: "I still can't identify birds that are flying around."

Such is the nature of our young people today. Their faces are buried in \$1,200 iPhones, watching 10-second videos on TikTok of girls preening in front of a mirror, kittens climbing screen doors and camels spitting out their tongues. The days of kids going outside to play tag, sandlot baseball or anything else seem as unlikely as them asking for seconds on broccoli. A walk through the woods to look for animal tracks, shed antlers or birds seems even more remote.

Author Richard Louv has even come up with a term for those kids and adults who don't get outdoors much or experience the wonders of nature: He calls it "Nature-Deficit Disorder." His book, "Last Child in the Woods" is a great read. The cure is as simple as an occasional hike or hunt.

Introducing kids to nature seems natural for those of us who appreciate the natural world around us. At the same time, introducing youngsters to hunting is the next step. It's no secret that hunter numbers have been dwindling for the past few decades.

In 1980, there were about 17 million hunting licenses sold nation-

wide, according to the U.S. Fish and Wildlife Service. By 2016, that number had fallen to 11.5 million. An aging population, more single-parent families (many who have not been exposed to hunting), more private lands being closed to hunting for a variety of reasons, and the dozens of electronic and indoor distractions competing for our children's diminished attention span are just a few reasons that fewer people are hunting.

Did I mention the lack of hunter recruitment? Many of us hunters tend to be loners, or at least we enjoy alone time in a tree stand or ground blind.

My opportunity to recruit a new hunter came last fall, when a neighbor boy stopped by our rural New London home to see if he could rake leaves for us.

I've learned that raking leaves on a 2-acre parcel surrounded by trees is an exercise in futility and only serves to encourage the grass to grow faster, which requires more mowing. Few ever see our yard anyway, but I admired his willingness to work, so I said sure. Soon Andy Beals was busily raking leaves and loading them into the dump bed of my 6x6 Polaris Sportsman, then driving them the 100 feet to a pile in another section of the yard. He

smiled broadly when I offered the ATV for him to use. That's when he explained all the mishaps he had with ATVs, dirt bikes, knives and even a roll of Saran Wrap.

The stocky lad seems content with the world, always smiling and speaking in a slow, deliberate fashion as he offers his views on any topic.

Beals, 17, loves firearms and plans to one day enter the military. Our discussions on firearms led toward hunting, and soon I was inviting him on a deer hunt. This spring, the topic turned to turkeys and he was happy to share a blind with me, just to observe and learn more about the sport.

I loaned him a camouflage jacket, cap and mask, but since we were in a large permanent ground blind built of scrap wood, he didn't need camo pants. After putting out three decoys, we settled in. I sent out a few notes with my trusty box call, but as I had experienced on several days earlier, not a single tom answered.

Two hens appeared, briefly walked past our decoys and then moved off to a nearby cornfield to look for breakfast.

"I see one. There's a turkey," Beals whispered, pointing toward a nearby woods. It was still a bit dark, but I could clearly see the butt-up walk of a small raccoon.

"That's a 'coon," I said.

"I'm not very good at this," he answered.

We watched sandhill cranes picking around in the same cornfield. Ducks and geese were plentiful in the marsh area, with the whistle of wood ducks overhead a couple times.

Later, a coyote started to come to my calls, but the wind gave us away and he trotted off, never coming in range of my 12-gauge Remington 870 Super Magnum, loaded with 3-1/2-inch No. 5 shot.

Then it was time for breakfast at a nearby café.

Sharing our knowledge of and love for the outdoors seems both simple and profound. Reaching out to a neighbor kid is easy to do, but easier not to do. Take the time to reach out and save a generation from Nature-Deficit Disorder. You'll benefit as much as they will.

The meats evaluation and technology team, which included Kierstin Genz, Cheyenne Krueger, Cole Schaal and Ryann Wagner, placed 18th. Members evaluated beef, swine and sheep carcasses, identified cuts of meat, and graded the carcasses for quality.

During career development event competitions, FFA members in grades 7 to 12 are challenged to develop critical thinking skills and effective decision-making skills, foster teamwork and promote communication while recognizing the value of ethical competition and individual achievement. Most career development event teams consisted of four members who advanced through regional live and virtual competitions to be able to represent their FFA chapter at the state level.

Chronic lower back pain can be conquered

If you are like most people, you will have at least one episode of low back pain in your life. In fact, low back pain is the No. 2 reason that Americans see their doctor — second only to colds and flus. Low back pain is most commonly associated with heavy physical work, lifting or forceful movement, bending or twisting, awkward positions or standing in one position too long. Even minor events may contribute to an episode. Typically, the pain varies from severe and long-term to mild and short-lived.

Although low back pain has been considered self-limiting, recent research suggests that it is not. The results of several studies show that short-term symptoms do not always

resolve in one to two months. Instead, they tend to recur intermittently in most patients. Once chronic, the condition is associated with long-term disability and work absence.

There are many treatment strategies for chronic low back pain. All of these approaches have one thing in common — they are accompanied by a recommendation for exercise. Research has concluded that exercise is beneficial for people with chronic low back pain. However,

until recently, health care providers were not able to advise their patients about the probability of success under specific exercise programs.

A scientific review sought to determine which exercise program was the most effective for people with chronic low back pain. The review found that back strengthening and stabilization exercises are more effective than aerobics for reducing pain and improving function. Still, aerobic exercise is important for heart health and should not be abandoned.

What does this mean to someone with low back pain or someone wanting to reduce the chance of a low back pain attack? You should focus

upon strengthening and stabilization exercises and do them on a consistent basis. Exercise is important to your overall health, and it will increase your spine's ability to help you do the things you want and need to do. It is important to start any exercise program slowly and to gradually build up your speed and the length of exercise sessions.

Please note that before starting any exercise program, you should consult with your health care professional.

Celebrating seven decades of service

The time spent serving community was 'an honor and a pleasure'

Hanke's Sentry Foods is under new ownership, and the family that has owned Wittenberg's grocery store for more than 70 years has retired.

The Hanke family has sold the local grocery store, located at 110 S. Mission St., Wittenberg, to Hometown Grocers Inc., a family-owned and Wisconsin-based company. The Skogen family that owns Hometown Grocers has been in the industry since 1946. Hometown Grocers, a subsidiary of Festival Foods, also operates four other grocery stores in Wisconsin.

"The main reason that we purchased Hanke's is because we are in the business and enjoy grocery stores," said Steve Burkhardt, vice president of Hometown Grocers, or HGI. "We have found that smaller grocery stores like this, we feel like we can help serve them. There are lot of independent grocers looking to sell as they get to the end of their career, and they are looking to someone that they can trust that is honest and will take of their people. HGI is doing what we can to do that for them."

The sale was initiated by members of the Hanke family who decided to

retire. Their last day was April 26.

"I think it was just time," said Sandy Hanke, who helped run the store with her husband, Gary.

"We are just going to spend some time with family and try to get to a couple ball games here and there," Gary Hanke added.

Hanke's began as a Red Owl cor-

ner store in Wittenberg in 1951. From there, Roger and Bernice Hanke purchased the former International Harvester building that was located on Howard and Reed streets. In 1988, the Red Owl name was purchased by SuperValu, and the store in Wittenberg became Hanke's SuperValu in 1989.

Eventually, Roger and Bernice's children became involved with the store. Under the ownership of Gary Hanke, Dale Hanke, Sherry Hersant and Gary's wife, Sandy, the store moved to its current location in 2012.

"This has been a place where people come to get together and catch up," said Sandy Hanke. "There

are people of all ages who just come in here and feel comfortable and talk about their families, children and lives."

Gary Hanke said that with the sale of the store, the family is confident the next owners will continue the tradition of providing high-quality food to the people of Wittenberg.

"We are happy to find another grocery store that is family-oriented and that shares our values with the community," said Gary Hanke.

"We aren't completely sure on the name yet," added Sandy Hanke. "I believe that they will keep it a Sentry Foods, though."

"Community involvement is one of our values," said Burkhardt. "For the most part, we are going to continue to do the same things that they are doing."

Burkhardt added that over the

next few months, Hometown Grocers wants to integrate into the community before they make any major changes.

"There are always categories that are expanding and shrinking in the grocery industry," said Burkhardt. "Over the next few months, those things will become evident to us. When we first go in, our goal is to keep as much the same as possible. We want to get to know the people, get to know the schedule and keep the shelves stocked."

Sandy Hanke said that the family was ready to sell.

"We went to UNFI, the parent company of Sentry Foods, and said that we are thinking about selling, but nothing is concrete yet," she said. "They called us in December and said that we have someone who might be interested. From there, it

just kind of happened."

She added that Hometown Grocers will try to keep the store the same as when the Hanks owned and ran the store.

"They have said that in so many words," said Sandy Hanke. "They want to keep it as local as possible. We are not aware of anything new that they want to introduce. The basics will stay the same. They told me that they are going to continue to be involved in the community."

According to Sandy Hanke, Hometown Grocers has offered the same positions to all of the employees who are currently employed at Hanke's.

Throughout their existence, Hanke's has been involved by serving the community, as well as being involved in local organizations.

"We have played a large role in the community," said Sandy Hanke. "We help with local groups that need support. We put flyers in bags for organizations that are doing fundraisers. We are there for our community; they can shop here comfortably."

She added that they wanted to carry on the tradition of supporting local businesses and organizations that started with her father-in-law.

"Roger was heavily involved in the community," said Sandy Hanke. "He was involved with the Legion, the church and other organizations. It has been what the Hanks have been doing since I have known them."

Gary Hanke said that with their community activism, the family received the Melvin Jones Fellowship Award, rewarded by Lions International.

"That is an award given to individuals and businesses that serve the community," said Gary Hanke. "We are really honored to receive that award."

Hersant added that her family

has always felt like they were a part of the community, especially before they moved to their current location.

"At the old store, we knew everybody and could talk to them about their lives and families," said Hersant. "With the new store, there are some strangers that come in, but we get to know them."

Gary Hanke said that to have the opportunity to provide community members with groceries has been impactful.

"It has been an honor and a pleasure to serve our friends and customers in the Wittenberg area and the surrounding communities," said Gary Hanke. "We have developed quite a few friendships and relationships inside and outside of Wittenberg."

Reflecting on their time owning the store, the family chose some fond memories that stuck out over the past 70 years.

"I really enjoyed doing our June Dairy Month, where I could dress up like a character," said Dale Hanke.

"We also did frozen food months, where we would hold contests," added Gary Hanke. "There was usually a customer who would win a special sale. We also used to do a produce sale — that was always a lot of fun."

Throughout their time owning and managing the store, the Hanks said that they have learned a lot about being involved in the community and will continue to stay in touch during retirement.

"I don't see me stopping working with community groups," said Sandy Hanke. "I see us doing that, because it is what we do. I have made a lot of friends. I enjoy people, and I enjoy being a part of the community."

Gary Hanke thanked the staff for the hard work that they put in under the family's ownership.

"The staff and our employees have been essential to our success," said Gary Hanke. "We appreciate what they have done for us."

Switalla added that the family has always supported all of the village's functions and events, including Community Days, in addition to supporting the schools in the district.

The Hanke family said that they wanted their store to feel like a place where community members could meet and visit, as opposed to just coming in for groceries. Rogowski said that this has been the case in his experience.

"It was very common to visit the store and chat with many local friends and families that were there at the same time," said Rogowski.

Former Wittenberg Chamber of Commerce President Travis Rose said the store has always been a place where he was recognized or he recognized someone else.

"It was always fun to be able to see community members, knowing that there was a local resource without having to drive to a bigger area," said Rose. "That was place that I felt comfortable, where I could just engage with others in the community."

He added that the community is very grateful to the Hanks for their years of dedication to the people of Wittenberg.

"We are very appreciative of the efforts that they have made to make their service available to us," said Rose. "It is nice to have that local resource as opposed to traveling to Wausau, Shawano or Green Bay."
