

Search for homelessness solutions in city continues

SAM25 reps inform council about shelter's purpose

Forward movement appears to be happening on the issue of homelessness in Shawano.

Shawano City Administrator Eddie Sheppard said he planned to meet with representatives from Shawano Area Matthew 25 for more in-depth discussions following the June 11 Shawano Common Council meeting, where details were revealed on what the shelter can and can't do when it comes to helping homeless people.

Currently, SAM25 operates its shelter from November through April, which leaves homeless people with nowhere to sleep the other six months of the year, an issue that came before the council in May.

Kendra Brusewitz, SAM25 executive director, told the council it's important to keep the dialogue going on the homeless issue and how everyone can come together to find a solution.

"This is a SAM25 problem. This is a community problem," Brusewitz said. "There are a lot of root causes of homelessness."

She added that substance abuse and mental health issues are among the causes that can rip a home away from someone. Brusewitz said physical health problems can cause someone to not be able to pay for housing and put them out on the streets, noting that there are a number of elderly people who find themselves homeless.

"That's a growing concern, because as we are an emergency shelter, we do have some restrictions," Brusewitz said. "We can't service everybody."

Shawano resident Mark Quast, who spoke to the council in May about the homeless situation, suggested that some land near the Shawano County Landfill might be set aside for a safe zone for homeless people so that they're not continuously cited by police officers for trespassing in city parks and other places. He also suggested having a permit system for any homeless who wanted to pitch a tent in the safe zone.

Matthew Klein, a homeless man in Shawano, also made a return appearance and talked about some of the issues that cause homelessness. Klein is a National Guard veteran who had a run-in with law enforcement and was imprisoned until November 2024. He was taken in by

SAM25 where he stayed until the shelter period was over, and now he must find other places to sleep until he can find his way to a job and, eventually, a stable living situation.

"Limited funding from the community and local government has places like SAM25 and Newcap stretched thin," Klein said. "While Shawano does not face the same scale of homelessness seen in large urban cities, the issue is nonetheless significant for a city of its size. Homelessness here often goes unnoticed, because it doesn't always manifest in a straight-out typical image of people living on the streets. Instead, it frequently takes the form of hidden homelessness, where people and families are couch surfing, living in cars, living in the woods and staying in temporary shelters."

Klein said the decline in manufacturing

County clerk to resign July 11

Shawano County Clerk Kara Skarlupka has been contemplating retirement "for a while" and chose July 11 as her last day on the job at the courthouse.

"After thoughtful consideration, I have decided to retire at this time," she said. "I want to emphasize that this decision is in no way a reflection on Shawano County. It has been a privilege to work here for the past 12 years, and I am truly grateful for the opportunities and experiences I've had."

Skarlupka was elected in November to another four-year term that ends Dec. 31, 2028.

Her replacement will be appointed by the county board. A job posting for the role was placed on the county website June 5 and was not visible June 11. County Board Chairman Tom Kautza said June 10 the county had received a couple of applications.

The appointment by the board will be for the remainder of the four-year term.

Vacancies in the position are filled by appointment of the county board at the recommendation of the executive committee, which can either be for the remaining length of the term or until a special election is held before the end of the term.

Kautza said the appointment will be for the remainder of the term.

"Because of the expense of a special election, we will post the position and take applications to fill the rest of the term," he said.

While Skarlupka is leaving her job with the county, she said she will continue as town clerk in the Town of Washington.

"In regards to the Town of Washington, I do plan on staying with them until I fully retire," she said. "This is not a new position for me. I have been with the town for over 10 years as their clerk."

Skarlupka did not share what she will do once she retires.

"I would rather not share my retirement plans, other than spending more time with my family," she said.

The clerk operates under the direction of the county board.

The clerk serves as the election official for the county; oversees the election process of various federal, state, county, school board and local elections; serves as the clerk of the county board and custodian of records adopted by the board; issues marriage licenses and permits to the general public; and provides general information to the public.

The current pay is \$72,904.67 per year. Erica Davel is the current deputy county clerk, and Charlene Milavitz is the assistant deputy county clerk.

Public safety, injuries concern police chief

Injury in the line of duty is always a risk for law enforcement, but local officers are feeling it more frequently, according to Shawano Police Chief Mike Musolff.

Musolff told the Shawano Common Council on June 11 that there has been an increase in attacks on his officers. He noted that two of the officers are currently out of commission due to injuries.

“That’s getting to be quite alarming,” Musolff said.

A third officer was

kicked by a suspect who was being taken into custody. A fourth officer fell and hurt his elbow while chasing a suspect.

“We do a lot of training to try to prevent these things, but we’re seeing an increase this spring and early summer in our officers being hurt because of the conduct of suspects,” Musolff said.

The injuries came from regular calls, but Musolff is also concerned about the safety of the public. He noted that the organizers of Sun Drop Dayz did not coordinate with the police department to make sure the event was safe.

“They’re not really asking for officers to be at that event, which was unfortunate,” Musolff said. “We did have officers go to the event, and they definitely saw an increase in activities that law enforcement needed to be there for, and I’m very concerned about that.”

One of the incidents included an 18-year-old event participant who had a fake gun.

Musolff said more needed to be done to work with law enforcement when events take place in the city.

Alderman Jim Hauer, who also works as a deputy

for the Shawano County Sheriff’s Department, suggested making security a requirement for anyone wanting to hold an event in the city. Musolff said he and City Administrator Eddie Sheppard have been discussing the matter

and are working on safety protocols.

Alderman Kevin Barkow was dismayed that Sun Drop Dayz did not coordinate with the city to make sure safety of event participants was a top priority.

“I know that, when I

was on the board for Sun Drop Dayz, we always worked closely with the PD (police department) to make sure we had emergency plans in place,” Barkow said.

Negotiations continue between county, hockey league

Shawano County and Shawano Hockey League officials are trying to hammer out a list of repair priorities at the Crawford Center in Shawano, the hockey league’s home ice rink.

The repairs are for broken and damaged items in the building, noted when Nick Hesse, the county’s facilities management director, went through the building earlier this year.

Black marks on the walls, dented garage doors and damaged service doors

were highlighted. Initial estimates put the cost for the repairs around \$63,000.

Jim Davel, the county’s administrative coordinator, told the public property committee June 12 that he and Hesse recently met Adam Gafner, president of the hockey league, and others to discuss the repairs.

“The damage was discussed, and obviously being a volunteer organization, they can’t necessarily pay for everything right away,” Davel said. “So what we discussed was coming up with a prioritized list to work off.”

He said the league re-

cently used donated funds to purchase a new chiller and Zamboni.

“Their donated funds for that are pretty much spent,” Davel said. “What I would recommend is we go forward with signing the agreement (a new rental lease) ... and then we work the prioritized list of when and what things are going to be worked off as we go along.”

He also said both sides agreed there needed to be better communication going forward. Davel said the hockey league offered to help attract other users during the offseason.

“We got the temperature toned down, which I thought was important,” Davel said.

Not all supervisors were so quick to settle.

“The 60 days we gave them two meetings ago, that was basically thrown out then?” Allan Kuhn asked.

Kuhn was referring to the committee’s meeting in April when members voted unanimously to have the hockey league complete and pay for a set of repairs within 60 days. Those fixes included having the 16-by-20-foot garage door cleaned to remove

black marks, and a smaller garage door replaced. All walls would be repainted, and touch-up work would be done in the bathrooms. Stainless steel was to be put on the entry doors by the county. It was noted Dearco will donate the paint, with the painting being done by Lakeview Revival.

Davel accepted the blame for not enforcing that motion.

“The reality is they’re not going to be able to do all this at one time,” he said. “They don’t have the money to do that.”

“If they had taken care

of it in the first place, they wouldn’t have to worry about coming up with the money to fix it,” Supervisor Randy Young said.

Keith Herm, the county’s lead maintenance technician, said significant turnover within the leadership of the hockey league in the past four or five years has caused several issues, including a lack of communication with the county.

Davel said there needs to be some give-and-take with these repairs going forward.

Feemster pleads no contest in attack on girlfriend

Defendant facing up to 10 years imprisonment

Jordan Feemster pleaded no contest June 13 to three of the four charges against him and will be sentenced Aug. 25.

Feemster’s plea included an amended charge of attempted first-degree homicide by use of a dangerous weapon to first-degree recklessly endangering safety by use of a dangerous weapon. He pleaded to a similar charge, as well as criminal damage. As part

of his plea deal, a count of misdemeanor battery was dismissed but read into the record.

A sentencing hearing is scheduled for 2:30 p.m. Aug. 25 in Branch I at the Shawano County Courthouse. Shawano-Menominee County District Attorney Greg Parker is recommending 8-10 years for each of the reckless endangerment charges and 1 year for the criminal damage charge. Parker is recommending the sentences be served concurrently.

Feemster told the court that he has not been diagnosed with any mental disorders, but he is seeing a psychiatrist.

Feemster was charged after an incident May 24, 2024, at the Shawano Square Apartments on East Richmond Street after police spoke with the victim, his girlfriend at the time, and learned about how plans to go out for the night turned almost deadly.

According to the criminal complaint, the victim in the incident was getting ready to go out when Feemster asked for her phone passcode. Feemster saw a message from a co-worker and then pushed her into the bathtub and hit her on the left side of her head. After dragging the victim from the bathroom to the bedroom, Feemster went

to the kitchen and grabbed a knife, and then he put the knife to her side and neck, according to the complaint.

The victim told Feemster that she loved him and wanted to be with him, claiming to deputies that Feemster had a history of talking about self-harm. Feemster’s mother was called to help calm him down. The victim got out of the house and jumped into her vehicle, but Feemster chased her to the Shawano County Sheriff’s Department, where she ran inside for help and he fled, according to the complaint.

Feemster and the victim had known each other for

at least eight years, but they had only been dating for a few months, according to the complaint. The victim showed an officer wounds in her leg and knee area and claimed she was fearful for her life.

The Shawano Police Department found a knife on the bed and asked the victim if it was the one used to cause a 3-inch laceration on her neck, and she claimed it was. There was also an injury found on the victim’s knee and blood on the victim’s shirt, according to the complaint.

Feemster is currently in Kettle Moraine Correctional Institution in Glenbeulah, transferred there

after serving a 10-month sentence in Dodge County after pleading no contest to fleeing and eluding of officers and resisting those same officers.

Feemster has a number of criminal convictions in Wisconsin. In 2018, he was found guilty of second-degree recklessly endangering safety, victim intimidation and battery in Brown County. In 2014, he was found guilty, also in Brown County, of false imprisonment, battery and criminal damage to property. In 2010, he was found guilty on a misdemeanor charge of disorderly conduct in Brown County.

'No Kings' movement draws large crowd

Protesters urge end to Trump's latest immigration roundup actions, budget cuts

With chants of “No Kings” and support from others honking their horns as they drove past the Shawano County Courthouse the morning of June 14, the Shawano-Menominee Counties Democratic Party joined millions of other protesters around the nation opposed to President Trump, his actions and proposed policies.

Several local residents offered brief speeches mixed in with songs as about 250 people held up poster and signs in opposition to the president.

“In the beginning, they said they were going to deport the undocumented criminals out of America,” Jack Young said. “Then it became just the undocumented. Then it became the documented, but they said the wrong thing about the wrong people at the wrong time. Then all of a sudden they start taking U.S. citizens and taking them out of the country to foreign prisons in El Salvador without so much as a court hearing.

“I don’t know about you, but I looked it up in the Constitution, and that ain’t legal. When you think, ‘Oh, that’s just some undocumented person,’ what if it’s you next? What if they take you and don’t give you a trial, and send you to jail or prison, and you never have a chance to communicate with your

family? This is the risk that we have right now.”

Some demonstrators carried American flags upside down, while others had posters comparing Trump to Hitler.

An SUV with a handful of counterprotesters appeared across the street from the No Kings rally. One man with a bullhorn shouted “White power” and “I’m proud to be a racist” while offering up a Nazi salute.

From the steps of the courthouse, protesters were urged to ignore the man and stay peaceful. Many lined up along Main Street with the signs, but other than boos and chants of “Shame!” there was no other confrontation between the sides.

A lone city police officer stood watch from the edges of the protest.

Dr. Heather Nennig told the gathering of her medical training days in California.

“We saw patients who died from preventable cancers like cervical cancer. We saw patients who had limbs removed because of diabetic ulcers, because of people who had cuts on their feet and didn’t come in until it was too late,” she said. “We saw moms who didn’t come in for prenatal care, because they didn’t have care or were afraid to come in and get their care.”

She said medical care is a human right for everyone.

“They didn’t get care because they were undocumented workers. They were migrant farm workers. They were poor that couldn’t afford Medicaid or didn’t know how to get Medicaid,” Nennig said. “They waited, because they didn’t have the insurance that we all take for granted when we have that insurance.”

Nennig said the current bill in front of Congress would result in cuts of more than \$8 billion from Medicaid in the next 10

years, as well as reducing subsidies for the Affordable Care Act.

It’s been reported that 15 million Americans will lose their health care due to this bill, and 15,000 people will die due to this bill every year.

“We are going to start seeing this kind of care everywhere, not just at places like county hospitals,” she said. “The hospital just down the street, we’re going to start seeing people who don’t have care, and they’re going to wait, and

they’re going to wait until it’s too late. When they come in, they might have to lose a limb. They might not make it. They might die, because they didn’t get the care they needed in a timely fashion.”

Nennig said the change will affect everyone, even those with private insurance.

When people without proper insurance don’t seek medical help until it’s too late, the costs of that care is more than the preventive care. Those

higher costs get passed along to insurance companies, who pass it along to the consumers through higher premiums, copays and other fees.

Demonstrations like Shawano’s were held in large and small cities across the nation. Trump was in Washington for a military parade marking the Army’s 250th anniversary that coincided with the president’s 79th birthday.

Bike trail path subject of public meeting

Shawano Pathways aims for safer route in Town of Richmond

A \$35,000 grant to conduct a feasibility study for a new route for the Mountain-Bay Trail in the Town of Richmond is coming to fruition with a public meeting scheduled for June 25.

The public is invited to attend the meeting from 5:30-6:30 p.m. in Room A of the Shawano County Courthouse, 311 N. Main St.

“The Mountain-Bay Trail covers 53 miles through the county and 81 miles or so through three counties,” said Nancy Brown-Koeller. She is president of the nonprofit Shawano Pathways group that facilitates the development, implementation and maintenance of a biking and walking trail system in Shawano County. “All of it is on an old railroad bed, except for 4 1/2 miles in the Town of Richmond.”

Officials with the engineering firm MSA Professional Services,

Friends of the Mountain-Bay Trail and Shawano County Parks Department will discuss the need for a new route and the five alternatives explored as part of the study. MSA officials will make a specific recommendation as to a preferred route between Maple Avenue and County Road M.

Brown-Koeller said this area of concern has been at the top of user surveys the past several years.

“Tourism gets calls from people who get lost on this stretch of the trail,” she said. “We’ve been looking for years at what are some options.”

Safety, accessibility and connectivity for all trail users are the goals of the new route.

Displays at the meeting will showcase existing conditions, proposed trail alignments and environmental considerations. Attendees can review the routes and provide feedback to project planners.

“We work with the city

and county parks departments,” Brown-Koeller said. “We’re glad to have such great partnerships with both of them.”

The Transportation Alternatives Program grant

covered 80% of the cost of the study. The remaining 20% was contributed by Shawano Pathways, Friends of the Mountain-Bay Trail and Shawano County tourism.

Brown-Koeller said it took years to get to this stage; once a new path is adopted, it will most likely be another five years for it to be completed.

“We need to talk with

the Department of Transportation, the DNR about wetlands, and what grant sources are available to pay for it,” she said.

Fourth user-activated light for street crossing is next contribution to city

Shawano Pathways will host a beverage booth and 50/50 raffle at various Thursdayz at Franklin concerts this summer with a few goals in mind.

First, sales of beer, water, soda and raffle tickets are a great way for to increase awareness of the group and add members.

“We can always use new members to help out at our events,” said Nancy Brown-Koeller, Shawano Pathway president.

Second, proceeds of the fundraisers will help Shawano Pathways contribute a fourth user-activated light setup on another city street; a crossing in front of Hillcrest Primary School will be the location for the next light.

“We have one on Main Street where the Mountain Bay Trail crosses and another on Green Bay Street where the Mountain-Bay Trail crosses,” Brown-Koeller said. “The third one where the trail crosses Airport Road — that one will be installed this summer.”

These lights, which flash when pedestrians press a button to cross, enhance safety by increas-

ing visibility and driver awareness.

While Shawano Pathways provides funding, the city of Shawano and Shawano Municipal Utilities handle the installation of the lights.

Shawano Pathways will sell 50/50 raffle tickets, beer, water and soda at Thursdayz at Franklin on June 19, July 10, Aug. 7, 14 and 21.

Shawano Pathways also has the Shawano Paddlers and the Shawano Adventure Sports under its umbrella.

Shawano Paddlers members host events on the rivers and lakes in the county. Adventure sports include a variety of activities such as rock climbing, parasailing, white water rafting and snowboarding.

Shawano Paddlers and Shawano Adventure Sports will host the annual Wolf River Paddle & Pedal on June 21.

Participants will paddle from Judd Park in Shawano to the County Road CCC boat landing and wayside park in the Town of Waukechon, then bike back on an 8- or 12-mile route. The cost is \$30 per person, or \$50 with kayak rental. The fee includes yoga, shuttle for boat,

snacks, maps, security for bikes and emergency sag vehicles.

Call 715-524-8823 to reserve a kayak ahead of time. Preregistration on Eventbrite is appreciated; walk-ins accepted.

Great Wolf Tubing, 1013 S. Water St., will team up with the Wolf River Paddle & Pedal and offer brats, hamburgers, veggie burgers and beverages from 11 a.m. to 2:30 p.m. as a fundraiser.

The Paddlers also have informal weekly paddles on Tuesdays or Wednesdays. Just arrive at the meeting place and go — all lakes, no shuttles.

Shawano Adventure Sports will team up with International Youth Sailing of Oshkosh and the Shawano Parks and Recreation Department for Summer on the Water at the Shawano County Park. Preregistration is required as space is limited.

Superintendent to get goals to accomplish

90-day reviews expected to help school board with annual evaluation

Efforts are underway in the Shawano School District to improve its attention to shifts in the school landscape, including better ways to evaluate Superintendent Kurt Krizan's leadership.

Part of the push, which Krizan said is greatly needed, comes from Tim Renard, the new Shawano School Board president. Krizan said that, when he was promoted to superintendent almost three years ago, there were no systems in place to indicate wheth-

er schools, classrooms and staff were improving.

Krizan attended the Wisconsin Association of School Boards convention earlier this year, and he said a lot of discussion surrounded quarterly cycles, with assessments every three months on how things are progressing. He said the system could also be used by the local school board to see how he is performing.

Three to five goals for the superintendent would be put in place, Krizan said, and then every three months, the board would review how he is progress-

ing. The goals would need to be achieved by the time the annual evaluation would come around.

"I started working through this with my admin team a little bit, and we looked at, for 90 days, what are our vitals?" Krizan said. "What are the things we want to look at weekly to determine the health of our organization? Also, our rocks, those big projects we have to work on."

Some of those vitals, according to Krizan, include weekly student attendance levels, readiness for iReady exams in the schools and open staff positions in the district at a given time.

Renard told the district's executive committee June 9 that one of the difficulties he's had in the past year after joining the school board is de-

termining exactly where the district is at. A recent evaluation of Krizan's performance was difficult for Renard, because most of his interaction with the superintendent was at board and committee meetings. That's something he wants to change.

"I want to see a better tracking, if you will, over the course of the year on how we're progressing," Renard said. "Kurt has pointed out that, with the board members, some of us only see Kurt and others at board meetings. We don't have that touchpoint with him throughout the course of the year. So finding a way to get snapshots at smaller portions of the year to track that progress will be more meaningful when we go to do his evaluation."

Board member Jeana

Winslow agreed there needed to be more to the annual evaluations than what board members could recall over the course of the year.

"We've done this before, but I don't know why it felt so impersonal this year," Winslow said. "I don't feel like we, as a board, have goals for you or goals for us as a board. I feel like if we're part of the team, then we want to see the district in a particular place."

Among the things the district is looking to improve is having the best staff available to work with students. Krizan noted that it can be difficult, because sometimes Shawano will wrap up an interview just in time for another school district to make an offer for the position.

"We're hearing some districts that are calling

people who are still in the parking lot — they haven't left yet — and they're making them an offer," Krizan said. "If we can get under 24 hours, that would help."

Open enrollment is another issue. Krizan noted that the district has no plan in place to stop students living in the Shawano area from attending school in another school district; an estimated \$8,000 to \$9,000 in funding is lost for each student who enrolls in another district.

"The ones that are really concerning are the ones that are living two blocks from Hillcrest (Primary School) and going somewhere else," Krizan said. "We've got to figure out why they're leaving, but also, why aren't they coming in?"

Radford still seeks attorney in homicide case

James Radford is still waiting on an attorney taking on his case, a June 9 status conference revealed.

Radford, 39, is being charged with first-degree reckless homicide in the death of his wife, Sabrina Radford.

Deputies responded April 11,

2016, to a residence on County Road J in the Town of Fairbanks for a report of a woman who had sustained a gunshot wound. The caller, identified as her husband, reported that his wife had shot herself.

At the time of the initial response, investigators were unable to conclusively determine the cause of death. However, due

to the suspicious circumstances surrounding the incident, a formal investigation was initiated.

Over the course of nine years, investigators dedicated significant time and effort to this case. Numerous interviews were conducted with James Radford and other individuals connected to the case, and previously collected evidence was reexamined.

With the aid of advanced investigative tools, evolving forensic technology and the involvement of expert witnesses, investigators determined that the death of Sabrina Radford was not the result of suicide.

On April 15, Radford was taken into custody in Waukesha County. He was subsequently transported back to Shawano

County, where he was booked into the Shawano County Jail and held on a cash bond of \$800,000.

Shawano-Menominee County Circuit Court Judge William Kussel Jr. scheduled another status conference for 9:30 a.m. July 28 to see if an attorney had been appointed by then. According to online court records, Radford is hiring his own attorney.

Shawano County officials have since been talking more with the family and debating whether to renew the lease for the Mielke Arts Center with the Shawano County Arts Council.

"After our discussion with the Mielke family and foundation, I think your lease is fine. I don't have any concerns with the lease," Jim Davel, the county administrative coordinator, told the public property committee June 12. "What I would recommend is we get that back to Tom Martel (with the corporation counsel's office). The next meeting, we can come, make sure you sign it, and we'll get it to the Mielke Foundation for their signature."

Davel said the family wants to make donations for more projects at the

park to help increase its usage by residents.

"They are looking at some other projects," Davel said. "We have better communication with them right now in terms of what they want. What we learned is we need to deal with the foundation and the family, and not the arts council."

More and improved walking trails are among the additional amenities.

"They're trying to get some other larger donations," Davel said. "They would like to do some landscaping projects, etc."

The 32-acre county park is located on Airport Road and Lake Drive on Shawano's east side.

The Mielke Family Foundation was

established in 1963 by Dr. Edward F. Mielke and his wife, Beulah (Bee), together with sisters Ruth and Sarah Mielke. A native of Shawano, Edward Mielke practiced medicine in Appleton for 60 years. Ruth Mielke presided over the library at Appleton West High School for 40 years, and Sarah Mielke taught advanced mathematics at Shawano High School.

The Mielke Park land was donated to Shawano County in 1971 by Edward Mielke. The Mielke Family Foundation donated funds to build the Mielke Arts Center, a 250-seat black-box theater in the center of the park, with groundbreaking in 1975.

If a bite or sting is not healing, getting worse or causing concern, contact your health care provider to determine whether you should be seen in the clinic or the emergency department.

Brought together by mastermind Hunter Krolow, who graduated from Shawano Community High School in 1988 and knows the jazz world well through his time with the high school's jazz band, the shows will feature many classic jazz songs but also incorporate some modern compositions, too.

"Born of barn dances and supper clubs, parades and polka halls, Lawrence recitals and smoky lounges in Milwaukee, Revive 715 emerges from the soil of central Wisconsin to bring big band music into the heart of our communities," Krolow said. "With roots in jazz, limbs in tradition and eyes on the horizon, we're reigniting a sound that once filled ballrooms, school gyms and town squares. We are the sons and daughters of this place, steeped in its rhythms and dialects. We've gone to the coasts, the conservatories, the clubs — and brought back something real. Something local. Something alive."

The show will have some classic jazz songs such as "Fly Me to the Moon," arranged by Quincy Jones, and "Moon River,"

Bowhunting heirs visit museum, share memories

As I grow older, I find myself drawn to earlier and simpler times. Cell phones are everywhere, and we can now make calls anywhere, including our cars or even the

bathroom. I remember the old Ma Bell phones that were built like anvils and almost as

heavy. We paid high prices for long-distance calls, but local calls were almost free. You didn't have a choice of carriers. It was AT&T or nothing.

Are cell phones better? I have continual issues making calls in our woodsy state, as 5G relies on cell towers every 5 miles, and our old 3G could make crystal-clear calls anywhere. Two steps forward, one step back.

I would probably set my time machine to the 1950s or 1960s. I was born in 1959 but would enjoy seeing that era as an adult. Everyone enjoyed hunting, kids owned and shot guns with no suspicion, there were no school shootings, kids mostly respected their elders, and you could buy guns and ammo at most hardware stores.

I felt that the time machine had landed in the 1930s to 1960s on June 7 when I attended the Wisconsin Bowhunting Museum open house in Clintonville. I hobnobbed with the offspring of Wisconsin bowhunting royalty, brushed shoulders with seniors who still hunt with traditional bows and wandered through the displays of historic archery gear with a huge smile as I daydreamed of Fred Bear, Howard Hill, Ben Pearson, Roy Case and John Schoenike.

America's bowhunting history is forever linked to our state's bowhunting history, because we were the first to have a bowhunting season in 1934. But four years earlier, a bowhunter and inventor named Roy I. Case (son of Jackson I. Case, an executive with J.I. Case Plow Works and grandson of Jerome Increase Case, founder of J.I. Case Plow Works and J.I. Case Threshing Machine Co.) shot the first deer with archery gear under authority of the state conservation department.

Roy Case and his son, Roy Jr., started a home archery business and built longbows and recurves, as well as several styles of broadheads, including his famed Kiska design (now very collectible). Case, his son and a third person also started Racine Ar-

IN THE KITCHEN WITH FRANCESCA

Recipes add flavor to dairy month

June is Dairy Month in Wisconsin. So, for this column, I decided to include recipes that used two or more dairy ingredients.

Hoth cocoa cream puffs are, as could be guessed from the name, from the Star Wars cookbook. These puffs are so good. The rich chocolate pudding is encased in the crispy-chewy shells and topped with super-sweet, toasted marshmallow cream.

These cream puffs are definitely a decadent dessert. Although there are many steps in the recipe, they are not really hard, just a little time consuming. The first time I made these cream puffs several years ago, they did not turn out well. They did not rise, the pudding flavor was kind of strange, and I even think I burnt the puffs.

When I was looking for recipes with lots of dairy, I found this recipe (this recipe uses three dairy products, heavy cream, whole milk, and butter) and decided to try again.

This time was a whole different story. Most of the puffs rose spectacularly. I was shocked when I checked on them. At first, I thought I had done something wrong, but no, they were just rising as they should. Three puffs did decide not to rise, but as 10 others did, I must have done something right. It is hard to beat the eggs into the flour paste. I started out by using my favorite wooden spoon, but had to resort to a fork to ensure that everything was mixed evenly.

The pudding filling also turned out. The last time I made it, I used instant coffee. This time I decided to try espresso powder, reducing the amount accordingly. The filling tastes so good; the espresso powder heightens the chocolate flavor, while the cinnamon provides a subtle heat. This results in a spicy chocolate pudding that is even good to eat on its own. This filling is basically a dressed-up chocolate pudding. In fact, it is remarkably similar to a

HOTH COCOA CREAM PUFFS

Filling:
1 tsp. espresso powder, or 4 tsp. instant coffee granules (optional)
1 cup heavy cream
1/2 cup whole milk
Cream puffs:
3/4 cup water
Pinch of salt
Topping:
1 jar of marshmallow crème
Filling: Dissolve the espresso powder or coffee in the boiling water in a medium bowl. Add the cinnamon, pudding mix, cream, and milk. Beat on low speed for 2 minutes. Cover and refrigerate until ready to use.
Cream Puffs: Combine the water, butter, sugar, and salt in a sauce pan. Bring to a boil over medium heat, stirring occasionally to melt the butter. As soon as it boils, remove the pan from the heat and add the flour all at once. Stir until it forms a ball around the base of the spoon. Return to low heat and dry the paste out slightly, stirring constantly, for about 30 seconds. A dry film will form on the bottom of the pan. Cool the paste 10 minutes. Preheat the oven to 400 degrees and line two rimmed baking sheets with parchment paper. Brush the parchment lightly with water. Whisk one egg in a bowl and set aside. Stir remaining eggs, one at a time, into the dough, beating thoroughly after each addition. Drop dough by tablespoons onto prepared baking sheets, trying to make them the same size and as neat as possible. With your fingertips dipped into the extra beaten egg, gently smooth out the tops of the cream puffs. Discard remaining egg mixture. Bake puffs for 15 minutes. Reduce heat to 350 degrees and bake 10-13 minutes more or until golden. The puff sides should be dry and not soft. Remove from oven and transfer puffs to a cooling rack; cool completely. Using a serrated knife, slice each cooled puff in half horizontally. Spoon a scoop of filling into the bottom half; replace top. Repeat with remaining puffs. Top each puff with some marshmallow cream. To toast the marshmallow cream, broil cream puffs for about 30 seconds to 1 minute, watching constantly to avoid burning.



super-simplified chocolate silk.

The first time I made these cream puffs, I used whipped cream instead of marshmallow cream for

the topping. This time I decided to follow the recipe and used the marshmallow cream. Make sure to watch the puffs carefully while broiling. Once the oven heats up, the marshmallow cream browns quickly.

Taco dip is my other dairy recipe. Using two dairy ingredients, sour cream and cream cheese, this is one of my favorite party foods. I have fond memories of eating this dip at countless piano recitals. Now, I enjoy eating it at any time that we have the ingredients for it.

This dip is super

simple. With only three main ingredients, it whips up really quickly, can be doubled or halved very easily, and can include as many toppings as you like. I like cheese, lettuce, and tomato, but you could also add olives, onions, salsa, etc. I also love that this taco dip is meatless, making it a perfect dish for Fridays, or for Advent or Lent. This dish is perfect for parties or for a simple meal or snack at home.

TACO DIP

8 oz. cream cheese
1 package Ortega taco seasoning
Chopped lettuce
8 oz. sour cream
Shredded cheese
Diced tomatoes
Mix softened cream cheese and sour cream together until smooth. Add taco seasoning little by little, until reaching the desired flavor. Spread evenly in a 9-inch square baking dish. Sprinkle cheese on top. Refrigerate until serving. Right before serving, add the lettuce and tomatoes, and any other desired toppings. Serve with chips.

chery Club. Case also was a founder of the Wisconsin Bowhunters Association.

His granddaughter, Teresa Case-Doney, a state veterinarian who attended the open house, recalled fondly how her grandpa taught her how to shoot a bow and arrow at his Racine home on Lake Michigan.

She remembered a moving target his creative mind built so he could practice shots at running deer. His home was one of the first in Racine with electricity.

Although shoulder issues have kept her away from the sport, she enjoyed archery golf for many years with her grandpa and others.

Also there to reminisce and help with fundraising efforts for the museum, which is overseen by the Wisconsin Bowhunting Heritage Foundation, was Bill McCrary, author of both "The History of Wisconsin Bowhunting: 1930-2014" and "Roy I. Case: Wisconsin's Bowhunting Legend." He signed copies of his books while Case-Doney signed photos of her grandpa with his legendary buck.

The best deals for both visitors and the museum were bags of collectible broadheads, priced at six for \$10. I quickly snapped up six packages, with McCrary helping me select a few that had oddities such as a six-bladed head. I had never heard of such a broadhead, and now I have two. Case was an avid broadhead collector, and his extensive collection can also be seen in the museum.

McCrary still hunts deer with bow and arrow, although he has switched to the compound bow. The mechanical advantage

the music programs weren't anything incredible or stellar or out there rocking the industry, but it gave me that appreciation, and it gave me the drive to see what happens when you bring a bunch of people together for a common goal," Krolow said.

Besides his university efforts, Krolow also worked with musicians around Milwaukee, Madison, Chicago and Rochester, New York, before returning home to bring everyone together to revive the big band sound of yesteryear.

"The big band medium is what I chose, for one, because it's what I've been studying to write for since the beginning of my undergrad," Krolow said. "I first started to put little pieces of music together and experiment and find cool little techniques and ways, and that eventually that grew into a full-blown study of composition and the history of jazz and jazz ensembles. Those worlds colliding in my creative voice, I now have an ensemble of local

offered by pulleys allows the hunter to hold just a fraction of the bow's initial draw weight, thus making a more relaxed shot even when holding for many seconds. Unless you are a bodybuilder, that's not possible with a recurve or longbow.

I had breakfast with the son and grandson of legendary Clintonville archery pioneer John Schoenike, who has a chapter in McCrary's history book. Schoenike, who painted gold leaf lettering on fire trucks for FWD in Clintonville, founded and ran Stalker Archery Co. in his basement for decades. At one time, it was one of the largest archery shops in the Midwest.

He also invented one of the first bow quivers. Samples can be seen in the museum.

Son Jerry Schoenike and his son, Jim Schoenike, mingled in the rooms and shared a few memories with visitors who couldn't get enough.

Bud Wiesman of Caroline and his wife Karen, both avid archers, recalled the time Fred Bear spoke to bowhunters at the Caroline Ballroom, which was destroyed in a fire. Bud said he has killed five bears with a Wing Thunderbird recurve bow and once went on a Canadian bear hunt with the late Schoenike.

You don't need a time machine to visit the museum at 17 E. 3rd St. in Clintonville (just south of Walgreen's). You don't even need money, because it's always free admission. Hours are 10 a.m. to 2 p.m. Monday through Friday.

people who are my friends and have worked with in the past come together and share something all of us have practiced and have an inner voice for."

Try these 10 ways to cut back on processed foods

Eating healthy and doing so consistently can be a tall order for many people, especially with the popularity of fast and processed food options. Fortunately, the cycle can be broken, said Lori Knapp, a registered dietitian with ThedaCare. A few key steps can help people begin to rely less on processed foods. “It would be difficult to avoid processed foods altogether, but eating them frequently can harm your health,” Knapp said. “If you’re looking to eat more whole foods, you can start with some simple changes to begin to shift

your habits.” Knapp shared these tips for scaling back on processed foods:

- Start by adding. Everyone has favorite junk foods. You don’t need to eliminate them entirely. Instead, add lean proteins, vegetables, fruits and healthy snacks such as nuts to your diet. These can help you feel fuller and reduce cravings.
- Read and compare food labels. Watch for ingredients such as added sugars, salt or ingredients that are unfamiliar to you.
- Schedule a meal prep day. Busy schedules can derail healthy eating. Con-

sider adding meal prep to your schedule. Evaluate your week and plan for a slow cooker meal on a busy day. Or make a large meal or two in advance and eat the leftovers with salads and fresh vegetables. Similarly, plan ahead for breakfasts, lunches and snacks. This can help cut down on waste, save you money and simplify meal prep.

- Shop the perimeter. Healthy eating means buying most of your foods from the edges of the supermarket, where the fresh food is. Stick to the produce section, dairy case and fresh meat

and fish areas. Avoid the bright, flashy boxes and bags in the center aisles.

- Skip processed drinks. Soda and energy drinks are some of the biggest culprits in weight gain and obesity. Opting instead for water, seltzer or unsweetened teas can help eliminate some empty calories.
- Make a fruit bowl. Keeping a fruit bowl on your counter or tabletop can make it easy for you and your family to grab a healthy, refreshing snack.
- Chop it up. Keep a selection of veggies on hand. Prep them ahead of time so they’re ready for snacks, salads and easy cooking. Most veggies store well in airtight containers in the refrigerator. Consume, cook or freeze cut veggies. Store carrots, celery and radishes in water in the fridge for up to five days. Replace the water regularly.
- Keep staples on hand. They can include lean proteins such as chicken or fish, beans, eggs, healthy whole grains like quinoa and brown rice, and veggies and fruits. These foods can serve as a foundation for healthy meals. You can also keep some fresh dairy like yogurt and a few healthy snack items like nuts and popcorn.
- Plan a cooking night. Invite friends over or

plan a cooking night with your family. This can help make healthy meal prep an event, a time to socialize and an opportunity to catch up on what’s happening with the people in your life while sharing a healthy, non-processed dinner together.

- Enjoy a night out once in a while. Think consciously about these meals rather than making them a go-to for when you’re too busy to cook. Choose your restaurants and meals wisely. Look for eateries that offer locally sourced veggies and meats or those that offer heart-healthy options. Then savor the time with your family or friends.

Processed foods are those that have been altered in some way. Most contain additives that give them a longer shelf life. “Basically, anything in a box or a package — like cereals, breads or even frozen vegetables — is processed food,” Knapp said. “Always read labels, even on those packages of frozen vegetables, because they may have additives like salt or preservatives.”

Other examples of processed foods include peanut butter and canned vegetables. Peanut butter is primarily made from peanuts but can contain other ingredients such as sugar, salt and oils.

Canned vegetables often include high amounts of sodium. While it’s best to consume mostly whole foods, a healthy diet can include some processed foods. Examples include whole-grain breads and pastas, canned veggies and beans and tofu. “And then there are ultra-processed foods,” Knapp said. “They often contain empty calories and offer little to no nutritional value. They usually have a heavy amount of added sugar or salt. Think potato chips, doughnuts, sugary cereals and candy. Consuming too much of these over time can lead to serious health issues.”

A 2024 Journal of the American Medical Association article stated that diets high in ultra-processed foods contribute to weight gain and are associated with increased risk for more than 30 health conditions. These include cardiovascular disease-related deaths, mental health disorders and type 2 diabetes. “You don’t need to completely eliminate ultra-processed foods from your diet. Remember to think of them as treats and consume them sparingly,” Knapp said. “Strive to eat more foods that offer you the nutrition your body needs.”

FARM LIFE FROM A FARM WIFE

Sights and smells of seasons on the farm

The serenity of rural life cannot be measured. All around, there is beauty in the countryside, if only we have eyes to see and noses to smell.

During this time of harvesting first-crop hay, the air is filled with the tantalizing aroma of fresh-cut alfalfa. Some fields yield a bountiful harvest, due to fertilizer spread earlier, either natural liquid straight from the pit or manufactured and spread, using trailers.

The natural fertilizer produced from cows has its own potent fragrance — you need sinuses cleared? Take a deep breath in passing a field being spread with liquid manure.

The massive equipment used these days makes our farming of days-gone-by antiquated. We would cut what we could handle, sometimes just one field at a time, depending on the size.

The triple-cuts, some 30-feet wide, knock down hundreds of acres in a day. The massive mergers drive in and merge numerous rows together. Soon after, the enormous self-propelled choppers get to the field to chew up those rows quick as lightning. Semis drive alongside the chopper and once filled, head off to the main farm to pile it. They leave and heavy pack tractors start in, driving up and down the mound, packing it tight to preserve the feed.

At the time we put in new landscaping, the guy we hired suggested they dig out a particular rosebush they deemed was in the way of their notion of the plan. Simultaneously, my husband and I disagreed.

“Ah, no. That’s a special rosebush. It has to stay.” My mother-in-law had planted that many years ago. Every year when it blooms I think of her and smile. She was a beautiful rose of a mama, and we just could not uproot that special little bush.

Strategically placed just beyond the farmhouse are pots of flowers we had

purchased from an Amish greenhouse. They are magnificent and my hope is that I keep them alive all season. It gives pleasure to the eye and nose, in chorus.

Fresh-washed clothes drying in the sun is another seasonal pleasure for the senses. It’s free from God, with a little effort on our part.

Another God-orchestrated smell is rain. Sometimes I can even smell it coming. There’s nothing like getting caught in the rain — scurrying to the shed and hearing the steady hammering on a tin roof makes me thankful, especially when we’d been

praying for rain.

Awe-inspiring country sunrise-brilliances to sunset-beauties are gifts straight from our Creator God.

Gazing at twinkling stars on a clear, calm night with no other light to deflect or interfere makes me feel small, compared to the immense vastness of the night sky.

Planting our garden with the wide expanse of fresh-tilled dirt just waiting to press the seed in the ground has a delightful aroma. The anticipation of a meal from there makes my live-off-the-land-farmer-girl-heart swell. Inhaling garden tomatoes are a delight. There’s not much of a smell when I pick some up from the grocery store. The taste isn’t the same, either.

Fresh-cut grass (and the satisfaction that comes so I can appreciate fresh-cut grass) entices me to inhale deeply. Soaking in the sight of our lawn after a full day of mowing brings a rush of contentment. I’m tired but happy. The downfall? It’s short-lived. Next week, back at it.

We have ongoing issues with skunks digging up the front lawn, especially when dry and hard. There are teeny holes with dirt splayed around them, and while I never spot them in action, their lingering odor is a dead giveaway. It’s one of the smells of the season I could do without.

Once years ago while

we were still milking cows, my husband caught sight of one in the barn. With his only instinct to get rid of the thing, he eliminated it. Never, ever again. We learned our lesson. The smell lingered for weeks, and we couldn’t even walk inside the barn right after without it literally making our eyes water.

Diamond, our sweet yellow lab, got mixed up with a skunk one year. We washed her down with soap and water and rubbed tomato juice all over her. We had to tie her to the swing set so she’d stay still long enough to rinse-wash-repeat. It was nasty.

While having a bad rap, according to Siri at cga.org, “Skunks play an important role in controlling pests such as rats, mice and other rodents.”

Thanks, but my cats do that.

Season sights and smells — good or bad — add to the deep satisfaction of rural life. I wouldn’t change a thing.

Adventure sports group gains momentum

Shawano County has a variety of natural offerings for those who enjoy the outdoors, whether it's in the water, land or air.

A relatively new group, Shawano Adventure Sports, is making good use of those resources to have some fun while meeting new friends with similar interests.

"The idea actually came from Matt Hendricks (Shawano parks director) in a meeting we were having about building a mountain bike trail in Shawano," said Brian Grieves, an organizer of SAS. "We had worked together already on a windsurfing and sailing program, and he half-jokingly — I think — said, 'You guys should start a club.' So we did. Initially we thought to call it Shawano Silent Sports, but we didn't know if the term 'silent sports' was widely recognized. So we changed it to adventure sports."

Organizing the group and its activities is an adventure in itself. Members participate in a diverse set of activities.

"We've hosted a variety of events, including downhill skiing, indoor rock climbing, yoga and mountain biking," Grieves said. "Looking ahead to this summer, we're planning a low-cost community sailing, SUP yoga and free windsurfing event next week. Times and sign-up are available through the Shawano Park and Rec website. We're also planning another mountain bike outing, along with assisting the Shawano Paddlers in the Paddle & Pedal event (June 21)."

Members include Dan Wilhelm, a former member of a ski patrol, and Jasmine Wiley, a cross-country ski instructor. Steve Eliason is the founder of International Youth Sailing of Oshkosh. Garrett Smith races mountain bikes; Brian Moristad guided white water rafting.

"We continue actively working to increase awareness, opportunities and participation in various outdoor adventure sports in Shawano, and build community around them," Grieves said. "This is a great place to be active outside."

The group is a subcommittee of the larger and well-established Shawano Pathways.

"The Shawano Optimists have also been amazing to work with, as we also have a youth focus, and the bike rodeo they do is a natural fit with our pump track," Grieves said.

SAS has been working with the city parks and recreation department for almost two years to plan to build a pump track at the far east end of Kuckuk Park, incorporating the existing bike path.

A pump track is a continu-

ous loop of rollers, berms and other features designed to be ridden by "pumping" — using

body movements to generate and maintain speed, rather than pedaling. The tracks are popular

for various wheeled activities like cycling, skateboarding and scootering.

"Our initial fundraising push was very successful, and we are about 75% to our anticipated build cost," Grieves said. "After working with a few larger contractors, we believe we have found our best fit and hope to be under contract with them within the next few weeks. If all goes as anticipated, it should be ready to ride next summer."

Grieves believes there are many benefits to their "silent" sports.

"Being in nature and on the water in these ways offers a unique combination of mental and physical benefits," he said. "They provide a peaceful escape to connect with and enjoy nature and take you into the present moment, in a way that fosters mindfulness and relaxation."

"There's something special about the feeling of gliding over the water powered only by the wind that's hard to describe. You can also get exercise without even realizing or feeling like you are."

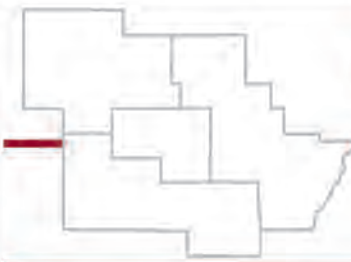

COURT NEWS

- Mitchell T. Malone, 39, Gresham, pleaded no contest June 10 to three misdemeanor charges of negligent operation of a motor vehicle. The charges were amended from felony counts in a plea agreement. Judge Katherine Sloma levied fines and sentenced him to 60 days in county jail.
- Alex J. Cassidy, 36, Algoma, had his probation revoked April 25 from a 2021 conviction for possession of methamphetamine. Sloma sentenced him June 12 to one year in county jail.
- Jose L. Fermin, 48, Bowler, pleaded no contest June 12 to felony bail jumping and driving or operating a vehicle without the owner's consent. Sloma imposed and stayed a prison sentence, then placed him on three years of probation with conditions.

jobs has contributed to the difficulty for the homeless to find employment and for people to make ends meet.

"Even people with jobs often find that their income does not cover rising housing costs," Klein said, adding that affordable housing is in short supply in Shawano, and rentals are rising in price.

While the shelter itself is closed at present after caring for 90 people for the six-month period that ended April 30, there are still a number of active programs at SAM's House, 105 E. Richmond St., Shawano, that can help the homeless, according to Chris Ciucci, who manages SAM25's resource center.

The resource center is open from 9 a.m. to 2 p.m. weekdays, Ciucci said. Through its thrift store, she said SAM25 can provide clean clothing to homeless people. SAM's House is available during the day to allow people to take a shower, do laundry, utilize phones and computers and even get a meal.

"You don't have to be homeless," Ciucci said about who can utilize the resource center. "You just have to be in need of any resources."

Ciucci estimated that the thrift store gives clothing to at least three people a week. She noted that some of the people helped have recently been released from jail or prison and have nowhere else to go.

"I had three calls within

the last week from families with children that have come to the area that either need clothes or need emergency housing and phones," Ciucci said. "Our goal as a resource center is to have folks come here and to connect them with the best resources in the area that are going to help them."

Brusewitz noted that there are certain people with criminal records who can't come into the shelter during its season. Among those are anyone who has had a violent felony within the last seven years, someone currently charged with violent felonies and registered sex offenders.

Brusewitz said that SAM25 also does not take in anyone who cannot provide self-care.

"You have to be able to toilet yourself, dress and eat," she said.

Also, the shelter cannot take in pets, Brusewitz said, so anyone who chooses to not surrender their pet to the humane society cannot come in.

The housing crisis is a key factor in homelessness, according to Brusewitz, with the wait for homes from the U.S. Housing and Urban Development homes averaging 600 days.

"Our goal is always to work with them so they become self-sufficient and they can get a job and a place and just have that stability," she said. "Sometimes we get them to that point, and then the resources run out. We don't have anywhere for

them to go."

Brusewitz noted that 21 of the 90 people who left the shelter in the past season did not have any place to go because of a lack of housing.

The issue of homelessness and shelters being in crisis is going on nationwide, Ciucci noted. Recent visits to shelters in Appleton and Green Bay prove that, she said.

"We're not unique," Ciucci said, noting that there are at least 35 people in Shawano who are homeless, more than the 21 beds at the current shelter. "We're just seeing it more now."

To become a year-round shelter would require more finances, according to Brusewitz, but it would also require changing SAM25's programs at a fundamental level. Currently, as an emergency shelter, there are fewer barriers for people to come in and stay for the night.

"It's a conversation, but it's not something that can happen quickly," Brusewitz said. "It would have to be part of our strategic plan to make sure if we do it, that we do it really well."

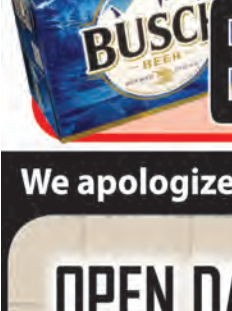

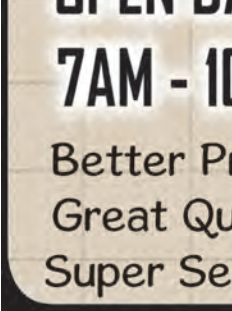

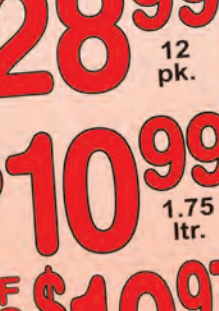
