Kautza wants to remove Hammett from panel

Supervisor not backing down from comments about staff, missing funds

Shawano County Board Chairman Tom Kautza said he intends to remove Supervisor Lowel Hammett from the ethics committee based on recent comments at a county board meeting.

For his part, Hammett said he stands by his comments, and Kautza's tactics won't bother him.

"On next month's agenda, I'm going to have a line item on there to remove Lowel Hammett from the ethics committee and replace him with another board member," Kautza told the executive committee July 16. "I did get several current board members ask me that I put it on the agenda to remove Lowel. There's a lot of them that are very disappointed of what has been ... comments being made, accusations, blah, blah, blah."

Hammett was contacted after the meeting for a reaction to Kautza's intentions.

"I'm a brand new county board member," Hammett said. "I sat there for a year and a half and didn't say anything other than when I was voting. The first time I bring up anything, I get yelled at. I get screamed at."

Hammett said he has no personal stake in the issue.

"Something is going on at the county," he said. "Someone's upset because I shook the basket real hard."

At the June county board meeting, Hammett wanted a closed session discussion to talk about past and future complaints against a county employee, as well \$1 million in county funds that is allegedly missing.

"I only asked to talk to the others (supervisors) in private," Hammett said. "He didn't want me to talk to them."

Kautza also wants to change the ethics committee to include only citizen members and no supervisors, a plan he will push in earnest later this year.

The committee is currently made up of two supervisors and three citizen members. Kautza said the committee should

New apartment complex tackles continued housing demand

The village of Bonduel is making new strides in its forward mission of growth with the groundbreaking for the new Bear Trail Crossing Apartments held July 17 on East Express Way.

By the time it is finished, there will be 48 two-bedroom apartments on the property near state Highway 29. The first 16 are expected to be completed by early 2026, with two more phases coming in after that, according to Jesse Rankin, Bonduel's municipal operations director.

"This is a new chapter in the village of Bonduel," Rankin said. "This is poised to address the growing demand for housing

Hockey league lease negotiations head to OT

Shawano group approves payment for damages, but Shawano County not so quick to cash the check

Just when it looked like Shawano County and the Shawano Hockey League had settled differences over damage to the Crawford Center, a statement denying guilt may have knocked the puck out of the net.

The hockey league board of directors agreed to pay tens of thousands of dollars in damage to doors and walls at the Crawford Center. Already one year into a three-year lease, the league also requested a two-year extension.

The county public property committee July 17 approved the lease extension but removed a pair of bullet points that were part of a list of conditions the league attached to the lease approval.

In essence, the league agreed to pay for stated repairs but denied guilt or fault; they also did not claim legal responsibility for the wear and tear to the building.

Supervisor Randy Young asked why the league felt the need to add those statements to its conditions.

Shawano Hockey League President Adam Gafner said the league board was unanimous in its decision to include them.

“The concern for the league was going back in time. Where does it end?” Gafner said. “I don’t think it does either party any good to stick our feet in and both stand off to our own sides. We have to come to the middle,” Gafner said.

He said some hockey board members didn’t want to pay for any repairs.

“Their concern was the time frame, that there has been a meeting annually, year after year after year, that has been agreed up between the county and the league,” he said.

Many of the damaged items the county is asking to be replaced happened under former

hockey league boards several leases ago but were never brought up until spring 2025.

“That was a concern of our current board — we’re being asked to admit things that we weren’t even around for,” Gafner said.

“At the end of the day, we are saying that we are going to pay for the damages that have been assessed,” added Tanya Anker, hockey league board secretary. “We just want to move forward. We want to get this done. We want to make the improvements and then continue to partner with you.”

Young agreed to moving forward but wouldn’t let go of the league not admitting guilt.

“I don’t know why you’d

want to make those statements, because let’s be honest,” he said. “The damage was from the hockey league. So for you to say you’re not going to admit fault or guilt, then why would you pay to repair it?”

“Because we’d like to move forward,” Anker responded.

Supervisor Tom Kautza made a motion to extend the lease but remove the two bullet points from the letter of conditions.

“The tooth fairy didn’t come in there and start putting hockey pucks all over hell. The hockey club did,” Kautza said. “The kids from the past did it, and apparently, nobody’s been paying attention to what’s been going on in the building. Yes, there’s fault on the county’s part; there’s a lot

of fault on the hockey side, too, and to sit there and say none of this is our problem, that’s ridiculous.”

Kautza’s motion was approved by the committee, but Gafner said the amended letter would have to be approved by the hockey league board Aug. 5.

The lease period is set to begin Sept. 15, and plans were to have the painting of the interior of the rink area complete before then. The work is set to be done by a local company that supports the program.

“I don’t know what to tell you from the painting side. You’re making it hard for the guy that’s here to help,” Gafner said. “I can tell you no money is being exchanged until it goes back to our

board, too, which is then going to push it out another meeting for you guys.”

Prior to discussing the letter of conditions, Gafner said the hockey league was going to make several proactive changes to help minimize damage to the building.

An annual meeting with parents will be held prior to the start of the season, impressing upon them the importance of being prudent with the gift of the Crawford Center.

A volunteer job will be created to keep a closer eye on the north side of the building where significant damage was reported.

Third, in the shooting area where players practice their shots, white pucks will be used instead of the traditional black pucks so errant shots won’t leave noticeable marks on the walls.

Finally, in the stick handling and dry land practice area, players will use brown, wooden balls instead of pucks.

Gafner said he and Nate Hesse, director of facilities and grounds, had agreed to a more formalized check-in and check-out at the start and end of the lease period.

Gafner said his walk-through at the start of last season, his first ever, was very brief.

“It was less than 30 seconds. ‘Here’s your key. Here’s what the building looks like,’” Gafner said of the exchange. “I’m not here to talk ill of Steve (Dreher, former director of facilities and grounds) or anyone with the league that’s not here anymore. But if I were a county employee, I’d be concerned with how that went, where I was handed keys and out the door he went. The walk-through I had was shabby at best.”

He said the new process will protect both sides and ensure situations like this don’t happen again.

Overall county staffing improved from last month

Pay, scheduling becoming more of a concern for employees

Overall staffing numbers for Shawano County are improving, but there remain concerns in certain departments, as well as the reasons people are leaving their jobs.

June Hasser, human

resources director, told the executive committee July 16 the 12 open positions are an improvement from the 20 open jobs the previous month.

“Last year, we had only eight open positions,” she said. “Some of them are the same as last year including dispatch, corrections, health.”

She noted there has not been a single week in 2025 in which at least one employee didn’t quit.

Recent openings include a crisis worker and a social worker at the Department of Health

Services.

“Both of those positions at DHS will take us months to fill,” she said. “They’re very, very hard to fill.”

Corrections and dispatch positions also have vacancies, as they have had on and off the past few years.

The annual turnover rate for the county is up from the previous year.

“Last year, we were at 16.05%,” Hasser said. “This year, we’re at 20%.”

Hasser said she has seen a few changes in why people are leaving the county — some good,

some not so good.

“The culture number is down to 22%; last year, we were at 34%, so we’re doing some things right,” she said. “Also, people leaving just for that personal reason, that’s also gone down to 25% from 34%.”

So, where did those numbers go? That’s the “not so good” part.

“Last year, I didn’t even have on your pie chart that people were leaving because of pay and schedule. This year, it’s on there, and it’s at 13%,” she said. “The other jump-up we need to

be aware of is last year, people were going to our competitors only 8%; this year, it’s up to 12%.”

Because of so many vacancies this year, the county’s payroll expenses (wages and benefits) are under budget for 2025. One consideration is to use those funds to provide pay raises to existing employees earlier than the standard Jan. 1, when the new fiscal budget goes into effect.

Jim Davel, administrative coordinator, said a few suggestions will be brought to the committee

in August.

“Next month, we’re going to bring what we think is going to fix the overall problem in terms of pay,” he said. “There’s other issues — leadership issues, scheduling issues — it’s just not pay that is the driving force for a lot of this.”

As of June 30, the county has 344 full-time employees, 58 part-time employees, 55 limited term employees and 80 committee and board members for a total of 537.

Suspects resisting arrest up 40% in 2025

Two officers injured in line of duty when dealing with violent people

There's always a risk when it comes to police officers answering calls where suspects could become violent, but the Shawano Police Department is suffering more injuries in 2025 when it comes to arresting people.

Police Chief Mike Musolf said that the department has seen a 40% increase in people resisting arrest this year, with two officers having to take time out of work for recovery because of injuries sustained apprehending suspects. One officer only had to spend a few days convalescing due to a hyper-extended knee after a suspect kicked him there, but the other officer is expected to be out of

action for at least three months.

"This is highlighting the real dangers involved," Musolf said. "If the officers didn't have to arrest somebody to begin with, there wouldn't be as many chances of an injury. Yet every time we place somebody under arrest and they resist, there is a decent chance they could be hurt, and imagine with a 40% increase in resisting, how many other officers could have been hurt over the course of that time if it didn't work out to our advantage?"

Having officers off due to injury also reduces the number of officers on duty, according to Musolf. Per department policy, at least two officers must be on duty at any given time, and when officers are on leave due to injuries, the shifts are usually at that lower benchmark due to Shawano's police force being small, which puts the community in more jeopardy and more strain on the

officers who have to pick up the slack.

Drug use by many of the suspects makes it harder for officers to anticipate responses, as paranoia caused by some of the drugs puts people in a fight or flight mode, and Musolf said they often choose to fight. He noted there have been times where he goes home after a day at work, and hearing on the radio that officers are involved in a fight, he prays for the best.

"The majority of these incidents appear to be connected to individuals under the influence or in possession of drugs, which often adds unpredictability and aggression to interactions," Musolf said, adding that many of the calls are related to domestic violence or disturbances in homes and businesses. "Our primary concern is ensuring our officers are able to return home safely at the end of each shift. That becomes more challenging when arrests become violent or unpredictable."

He noted many of the altercations are hands-on, with officers trying to avoid using weapons that could injure or kill people. The use of force is something that is only encouraged as a last resort.

"We have had people who have had guns on them or knives, things like that, which significantly increases the risk," Musolf said. "We do a lot of training, deescalation training that gets the officers to be prepared for situations with the hope of stopping that sort of thing from happening. Honestly, you can't stop everything from happening, because you can't control the other brain you're dealing with."

Shawano is fortunate in that officers can refresh themselves on deescalation training and other matters close to home, because the police department has several training officers, which prevents constant travel elsewhere to bone up on issues. The state recommends at least 24 hours

of refresher courses, but Shawano does at least 48, according to Musolf.

Musolf noted that the Shawano-Menominee County Circuit Court is severely understaffed regarding both judges and attorneys. Many of the city police cases drag out so long because of this, and suspects out on bond risk reoffending again.

The circuit courts and district attorney offices are handled by the state of Wisconsin, and the Shawano County district attorney's office will get two assistant district attorneys through the recent 2025-27 budget signed into law just before July 4. Musolf said he understands how DA Greg Parker has tried to keep cases moving with the limited staff he has, and he's hopeful the additional attorneys will help matters.

"Sometimes this can go two or three years (for some cases) from when the initial case gets heard," Musolf said. "I think a lot of

the problem with that is the person is not getting help in a timely fashion, and I think they probably just give up in their minds and think 'I'll just keep using drugs.'"

Prevention is difficult for the police, as most of the time they're not meeting the people involved until a crime has been committed, although the city has several outreach activities where fun activities are mixed with efforts from officers to encourage a crime-free lifestyle, especially among younger people.

Low numbers of people going into policing is an issue, too, according to Musolf, who noted his department and the Shawano County Sheriff's Department could always use more officers.

"Everybody needs more help," Musolf said. "There's way too much work to go around for the skeleton crew that everybody has."

Changes coming soon to local Catholic churches

New priests, temporary 'link' announced by Green Bay bishop

A continual aging population of priests, along with the traditional summer reassignments, will mean a few changes for local Catholic parishes.

Green Bay Bishop David Ricken announced several changes in the past couple months.

Assumption BVM, Pulaski, St. Casimir, Krakow, and St. Stanislaus, Hofa Park, are served by the Franciscans in Pulaski.

The Rev. Carmen Scuderi, who serves as parochial vicar in Pulaski, Krakow and Hofa Park, is being reassigned to serve a parish in Illinois.

Due to the lack of priests the Franciscans have available, his role as parochial vicar will not be filled, according to a July 11 letter from Deacon Peter Gard, associate to the vicar of priests and pastoral leaders for the Green Bay Diocese.

"In light of this, Bishop

(David) Ricken has asked that the parishes in Cecil, Krakow and Hofa Park be linked temporarily for one year to help us assess the needs of all the parishes affected," Gard wrote.

Ricken appointed Deacon Todd Raether, pastoral coordinator at St. Martin of Tours, Cecil, to serve these parishes as their pastoral coordinator effective Sept. 1. Ricken also appointed the Rev. Peter Onyango as the

priest celebrant.

The change will also mean a change in the Mass schedule. Leaders from Cecil, Krakow and Hofa Park have already started developing a new schedule that will be implemented the weekend of Sept. 6-7.

Scuderi's departure means the Rev. James Vacco will be the only full-time priest for the Pulaski family of parishes, led by the Franciscan Province of our Lady of Guadalupe.

Among those Franciscans, 62.3% of the friars are older than 70. Many of them are dealing with the issues that accompany aging and limitations associated with the aging process, Vacco said.

Only 17% of the friars are younger than 50, which means the number of friars available to staff the number of ministries presently served with friars will not

be sustainable within the next 10 years. Added to this is that of the number of men enrolled in the formation process to be a Franciscan friar, there is a significant number who do not feel called to ministry as a priest. These men want to live a Franciscan lifestyle and spirituality, but not minister in roles that require ordination.

Of the seven friars in residence at the friary in Pulaski, the age range is 70-89.

Assistance from the other priests in the Pulaski friary will be subject to their availability.

The reassignments could lead to additional changes in Mass schedules.

With Onyango named as priest celebrant at the Cecil parish, the Rev. Edward Looney, who serves as pastor of Sacred Heart Catholic Church in Shawano, will be freed of his duties as priest celebrant and moderator at St. Martin of Tours.

"With no longer needing to accommodate the 9 a.m. Mass in Cecil, we now have the opportunity to revisit our Sunday Mass schedule and consider

options that best serve our parish family moving forward," Looney said.

Other leadership changes announced by Ricken include the following.

The Rev. Thomas Pomeroy was appointed pastor of St. Anthony Parish, Oconto Falls, and St. Patrick Parish, Stiles, effective July 1. Formerly, he was pastor of Holy Family Parish, Brillion.

The Rev. Walter Stumpf, who served the Oconto Falls and Stiles parishes until June 30, was appointed pastor of St. Joseph, Wautoma, and priest celebrant for Hispanic Masses at St. Peter and Paul Parish, Weyauwega.

Rev. Matthew Settle served as pastor of Holy Family-St. William Parish, Wittenberg, St. Anthony Parish, Tigerton, and St. Mary Parish, Marion, until June 30. He has now been appointed be pastor of St. Mary Parish and St. John Parish, Menasha.

Replacing Settle is the Rev. Mark Rydell, who was parochial vicar of Holy Cross Parish & St. Katherine Drexel Parish, Kaukauna.

Sunflowers ready for visitors at festival

Live music,
wagon rides
part of the fun

Bergsbaken Farms in eastern Shawano County will host its 10th and final Sunflower Festival at the farm, located at W2095 County Road E, Cecil. The farm is about 10 miles northeast of Bonduel and southeast of Cecil and will include live music, food, vendors, family activities and an opportunity to get up close and personal with 50 acres of sunflowers.

Lee Bergsbaken operates Bergsbaken farms with his brother, Dale.

The first Sunflower Festival in 2016 drew about 1,500 visitors and now draws at least 10,000.

"It's amazing," Lee Bergsbaken said. "The first year we did it, we figured we had about 1,500. We left a book out for people to put their names in and where they're from. The next year, we figured we'd get a couple thousand. We guessed it was 9,000. We had a wheat field on the other side of the road and mowed down some corn to get to that field for parking."

This year's lineup includes live music all three days, including acoustic music from Bill Hurley and Mike Daley from noon to 4 p.m. July 25; bluegrass music from Biscuit Creek from 11:30 a.m. to 3:30 p.m. July 26; and polka music from Pulaski's The New Generation from noon to 4 p.m. July 27.

Wagon rides through the farm's sunflower field will also be held from 10 a.m. to 4 p.m. each day.

"We have food and a vendors' tent with very nice stuff," Bergsbaken said. "We have bouncy houses, a corn pit, a lot of opportunities for picture taking."

Visitors to this year's festival will also find 50 acres of sunflowers that recently began blooming.

"We cut back a little bit this year," Bergsbaken said. "We had some seed left from last year, and we wanted to get it used up. Normally, we'll put 150 (acres) in."

Although the flowers have not yet bloomed, this

year's crop looks good, according to Bergsbaken.

"It started out slow," he said. "We had a cold May, and they didn't come up as fast as they normally do. I'm pretty confident they'll be blooming by the weekend of the 25th."

Flowers are planted in mid-May to make sure they are in bloom for the festival.

"Sunflowers have a maturity date and also a bloom date," Bergsbaken said. "From the time you plant until bloom should be 70 days. We usually go from the Wednesday before (the festival begins) and go back 70 days."

Three walking trails will take visitors through the field to see the sunflowers up close.

"We have a short and a long trail and viewing platforms in the field where they can walk up and be above the flowers," Bergsbaken said. "They'll get to be about 5, 5 1/2 feet tall. We have another trail for wagon rides. There are a lot of waiting lines for wagon rides. We also have a spot where they can pick flowers. We charge \$1 a blossom. They don't plant them; they just put them in a vase."

Festival visitors include children, their parents and grandparents.

"They come from everywhere," Bergsbaken said. "We get people from every state and other countries. Last year, we had a couple here from China. I asked

one lady where she was from and she said Orlando, Florida. She said, 'We came up here just to see your festival. We got off the plane an hour ago and drove out here.' She said they were going to Door County and Upper Michigan."

There aren't a lot of sunflower farms in northeastern Wisconsin, which helps make Bergsbaken Farms unique.

"There are a couple around that have a small festival, but nothing like ours," Bergsbaken said. "I have some friends north of Escanaba (Michigan) that put on a sunflower festival. I got them to grow sunflowers, and now they have a festival pretty much like ours."

Weather can have an effect on festival attendance, but the Bergsbaken have been lucky so far.

"We haven't had rain for very many (festivals)," Bergsbaken said. "One year, we had about an inch of rain an hour and the parking lot was mud. We ended up pulling cars out. They kept driving in and it didn't stop them. They were parking on the road and that gets dangerous. We had to do something different. Now, we have a 10-acre parking lot that roped out with signs. We have handicapped parking spots. We've learned over the years. Every parking lot has to have an in and an out. Otherwise, it gets boggled up."

Sunflowers can grow anywhere, according to Bergsbaken.

"South Dakota grows more sunflowers than anywhere," he said. "I have a friend that lives in western South Dakota. There are thousands and thousands of acres out there."

Bergsbaken said his farm's sunflowers are expected to be in bloom through most of August.

"We have one field that we always plant a week later so we extend the bloom," he said. "People are welcome to come after the festival and walk. They can take pictures and walk through the flowers. We'll have blooms for almost a month. After the festival, they can come anytime from sunup to sundown. We still put the donation boxes. They can put money in them if they want."

The flowers eventually lose their bright yellow petals.

"They'll turn brown and then black and the heads will tip," Bergsbaken said. "We'll harvest them in October."

The flowers' seeds are sold as bird seed.

"We clean them, bag them and sell them here on the farm," Bergsbaken said. "We have a few gas stations that sell them, but everything else gets sold right here. We sell them in 50-pound and 30-pound bags. We sell thousands of

The Bergsbaken family opened the doors of their rural Cecil farm to sunflower lovers for the past decade.

This year's Sunflower Festival at Bergsbaken Farms, located at W2095 County Road E, Cecil, is scheduled for July 25-27.

Not only is the festival marking its 10th anniversary this year, the Bergsbaken family also announced that it will be the last.

"What began 10 years ago as a small idea to host a sunflower festival has grown into something truly unforgettable," according to a July 14 post on the Bergsbaken Farms Facebook page. "Each year, we've been humbled and overjoyed to see so many families walk the same fields we did as kids. Watching others create memories, laugh together, and soak in the sunshine has been the greatest gift of all."

Brothers Lee and Dale Bergsbaken operate the farm with their wives, BettyAnn and Shari, and help from Jason and Lisa Peterson.

Lee and Dale's parents, Daryl and Marie Bergsbaken, started the farm.

"This will be our final one," Lee Bergsbaken said. "I want to retire. I'm 70, and my brother is 63. We're at the point where we're not getting any younger. Even our volunteers are getting older,

and it's getting harder to get people."

The festival has a \$3 admission fee and has attracted thousands of visitors from throughout the country.

"The dream behind Sunflower Fest wasn't about profits," according to the Facebook post. "It was about sharing the beauty of this land with others – the land we grew up on, where we get to see the beauty every day. Even as other sunflower festivals popped up elsewhere, we kept our prices low because we believe every family deserves a chance to enjoy this beauty."

The Bergsbaken family works together to make the festival happen.

"Just as this event brings visitors together, it brings our family back together, too," according to the Facebook post. "From the work of the owners, sons and daughters, sisters and brothers, nieces and nephews and grandkids working every corner of the festival, it truly is a labor of love."

"After 10 beautiful years, it's time for our family to rest, reflect and spend more time together not just working, but being together. We hope you'll join us for one last celebration to walk the fields, smile in the sunshine and help us say goodbye to this special tradition that's meant so much to us and our community."

"We started it and it grew bigger than we ever imagined," Lee Bergsbaken said. "It's been a good run. All good things must come to an end."

The family also grows corn, soybeans and pumpkins and sells sweet corn at three self-serve stands, but the farm is best-known for its sunflowers.

Saturday is usually the festival busiest day.

"They're all pretty busy," Bergsbaken said. "Friday is probably the least amount of people. We expect a pretty big crowd. One nice thing is you can bring your

family and it's not very expensive. We ask for a \$3 entry fee a person. The food is pretty reasonable. There's no other charge other than the food and the flowers.

Foreclosure properties bring in \$194K for county, more than expected

The sale of five foreclosed properties went better than expected, according to Shawano County officials.

Bids on the properties were opened July 15, after each site was advertised with an appraised value.

The total appraised value of the five sites was \$108,200. They sold for a combined \$193,787.99.

The highest amount received was for a site in Aniwa.

"This floored me, because I couldn't even speak," said Deb Wallace, county treasurer. "We got \$113,000 for the meth

property."

The property is 8.26 acres at W18776 County Road Z. It had an appraised value of \$80,000. It was the only bid on the property, she said.

A 23.5-acre lot on North Airport Drive and Lake Drive in the Town of Wescott, with an appraised value of \$3,200, sold for

\$17,100.

"That was another surprise for me, that we got that much for it," Wallace said. "We had nine people bid on that."

A lot and building at 519 Flint Ave., Mattoon, had an appraised value of \$12,000. It sold for \$26,770.

There were also two properties in the city of

Shawano.

First, a lot on Weed Street sold for \$5,350. The appraised value was \$3,000.

Finally, a house and lot at 502 S. Andrews St., sold for \$31,567.99. The appraised value was \$10,000. There were three bids on the house and land.

The properties were

seized after the owners failed to pay back taxes.

The difference between the appraised value and sale price will be refunded to the previous owners, after the county collects all of its fees for the foreclosure and sale of the properties.

Vehicle break-ins see uptick on police radar

Police chief urging parents to keep kids home at night

A rash of vehicle break-ins in the city of Shawano has Police Chief Mike Musolff calling for parents to keep closer track of their teenage kids.

“There’s a significant amount of increased calls of people — kids, most likely — breaking into cars and breaking windows around town, which we’re investigating,” Musolff said.

He noted that there were three calls on the night of July 16 alone about broken vehicle windows, and there have been spurts where there are multiple calls in a single night.

“Parents need to be on top of this because their kids, they shouldn’t be out at 1, 2, 3 in the morning,” Musolff said. “I don’t know how they’re getting out of the house. If we could get parents to parent a little bit better, maybe that wouldn’t happen. I’m calling them out, whoever their parents are.”

Musolff noted if it’s the same perpetrators, there could be at least a couple dozen charges levied by the time the police catch them, which could result in serious sentences and fines.

“That’s the part that’s bad for those kids, because they don’t realize that they might have got away with it last night, but they might be caught two nights later and they might have already done three more,” Musolff said. “If they don’t get caught for a couple of weeks, they might have 14 things hanging over their head.”

Musolff said he doesn’t believe parents aren’t aware that their children are leaving the house at night.

“They’ve got to figure out a way to get them to stay in the house,” he said. “That’s not unreasonable to ask that the parents parent so the police don’t have to.”

Locking a vehicle’s doors makes it less likely someone will steal stuff out of it, and Musolff also recommends not having valuable items in the vehicle at night.

“Take the extra time, but at the minimum make

sure to lock your cars to try and prevent any of those crimes from happening,” Musolff said. “Those crimes are the ones that are quality of life issues in the city of Shawano, when they have their space violated. Nobody wants that to happen. Thefts are the worst.”

There can be multiple vehicle burglary calls in a single night, followed by several nights without complaint, and then another night where there are more calls, according to Musolff.

“It seems like every summer we have this different group of kids who break out of their house or whatever they do, or their parents just don’t care, and they vandalize or do graffiti or whatever they do,” Musolff said. “Then we catch them, and then it stops. It seems like it’s rinse and repeat every year. I don’t know where they get this idea from. Do they sit around in the basement and go, ‘Hey, let’s go damage somebody’s window that is unsuspecting of us doing it? What are you getting out of it?’”

Marion hosting Heritage Day celebration July 26

County audit shows no fraud concerns in 2024

The Marion Area Historical Society will host its annual Heritage Day on July 26 on the grounds of the historical society at 620 E. Ramsdell St., near the ballpark.

Events start with a car show.

Registration begins at 8 a.m. Vehicles include cars, trucks, hot rods, tractors and motorcycles.

Crafters and vendors will be on site from 9 a.m. to 3 p.m.

The event will also include basket raffles, a silent auction, children's games, a coloring contest, food and refreshments.

Raffle tickets are \$2 each or three for \$5. First prize is \$500, with \$250 for second prize and \$100 for third.

Music under the bandstand will include Zander's Music RayMakers from 9-11:30 a.m., and Mike Daley and Bill Hurley from

12:30-3 p.m.

Naturally, the museum will be open for viewing.

- A future Badger Amateur Baseball Association building to showcase their memorabilia.

Revenues up, expenses down more than projected

An audit of the Shawano County financial records of 2024 turned up good news for officials.

Revenues were up and expenses were down from the projections, leaving the county with a satisfying general fund balance. The county's debt is all well below state limits and even the county's own tighter restrictions, noted John Rader of Baker Tilly at the executive committee meeting July 16.

County Board Chairman Tom Kautza made it a point to ask if any fraud was detected.

"There is no fraud, correct?" he said. "No missing money?"

"Correct," Rader said. "We're not auditing for fraud. We do fraud risk assessment, and there's nothing that came to light to cause us concern. Now, I can't say there's no fraud — I don't think any firm would ever do that — but we certainly didn't come across anything."

Kautza was referring to accusations made last month by Supervisor Lowel Hammett about \$1 million missing from the county treasury. In his claim, he did not say when the disappearance of the money happened.

As for the audit itself, Rader said unassigned money in the general fund — the primary operating fund — increased from \$11.9 million in 2023 to \$14 million in 2024.

The increase is mainly due to decreases in non-spendable funds, restricted funds and assigned funds. Committed funds increased from 2023 to 2024.

Overall, the general fund decreased from \$19.8 million to \$19.2 million.

"It went down, because you planned on spending it all," Rader said. "You planned on spending it down by about \$3.5 million. It didn't go down that much. It went down \$606,000."

Revenues came in over budget by \$901,311.

"Most of that, \$776,000 of it, is because of invest-

ment income," Rader said.

Expenses came in under budget at \$1,951,023. He said this includes costs associated with jail operations, courthouse maintenance, the sheriff's department, land conservation and other departments.

"The county has a policy of trying to establish between 20-25% of next year's budgeted expenditures for these funds," Rader said. "You've been above that the last four years. You're at 30% this year."

The higher general fund was booked by a low debt amount.

By state law, the county debt ceiling is 5% of its equalized value, which would be \$258,280,475 for 2024. The county debt was \$15,816,763, which included \$2 million in short-term borrowing that was paid off in the first quarter of 2025.

"Your'e only at 6%, so you're well below the statutory or your own limitations," Rader said.

Shawano, Menominee counties draft hazard mitigation plan

Shawano and Menominee counties, like the rest of the state of Wisconsin, are vulnerable to a variety of disasters. Wisconsin has incurred disaster-related damages totaling \$3 billion in the last three decades, but future losses can be reduced through mitigation activities.

To better prepare Shawano and Menominee counties to manage their vulnerability to disasters, Shawano and Menominee County Emergency Management jointly applied for, received and has completed a pre-disaster mitigation (PDM) update planning grant.

"This plan update will serve as a roadmap that outlines potential cost-effective hazard mitigation

activities, some of which might be available for future grant funding," said Lt. Chris Madle, emergency management director. "The updated plan outlines the risks and vulnerabilities that the counties face from natural disasters and highlights mitigation strategies that might reduce future losses."

A recent study by the Multi-hazard Mitigation Council shows that each average dollar spent on mitigation saves society more than \$6.

Since 1993, more than 400 disasters have occurred in the United States, affecting communities in all 50 states, costing the country more \$500 million per week and killing more 24,000 people.

Mitigation actions

reduce or eliminate the long-term risk to human life and property from hazards. These preventative actions can be as simple as elevating a furnace in a basement that sometimes has water on the floor. Mitigation can also have a comprehensive approach, such as relocating buildings out of the floodplain or strengthening critical facilities to prevent wind damage and provide stronger shelter.

The completed draft hazard mitigation plan update is available during business hours at the Shawano County Clerk's Office, 311 N. Main St., Shawano, and the Menominee County Clerk's Office at W3269 Courthouse Lane, Keshena, for review and public comment until Aug. 4.

Mengert has honey of a job at his farm

About a dozen bee hives maintained in Grant

There's a buzz in the air at the Rick Mengert farm, located in the Town of Grant.

Mengert is an apiarist — better known as a beekeeper — maintaining close to a dozen bee hives on his farm. Bees produce honey and provide pollination services.

"Depending on where the bees go for nectar reflects the color, taste and condition of the honey," Mengert said.

Mowing clover keeps the crop fresh for the bees. Locust tree is a source of nectar in Waupaca County, producing extra-light, virtually clear honey. Buckwheat produces honey almost as dark as maple syrup.

Where the best source of nectar there is, the bee will intuitively gravitate to that source, according to Mengert. Dandelions are one of the first flowers that provide a supply of nectar and pollen in the spring.

"There's a job for every bee," Mengert said.

First-born nurse bees clean up the cells, according to Mengert. A worker bee is a female bee that isn't fertilized, and they gather nectar and pollen. Guard bees protect the hive from outsiders such as yellow jackets or ants, etc.

Attendant bees bring food to the queen. If there are dead bees, certain ones have the job of carrying the dead out of the hive. Some are hygienists. Drone bees' only purposes in life are to eat, and to breed queen bees. Once they breed the queen, they die.

Mengert said that, to sustain themselves, the bees fill a bee hive box and deposit the nectar in a cell. They make a bee-bread out of a pollen and nectar mix — ingesting that, they also feed it to larvae, to give them energy. A queen cell gets more room and in 16 days becomes a full-grown queen. She then goes on a mating flight within an airspace called a drone congregation area, to get bred — laying up to 2,000 eggs a day for to two or three years.

Within an hour of a queen bee's death, the bees know they'll die off so they start working to replace her, Mengert said. If there are eggs in the hive, the bees will

start feeding the larvae royal jelly, which is high in nutrients, to replace an expired queen. If after 40 days without a queen, the hive does not survive.

"As long as there are eggs in the hive, there is a live queen," said Mengert.

About the middle of August, Mengert starts to extract honey, getting a box full of honey in a week's time. When the bees get the moisture down far enough, they put a wax coating on to seal it off. Too much moisture in the honey will cause it to ferment.

To extract the honey when it's ready, Mengert cuts the capping off the honeycomb with a knife and puts the frames

into a big drum. As it spins, centrifugal force extracts the honey from the comb. Mengert leaves the boxes outside, and the bees clean all the leftover honey, recycling it back into the hive.

Mengert got started by purchasing a nuc — an all-inclusive starter pack with a five-frame box with bees, a laying queen with a brood, and food to feed the growing hive. After beekeeping for 11 years, Mengert has learned the art by doing.

"My dad's grandpa had bees, so I guess it's sort of in my blood," said Mengert. "I bought a 'Beekeeping for Dummies' book from Fleet Farm. Bees are pretty self-sufficient and take care of themselves, for the

most part — it's best if I just stand back and let them do their own thing."

As far as any maintenance needed, Mengert treats them for mites a couple times a year using a respirator, and a 99.6% pure powder concoction called oxalic acid. It's crystalized and heats up to over 300 degrees — the solid turns into a vapor.

Once a month, Mengert meets with the Portage County Hobbyist Beekeepers Club in Amherst Junction. The group leaders keep members updated on what everyone needs to do or just share infor-

New Menominee pageant scripted from adaptation of book

The Menominee Pageant Players have been reviving old pageants since 2016, but the current generation of tribal members is taking up the mantle of telling cultural stories through words and dance.

The next pageant comes July 30, the night before the annual Menominee Nation Contest Pow Wow, titled "Short Stories From the Elders." The script is an adaptation from Frances Weso Walker's book of the same name, published in 1979 by the late fourth-grade teacher for the Wisconsin Native American Teacher Corps Reading Curriculum Project.

"When we went to write an original pageant, we logically went to look for a book we could use," said Ryan Winn, pageant director. "When we found 'Short Stories From the Elders,' it was right on the nose."

The script was crafted by Winn and

pageant guild members Cedar Fernandez, Lloyd Frieson Jr., Karen Ann Hoffman, Brian Marquardt, Jeremiah Moses Jr., Bruce Wilber Jr. and Dawn Wilber in the spring. More than 25 performers will be part of the production, which is sponsored by the College of Menominee Nation, the Menominee Indian Tribe of Wisconsin and Menominee Tribal Education.

The pageant opens with a family of Menominee storytellers telling visitors of the humor and wisdom subtly woven into the fabric of cultural stories. The actors rise up and portray the characters

GARDENING WITH MELINDA MYERS

Reduce maintenance; boost garden enjoyment

Every gardener has personal reasons for gardening, whether it be the hope that their garden brings joy, productivity, beauty or peace throughout the growing season. Embrace what makes you happy as you tend, view and enjoy every aspect of your garden.

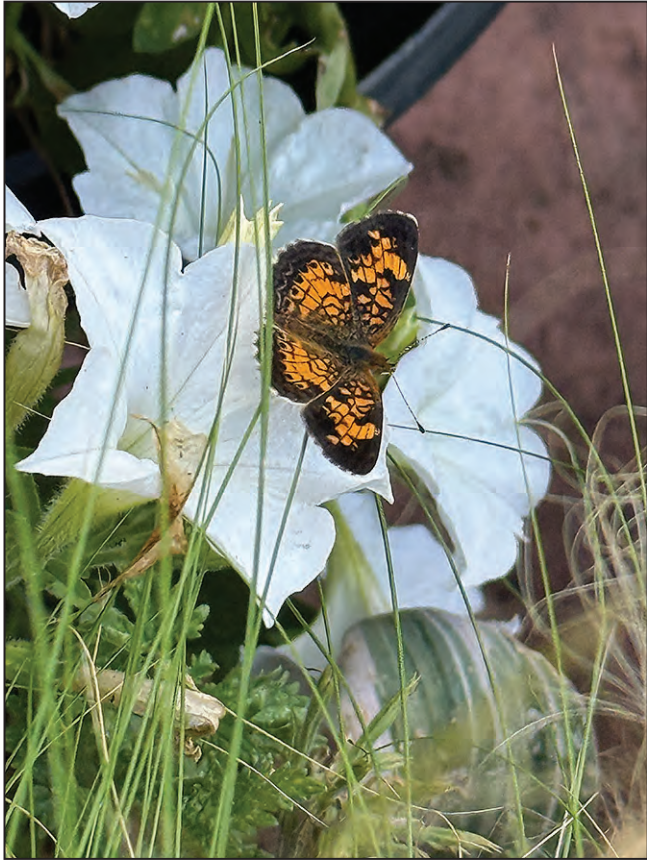
Weather, busy schedules and life in general can interfere with the best laid plans for any garden and landscape. Take some time now to evaluate what is working so you can do more of that and decide what needs changing in your garden plantings, designs and maintenance.

If you are feeling overwhelmed with the maintenance but still want seasonal interest, consider filling garden beds with shrubs. Look for low maintenance varieties suited to your growing conditions and climate. Select those with multiple seasons of beauty from flowers, foliage, fall color, and interesting form and bark. Include some that provide birds with food, shelter and protection from predators. You'll appreciate the beauty and motion these winged visitors provide.

Consider using fewer species of low-maintenance perennials and more of each. You'll have fewer plants to try to identify as the garden comes to life in spring and as you weed throughout the growing season. Look for those that are disease- and insect-pest resistant, need minimal or no deadheading and pruning, and attract and support pollinators as well as provide winter interest and food for songbirds in the winter.

Then add season-long color with pockets or containers of annuals. With fewer to buy and maintain, you may decide your schedule and budget will allow you to change them out as the seasons change.

Accept and embrace the beauty of a less-than-

perfect garden. Most visitors won't notice the imperfections unless you point them out. Plus, faded flowers and seed pods can provide unique texture and food for songbirds.

Do minimal cleanup that is better for the plants, pollinators and songbirds. Do remove or cut back diseased and insect-infested plant material as needed. Leave fall leaves in the garden to serve as mulch, a home for some beneficial insects, and insulation for toads, queen bumblebees and others that overwinter underground. Allow perennials to stand for winter, increasing hardiness, providing homes for beneficial insects, food for songbirds, and adding winter interest. Leave some of these stems standing throughout the upcoming growing season to serve

as homes for some of the native bees.

Ask for or hire help if needed. As much as you love gardening, securing help for some of the larger tasks or those that just aren't getting done can help boost your enjoyment.

It can be hard to find gardening help, so you may need to get creative. Consider sharing your gardening space with someone who loves to garden but lacks space. Barter your knowledge and skills for help in your garden. Plan a round robin of fun and gardening with a few friends. Take turns visiting and tending each other's gardens. You'll enjoy the time spent together in each other's gardens as you tackle a gardening task or two. Then top off the visit with a favorite beverage and snack or meal.

Don't let your list of unaccomplished tasks or weeds stop you from enjoying your garden and what you have accomplished. Relish every bloom, fresh tomato, or visiting bird or butterfly.

mation and help mentor new beekeepers.

"You can ask 10 different beekeepers about how to do something, and you'll probably come up with 11 different ways of doing it," Mengert said. "Everybody's got their own way."

To prepare for winter, the honey is removed in August, and the mite count needs to be as low as possible.

Winter bees are different than summer bees, according to Mengert. Winter bees have stored their honey, and that remains in the hive as food for the winter. Additionally, sugar water

is offered. The bees get the moisture to a certain percentage by fanning the concoction with their wings to dry it.

According to Tech Facts, "Scientists have declared bees the most critical species due to their role in pollinating 70% of crops. Bees have officially been named the most important living species on Earth."

"All our food needs pollinators. Every bee has their own thing they specialize in. Honey bees, bumble bees, wasps, yellow jackets - they are native pollinators and only go to certain plants. They all have their

own purpose in life," said Mengert.

To place an order for Papa's Honey, call Mengert at 715-250-3898. He also sells his wares at the Clintonville Farmers Market at 20 S. Main St., Clintonville, on Thursdays from June through October. The honey is also available at No Boundaries Nutrition, 35 S. Main St., Clintonville.

Raw honey is sold in one-pound, two-pound or three-pound containers, in addition to his homegrown maple syrup. Honey candy and honey sticks, which are straws filled with honey, are also available for purchase.

of yarns such as "Muskrat's Tail," "The Great Race," "The Raccoon and the Wolf" and "The Hunter." The players will also perform an original story by Walker that was in the book, "Na'ma Kee sa."

The Wilbers were the driving force behind adapting "Short Stories From the Elders" into a play. Dawn Wilber, who will also be the narrator for the pageant, said that, when she found the book, she felt compelled to bring them alive through the Menominee pageant style. She wrote the adaptation for "Na'ma Kee sa" in Winn's playwriting class.

"I have to say that, when I first started, I was like, 'How am I going to do this?'" Wilber said. "Ryan's teaching walked me right through everything, and pulling in facts and situations within our community."

When writing, Wilber wanted some of Walker's descendants to be a part of "Na'ma Kee sa." At least two family members are slated to be part of the show, she said.

"Serendipitously, it just kind of worked its way in there," Wilber said. "I think that our community is in for something very rich because this is something very new. It hasn't been done before."

Fernandez is eager to jump into the story. Besides being one of the writers, she will play Aehsepan in two of the stories. Aehsepan is one of the two main characters in "The Raccoon and the Wolf," and in "Muskrat's Tail," she is one of the animals of the forest trying to obtain the tail.

"I feel very lucky, especially being a young person who is hoping to help support this through our lives and keep it going and help it adapt," Fernandez said. "Stories are always adapting."

Moses said he also felt lucky, having heard of

some of the stories from Walker's book when he was growing up. He noted that the stories in the book form were short, but the pageant writers were able to flesh them out more in order to fit a two-hour show.

"We started brainstorming and looking at the adaptation of the stories from Frances Weso Walker's book," Moses said. "We started to flesh things out more, because the stories were already there, especially being based on our culture and the things we heard growing up, like 'The Great Race.'"

Moses also recalled finding a rare recording from more than 65 years ago, in 1959, where the performance had traditional Menominee language, something the tribe has spent years trying to revive in all aspects of reservation life.

"It was the only pageant that we've been able to track down that really made a point of using Menominee language, and we're trying to bring that forward this year," Moses said. "I think it's a really wonderful thing."

Moses has a 9-year-old brother who is participating in the pageants for the first time this year, something the elder sibling is very excited about.

The family aspect is something that is common in the Menominee pageants. Frieson has four children that are participating in "Short Stories From the Elders," and he is eager for them to take part in a tradition that he remembers fondly from his childhood. His youngest son, age 3, will be playing a fox chasing a rabbit in one of the scenes.

"Back in the '70s, when I was a little guy, I remember a pageant going on in the (Woodland Bowl), and I was just running around, and they were doing the storytelling and whatnot. I thought that was really

cool," Frieson said. "For me to experience that and get my children involved in doing these stories for the community, we enjoy it. We love doing this, and we wait every year to do it."

Alexis Frieson, Lloyd's daughter, echoed her father's sentiment about the pageant being a family affair.

"I just like to be involved," she said. "I don't do stuff like this, but I think it's really cool to do this with my dad and my brothers."

Richard Frieson, one of the Frieson sons taking part, enjoys being table to take the stage in the Woodland Bowl and tell a story.

"I like the lights, the pow wow grounds," he said.

With this being an adaptation, Walker's family wanted to be sure that the script stayed true to the author's vision. Mary Walker-Sanapaw is an observer and said that the pageant writers did a good job when expanding on her mother's stories to be sure that the additional scripting was spot on with the original stories.

"The book was my mother's baby, and we were always proud, like her, of her book that to see it go to stage now is, I believe, her dream come true," Walker-Sanapaw said. "As a storyteller, I believe everyone wants to see their stories come to life."

The important thing about the book and pageant versions of "Short Stories From the Elders" is that there is something to learn from each story.

"Our Native stories are meant to teach lessons, and for us, stories seem to be an everyday thing in life," Walker-Sanapaw said. "There are many things in life, so there are many stories."

Purple martins need good homes in Oconto County

A good home, secure from the weather and a solid place to raise a family not only works for us humans, but also for the birds. One species of birds that especially needs our help with home building is the purple martin.

The purple martin is hard to miss. It's North America's largest swallow. According to The Cornell Lab All About Birds (AAB) website, it is one of the earliest South American migrants to arrive in the spring. Older males arrive in Wisconsin as early as late March, the females a bit later. The adult male is a striking glossy bluish purple that seems to glow in the sunlight; the wings and tail are brownish black. Females are duller in color with varying amounts of gray on their heads and whitish lower belly.

Masters of flight, purple martins get their food (insects) and water, according to AAB, on the wing. They snap up insects (e.g., mayflies, wasps, dragonflies, etc.) while in flight but also water by scooping it up in their lower bill as they skim along its surface.

Purple martins are considered cavity nesters. Herein lies the rub. Natural cavities such as those occurring in older trees or the tops of old wooden fence posts are lacking in our modern developed landscape.

In addition to the lack of housing, according to AAB, the martins suffer from competition for nesting sites and predation of eggs and young from aggressive house sparrow and European starlings. Fewer insects due to pesticide use has reduced the amount of food available to the birds.

What is helping to

conserve the purple martin population is people, people who put up purple martin houses and tend them. According to AAB, in eastern North America purple martins nest almost exclusively in human-built nest boxes near cities and towns. Providing housing for purple martins is an age-old tradition; even the early Native Americans hung empty gourds for purple martins to use as nest sites.

Over the last several

years, Bird City Oconto has been helping to boost purple martin numbers by providing three purple martin houses at City Park, and another two houses at City Docks. This year, the houses provided homes for 122 adult martins and 250-300 young, a record year.

Banding purple martins helps us learn more about these birds and how to help them. This year the Wisconsin Purple Martin Association's (WPMA) 15th annual MartinFest held at City Park in Oconto on June 28 provided information on bird banding.

Dick Nikolai, an expert on purple martins and board member of the WPMA, demonstrated

how he bands the martins. While gently cradling the bird in his hand, he affixes a numbered band onto one of the bird's legs using a special bird banding pliers that prevents injury to the leg. All the purple martin chicks at City Park and the city docks in Oconto are fitted with bands, as are some of the adult birds.

Bird banding is an important conservation tool within the Migratory Bird Program of the U.S. Fish and Wildlife Service. The bands provide information on breeding and wintering locations, behavior, migratory routes, survival and reproduction that is used to help manage and conserve birds. You can contribute

to this effort, by reporting bird bands you find on any species of dead birds including those legally harvested during hunting seasons. To report bird bands, go to <http://www.reportband.gov>.

Since 2013, the Wisconsin Department of Natural Resources has listed the purple martin as a species of special concern.

According to Dick Nikolai, the purple martin population has declined 5-6% annually over the last 55 years in Wisconsin. There are no longer purple martins in the northern one-quarter of Wisconsin, and the population in the northwest part of Wisconsin has declined due to the tornados that passed through this area

from 2021-2023. If you are interested in helping purple martins, check out the WPMA's website, which provides a wealth of information and guidance on how to construct and manage purple martin houses. It is a time commitment, but well worth it and with lots of great support.

You can also donate to Bird City Oconto. Because the purple martin houses at the City Docks are full, they would like to purchase another martin house for this site. Donations can be made to Bird City Oconto at the Oconto City Hall by calling 920-834-7711.

The reward in helping these birds is seeing them move into new housing and the satisfaction of knowing you are part of a larger conservation effort. And the purple martins will certainly repay your efforts with their lively company, chatty songs and calls, and their aerial acrobats as they pursue and catch a myriad of insects in your own backyard. In addition to technoference, Jon has been exhibiting mild symptoms of the DD variant cyberchondria, a compulsive need to research health symptoms online and self-diagnose. Medical experts sternly warn about doing this, but at least WebMD and Cleveland Clinic are his go-to websites. It's not all bad. It often saves time, trouble and treasure as we avoid needlessly accessing the excellent health care providers we are blessed to have here in the rural Wisconsin Northwoods.

A particularly virulent

variant of DD is nomophobia, a state of pure panic induced by misplacing your cellphone. Jon is not susceptible, but I have it in spades. I can spiral into total despair when I can't locate my phone. For a while, I deleted the Find My Phone app, which can be an open invitation for cyber criminals to make your life cyber-hell. So is misplacing my phone, especially when in silence mode. Yet that's nothing compared to when Jon leaves and forgets his. The resulting distress is hazardous to our household health.

Good news. Neither one of us has ringxiety: the false perception that your phone is ringing or vibrating when it isn't. And we haven't come down with TSD (Truman Show Delusion), a narcissistic state of paranoia caused by an obsession with social media. Those afflicted actually believe their lives are being recorded and broadcast

across multiple platforms. I know — certifiable.

You may be wondering if DD is treatable. Nope. The only remedy is going cold turkey by moving totally offline, and I doubt that will ever happen. But we've had some success with nomophobia. I often misplace my phone at home, but it's always in my purse when I go out.

Posting a "Do You Have Your Phone?" sign on the garage access door proved futile, so I always ask Jon if he has his phone when he leaves. I did that an hour ago when he went to Pintsch's Hardware. You know, I really should call and remind him to pick up the eggs I ordered from Rosemary. Uh oh, I can't find my phone. Now where the heck did I put it?

YOUR RIGHT TO KNOW

Transparency disregarded in two egregious cases

Last month, the Wisconsin Town of Hazelhurst postponed discussion of a proposed ordinance due to a typo. The meeting agenda had incorrectly listed “wake board” instead of the intended “wake boat.” Town chairman Ted Cushing said, “I’m not going to violate the Open Meetings Law.”

It was the right call, one that affirms my belief that public officials in Wisconsin are, by and large, intent on complying with the state’s openness laws.

Sadly, this is not always the case.

Recent weeks have brought forth two of the most egregious violations of the public’s right to know that I have seen in more than three decades of tracking openness issues on the Wisconsin Freedom of Information Council.

The first happened in the village of St. Francis, south of Milwaukee, on June 2. Megan Lee, a reporter for television station TMJ4, and photographer Dan Selan tried to attend a meeting of the St. Francis school board. The district superintendent, Deb Kerr, confronted Lee, in an exchange that Selan captured on video (see <https://tinyurl.com/4pwr58z7>).

“You are not allowed to come to our meetings because you did not give us any notice or tell us why you were here,” declared Kerr, saying she had just spoken with the district’s lawyer. “Like you said, it’s an open board meeting, but you’re not filming.” When Lee pressed for an explanation, Kerr replied, “I’m going to ask you to leave now, and if you don’t leave, I’ve already told you, I will call the police.” Thankfully, this did not occur.

For the record, no one is required to give advance notice before attending a public meeting. The state’s Open Meetings Law, at 19.90, expressly directs all public bodies to “make a reasonable effort to accommodate any person desiring to record, film or photograph the meeting,” so long as it is not disruptive.

Kerr, a one-time candidate for state school superintendent, did apologize, sort of, saying “I wish I had handled it differently.” TMJ4 has filed a verified complaint against the school district with Milwaukee County’s Corporation Counsel, the first step toward possible legal action.

The second transgression involves Steven H. Gibbs, a circuit court judge

in Chippewa County. Gibbs recently issued an order that not only barred the media from recording witness testimony at pretrial evidentiary hearings but also instructed that they “may not directly quote the testimony of the witnesses, and may only summarize the content of the testimony,” or else face contempt proceedings.

“Wow, this is quite the court order,” said Robert Drechsel, a UW-Madison professor emeritus of journalism and mass communication and expert on media law and the First Amendment, when I asked for his thoughts. He cited a 1976 U.S. Supreme Court decision, *Nebraska Press Association v. Stuart*, which limited judges’ ability to impose constraints on media, requiring that they consider less restrictive alternatives and ponder whether the order would be effective.

That was not done here. In fact, requiring summation over quotation “would be more likely to introduce a risk of error and possible prejudice,” Drechsel said. “So no, I do not think the judge can prohibit the media from directly quoting what they hear during an open court proceeding, and I don’t think it’s a close call.”

Gibbs, asked under what authority he was forbidding direct quotation, cited a Wisconsin Supreme Court Rule that allows judges to “control the conduct of proceedings” before them. Gibbs said he believes in the First Amendment and freedom of the press but “my concern is a fair jury pool in this matter not tainted by any media reports” about evidence that may or may not be introduced.

He did not explain how threatening the media for trying to be as accurate as possible would achieve this end.

The truth is that public officials, even if they’re well-intentioned, sometimes broadly overstep. Let’s just be grateful that this is the exception and not the rule. You can quote me on that.

Village wrong to dismantle kayak launch

To the editor:

I am writing to you to express concern over the village of Cecil board’s recent decision to remove the ADA compliant kayak launch — an amenity donated through generous community contributions. This action was taken without public input or opportunity for discussion, and it undermines the values of transparency, accessibility and community collaboration

that define our region.

This launch was more than a piece of infrastructure — it was a symbol of inclusion. It allowed individuals of all abilities, including veterans and seniors, to safely enjoy our local waters. Removing it without engaging the very community that funded and benefited from it is deeply disappointing.

Kayaking and other silent water sports are booming in popularity across Wisconsin. According to the Wisconsin

Office of Outdoor Recreation, outdoor recreation contributes over \$11.2 billion annually to our state’s economy. Silent sport enthusiasts alone generate \$14.7 million in just three northern counties. Trails like the Kickapoo Water Trail attract 16,000 visits per year, bringing in \$1.2 million in local spending. These numbers reflect a growing demand for low-impact, nature based recreation — something our region is perfectly positioned to support.

Instead of dismantling access, we should be expanding it. The removal of this launch sends the wrong message to residents and visitors alike. I urge the village board to reconsider and to engage the public in a transparent dialogue about the future of our shared outdoor spaces.

Let’s work together to preserve and promote the amenities that make our community vibrant, inclusive and economically resilient.

Pulling USPS back from brink

The United States Postal Service is on the brink of a self-induced collapse. The failed policies of the Delivering for America Plan have driven away customers through a combination of sky-high rate increases and degraded service. David Steiner, who will take over as postmaster general July 14, has a tough job to do and little time to do it with some estimates indicating the USPS could be insolvent as soon as 2028.

Congress has a key role to play in helping him right the ship but must get off the sidelines and act. A useful step occurred earlier this week with a hearing before the House Oversight Subcommittee on Government Operations. The National Newspaper Association (NNA) provided a statement for the hearing that lays out key actions

Congress can take to help restore the USPS.

We emphasized that NNA members serve their communities, providing news on local events and civic matters that are not covered anywhere else, and that they depend on the USPS to get their papers to subscribers. The USPS — and by extension the small businesses in the communities they serve — faces an immediate and existential crisis. We urge Congress to act swiftly and compel meaningful reform at the USPS.

Here are three actions Congress can take right now to get the USPS back on track and keep commerce in America

moving:

- Demand the USPS Board halt the Delivering for America Plan including the large rate increase planned for July 13. This increase, far above the rate of inflation will only deepen the hole and ties the hands of Steiner, who should have the opportunity to assess the situation. The same holds true for the network consolidations and service cuts. Every customer that is lost through these increases and service reductions is one less Steiner can rely on in the future.

- Modernize and empower the USPS regulator. Effective checks and balances are needed to keep the USPS on track. Congress needs to update and modernize the postal regulatory process to better safeguard against excessive rates and poor service by passing House

Resolution 3004, The USPS Serves Us Act.

- Measure newspaper costs accurately. Congress should compel accurate measurement of newspaper service and hold the USPS accountable for maintaining and improving service quality by enacting House Bill 2098/Senate Bill 1002, the Deliver for Democracy Act.

These are all common sense steps Congress can take to address what has been clearly a failed approach by USPS management. Steiner has a huge job ahead of him and will need all the help he can get.

Congress must act now to make sure the nation’s next postmaster general is not the last one.

• Kerry D. Kluck, 68, Stevens Point, pleaded no contest to a possession of THC ordinance violation. The charge was amended from a felony count. Judge Katherine Sloma levied a \$50 fine plus court costs.

• Robert V. Julius, 30, Sur-
ing, pleaded no contest July 14 to strangulation and suffoca-
tion and felony bail jumping. Sloma withheld sentencing and placed him on four years of probation with conditions.

• Stephen M. Shields, 43, an Antigo man serving a sentence at Redgranite Correctional Institution, pleaded no contest July 16 to fleeing an officer in his vehicle, second-degree reck-

in a very competitive local market and provide modern living options for current and future residents of Bonduel. Today, it's more than just moving dirt. It's about laying the foundation for the future of Bonduel."

Rankin sees the new apartment complex, one of the bigger housing developments in the village in more than 15 years, as a way for the village to grow and improve on the heels of the recent improvements on state Highway 117 and the renewed efforts to revitalize the village's downtown business area.

"This development represents progress, opportunity and our commitment to ensuring the village remains a welcoming and vibrant place to work, live and raise a family," Rankin said. "We are not just building apartments. We are building homes and strengthening our community."

While it's expected to bring new people into the community, Bear Trail Crossing will also provide more modern options for existing people in the village, according to Rankin. The project is being created through Nature's Ridge LLC, based in De Pere, along with Duquaine Development, based in Green Bay.

"The design is expected to complement the existing character of Bonduel while providing residents with modern amenities," Rankin said.

Stan Wilson, Nature's Ridge spokesman, said his company is excited to work with Bonduel on its housing needs.

"We feel it's a great fit and will provide a great need for the community,"

Wilson said. "All in all, this has been a very seamless process."

It's the first time Duquaine has worked on a housing project in Bonduel, according to spokesman Jake Hoffman, but the company has worked with Nature's Ridge on a number of developments in other communities.

"One of the things that everybody needs today is affordable housing," Hoffman said. "We're trying to provide something that your average worker can afford nowadays."

Demand has been high for housing in Bonduel, Rankin said, noting that a housing study done with Shawano County Economic Progress Inc. in 2021 showed lots of people were clamoring to live in the rural environment that Bonduel provides. The village has built single-family housing recently on Sunrise Court, and work is underway with multi-family housing through the Rolling Meadows area, but Bear

Trail Crossing will help with the need even more.

"We were not only missing multi-family, but we were also missing single-family housing," Rankin said. "When a house goes on the market here, it gets scooped up pretty quick."

Things going for the village include the growth of the Bonduel School District, which has more students coming in than going out through its open enrollment program, as well as being less than 30 minutes from Green Bay and Appleton, along with all of its amenities, according to Rankin.

"It's well-located," he said. "You can have a small-town feel but still work in the larger municipalities. We have a great location. We just have to expand on it and draw more people in. More people equals more economic growth."
