Sleeper and Dallas targets for local recall petitions

School board members blamed for district's current state

Recall petitions have been taken out against two Shawano School Board members as local parents say they're seeking local representation that will listen to community members and not just blindly follow administrators.

Petitions were recently taken out against Michael Sleeper, former school board president, and Chuck Dallas, board treasurer. The petitioners have until July 25 to gather at least 1,829 valid signatures against each board member in order to trigger a recall election, which would be in the fall.

Bobbi Lemerond, one of the parents involved in gathering signatures, said that, for her, the catalyst for seeking the board members' recall came at the April 18 school board meeting. When 20 people signed up to speak during the community comments segment, Sleeper announced the board would not be listening to all 20 commenters and would instead select the speakers.

Lemerond was one of the people denied the opportunity to speak, as she planned to address a petition circulating at the time that sought the removal of Superintendent Randi Anderson. That petition gathered more than 1,200 signatures but has not been addressed publicly by the board.

"When they decided to cut our rights to give our opinion, we decided it was time for a change," Lemerond said.

Lemerond said that both Sleeper and Dallas were on the board when Anderson was hired in 2019. That makes them responsible, in her view, for the current situation where the district is facing budget shortfalls amid continuous declining enrollment. She claimed that Dallas is particularly culpable as treasurer, because he should have, in her opinion, been aware of the district's flagging finances and sounded the alarm much earlier.

"I feel he has been overlooking the finances," Lemerond said of Dallas.

Theoretically, most of the board members could have been subjected

to recall, but Lemerond noted that the members recently elected to a new term like Mart Grams, Chris Gull and Jeana Winslow cannot be touched by a recall for now. She also felt board members who'd only been in their positions for a year, like Jamie Beyer and James Davel, should be given an opportunity to change their minds and their actions.

"I'd like to see them given a chance," Lemerond said.

Lemerond feels the board has not been doing its job and has stood by while the district has plummeted. Besides the continued loss of students, the schools are seeing a mass exodus of teachers and other employees, including three principals — one of whom is going to Wittenberg-Birnamwood High School to be its principal, and an assistant principal going to Gresham Community School to be its principal.

"They didn't do their homework, and now we're doing their homework for them," Lemerond said, referring to herself and others in the community who have been regularly attending board and committee meetings and pursuing open records requests to bring forth facts about the current school district environment. "They're the ones who brought (Anderson) in here, and they're not holding her to the standard that she presented herself during the interview process."

Parents and community members first started coming out to protest and fight when it was announced in March that there were plans to close either Shawano Community Middle School or Olga Brenner Intermediate School to address an expected 2022-23 shortfall of over \$2 million. That didn't happen, and the board chose to use Elementary and Secondary School Emergency Relief funds to balance next year's budget, but a school closure could still happen, especially if a proposed opera-

DID YOU KNOW?

There are certain rules in place when someone seeks to recall an elected official in Wisconsin. Among them:

- The number of valid signatures required for a recall election is 25% of the number of persons that voted in the last preceding election for the office of governor within the electoral district of the officer sought to be recalled. Each signer must be a qualified voter within the district represented by the officeholder being recalled, and the address of each signer must be located within that district.

- Circulation of the recall petition must be completed within 60 days after registration. The completed petition must be returned to the original filing officer no later than 5 p.m. on the 60th day from the date of registration. Any signature dated before this 60-day period is invalid.

- Within 31 days after the petition (with signatures) is submitted to the filing officer, he or she has 31 days to determine the sufficiency of the petition and also that it meets all necessary requirements. Following this review, the filing officer must attach to the petition either a certificate of sufficiency or of insufficiency, allowing at least 10 days for the officeholder being recalled to file any challenges.

- If the petition is considered sufficient, the filing officer will submit it to the appropriate local governing body, which will then immediately call a recall election to be held on the Tuesday of the sixth week after the date on which the clerk issued the certificate of sufficiency.

tional referendum for November fails.

Lemerond was one of the parents angered by the lack of transparency. She has made it clear through her public comments that she feels Anderson is not working with the community to find solutions, including looking into why families are leaving the school district or sending their children to parochial schools or other school districts through the open enrollment program. Because the board has been, in her view, following Anderson's lead during the pandemic the last two years, Lemerond feels its members are culpable for the current situation.

"They're her boss, and they've been on the board the whole time," she said, referring to Sleeper and Dallas.

Lemerond said there are people interested in filling their seats, but she declined to name names, claiming it would be moot if they are unable to gather enough signatures to initiate a recall election.

Gresham says goodbye to 16 graduates

Speakers talk about last four years and the future

The 16 graduates who received diplomas June 3 have been in every corner of Gresham Community School, but they will now be learning and living outside the hallowed halls as they move on to the next stage of their lives.

The graduation commencement combined the patriotic melody of “The Star-Spangled Banner” with the Native American tradition of a drum group performing honor and travel songs and even included a valedictorian getting some brief heckling from his father, the superintendent for the Gresham School District.

“As we march across the stage and move on with our lives, we leave a piece of us here,” said Abby Page, senior class president, who also introduced the Class of 1972, which walked the stage 50 years earlier.

The seniors chose Lisa Hoffman, who taught them in both third and fifth grades, to be their featured commencement speaker. Hoffman told the audience she wasn’t going to cry like Superintendent Newell Haffner did, but toward the end, she was unable to keep the tears back.

“In third grade, they were trying to figure out where they fit in and realized they weren’t kids anymore.

They went from learning to read to reading to learn,” Hoffman said. “In fifth grade, their personalities started to develop. They were at the top of the elementary food chain, and then they moved to the junior high hall. Life was good.”

Joe Ejnik, Gresham School Board president, said it might have seemed to the graduates like forever to reach the big day, but he warned that life is about to get a lot faster.

“You’re going to blink, and you’re

going to be 28,” Ejnik said. “When you blink again, you’re going to be 40, half bald and you’re going to have the really cool hats like me. You laugh, but it’s coming.”

Ejnik urged the graduates to avoid making excuses in life. He noted that they’ll fail in many of the things they attempt, but those failures shouldn’t make them afraid to pursue what they want out of life. He promised that if they work hard, people will notice.

“If you want something, go get it,” Ejnik said. “Don’t blame other people. You put yourself in a position to succeed or not. When you look in the mirror, the person staring back at you is the only person you can blame.”

The past four years have been difficult and challenging, said salutatorian Hannah Cervený, noting that the coronavirus pandemic put a particularly big bump in the road midway through.

“Our freshman year was the only normal year of high school we had,” Cervený said. “Then we got to our sophomore year, and COVID hit and we were virtual the last half of the year.”

What makes the Class of 2022 special, in Cervený’s view, is that most of the graduates started in school together and have continued to graduation.

“A majority of this class has been together since pre-K on, and let me tell you, there are some days we loved each other, and others where we couldn’t stand one another,” Cervený said.

Valedictorian Jack Haffner announced he would not be pursuing his pre-kindergarten dream of becoming a hip-hop artist.

“Dreams are good, but in order to make things happen, you have to work at it,” Haffner said. “Some things aren’t going to go how you want, but the two important things to remember are to keep going and don’t give up.”

"It really went full circle for me," said Hammond. "I was able to work with both employees and the community and get different point of views from each party in my work experience."

Hammond said that she was approached by SAM25 President Muffy Culhane to be on the board for SAM25.

"I had volunteered in the past for SAM25," Hammond said. "In our first communication, we were talking about the whole scope of SAM25. I thought that this was a good time in my life to make the commitment to the board."

Culhane said that, due to a prior relationship with Hammond, she thought that it would be a perfect fit.

SAM25 hosted an open house on June 1, the same day that Hammond began work. Hammond said that she was able to integrate with volunteers and staff members.

"It was just the greatest day to me," said Hammond. "The welcoming support that I had from the volunteers was incredible. It was all open arms."

Her duties at SAM25 include overseeing operations and focusing on helping Shawano community members who are at the poverty line.

"In my position, I am going to be wearing a lot of hats," said Hammond. "I will help to oversee the operations and help to grow and develop. I will help to play a strong role in the community outreach and awareness. It

is really growing and developing the organization, as well as handling funding and donations."

Culhane said she is expecting that Hammond will take the SAM25 organization and mission and help them move forward and succeed.

"She has such a great heart and has a great relationship with Shawano," said Culhane. "This is her passion, and I think she is going to do a really great job growing the organization."

As her time at SAM25 is just beginning, Hammond has a couple of goals that she wants to meet.

"The number one priority for me is for sure helping those individuals who are that poverty line have a better life," said Hammond. "I also really want the community to be in the know and have them be a part of SAM25 as well. If I can accomplish that idea of getting others involved and getting them to know what we are about, then I am doing well."

In her first couple days on the job, Hammond noted that she has felt very comfortable and that she is excited for what the future holds.

"I had a wonderful first day and I don't know that I have every said that about a job," said Hammond. "I think I have really found my niche."

Using her past work experience, Hammond believes that she is prepared for her future at SAM25.

"I have developed very strong leadership over my career," said Hammond. "I have also learned from past experiences, that if you want to succeed in a job, you have to believe in it. You have to believe in the mission and goals of an organization — I always thought that if I am going to do a job, I am going to do it to the best of my abilities. Through leadership, I feel that I have gained that idea of belief."

Hammond said the Shawano community means so much to her, and she wants to do her part in serving it.

"Being from Shawano, a lot of it is in my heritage," said Hammond. "With family being very important to me, I guess I see our community like one big family. If I am a part of that community, how can I help to serve it?"

17-year sentence ordered in child pornography case

A Shawano man was sentenced to prison June 6 after being found convicted of owning dozens of child pornography videos.

Shawano-Menominee County Circuit Court Judge Katherine Sloma sentenced Johnie E. Chandler, 42, to 17 years in prison, followed by 17 years of extended supervision, after he was convicted of 53 felony counts and a misdemeanor.

Chandler pleaded no contest in March to 49 counts of possession of child pornography, two counts of child sexual exploitation, two counts of felony bail jumping, and a misdemeanor charge of possession of a controlled substance.

Another 33 child porn charges and three counts of child sexual exploitation were dismissed but read into the record as part of a plea agreement.

According to the criminal complaint, the Internet Crimes Against Children Data System notified Shawano County authorities in May 2020 that numerous pornographic videos had been downloaded and uploaded from a Shawano IP address. The Department of Homeland Security issued a summons to Charter

Communications asking for customer information, which linked Chandler to that address.

Local police then obtained a search warrant for Chandler's phone and computer, which were full of videos showing girls, ranging in apparent age from about 4-11, being forced to perform sexual acts with men. The images had been downloaded from an instant messaging app.

The child sexual exploitation charges were filed because Chandler used the instant messaging app to share some of the videos he had downloaded with other online users.

A report entered into evidence during the sentencing hearing indicated that Chandler communicated with 13 unique users of the app, receiving 90 child porn files and sending 84.

At the time the child pornography files were discovered, Chandler was on bail awaiting trial on a felony charge of possession of narcotic drugs and three counts of possession of a controlled substance. His bond conditions included that he refrain from committing any more crimes, which was the basis of the bail jumping charges.

Safety on the minds of school board members

Update on what Shawano public schools are doing to come later this month

Shawano School Board members are calling for a discussion on school safety in the wake of the mass shooting in Uvalde, Texas, that left 21 people dead — 19 of them children.

Board member Chuck Dallas broached the issue during a June 1 meeting of the Shawano School District's executive committee.

"After what happened down in Texas, it may help to have our school liaison officer talk about safety and what we're doing, not only during the school year but maybe even during summer school would be a nice topic," Dallas said.

The matter will be brought to the full board during its June 20 meeting, but discussions on matters involving potential school violence have already been taking place. Board president Mike Musolf recommended the district once again conduct training through ALICE, which stands for Alert, Lockdown, Inform, Counter and Evacuate, noting that there has been turnover in staff since the last time the community conducted the training in 2016.

Musolf suggested doing the training in late August, when all of the teachers would be back in school.

The district's safety plan is already being reviewed, according to Superintendent Randi Anderson, and administrators plan to brief the executive committee in July on the

progress of the revisions.

"We're in the complete process of revamping and updating that," Anderson said. "We're going to talk about what we're doing and keep everyone informed."

The district is also looking at purchasing buckets for classrooms to have emergency supplies available in the event that students and teachers need to be in a lockdown for an extended period of time.

"There is a cost involved, so the discussion for (the district's) finance (committee) is, 'Do we want to fund something like that or have a fundraiser?'" Musolf said. "It is something that we should have done a long time ago. I thought we did it when we had ALICE training six years ago. We had discussed it, but it kind of fell through the cracks."

Musolf noted that it wasn't just concerns about someone committing violence within the schools. There have been times when schools, including ones in Shawano, have had to keep students and staff inside under heightened awareness because of incidents taking place near the schools.

"A school goes into lockdown, and suddenly you need some snacks," Musolf said.

Board member James Davel, a U.S. Army veteran, encouraged that if future training sessions are put into place for school employees, they should include scenarios where the violence is happening off-campus.

"I was at Fort Bragg when that guy shot and killed a lot of soldiers (in 1995), so that's a whole different dynamic in how you get control of that situation," Davel said. "Everyone likes to focus on the (school) building."

Arming school staff only way to stop mass shooter

While most politicians and bureaucrats seem stymied by the problem of school shootings, some states and school administrators have already figured out the answer.

When I teach my students at concealed carry classes in New London (I've taught about 1,000 students over the past decade), I ask them if they know the average time, start to finish, of a mass shooting.

It's six minutes.

What is the average law enforcement response to that shooting?

It's also six minutes, which means that the cops or deputies get there after the shooting is over, and of course, that is too late.

The odds of a fire in a school are slim, and fire departments are normally not too far away, but every school has fire extinguishers in the building. We make sure our school football players wear helmets and padding. We require ATV helmets and seat belts. Then we leave those same kids for eight hours a day, call for armed response if a shooting starts, and then act surprised when students are killed or injured.

Texas is one of 28 states that allows school staff, including teachers and administrators, to carry firearms in schools. Wisconsin has a provision in its state concealed carry law that allows anyone with a schoolcontract (teachers, administrators, janitors, etc.) to carry if the contract allows it. No law changes are needed to allow staff to carry in a Wisconsin school; it's still a felony for anyone else to carry on school grounds, however.

John Lott Jr., an economist and author of several books, including "More Guns, Less Crime," a book that documented how concealed carry nationwide has reduced the violent crime rate, founded a website called the Crime Prevention Research Center. His scrupulous research crushes most of the myths surrounding crime's relationship to firearms, especially the oft-repeated lie: "America is the only nation with mass shootings." For the record, we are 10th from the top on the number of mass shootings per capita and 14th

in terms of overall fatalities.

Shortly after the Uvalde, Texas, school shooting, Lott wrote an article noting that no student has ever been shot in a school that allows staff to carry firearms. Uvalde was one school that had strict rules against staff carry. Lott also notes that most mass shooters intentionally choose "no-gun zones," just as the shooter at the Aurora, Colorado, movie theater did. Crazy gunmen, no matter how deranged, typically don't want to get shot by armed citizens, or anyone else.

When I listened to Lott speak in Milwaukee at an NRA convention, he gave our group one statistic that has stuck with me — concealed carry holders, as a group, are six times more law abiding than police.

This is another reason why more gun laws will never stop violent crimes like mass shootings. First off, murder is illegal. Possession of a firearm by a felon, or someone with a history of mental illness who has been involuntarily held, is illegal. Only the law-abiding obey gun laws. Making it harder for the law-abiding

to protect themselves is the exact opposite of what we need when there's an armed maniac on the loose.

ALICE, a program of "Run-Hide-Fight" taught in some schools, is better than nothing, if you think grade-school kids can fight an armed intruder. One Pennsylvania school came up with the idea of putting buckets of river rocks next to each classroom door. In the event of an attack, each kid grabs a rock and waits to toss it at the gunman. Remember, these educators are also teaching our children, folks.

Many schools have armed police officers or security guards, but it's difficult for one officer to protect an entire school.

In Uvalde, the latest information shows the elementary school that was attacked had no officers present. Other officers waited up to 45 minutes to enter the school and finally kill the shooter. A delayed response was proven to be disastrous in the 1999 Columbine school shooting, when those trapped inside held signs to the windows pleading for officers to come and save them. A total of

13 people died in that shooting, and police afterward generally agreed nationwide to immediately confront attackers rather than wait.

Having firearms present in the school would allow staff to immediately respond to an attack. Basic firearms training can be sufficient to stop a gunman, since most attacks are by someone without extensive combat training. The presence of firearms is never a guarantee that nobody will be harmed, but it certainly is preferable to being helpless and watching people die.

Instead of wringing our hands and suggesting we add "just one more gun law" to the estimated 5,000 on the books, we should consider protecting our schools the way we protect our citizens, Congress, president, prisons and soldiers — with firearms. We put our kids' minds in the hands of teachers and administrators every day. Isn't it time we trust those good and decent people with the means to protect our kids' bodies, too?

District seeks second manager for pool

Proposal gets split vote from board

The Shawano School District is looking to hire an assistant manager for its pool while working to fill its roster of lifeguards.

Currently, there is only one management position for the pool, according to Superintendent Randi Anderson, and that person must be on the job when the pool is being used to supervise lifeguards. With the pool being open five or six days a week, that has required a lot of flexibility for the current manager.

"It puts our district employees at risk, being in the pool without a management or administrative position when that pool is being used," Anderson said.

Robyn Shingler, community education director, told the Shawano School Board on June 6 that the assistant manager would be a part-time, 10-month position. The assistant manager would be 20 hours per week at \$16 per hour. The funding for this position would come out of the community education fund.

Five lifeguards are employed by the district, with three of them currently college students. Shingler said the district normally has eight to 10 lifeguards from the high school alone, but nationwide there is a shortage of lifeguards.

"Our pool is currently our most widely used facility, next to our gyms," Shingler said. "Outside of the school day, our pool has been used approximately 700 hours."

The proposal was met with tepid

response from the board. It passed 4-3, with board president Mike Mulsolf and board members Mart Grams and Jeana Winslow voting against the measure and board members Michael Sleeper and Alysia Pillsbury absent.

Grams was the most vocal against the proposal for an assistant manager, noting that it would add another non-teaching position in a time when the district is downsizing its staff overall and facing seven-figure budget shortfalls in coming years.

"There's going to be a hurricane coming, and to ask for more money from people who have none is a little crass," Grams said. "Adding a pool manager is beyond my comprehension when I can't even get a teacher to sit in a classroom and no aides during the summer."

Grams went on to suggest letting the Shawano Recreation Center handle the community's pool needs, and he questioned whether the district should be continuing its community education program, geared primarily at adults, when it was laying off staff and seeing massive resignations for its K-12 mission.

Shingler pointed out that the pool is paid through the district's community education fund, and that fund charges for classes, pool use and other items in order to pay for programs. At a meeting of the district's executive committee a few days earlier, she had said there was a surplus of \$15,000 in the fund to pay for the position.

"The goal is to break even," Shingler said.

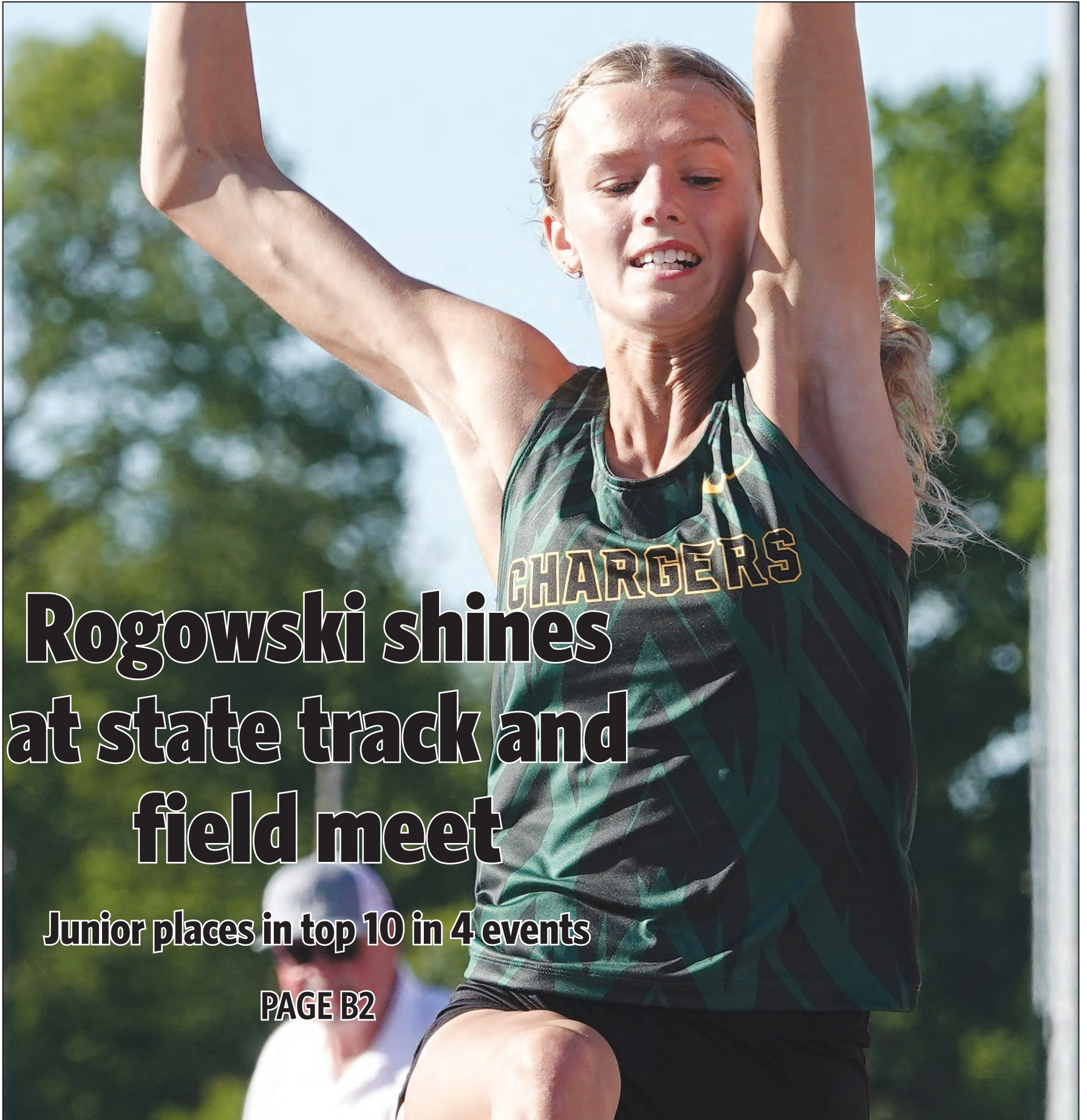

Chargers' Rogowski 2nd in 200, 400 at state

Witt-Birn's Schairer, Horacek happy with state efforts

Wittenberg-Birnamwood High School's Reese Rogowski turned in a pair of second-place finishes during a busy weekend at the 2022 WIAA State Track and Field Championships on June 3 and 4 at Veterans Memorial Stadium in La Crosse.

Rogowski was second in the 200- and 400-meter dashes, while also placing seventh in the 100 dash and 10th in the long jump.

Witt-Birn's Simon Schairer also had a busy couple days, taking part in the 400 dash, long jump and triple jump, while Jalynn Horacek competed in the triple jump. Schairer placed seventh in the triple jump and 14th in the 400 and long jump, with Horacek 14th in the triple jump.

It was the second straight season Rogowski competed at state in those four events. She was third in the 400, fifth in the 200, sixth in the 100 and 10th in the long jump in 2021.

"It means a lot because I knew I wanted to place higher this year in at least a few of my events, and that's what I did," said Rogowski of her performances at state.

On June 3, she competed in all four events.

Rogowski got her day started by taking fifth in the 100 prelims in 12.4 seconds. She later posted the best time in the 400 prelims of 57.25 seconds and capped her running events with a fourth-place finish in the 200 prelims with a time of 25.5 seconds.

In the long jump competition, Rogowski had a couple strong jumps marked and then used a leap of 17 feet, ¼ inch to make the finals.

She wasn't able to extend her distance in three additional jumps, so she settled for 10th in the event.

"I jumped right after the 400 (prelims), so my legs felt really tired after that," said Rogowski. "So I knew that I'd really have to pop one to get on the podium, and that just didn't happen. A little disappointed in that, but I'll come back next year."

With the long jump completed, Rogowski got the chance to focus on her three sprint events June 4.

Rogowski started the day with a seventh-place finish in the 100 after posting a time of 12.71 seconds.

After a break, the junior placed second in the 400 in 57.02 seconds, beating her prelim time despite rainy and cooler conditions.

"It felt really good being able to get second after not making it on the podium for the 100. I used that as fuel to drive me through the 400," said Rogowski.

The junior added the 100 "isn't really my main race or focus." She said her long strides help her overtake runners in the 200 and 400, but it's a tougher task in the much-quicker 100 race.

Rogowski returned to the track one last time for the 200 and placed second in 25.44 seconds, again beating her prelim time.

"I wanted to finish on a high note, so I went out like it was my last race," said Rogowski. "I pushed until the end and I'm happy with how I placed."

Both events in which she took second, it was Rice Lake sophomore Eliana Sheplee who came in first, so Rogowski knows there's some work needed to come away with top finishes next season.

"I'm going to have to work hard

and focus more on sprinting mechanics and lifting to get where I want to be next year," said Rogowski.

Rogowski's three top-eight finishes scored 18 points for the team, and it tied for 11th place in the Division 2 field.

Schairer competed in the triple jump and 400 on June 3 before taking part in the long jump on June 4.

It was an up-and-down performance for the senior in the triple jump, but he was still able to come away with seventh place.

In the prelims, he scratched his first and third jumps, but made it through to the finals after a leap of 43 feet on his second attempt. Schairer wasn't able to extend that distance on his first two final attempts and then scratched his last attempt.

In a loaded 400 field, Schairer turned in a 14th-place finish in the prelims with a time of 52.13 seconds. He missed out on the finals by less than a second.

In the long jump competition, Schairer had the exact same prelim experience as he had in the triple jump. He scratched his first and third jumps and posted a mark of 19-1¾ on his second attempt.

"It was my goal all season to end my career at state, and I'm glad I was able to accomplish that in multiple events," said Schairer.

"I didn't compete as well as I know I can, but I'm just glad that I made it that far and was able to end my sports career at that level."

Horacek came into state hoping to improve upon her 2021 state appearance, when she scratched all three triple jump attempts. She posted marks on two of her three leaps and ended up placing 14th.

She started out with a jump of 33-2¼ before scratching her second attempt. Horacek ended her career on a high note with a leap of 33-6¾ on her third jump.

"It was a really nice way to end track and field. I was ecstatic that I achieved my goals of making it to state again and getting a legal jump in," said Horacek.

"I did as I expected in the triple jump. I wasn't expecting to get to finals or place because I would've needed a PR by a few feet. I was just happy to get a good jump in and finish track at state."

Bowler's Kietlinski earns pair of top-3 state finishes

Athlete places 2nd in high jump, 3rd in triple jump

Gresham/Bowler's Emmitt Kietlinski had a weekend to remember after a pair of top-three finishes at the 2022 WIAA State Track and Field Championships on June 3 and 4 at Veterans Memorial Stadium in La Crosse.

Kietlinski placed third in the Division 3 boys triple jump competition on June 3 and then took second in the high jump on a rainy June 4.

"I actually did way better in the triple jump than I hoped to do, and I'd say I did better in the high jump than I would have hoped, too," said Kietlinski. "There were a lot of good jumpers coming in in both events, and I didn't know how it was going to play out. I just wanted to do my best and see where that placed me."

Despite the second-place finish in the high jump, Kietlinski got off to a shaky start after missing on his first attempt at 5 feet, 10 inches. The junior settled in quickly, clearing the bar on his next attempt and then clearing 6 feet on the first try.

He cleared 6-2 and 6-4 on his second attempts.

"I just had to rebound (after missing the first attempt at 5-10); I just had to settle in," said Kietlinski. "Once I did, I hit my groove and I felt good. I felt like

I had all year. Even though I didn't win it, I was very happy to get top three."

There were just four jumpers remaining when the bar got moved to 6-5, and none of the athletes were able to successfully clear it.

Benton/Scales Mound/Shullsburg's Collin Fosler was granted first because he cleared 6-4 on the first attempt. Kietlinski took second because he cleared 6-4 on his second attempt, while Cambridge's Trey Colts was third and Chetek-Weyerhaeuser's Lawson Davis fourth.

In the triple jump competition, Kietlinski had come into state hoping to place in the top six. For almost the entire event, Kietlinski was the leader.

Kietlinski posted a mark of 44-11 on his first jump of the day, which immediately put him atop the leaderboard of 16 competitors. The junior continued to post marks in his last two prelim jumps and all three finals jumps, but he wasn't able to top his first leap.

The 44-11 mark stood until Mondovi's Dustin Mohler edged Kietlinski with a leap of 45- $\frac{1}{4}$ on the second-to-last jump of the day. Cambridge's Colts topped both marks with a leap of 45- $\frac{8}{4}$ on his sixth and final jump.

"It means a lot to me," said Kietlinski of the third-place finish. "Even though I was in first place for awhile and couldn't quite pull that up, it meant a lot to me."

While Kietlinski was more than happy with his finishes, falling short of first gave him motivation and confidence for next season.

In the triple jump, Kietlinski will head into next season with the best

remaining leap of the D3 state competitors. In fact, Kietlinski was the only junior to place in the top seven.

For the high jump, Kietlinski also will technically be the top-ranked individual, although Davis tied his mark

and is also a junior.

"The goal next year is definitely to win both (events)," said Kietlinski. "No doubt."

Suring's Sleeter ties for 2nd at state in high jump

Eagle also 17th in pole vault

Suring High School's Christine Sleeter tied for second in the Division 3 girls high jump competition during the 2022 WIAA State Track and Field Championships, which ran June 3-4 at Veterans Memorial Stadium in La Crosse.

The junior earned the second-place finish on June 3, before coming back June 4 to take 17th in the pole vault competition.

Sleeter came into state seeded fifth in the high jump with a mark of 5 feet, 2 inches. She cleared 5-4 at state to grab a share of second.

"It definitely means a lot to me. It was better than I thought I was going to do," said Sleeter of the high jump competition. "My main goal was to get on the podium, which I achieved, so I'm pretty stoked about that. Getting second place makes me even happier."

Despite it being her first time at state, Sleeter made things look pretty easy during her first several jumps. She was one of only four jumpers to clear the 4-8, 4-10, 5 and 5-2 heights on their first attempts.

Sleeter said she tried to "put everybody out of her mind," focus on just herself and treat it as another meet.

Sleeter and the rest of the remaining competitors ran into a buzzsaw with the 5-4 height. Only three competitors were able to clear it, with Sleeter and Fennimore's Izzy Bender achieving it on their third tries and Three Lakes' Kallie Volk on her first. The height took out six jumpers.

Volk cleared 5-5 on her second try, but Sleeter and Bender both were un-

able to, creating the second-place tie.

Like, Sleeter, both Volk and Bender are non-seniors, so the top-three finishers could all be in the mix for a state title again next season.

"Now that I know how close I am to getting first — at least I was this year — I'm definitely going to work a lot over the summer and up until track season," said Sleeter. She added that she plans to "really put in that work so I can hopefully make 5-5, maybe higher next year, just so I can

get first place at state."

Sleeter and the rest of the 20 pole vault competitors were forced to compete indoors June 4 with rainy conditions outside. The Suring junior cleared two heights to earn her 17th-place finish.

The starting height of 8-6 looked like it might take out Sleeter, like it did to two other competitors, but Sleeter was able to clear it on her final try. At 9 feet, she missed her first attempt before clearing the second.

Sleeter was unable to clear 9-6, a height that took out eight others as well.

"Today during pole vault, I got a PR (personal record) of 9 (feet) so I'm pretty happy about that," said Sleeter. "But I don't think I placed that well. The Gillett Secondary School track and field team sent a relay team and one individual competitor to La Crosse for the 2022 WIAA State Track and Field Championships on June 4 at Veterans Memorial Stadium, and everyone came away with podium finishes.

The boys 4x800-meter relay team of Evan Peterson, Connor Hanson, Ben Matczak and Alex Peterson placed third to start the second day of the championships before Alex Peterson returned to the track to take sixth in the 3,200.

Peterson ran a 1:13.57 on lap two, a 1:14.15 on lap three and then a 1:13.85 to slide into sixth place. He remained in that spot for the remainder of the race, even after a mad dash to the finish line for a time of 1:05.94 on the last lap.

The junior set the school record at sectionals and then broke that mark at state by about a second-and-a-half.

Peterson won't jump into his off-season quite yet, as he plans to run in the WiscoMILE on June 11. He hopes to set a new personal record there before taking a few weeks off to enjoy some family vacations. He'll mix in some running while on vacation before starting summer training in preparation for the fall cross-country season.

Junior saves best jump for last

It was a bit of a frustrating day at the 2022 WIAA State Track and Field Championships Veterans Memorial Stadium in La Crosse for Lena/St. Thomas Aquinas Academy's Natalie McNurlen, but perseverance paid off and earned her a spot on the state podium.

The Lena junior made the podium after placing sixth in the Division 3 girls triple jump competition on June 4.

McNurlen came into state seeded fifth in the event with a leap of 34 feet, 11¾ inches, but she struggled to post marks on the day.

She scratched her first jump in the preliminary round before posting a mark of 33-8¾ on her second jump.

McNurlen also scratched her third jump, but her one mark was good enough to move her to the finals, where she was given three more jumps.

McNurlen's tough day continued with scratches on her first two jumps in the finals, but she erased all the tough times with a leap of 35-5¾ on her final jump at state. The

mark briefly put her in fifth before she got bumped down a spot before the end of competition.

"I knew I needed to do something; I had to pull out something. I had four scratches and I actually only jumped twice, so that last jump felt amazing. I'm just so happy," said McNurlen. She added competing at state was a bit intimidating at first, but she settled in when conversing with other competitors.

McNurlen said her scratches were coming with just a toe over the board after reviewing video with her coaches.

"I moved myself back 2 feet, which is a lot, and I just went for it. It was my last jump, and it just happened to be my best," she said.

The Lena athlete had a goal of setting a new personal record at state and accomplished that with her final jump.

"It's super special. It's beating my PR by so much and creating a new school record, which hopefully will be broken again next year," said McNurlen.

She said she hopes to make it into 36-foot territory next spring as a senior, saying she could do so with more training and dedication to the sport.

Bonduel High School's Brenna Hertzfeldt and Karter Schroeder placed ninth and 13th, respectively, during the 2022 WIAA State Track and Field Championships, which ran June 3 and 4 at Veterans Memorial Stadium in La Crosse.

Hertzfeldt was part of the Division 3 girls discus field, while Schroeder was in the boys high jump.

Hertzfeldt came into state with the third-lowest seed mark of 109

feet, 4 inches out of 16 competitors but definitely wasn't intimidated.

Her first throw of 106 feet was one of the top marks of the first flight, and after a second throw of 101-2, she had her top toss of 107-9 on her third throw.

"It was definitely the most exciting experience of my high school sports career," said Hertzfeldt. "I came up just short last year, so to be able to finish my high school career with a state appearance means a lot."

The senior qualified for the finals, and despite not being able to extend the mark on her top throw, she posted marks on all three finals throws. Hertzfeldt was one of just four throwers to not scratch in the

cool and rainy conditions the morning of June 4.

"I didn't hit the PR (personal record) or school record that I was looking for, but I can't complain at all with how I finished," said Hertzfeldt. "A big goal was to make it to the finals and I did that, so it was still a positive outcome, and overall just being able to compete at state was the icing on the cake to end my high school sports career."

Schroeder came into state with the second-lowest seed height (5-11) of the 16 high jump competitors, but calmly cleared the starting height of 5-10 on his first try.

There were two competitors who failed to make it over the starting height and six others that failed

on their first try.

Unfortunately for Schroeder, he was unable to clear the next height of six feet, so he had to settle for 13th place.

"I wish I would've performed better, but I'm happy with making it over the starting height because it is such a drastic change from what I am used to starting at," said Schroeder.

The junior is hoping to make a return trip to state next year, where he hopes to improve on his place.

"I gained the experience of state and I know what to expect from it all, and I fully expect to be at state again next season," said Schroeder.

In the final, Roloff's time of 12.71 was good enough for seventh, just missing the podium.

"For the 100, I felt good about my preliminary time and I got a personal record with my time of 12.2 seconds. My final race did not feel like my best race but I'm still glad that I gave my best and placed in the top eight in Division 1," said Roloff.

"It was a great experience to end my high school running career at state," the senior added. "Having a state experience with all three divisions at once was an event to remember."

Roloff ran in the 4x200 relay along with teammates Onna Hermann, Adalyn Barkley and Makenna Bubolz on June 3.

The team came in seeded 22nd in the event and walked away from state after placing 22nd with a time of 1 minute, 49.32 seconds.

"As a team, it was an incredible opportunity to make it to state with such a young team," said Hermann. "We knew Division 1 competition was challenging, but we continued aiming to advance, until eventually state was within reach. We worked endlessly this season, and are beyond grateful for making state."

The three-run fifth for the visitors was a tough one to swallow for Bonduel, as many of the hits came on groundballs that snuck past infielders, including a couple that took bad bounces.

All of the runs came with two outs, and Gehm was eventually replaced in the circle by Nakiyah Henning.

"I definitely think they knew right

Iola-Scandinavia got a single to start the ninth and then had another with one out. Henning got a foul popup for the second out before a flyball down the left-field line got just past the outstretched glove of Audrey Weier for the go-ahead RBI double.

Bonduel went down in order in its half of the ninth.

Bonduel caps the season with a 20-1 overall record, a Central Wisconsin Conference-East Division title after going 12-0 and a Division 4 regional title after a pair of shut-out playoff wins.

"I don't think there's a game that I'm not going to remember," said Gehm. "Even if I was sitting, I still had the most fun time that I could have dreamed of. This season was everything I ever wanted."

Julia Lorbiecki is the only other senior on the Bonduel roster this spring.

"To our two seniors, we said thank you for setting the groundwork for what we believe is a good young team. The difference between us ending the season today and moving on is very small and we'll make up that difference," said Grayvold.

Grayvold also thanked assistants Jerry Reinke and Amy Zernicke for their help this season and praised their dedication to drilling the team on fundamental work.

Features include an exhibit displaying the sports history in Mattoon, a Native American exhibit and an exhibit detailing what women would traditionally wear throughout the years. The second floor opened on May 30.

"We needed more room for everything that we wanted to put in the building, so we had the upstairs redone," said historical society secretary Kathy Zarda. "We liked having old furniture up there and old clothing."

Former society president Dick White said the society wanted to create another area in the museum where memories can be preserved.

"We are trying to preserve the history of Mattoon, not the artifacts," said White. "The artifacts are all from this area. They are not all antiques; they all have meaning to someone in this area."

Zarda said that most of the items on display were donated from people with past connections with Mattoon.

She also said that it took a couple of months to get the second floor completed.

"We didn't start until February, but you know I think it got done quite nicely," said Zarda.

White said the historical society wanted to display sports, Native American life and women's clothing, because Mattoon has a history surrounding those three topics.

"We thought that those sections were meaningful to the people that live here," said White. "These are just aspects that people can relate to, as their families started and grew."

White said it's important to maintain memories of Mattoon's history.

"This means a lot to me, because it is starting to fade away," said White. "We need to put the brakes on it and preserve it, so it doesn't go away forever. We have people here who are

in their nineties, who won't be around much longer."

White added that the upstairs section of the museum gives younger people an opportunity to put a face or an event to mind when they hear about their grandfather's sports career.

"These displays really give the younger generation a chance to relate to something that maybe they have not seen, but have heard about," said White. "Throughout the museum, there are things that they can see, where they say, oh, that's my uncle, or grandma, or any family member."

Talking about the sports section, which highlights school teams and club teams, White said Mattoon has always had a strong interest in community sports.

"School leagues, city leagues, little league and even beer leagues — those

were all big social parts of the community," said White. "We have had the Harlem Globetrotters here. In a small town, there is not always a lot to do. So, when there is a ball game, it is a big deal — where people would come out and just hang out and catch up with neighbors."

White added that they wanted to display Native American history in Mattoon as well, because of the strong history behind it.

"We are about a mile from the (Menominee) reservation," said White. "We had a lot of Native American foster children, who were raised in Mattoon and went to school with us. There is a very strong connection between Mattoon and Native American history."

Finally, White said that the historical society wanted to display what

clothing and bedrooms looked like over a century ago.

"It is just to show the differences in how people dressed back then, compared to today," said White. "The dresses upstairs are small. People were a lot smaller back then than we are now."

White hopes that those who come to the museum will be an addition to preserving the memories and history of Mattoon.

"People really do appreciate these new sections and we want them to continue to share memories and history," said White.

The museum, located at 611 Fourth St. in Mattoon, is open in the summer on Tuesdays and Saturdays from 9 a.m. to 2 p.m. or anytime by appointment.

Father, daughter team up to pen book

Farmers offer insight on 'Simple Miracles' to tackle everyday life

There are tons of self-help and inspirational books out there, but there's a new one that's more down to earth — specifically the soil in Oconto Falls.

"Simple Miracles: 52 lessons to transform your life and rewrite your future" looks at setting goals, showing respect, forgiving, overcoming securities and believing in yourself. The book is written by father-daughter duo Hank Wagner and Laura Wagner Raatz, who operate Wagner Farms as a family and also manage the Wagner Leadership Training program.

Wagner has previously published a book based on the time he spent on a mission trip in Africa, but "Simple Miracles" not only gave him the opportunity to share some of the things he's learned in life as a farmer, it gave him the opportunity to bring in his daughter and provide perspectives from two different age groups.

"I wanted to have that experience," Raatz said about being an author. "It's kind of been on my bucket list to author a book, and I guess what better way to do it than write alongside my dad."

The book is broken down into 52 chapters, each one written by either Wagner or Raatz. They offer insights into everyday life, showing the miracles within, and each chapter ends with call-to-action questions that motivate people to reflect and take steps to change their lives.

Wagner's motivation for the book was to reach out and touch as many lives as possible.

"I'm a dairy farmer, and I love everything about farming and feeding the world, but my personal goal is to help the lives of others," Wagner said. "I set that specific goal a number of years ago to have a positive influence on a minimum of 100,000 people in my lifetime. The way to do that is you have to reach out and touch people's lives."

Wagner said it was important to him and Raatz to divide the book into 52 chapters to allow readers the option of taking on issues one at a time, once a week during the course of a year and tackle what they are dissatisfied with. They felt it was important to have a shining light during a time period

where everyone is uneasy due to the coronavirus pandemic and other issues causing people to worry and fear.

"We felt that our world could use something positive, and people are always looking for improvement, for things to be better in their lives," Wagner said.

People seek to either change their circumstances, according to Wagner, or to change the people around them. "Simple Miracles" helps to accomplish both of those, he said.

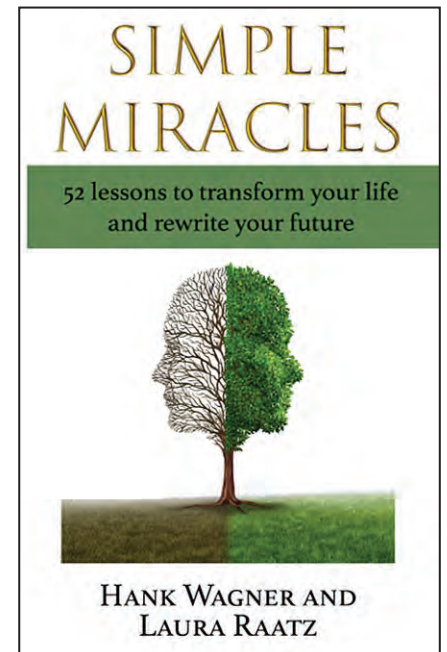
"We don't realize that the best way to do that — maybe the only way to do that — is to change ourselves first," Wagner said. "Each one of these chapters gives people the idea to think into that particular subject and decide if they want to take any steps to change something."

Raatz loves that the book is show-

ing two different perspectives on life. While Wagner is older with more life experience, she has experienced different things in life to be an expert in her own right.

"I don't think one is better than the other," Raatz said. "It's just a whole different view on a specific topic. Maybe some of the topics my dad goes into are more related to something that somebody would experience later in life but still relate to somebody my age, and the same for my chapters. Some of the chapters I speak on are about bullying or the influence people around you have in your life. Those chapters are spoken by me from experience at a younger age."

Wagner noted that, even though the goal was to have readers go through one chapter a week, he and Raatz have done too good a job and heard that

many readers can't stop at one chapter.

"They say they can't do it. They can't put the book down," Wagner said. "It's encouraging. It's a book you can highlight or put a bookmark in or jump ahead to a topic that's relevant in your life right now and then go back and read another one later."

For Wagner, he's excited to show that people in the agriculture industry can conquer the writing world, as well.

"Dairy farmers are not supposed to be authors," Wagner said. "That's what the perception of most people is. I wanted to write a book because I wanted to influence more lives."

Raatz said she was excited to finally be a published author.

"I think for us, to establish that credibility of, we are just farmers and that's what we do for a living, but we're passionate about having a positive influence on the lives of other people."

Originally, Raatz and Wagner had compiled more than 52 chapters, so that resulted in cutting out certain things. However, it has inspired the pair to look at doing other books based on the "Simple Miracles" theme. Wagner said there are potentially three or four more books in the works, including "Simple Miracles for Youth."

Rhubarb Fest to transform Heritage Park

Event has evolved from small community event to major historical society shindig

Looking at the Heritage Park grounds today, there is no indication of what they will look like on June 18, the date of the Shawano County Historical Society's 14th annual Rhubarb Fest.

Preparations for the festival have been in the works for months, though, with organizers looking forward to filling the park with a multitude of activities for fest-goers to enjoy.

Lana Buelow, the festival chairwoman, is currently working a 40-hour week and more to put together all of the pieces that guarantee a perfect Rhubarb Fest. Her planning started at the end of the fest a year ago, when she started checking off what went well and what needed improvement.

"It's a year-round thing," she said, noting that she started out just as a volunteer for a couple of years before becoming a co-chair with Mary Crawford in 2019.

"Planning starts in January, when I start communicating with my committee chairs," said Buelow. "We have 15 different committees. The repeat chairpersons of the committees have made planning easy for us."

Committees include brat stand, marketing, bake sale, ice cream and raffle baskets, among other vital groups.

According to Buelow, there has been an evolution of the festival over the past 14 years. The event started as a small community event hosted by the historical society.

"It was meant to get the word out to the public that we have these wonderful museums to come to see, and it was a way to get the community involved in what we have there," said Buelow. "From that beginning, it's expanded and now we do focus more on fundraising. As we grew, we had more operating expenses, and we had to figure out a way to cover those."

Buelow said that Crawford was instrumental in getting the marketing ramped up.

"One of the ways that it started growing was to start marketing it beyond Shawano," she said. "We expanded the marketing to the Fox Cities

magazine, for example, and onto area calendars. Those things start in the fall, and we had to get the information out then for those publications."

More than 66 volunteers were involved in the 2021 event, many who have been involved for years. The volunteers do things such as working in the gift shop, being docents in the historical buildings or cooking the brats and hamburgers. Heritage Park is where Shawano was first settled, so the buildings will be open, with volunteer docents to highlight the historical pieces in each one.

"Festival guests can wander through the buildings. They can just enjoy walking through the museums," Buelow said. "Outside of rhubarb, we want to have people come and have fun, yet recognize the history of Shawano County."

Many people donate items to be sold at the festival, such as baked goods that highlight rhubarb as an ingredient. Rhubarb jams and rhubarb salsa are also donated for sale.

Sheila Dovorany and Janet Koller, from the Shawano Woman's Club, are this year's co-chairs of the plant sale. Club members donate a variety of plants for sale at the fest. Last year, the club raised about \$1,000, with all proceeds going to the Historical Society. Club member Darlane Kroening, a master gardener, is on hand to help fest-goers choose plants; she also provides advice on the planting and care of them.

"Last year, Darlane dug up 45 rhubarb plants for the sale. We sold out of them," Dovorany said. "This year, we got a committee together and went out and dug up rhubarb plants and have 75

plants for this year."

The woman's club staffs the plant sale with its members. Planning starts around March, and Dovorany and Koller asked members to sign up to work at the festival and/or to donate plants so that they could have an idea ahead of time how the sale would proceed.

The festival is open from 10 a.m. to 4 p.m. June 18, with volunteers setting up and filling the grounds at Heritage Park at 7 a.m. A lot of the preparation work starts the day before, when volunteers start to deliver baked goods and other rhubarb edibles, and plants for the plant sale. Tents go up, tables are placed and the year-long planning to change the wide-open lawns of Heritage Park into a vibrant and unique festival culminates with the arrival of the first guests.

Sowing the seeds of sustainable agriculture

The Menominee word for garden is monahekaehsah — which directly translates to “little field or farm.” For Dr. Frank Kutka, the diminutive suffix “sah” offered him both a lesson and an opportunity to use humor.

“Once I recognized that ‘sah’ meant ‘little,’ I added it to words and names to tease people,” Kutka said.

He realized early on that Menominee people only tease those whom they value.

Since his hiring in 2019, Kutka has become a valued member of the College of Menominee Nation faculty — a fact announced publicly when the college’s leadership team presented him with the 2022 Faculty of the Year Award at the school’s May commencement. Kutka was lauded for his work writing and teaching the core curriculum for a bachelor’s degree in sustainable agriculture, a program that began offering courses in the fall of 2021. Celebrated as a hands-on educator, Kutka described teaching at CMN as his “dream job,” noting that “everything I had ever done led to this position.”

Born in Cudahy and raised on a small farm in Jefferson County, Kutka matriculated at UW-White-water, earning his bachelor’s in field biology. He then went to Iowa State for a master’s degree in animal ecology and, later, Cornell for his Ph.D. in plant breeding. Along the way, he did a stint in the Peace Corps, completed water quality research for the University of Minnesota, led research at North Dakota University, held a U.S. Department of Agriculture job in the “Peace Garden State” and started a seed saving business in Door County.

Kutka began at CMN unaware of the tribe’s storied history as sustainers, but he set out to change that by meeting with local knowledge keepers.

“I did a lot of outreach before the pandemic, including at the wonderful quarterly Community Engagement Meetings held at the casino, as

well as with the folks at Menikanaehkem and Project FRESH,” Kutka shared. “I also spoke with groups in the Oneida and Mohican communities and, once COVID hit, we used what we learned to draft a survey that guided our course topics.”

According to Kutka, survey respondents were interested in a program that “had the inclusion of traditional wild harvested food” in addition to conventional modern agricultural practices. There was little interest in what he described

as “chemical agriculture,” instead favoring the “Indigenous agriculture” that is at the heart of traditional Menominee food ways.

Kutka spoke in awe of the Menominee forest, noting “it’s the best example of sustainability I’ve seen,” but he further explained that trees weren’t the only thing the tribe thrived at producing.

“The Menominee ancient gardens are astoundingly left out of what some teachers pass along,” Kutka said. “The archaeologists knew

they had corn and squash growing up into Michigan. It was the most amazing agroecosystem, and it is absolutely flabbergasting that this isn’t taught elsewhere.”

CMN’s program seeks to not only ensure the history is recognized, but that it’s applied in classrooms and thereby known to graduates who will employ it to make a difference. Kutka revealed, “We took a hard look at the purpose of the whole enterprise. It’s not about combines; it’s about people at the table eating and being healthy. It all starts with human nutrition.”

When asked about his success in course creation, grant writing and project coordination, Kutka deflected by stating, “All I do is reflect what’s around me.” He then elaborated, “I work for the Menominee people. It’s not my program. It’s not for me. It’s all about Menominee people achieving Menominee goals.”

Still, like all programs at CMN, the sustainable agriculture program is open to all students.

“Our graduates will have all kinds of options,” Kutka said. “We prepare students to go directly into production agriculture, graduate school, agency work or environmental protection. We focus on community health, offer business electives, teachings in traditional Indigenous agriculture and also in the technical side of farming.”

Kutka added, “The world is complicated, and agriculture is a complicated part of it.”

Yet, he’s doing his part to demystify the field through both classroom teaching as well as by toiling alongside his students in the soil. Kutka stated that from the get-go, his message to the Menominee nation is that “I’m here to learn, and I’m here to work.”

Of course, the proof is in the harvest. Often when you drive by the campus, you will see Kutka working, laughing and likely teasing his students in CMN’s “little field,” doing his valued part to sow the seeds of sustainable agriculture within the next generation of Menominee farmers.
