Retzlaff arrested in Oconto County on warrants

Former campground owner turned fugitive has been missing since January

Fugitive and former campground owner Ann Retzlaff was apprehended Aug. 23 in Oconto County after disappearing seven months ago.

Shawano County sheriff's logs show Retzlaff was apprehended at an address in the Town of Lena at about 4:30 p.m. According to Sheriff George Lenzner, his department received a tip shortly after a Facebook post about her went live earlier in the day that Retzlaff was believed to be somewhere in Oconto County.

"Somebody recognized her, and she was picked up in Oconto County without incident, it appears," Lenzner said on the morning of Aug. 24. "She was transported directly to the county line where our officers took custody of her, and she's safe and sound in our jail right now."

Lenzner said the sheriff's department has been getting a number of tips about Retzlaff's whereabouts after bench warrants were issued in January when she was not in court, but it wasn't until the county featured Retzlaff on its Warrant Wednesdays, used to get public tips on fugitives, that the timing worked out and the Oconto County Sheriff's Department was able to find and arrest her.

"We've been looking for her long enough," Lenzner said, noting that the Facebook post was shared more than 900 times.

Lenzner noted Shawano County tried every means at its disposal, including enlisting the help of the U.S. Marshal's Office, prior to posting information on Facebook. He said the law doesn't allow his deputies to arbitrarily arrest someone in a different county or state, even if there's an active warrant.

"We can't go to a different county, and we can't go to a different state to arrest somebody," Lenzner said. "We can't kick down doors. We still have to

act within the guidelines of the law."

Lenzner noted that the Warrant Wednesdays has resulted in a number of arrests, usually of people who are high-profile in the community like Retzlaff.

"It hasn't worked for all of them, but a lot of them were put into custody," Lenzner said. "Annie's face has been in the news enough that people are more aware of her case over a lot of other cases."

Retzlaff is facing felony charges in Shawano County for fleeing and eluding officers and two counts of second-degree recklessly endangering safety, as well as a misdemeanor count of resisting or obstructing an officer. She also faces misdemeanor charges through Menominee County for resisting and failing to stop.

On May 15, 2021, a Shawano County deputy heard on Menominee County radio traffic about a high-speed chase involving a vehicle registered to Retzlaff for failing to stop at a traffic light, according to the criminal complaint. The chase, starting in Keshena on state Highway 47-55, continued through the towns of Wescott and Richmond, where deputies twice laid out spike strips, and ended on state Highway 29 just west of County Road MMM.

At first, Retzlaff delayed court proceedings by first stating on two occasions that she had not found an attorney who was constitutionally sound, and the court agreed to give her additional time to do so, outside the usual 10-day period as Retzlaff claimed she was in the busy season for her business.

Then Retzlaff did not appear on Oct. 5, 2021, claiming she was ill, and she was granted a continuance but stipulated that she must appear in person a few weeks later. When she did not do so, her previous bonds were forfeited, and a bench warrant was issued. Retzlaff paid the bonds for the new warrant but then missed court again in November 2021, claiming she felt she wasn't safe in the courtroom due to COVID-19. Body-only warrants were then issued to compel her to return to court.

Retzlaff was recaptured in April

2022 in a restaurant in the Town of Wittenberg and additional charges of bail jumping and disorderly conduct. She was held for several months on a \$15,000 cash bond, which was originally \$25,000 until she convinced Marathon County Circuit Court Judge Mark Moran to reduce it because she was the only caregiver for her father, who has ALS.

The conditions of her bond required her to not travel outside the state without the court's permission, but on Dec. 5, 2022, she convinced Moran to let her take her three teenage children to travel out of state for a winter break, giving the judge an itinerary that had her returning to Wisconsin on Jan. 3.

However, at the next court hearing Jan. 12, Retzlaff was again a no-show in the courtroom, and Moran issued

bench warrants that allowed for her to be arrested nationwide if located. She's facing two more felony bail-jumping charges after it was discovered she left Wisconsin for Michigan prior to her request for the family vacation.

Retzlaff is facing five counts of criminal slander of title and two felony bail jumping charges in Sauk County after allegedly filing liens against representatives with Bank First and the new owner of the campground, now known as On the Rocks Family Kampground.

Retzlaff made an initial appearance by video Aug. 24 from the Shawano County Jail. Moran ordered an additional \$50,000 bond added for the 2021 charges and an additional \$5,000 for the 2022 charges.

Sewer dump among proposed capital projects

Shawano also looking at work on civic center, chapel at Woodlawn Cemetery

Constructing a sewer dump station, making some fixes to the civic center and replacing the roof of a Shawano icon are among the items the city of Shawano is planning for its capital projects in 2024.

The Shawano Common Council kicked off the first in a series of meetings about next year's budget on Aug. 23 by looking at the upcoming capital projects totaling close to \$5 million. According to Greg Smith, the city's finance director, the city has almost \$2 million in its general obligation fund to go toward the capital projects, totaling almost 39% of the funds to pay for them.

"We're getting a lot of other funds to pay for our projects this next year," Smith said.

The sewer dump station is needed now that the Shawano Landfill plans on closing at the end of 2025, according to Scott Kroening, public works director. The station is where the city can dump its sewer grit, which Kroening said is actually

90% water. That grit comes when the city cleans its lift stations and manholes, and a place must be found to disperse the waste.

"The landfill is certified to accept that grit, so we're able to dump there," Kroening said.

Without the dump station, the city would have to transport the sewer grit to stations in either Brown County or Marathon County, which Kroening noted would cut into staff availability for other projects and would be costly in fuel and vehicle wear and tear. Having the dump station, the city would still need to transport the grit, but workers could do one load during the month instead of doing it every time a cleaning takes place.

"That's several hours transit there and back," Kroening said. "We

really don't want to do that and put the mileage on the trucks."

The dump station is just a concrete pad with filters, according to Kroening.

The civic center is in need of some care, according to Matt Hendricks, parks and recreation director. He noted that much of the attention has been going to the parks in recent years, but there are buildings geared for recreation that need to be maintained, as well.

Hendricks said the civic center will get improved lighting, which is expected to cost around \$25,000, and some work on the exterior is expected to cost another \$25,000.

"We've been having conversations for the last three years," Hen-

dricks said. "They're not big ticket items, but they're things we need to be doing to maintain our facilities."

The city is also proposing to spend \$80,000 to replace the roof on the chapel at Woodlawn Cemetery. Built in the 1900s, according to Hendricks, the existing roof is leaking water into the building and needs to be replaced in short order.

"There are also other items out there that need to be fixed, like windows and doors," Hendricks said, noting that the city doesn't charge for the chapel's use.

City Administrator Eddie Sheppard suggested finding additional uses for the chapel besides funeral services.

"It is a pretty iconic piece of the cemetery, but it's probably underutilized," Sheppard said. "It's probably because of the condition it's in. We need to do an analysis on what it could be used for, in addition to what it's being used for now."

Speedway drama rears head at county board

Ag society, board committee could meet to discuss issues

Members of the Shawano County Board may soon get involved in the controversy surrounding the Shawano Speedway, its scales and other drama after a longtime videographer was told he was no longer welcome at the track.

Cody Hudson, a member of Shawano Area Ag Society, which oversees

the fairgrounds, told the board Aug. 23 the scale issues are taking away from the importance of the track to the community.

Another winning driver was recently disqualified after his race when it was discovered his car weight did not meet regulations, and he forfeited his winnings.

"The race track brings so much stuff to the community. They bring a lot of revenue to the area," Hudson said. "There is so much more to be talked about. There is even talk about wanting to close the track down. We want to keep seeing racing going."

He said financial help would be welcome to address scale and water truck issues that could cost tens of

thousands of dollars to correct.

County Board Chairman Tom Kautza said funds are available if a request is made. He said officials would have to look into whether there are limits on what those funds could be used for at the fairgrounds.

Social media has been buzzing with rumors and comments after Mike Thorne announced in late July he was told via letter from the Ag Society he was no longer welcome at the track. Thorne, who declined to speak to the media, said in several social media posts he simply asked questions posed by fans, and the Ag Society executive board took it out on him.

Hudson told the county board he said in a video that Shawano was

going through a lot of drama, but it was nothing that couldn't be fixed if officials wanted to fix it. Days later, he received the letter.

"Did I meet with the executive board before that decision was made? No, I did not. I was never asked," he said. "I was never told that anything was wrong or being done wrong or anything. That was a kick in the groin."

Board member Sandy Steinke suggested the board meet with the Ag Society to discuss the controversy. Kautza suggested the meeting be at the committee level, with Ag and Extension the appropriate starting point.

County broadband BEAD task force holds first meeting

Shawano County has nearly \$21,000 in grant money to help spread fiber optic internet access to homes and businesses.

A meeting of the newly created Broadband Task Force - BEAD (Broadband Equity, Access and Deployment) was held Aug. 24 to begin to determine how to spend that money.

However, until official rules and

regulations are passed along from the Public Service Commission of Wisconsin, the committee's activities were limited to electing its leaders, crafting a vision statement and discussing internet access and speeds.

Grant funds will support planning activities that include but are not limited to outreach initiatives, conducting local needs assessments and developing local plans for broadband development.

Access and affordability are the two

main concerns.

The goal is to provide internet access at speeds of 100 Mbps for uploading and downloading, which in effect ruled out wireless companies from accessing the grant money. Instead, it leaves the funds for fiber optic installation.

"Fiber is as important as electrical," said County Board Supervisor Devin Krizan, who was chosen as the committee's vice chairman.

The county will work with New

North, a nonprofit economic development corporation that will provide GIS mapping and other things, to help develop a five-year action plan.

Any committee recommendations will be forwarded to the County Board Executive Committee and then to the County Board itself.

Matt Hietpas, the county's technology services director, will serve as committee chairman.

Building addition at TimberPro completed and celebrated

Crawford family honored for their contributions to forest industry

The forest products industry in Wisconsin provides more than 61,000 direct full- and part-time jobs and has a total industry output of \$24.4 billion.

A significant part of that industry is due to the efforts of a Shawano company.

Officials with Komatsu, which purchased Shawano's TimberPro Inc. in 2019, celebrated the completion of a 48,765-square-foot addition to its manufacturing building at 1407 Industrial Drive on Aug. 25. Prior to the expansion, the building encompassed 104,615 square feet.

The expanded part of the building was dedicated to the Crawford family, as it was Pat and Ruth Crawford who founded TimberPro.

A plaque outside the building reads: "In recognition of the Crawford family's leadership, innovation and long-lasting impact on the forest industry and the Shawano community."

Doug Morris, vice president of Komatsu's North American Forest Machine Business Division, addressed the dozens of employees and Crawford family members at the dedication event.

"We spent time trying to understand those special attributes that made TimberPro so successful in the forest industry," Morris said. "What it really came down to and what we recognized is that it ultimately boils down to the skill, the passion, the dedication of the employee base that works here — the entrepreneurial spirit, customer-centric, being responsive to their needs. We had to find a way and scale that up so that we could expand and grow this business to be successful."

The Komatsu company was founded more than 100 years in Japan by Meitaro Takeuchi. Komatsu means

"small pine tree" in Japanese, and it was Takeuchi's vision to create a company that would grow with the community surrounding it.

Morris said there are a lot of parallels between the vision of Takeuchi and that of the Crawfords.

"If Takeuchi were here today, I think he would be very impressed and proud of the business that TimberPro has built in this community, the way that it's grown with the community," Morris said. "I think he'd agree that

we have a very bright future ahead with this company."

Established in 2002, TimberPro is a manufacturer of purpose-built forest machines and attachments, offering tracked feller bunchers and harvesters, forwarders, wheeled harvesters and felling heads.

The company was sold in 2019 to Komatsu America Corp. a U.S. subsidiary of Komatsu Ltd., the world's

second largest manufacturer and supplier of earth-moving equipment — consisting of construction, mining and compact construction equipment.

Pat Crawford died in August 2018, and the anniversary of his death caused son Lee to reflect on the family business.

"When he started logging, he had a team of horses and a power saw that was used," he said. "I look at today; we have these amazing machines. We can cut roughly 3,000-4,000 trees a day. That's about six to eight trees every minute. We have machines. We have machines that have processing heads that can cut a tree, tip it over ... cut the branches off. It measures the diameter, the crookedness of the tree, and it optimizes the lumber that is going to come from that tree at 14 feet per second."

Crawford said his dad would be proud of how the company has progressed in the past five years and of the building addition. He said it was the employees who made his parents the proudest.

"This (the Crawfords) is not the family that built this company," he said. "It's the TimberPro family that built this company."

SMU ready to have newer building in city

Better efficiencies, access to new tech key reasons to replace aging facility

An 82-year-old building in Shawano will soon be nothing more than a memory as Shawano Municipal Utilities celebrated the beginning of a new facility being built.

The new 29,000-square-foot SMU building on North Sawyer Street is expected to be built by fall 2024 and is expected to cost \$12.9 million once all is said and done. Currently, SMU is operating out of office space rented in the GenEx headquarters across the street.

SMU Manager Bruce Gomm said the process to get a new building for the electric utility has been going on for more than five years. He noted that, when he came on board in January, he had questioned why SMU was going to build its new building in the same location as the old when he thought there should be a bigger area for the new building and other amenities.

Gomm soon learned that removing SMU from downtown Shawano would be akin to amputating a body part.

"My first question was 'Why aren't we looking at something on the edge of town with five to 10 acres and all the room in the world?'" he said. "Then I got to Shawano, and I got to know the community. I learned that SMU is part of downtown and always should be. We are accessible to our customers. We are part of this community, and we are here to stay and serve you."

Gomm noted that building near downtown might inspire other businesses to see the value in relocating to Shawano and build up the area even further.

"It's an investment in the community," Gomm said. "We'll be paying more taxes because we'll have more value."

Gomm noted that the groundbreaking is purely ceremonial, with officials putting shovels into a prepared pile of dirt instead of actually breaking the ground for the new building.

"I've had a couple of employees comment that we're not actually digging. We should be over there where we need foundation holes,"

Gomm said. "This is really just a ceremony to celebrate the start of the project."

The manager boasted about the newer amenities and how, in the long run, it will save the utility money compared to how much it cost to maintain and operate the old building.

"It allows our staff to have the latest technologies," Gomm said. "It allows us to have more efficiencies. It's ADA (Americans with Disabilities Act) compliant and probably one of the bigger things is it allows us to be safe."

City Clerk Lesley Nemetz, the city's community relations manager, spoke on behalf of City Administrator Eddie Sheppard, who had

been delayed at an event at Timberpro, and noted that work with Timberpro, SMU and Arrowcast is helping to move Shawano forward into the future.

"These things are connected," Nemetz said, reading from Sheppard's prepared speech. "They are all part of our shared goals to continue to move Shawano forward. These infrastructure developments are just a few examples of the tremendous growth and development we are seeing in our community. Projects like these strengthen our foundation and lay the groundwork for future success."

Roger Pescinski, president of the Shawano Municipal Utilities board, noted that talking about a new

building started in October 2017, but even though plans were drafted, the effort was shelved because of the potential cost of the building. The discussion was revived in 2021, he said, after it was realized that a lot of money was being wasted on maintaining the existing building.

"Every year, when we start the budget process, we look at how much money we need to put into the building, and to keep employees happy and productive," Pescinski said. "We don't have enough room for all of the vehicles here, with things parked off-site. Our idea was to bring everything back into one location."

Retired teacher volunteers at school in Ghana

Like many, Going experienced culture shock in foreign land

Kris Going recently retired after working 28 years in the Shawano-Gresham School District. In weighing what to do in the next phase of her life, she decided she wanted to volunteer in the education field in a developing nation.

She settled on Ghana — more than 5,700 miles from home.

"I considered the Peace Corps, but the 2½-year commitment was too much," she said. "I also wanted to avoid the 'white American woman come to save' ... It didn't fit."

Several years ago, Afia, the aunt of her daughter's boyfriend, had started a day care (creche), and she was in need of volunteers to help train the teaching staff. Afia is assisted by her brother, David.

The May 26 to July 7 volunteer session was run through The African Child Charity Organization (TACCO).

"Like everywhere else, 2014 was the last time they had any volunteers, and the donations have dried up," Going said. "So, they are funding the schools all by themselves."

The school is like a day care, from pre-kindergarten through third grade, although they hope to expand to fourth grade soon.

"He (David) wanted me get an assessment system started," Going said. "My role in the schools in the last 15 years wasn't a classroom teacher; it was an instructional coach, so it was working with teachers. I always thought of myself as a thinking partner with teachers."

Concentrating on curriculum and instruction, Going's volunteer efforts were to be aimed at the big-picture things, not necessarily

classroom teaching.

"He wanted me to bring in the creative arts standards," she said.

Going said 80% of the country's residents speak English, as they see it as a better way to improve themselves on the world stage. She learned a little twi (pronounced "chwee") to converse with the younger students.

Like most people experiencing a new lifestyle ritual in a new place, Going suffered culture shock. After only a few days, she was already looking at return flights.

"My third night, I had a poisonous scorpion in my room," she said.

Instead of packing up, she did a little research to discover her new feelings were normal, and she managed to put them aside — for the most part — for six-week adventure.

The school organizers had a house built for their volunteers, about a 10-minute walk to the school. All meals were cooked for Going, and she learned that all food given to her is considered a gift in Ghana and cannot be refused.

For the first three weeks, she was at the school part time, and spent the other time exploring and sight-seeing, including sights of the slave trade. Many Africans spent time in the "slave castles" on Ghana's coast as their last stop before being forced onto the slave ships from the 16th through the 19th centuries.

"That was an emotional experience," Going said. "I can't even talk about it, but I'm glad I went and saw it."

As in many other developing nations, life in rural Ghana is relaxed, and the concept of time is much different than in the West. Going quickly learned that a meeting set to begin at 8:30 a.m. meant partici-

pants could show up as late at 10 a.m. to 10:30 a.m. and still be considered on time.

Teachers also would gather for staff meetings and leave all 150 children in the school mostly unsupervised. They also would leave the classroom on a quick errand to the market.

She worked with staff to help them understand leaving the children unattended was not safe for them.

Going said students there aren't taught that it's OK to make mistakes, so she set out to change the attitude of the teachers and students.

"They use corporal punishment in the school," she said. "They call it caning. Teachers have switches and sticks in their hands. They would hit the child in the head if they were late, if they made a mistake, if the answer was wrong."

She knew she couldn't order them to stop the caning, not if she wanted to make any lasting change.

Instead, it was more of a conversation, showing them why it doesn't work as a teaching tool.

She suggested an alternative — the 1-2-3 Magic discipline program and the use of timeouts.

By the time she left, half the staff decided to no longer use corporal punishment. In subsequent emails after she returned home, the remaining staff have also done away with the practice.

"That was meaningful," Going said. "That was like, 'OK. Was my presence there helpful?'"

Prior to her departure to Ghana, Going collected donations from friends, family and local organizations to send two large boxes of school supplies and chairs overseas.

She hopes to continue her involvement with the school, possible returning in a year or two.

Black-eyed Susans take center stage in garden

August and September are black-eyed Susan time. The many varieties of black-eyed Susans are at their peak, and even more are on the way as garden centers prepare us for the fall decorating season with beautiful varieties of large-flowering black-eyed Susans.

Many of the black-eyed Susan varieties that we see in gardens during late summer and fall are treated as annuals here in our area. There are many varieties of perennial black-eyed Susans; however, the lush, large blooms we see in fall decor are often annual varieties. This means that they may not return the following season. Nothing wrong with that though, as it is wonderful to enjoy their sunshine colors throughout late summer and fall.

This week, I'll focus on some of the stunning annual black-eyed Susan varieties.

Irish eyes is one of my favorite black-eyed Susans, or Rudbeckia. This one is different and unique with a bright, lime green central cone, or "eye," instead of the normal chocolatey brown. This gives this flower a unique appearance and an unusual color combination in the garden. This is also one of the largest, with blooms that may reach 6 inches across.

Another black-eyed Susan variety that is especially unique is

Cherry Brandy. As the name implies, this black eyed Susan actually features blooms that are a beautiful shade of cherry red when they first open, fading to a cherry brandy color as they mature. This one is also best treated as an annual since it is difficult to perennialize here in our area.

The Indian Summer mix of annual black-eyed Susans offers fascinating and unique blooms. Almost every flower is different. These may bloom in shades of orange, red, yellow and brown, often mixed together on the same bloom. It's one of the best for fall decorating in containers or in garden beds.

Many of the late summer and fall blooming black-eyed Susan varieties, such as Cherokee and others, are double flowering forms. This means they look lush and full with layers of petals, like a mum, rather than the classic daisy look.

In shades of brown, red and orange, as well as the classic gold, these double-blooming, pom-pom

style black-eyed Susans are another great choice for classic fall planters, containers and garden beds.

All of the black-eyed Susan varieties, whether they are perennial or annual, offer an excellent source of pollen and nectar for our bees and butterflies. Since they bloom very late into the season, they are especially important for migrating monarchs, painted ladies, as well as late-flying bumblebees, honeybees

and more.

Celebrate black-eyed Susans over the late summer and fall season, incorporating as many varieties as you can into your planters, beds and borders. The colors of summer live on in their glorious blooms.

Pulaski schools honored as model PLCs

School district recognized for honor during welcome back event for teachers

The Pulaski Community School District was recently recognized by Solution Tree for its sustained success in raising student achievement.

PCSD's successful implementation of the Professional Learning Communities at Work process was a major contributing factor in the improved achievement of its students. PLCs are schools and districts in which educators recognize the key to improved learning for students is ongoing, job-embedded learning for the adults who serve those students. The three big ideas of a PLC call upon educators to focus on learning, build a collaborative culture and create a results orientation.

The PLC journey has helped the district bring clarity to four critical questions and the work within the district through teacher collaboration teams, leadership teams and school-wide intervention teams. The four critical PLC questions that focus the work of higher levels of learning for all students include: what the school district wants students to learn through curriculum, power standards and learning targets; how the district knows they've learned it through assessment; how the district supports students who haven't learned it; and how the district supports students who already learned it.

Superintendent Allison Space said that the journey is a marathon, but the news of the recognition shows Pulaski is on the right track.

"The distinction of model district speaks to the intentional work done every day by our staff," Space said. "We are honored to be part of this work ensuring students are learning at high levels at all times."

During the award presentation held Aug. 22 during the Welcome Back to School Session for all staff in PCSD,

Joe Cuddemi with Solution Tree congratulated the district for being "a beacon light of hope."

"The PLC at Work framework embraces the best practices in our profession, and while many districts across the country attempt to implement this process, it is very difficult to deal with distractions and remove excuses in order to focus on the right work and stay the course," Cuddemi said.

Schools are recognized based on strict criteria, including demonstration of a commitment to PLC concepts, implementation of these concepts for at least three years and clear evidence of improved student learning over that period. Once measurable results can be seen, the school must explain its practices, structures and culture and submit its application for consideration by the PLC Review Committee.

Cuddemi has worked with the district the past three years on its PLC journey supporting the learning leaders, guiding coalitions, school-wide intervention teams and overall teaching staff at the seven schools and at the district level.

"Working with the Pulaski educators was truly an honor," Cuddemi said. "From the boardroom to the classroom, Pulaski educators continuously demonstrated an unwavering commitment to work together in order to improve the results for the students they serve."

According to the Champions of PLC at Work, educators in the schools and districts selected for this recognition have shown "a sustained commitment to helping all of their students achieve at high levels. They have been willing to alter the structure and cul-

ture of the organization to reflect their commitment."

Pulaski High School recognized for AP coursework

The Wisconsin Department of Public Instruction, in partnership with the Wisconsin Advanced Placement Advisory Council, announced that 142 schools have received recognition for high participation and achievement on Advanced Placement exams, and Pulaski High School was among those listed.

The 2022 Advanced Placement Pacesetter Awards are unique to

Wisconsin and represent a celebration of excellence from students across the state. AP courses provide students with the opportunity for challenging college-level work and potentially earning college credit while in high school. Awards are presented to schools that have high participation in AP courses and have high percentages of students who earn a score of three or higher on the

AP exam and are therefore eligible for college credit.

The Pacesetter awards use data from the 2021-22 school year and are broken down into three levels, which are awarded based on the combination of the AP student participation rate as well as the percent of students earning a score of three or higher. Pulaski High School was placed in level three, where the

requirement is that 10% or more of all students participate in at least one AP exam, and that 60% or more of those students earn a three or higher.

Of the state's 421 public school districts, 332 offer AP courses and exams. However, of 1,987 public high schools within these districts, only 410 offer AP courses and exams, signifying patterns of inequity across the state.

How seniors can save on prescription drugs

Dear Savvy Senior:

I take several medications for multiple health conditions, and the prices keep going up, even with my Medicare prescription drug insurance. Can you recommend any tips that can help cut my costs?

Dear Tina:

The high cost of prescription drugs is an ongoing problem that stings everyone, but it usually affects seniors more because they have a greater need for medications and because Medicare doesn't cover all their drug costs.

While the Inflation Reduction Act, which was signed into law last year, will help seniors save on their medications by negotiating lower drug prices and capping out-of-pocket spending at \$2,000, it will be a few years before the law is fully enacted. In the meantime, here are some different strategies that can help reduce your costs so you can afford what you need.

- Talk to your doctor: A good first step is to review your medications once a year with your doctor to find out if any of them can be stopped or reduced. If you're taking any brand-

name drugs, check to see if they are available in a cheaper generic form. Also, for any drugs you're taking long-term, ask your doctor for a cheaper three- or six-month prescription, versus a one month. And find out if any of the pills you're taking can be cut in half. Pill splitting allows you to get two months' worth of medicine for the price of one. If you do this, you'll need to get a prescription for twice the dosage you need.

- Review your insurance: Carefully review your drug coverage during the open enrollment period, which runs Oct. 15 to Dec. 7 for Medicare beneficiaries. Make sure all your regular medications are covered in the plan's formulary; that your current

pharmacy is in the plan's network; and that your plan covers additional medication coverage in the gap. To shop and compare Medicare prescription drug plans, go to [Medicare.gov/plan-compare](https://www.medicare.gov/plan-compare).

- Pay cash: Not using insurance for prescriptions seems counter-intuitive, but in some cases, it may save you money. For example, many chain pharmacies and big-box stores like Walmart and Costco have their own prescription savings programs that may be lower than your insurance co-payment. You can use coupons through [GoodRx.com](https://www.GoodRx.com) or [RxSaver.com](https://www.RxSaver.com) that can save you up to 80% off the list price of generic and some brand-name drugs in certain pharmacies.

- Shop online: You can also save on regularly used medications by having them sent to you from a mail-order pharmacy. Check with your health insurer or regular pharmacy to see whether it will get you a better deal. If not, check online pharmacies like [CostPlusDrugs.com](https://www.CostPlusDrugs.com) or [HoneyBeeHealth.com](https://www.HoneyBeeHealth.com). With these, you may spend less in some cases than you

might with insurance.

- Buy from Canada: Because prescription drugs are often much cheaper north of the border, many Americans have chosen this option for years. While this is technically illegal in most states, the Food and Drug Administration generally does not stop people from doing it. If you want to explore this option, use [PharmacyChecker.com](https://www.PharmacyChecker.com), an online tool that will help you identify reputable Canadian and international online pharmacies.

- Get more help: If your income is limited, you may also be able to get help through Medicare's Extra Help program ([Medicare.gov/basics/costs/help/drug-costs](https://www.Medicare.gov/basics/costs/help/drug-costs)), your state pharmaceutical assistance program ([Medicare.gov/plan-compare/#/pharmaceutical-assistance-program/states](https://www.Medicare.gov/plan-compare/#/pharmaceutical-assistance-program/states)) or patient assistance programs ([Medicare.gov/pharmaceutical-assistance-program](https://www.Medicare.gov/pharmaceutical-assistance-program)). Visit each website to see if you're eligible and to apply.

Lakewood breaking ground on library expansion

The Lakes Country Public Library Board of Trustees has announced that it has raised enough money to begin its building expansion project.

Official groundbreaking will take place at 1 p.m. Sept. 13 at the library, 15235 State Highway 32, Lakewood. A reception with light refreshments will be held in the library after the ceremony.

"With the full support of the Towns of Doty, Lakewood, River-view and Townsend, we are about to complete an effort begun almost 30 years ago," said Tom Thielke,

building expansion and renovation committee co-chairman. "Even as the 1996 building committee completed the first addition to the original library built in 1982, they were making plans for another expansion they knew would be needed in the future. Most of those people are gone, but their dream lived on."

Capital Campaign Chairwoman Kathleen Marsh concurred.

"I'm honored to lead the effort to raise the funding needed to make their dream come true," Marsh said. "I only wish they could be here to see this. I credit our success to the

dire need for the project and committed volunteers coming together to make this happen. We have raised over \$256,000 from 260 private donations ranging from \$5 to \$25,000.

"Contributions came from donors living next door to all over the country," Marsh continued. "They all had one thing in common: a deep affection for Lakewood Library, our northern Oconto County CLIC (Community Learning and Information Center)."

Architect Jeff Musson, Rhinelander, designed the project. RJM Construction of Black Creek will be

the general contractor.

Besides the individual private donations, substantial funding for the project came from grants: Wisconsin Public Service Foundation (\$25,000), Leon H. and Clymene M. Bond Foundation (\$50,000) and Otto Bremer Trust (\$100,000). The library is also being supported with \$300,000 in American Rescue Plan Act funds awarded to Oconto County by the U.S. Department of the Treasury and \$500,000 in Congressional Directed Spending sponsored by U.S. Sen. Tammy Baldwin.

Corn harvest reminder of hard-working ant

Once a farmer, always a farmer. Cranking his neck as we drive, my husband checks out the activity going on all around us during the harvest seasons; chopping and/or baling hay, combining wheat, combining oats, baling and/or chopping straw, soon-to-be combining soybeans and of course, the upcoming corn harvest.

As we liquidate and downsize machinery no longer needed, I know he is still completely immersed and is especially fond of watching the corn crops. I don't know how many times he's commented on corn fields around the area and even as we go out beyond Shawano and Waupaca counties.

I find myself checking it out as well because, let's face it, 42 years of farming with this man rubs off. I say, "Look how stressed that corn is," or "See? Aren't those cobs forming nicely?"

One day I exclaimed out loud, "Man, that corn is so dense. Why do they plant it so thick?"

"To get more crops that way." He looked at me pointedly. Like seriously, farmer girl?

He went on to say, "Companies are modifying the seed to be drought resistant, to tolerate dry conditions more." As we continued on our drive we again marveled how much corn is planted, acres and acres of it all over.

Our garden corn is maturing at a sporadic rate. We can get a full meal

here and there, but wanting to make the hassle of harvest worth it, I bought some fresh picked, bi-colored sweet corn at Glendale Farms in Clintonville. Paying \$5 a baker's dozen, I brought home four dozen. We had to preorder a few days before, specifying a date/time. Placing our order, they assured us we could pick up four dozen cobs at 1:30 that next Thursday afternoon. It worked out great — they had it all ready to go with very little traffic going in and out.

Enlisting the help of my husband, early next morning we sat down together at the kitchen table to husk out mounds of sunny yellow cobs of corn. Working over freshly-lined garbage bags, we tossed the husks in along with meticulously picking off the silky threads, gathering it all to give as a treat later for our four, very hefty pigs.

"We can talk while we work!" I exclaimed with a smile. With a twinkle in his eye he smirked back at me like, ya think, huh? That goes without saying.

Between the two of us, we made quick work of the golden mounds.

When we got done and he had cleared out the pile of husks, taking it out with him as he went out to clean and feed our livestock, I got busy in the kitchen. Pulling out last year's notes I scrutinized them, checking what worked and remembering tidbits from my late sister.

She gave me the corn recipe and I followed her hints to the letter, writing fastidious notes. Good thing because sadly I can't call her this year. I even included how many cobs, how many quarts those cobs produced, the date I froze in years' past (Why? It's a mystery). I even made a note that Beth told me to keep knobs on bottom of cobs for ease of cutting.

Hauling my big blue porcelain cooker pot out of storage, I stuck it in the sink. Peeling sheets of paper towel off, I covered the window so that as I sliced off the raw corn into the pot it would splatter on the paper towel and not on my kitchen window. The milk from the kernels once dried, is like cement. (One of my scribbled notes on my recipe card states: "Clean up splatters right away or they turn into cement." Thanks for the reminder, Beth.) Ease of cleaning makes me less likely to dread the job.

Once I got all the corn cut off, I transferred it into two large roasters

and placing a stick of butter on top of each mound of corn, I covered the roasters, baking for 45 minutes at 350 degrees, stirring every 15 minutes. The aroma in the kitchen made my mouth water. (I had kept some cobs back for supper.) After taking it out, I let it cool on the counter and presently, scooped it up into quart freezer bags.

What a sense of satisfaction that brings to see those golden bags of corn labeled and stuck in my freezer. The pleasure of hauling them out in the dead of winter and enjoying corn that tastes like fresh from the garden is so gratifying. Because I had Beth in mind during the task and her notes in front of me, it felt like she was working right alongside of me as in years' past.

This good job done reminds me of the proverbial ant industrially gathering its food at harvest. I know, despite the mess, it's all worth it in the end.

("Go to the ant you sluggard; consider its ways and be wise! It has no commander, no overseer or ruler, yet it stores its provisions in summer and gathers its food at harvest." Proverbs 6:6-8)

Sunchokes tasty, good for your health

Posoh. There are a few names that people call me. Sunroot, earth apple, sunchoke and Jerusalem artichoke are some. I'm around in the summer but ready to harvest when it gets chilly.

Some people mistake me for just a regular sunflower, but I'm usually much taller. I live all over in prairie fields. If you pass a field on your way to work or school, I'm there.

It's my roots or tubers that are most enjoyable to eat. I can be pickled, sauteed, added to salads or roasted — just some of the many ways to prepare me. I taste similar to a water chestnut.

I'm helpful to your gut health. I'm good for blood sugar balance, good for reducing cholesterol, and I'm known to help protect against some cancers. All these good things are probably why Indigenous tribes have been harvesting me for hundreds of years or longer.

When you find these sunchoke flowers, you have to carefully dig them to get to the tubers. If you harvest them a bit early, they can be tough to work with. Once it gets cold out is best. Fall or early spring works. They are very similar to a water chestnut or maybe even a potato. You can substitute them for potatoes in a variety of dishes. Try making a sunchoke mash.

The reason we chose this recipe for this month's Indigenous food column is because they're all around us. This will add just another versatile ingredient to everyone's list of what to cook at home, which brings me to a question I get asked a lot: What do chefs eat at home? What do we prepare for our meals? Well, whatever is in season would be my response to that question.

I call these ingredients the kitchen sink because I use them to build the rest of my meal or plate. What's in season? What looks good? OK, let's

build around that. That is exactly how a chef shops or thinks of today's special, whether it be a fine dining restaurant or simply meal planning at home for the family.

In my first column, we touched on taking Indigenous ingredients and using them in our everyday meals. Make them a comfort food. Sunchokes are another great example of just that.

SAUTEED SUNCHOKES WITH GARLIC

- 1/2 pound of sunchoke roots, washed and scrubbed clean
- 2 tablespoons of sunflower oil
- 4 garlic cloves, minced
- Sea salt to taste
- Cracked black pepper to taste
- 1 tablespoon of fresh lemon juice

Cut your sunchokes to a medium dice, 1/2 inch thick. Heat your sauté pan to medium high, add your oil. Sauté the sunchokes for about 4-5 minutes. Then add your garlic. Sauté another couple minutes. Season with salt and pepper and finish with the lemon juice. Serve, enjoy.

Have I mentioned also how easy they are to grow? Going out and harvesting is one of my favorite fam-

ily things to do, but you can also just grow sunchokes at home. For people who are intimidated by growing plants, these are pretty hardy. From the exact words from the Stone Pier Press, a food and environment publishing company, they are basically drought resistant.

Thanks again for reading this month's Indigenous food column. We will try to continue these throughout the seasons. Fall is coming up, and we look forward to discussing our next ingredient, recipe or technique.
