Shawano County supervisors adopt budget, levy

Equalized value increases, mill rate decreases

Shawano County uses its annual budget of \$73.3 million and 386 full-time equivalent employees to administer more than 330 mandated programs across 31 departments.

The 2024 budget and corresponding \$17.99 million tax levy were approved by supervisors Oct. 25.

"Overall, we have a very lean budget," Jim Davel, administrative coordinator, told supervisors as he touched on several key aspects of the budget.

Health rate increases will be between 5-6%, although the original plan was a 10% increase.

"Additionally, we don't have to switch carriers, so that's a benefit going forward," he said. "It's about a \$30,000 increase overall. We pay close to \$6 million in health insurance ... for all of our employees here."

The county will use \$1.1 million from its reserve funds as its matching grant amount for a \$7 million highway grant.

"Because of our fund balance, we can spend cash for that instead of borrow or bond for that," Davel said.

Also, fund balances in the public health and library accounts will be used for some of those 2024 operations instead of adding the cost to the levy.

"Over time, the board has approved money to those departments, and that money has not been utilized," Davel said. "In this case,

we did utilize some of those funds to help with the overall budget for those departments."

Initial requests included 11 new positions within the county, but only five were added to the budget.

Although \$100,000 in new requests were made for courthouse equipment, only the absolute essential \$4,000 was included.

The levy includes \$16.4 million for general county operations, \$1.4 million for debt service, \$175,245 for bridge aid, \$676 for special charges and \$3,525 for property taxes charged back.

Carrie Buntjer, finance director, noted that the mill rate will decrease to \$3.89 per \$1,000 or equalized value. In 2019, the rate was \$5.32.

"Our equalized value has taken a large jump," she said. "The equalized value went up 12.9% from last year

to this year, and the year before was 14.6%."

Typically, as the value increases, the mill rate decreases.

"For this year, net new construction came in at 1.35% or about \$220,000," she said. "Last year was \$209,000, and the year before was \$240,000."

She noted the county will receive an additional \$673,000 in state shared revenue this year. The millions of dollars in unused American Rescue Plan Act money generated \$250,000 in interest for the 2024 budget.

The county has about \$14 million in debt from two projects — the human services building and the jail locks. She said that by law the county could borrow up to \$238 million.

New pay scale OK'd for Shawano County employees

Plan will cost additional \$290K next year

The Shawano County Board of Supervisors adopted a new pay plan for county employees as part of its 2024 budget approved Oct. 25.

Officials intended to develop a pay plan that would balance internal equity, maintain market competitiveness and provide a consistent pay plan for all covered staff.

"This really does fix a long-term overall pay problem that we have," said Jim Davel, administrative coordinator. "It's incredibly expensive when we look for people, and we compete with everybody in the community."

The initial cost to implement the new pay plan will total \$290,615, of which \$244,946 will be wages and \$45,668 will be fringe benefits.

The additional cost will be covered by the tax levy, additional

shared revenue and fund balance surpluses.

The plan affects all regular full-time and part-time positions, excluding employees currently in the Wisconsin Professional Police Association collective bargaining unit and elected officials. Wages of these employees were scrutinized as part of a study completed earlier this year.

Carlson Dettmann Consulting LLC reviewed the county's existing classification and compensation programs and conducted a market analysis for wages in similar jobs in the county's competitive and comparable markets.

The new plan consists of 20 pay grades and 11 steps per grade.

Davel said that in 2014, 2015 and 2016, no raises were given to county workers. Also, a decision to be in the 50% range (middle of the pack) for pay backfired, when the county ended up only in the 25% range, meaning three-fourths of competitive jobs were paying more than the county.

"That really caused a pretty big

hole," Davel said. "We've been slowly trying to get back to (being) competitive."

As part of the most recent study, county wages were also compared with 11 other counties, with the aim that Shawano County would be in the middle.

"I think it's the appropriate thing to do, going forward," Davel said.

For correction officers, jail cooks and jail sergeants, the \$3 per hour raise (configured in 2023 with the use of federal COVID-19 money and local funds) will be added to the employee's hourly base pay as of Dec. 31, then the employee's new base pay will be placed at the next step that gives them an increase.

Two years ago, the board approved a \$3 per hour increase for correctional workers using American Rescue Plan Act (ARPA) funds. Last year, the county took \$1 out of its levy to cover some of that ARPA money.

"This budget and this pay scale covers that \$2 that's remaining from the ARPA money," Davel said. "If you

recall at the time, I wrote ... that we should use the levy money instead of ARPA money, because ARPA money was going to run out, and this is our solution ... to cover that \$3 that the board approved previously."

Davel said one of the goals of the new plan is to make the county one of the employers of choice for residents.

"We have to be competitive. At the highest point since I've been here, we've had a 23% turnover rate," he said. "We spend a tremendous amount of money looking for people. We need folks that stick around here. That saves us money in the long run."

Going forward, a review of the pay structure based upon market conditions and other factors will be conducted annually by the Shawano County Executive Committee with any resulting revision to the pay structure to be approved by the Shawano County Board.

Fontanini gets 10 years for child abuse pics

Former Shawano man was already sex offender at time 2,000 photos, videos discovered in his home

A former Shawano man was sentenced in federal court to 10 years in prison for possessing depictions of child sexual abuse, was ordered to pay \$75,000 restitution to the known victims and was placed on lifetime supervised release.

According to court documents, a July 2020 search of Denis Fontanini's Shawano residence recovered several electronic devices that contained 2,000 videos or images that constituted child sex abuse. Many videos depicted violent sexual abuse of a child who was less than 12 years old.

At the time, Fontanini, 29, was a registered sex offender for having been convicted in 2016 in Menominee County on two counts of child enticement and a single count of exposing genitals to a child.

In that case, Fontanini also was charged with two counts of child

sex assault for allegedly luring two children into a building and sexually assaulting them. Those charges were dismissed but read-in at sentencing in exchange for Fontanini's guilty

pleas to the enticement charges.

Shawano-Menominee County Circuit Court Judge James Habeck had sentenced Fontanini in 2017 to a year in prison and six years' probation, according to online court records.

Prior to the search of his residence, state officials determined that Fontanini had distributed child pornography on the Kik messenger online platform. Fontanini admitted to possessing and distributing the child pornography but said he did so in order to "bring these groups down."

He also said that he distributed the child porn to gain the trust of other online users.

Fontanini was indicted in federal court in November 2022 on a single count of possessing child sexual abuse materials. He pleaded guilty to the charge in July.

At sentencing on Oct. 26, Fontanini faced maximum penalties of 20 years in prison, a \$250,000 fine and lifetime supervised release. If found to be non-indigent, District Judge William Griesbach could order Fontanini to pay a \$5,000 special assessment.

Assistant U.S. Attorney Alexander Duros recommended that Fontanini serve a 10-year sentence and that Griesbach should factor into the sentence that many of the images depicted sadistic conduct toward a minor and that more than 600 images were recovered from Fontanini's electronic devices.

Fontanini's attorney, John Birdsall, sought a five-year sentence for

his client, arguing that Fontanini's state probation was revoked due to the federal charges, and is currently serving a five-year sentence for his Menominee County convictions.

Birdsall wrote the court that Fontanini has support from friends and family members who "know his true character."

Robin Taklo wrote the court that Fontanini "wants chemical castration, so he can focus on a positive future. He wants to contribute to society."

Ronald Gourde, a friend of Fontanini's, wrote the court that while detained at Racine Correctional Institution, "He always tells me that he is working hard to be a better person ... Denis speaks as if he wants to do the right things to correct his misdeeds of the past and looks forward to a new, positive future."

Mold issues at the Shawano County Library and the safety of the employees who work there brought out the ire of a Shawano County supervisor toward the end of the Oct. 25 county board meeting.

District 21 Supervisor Joe Miller pointedly asked Chairman Tom

only one here talking about this," Miller said. "This should be on all our radar screens, and we should be demanding action be taken immediately to protect those employees." He questioned whether either the

Kautza if the library mold issue still existed and if the county employees were still working there. Kautza answered yes to both questions.

"That's unacceptable. I should not be the

public health department or corporation counsel had weighed in on the issue with written comments. To this, Kautza said he did not believe either had done so.

"We talked about how important our employees are during the budget," Miller said. "Well, let's put our money where our mouth is and let's take care of them."

Miller asked why the library is still open.

Kautza said the building is not owned by the county. Technically, the library board owns the building.

"But they're county employees," Miller said.

An employee became sick from

the mold and has since quit working at the library because of it.

Water leaks, mold, and horizontal and vertical cracks in the foundation of the building are forcing the library to move out of its home at 128 S. Sawyer St. It is hoped the library can find a temporary home until a new, multi-use county building is constructed that would contain courthouse offices and a library.

In early October, the library board created a subcommittee to research a temporary home. The subcommittee has yet to meet.

Leaky roof forces cancellation of hockey events

Crawford Center issues go back more than a decade, coach says

Shawano Community High School hockey coach Adam Gafner told the Shawano County Board of Supervisors on Oct. 25 that the leaky roof at the Crawford Center on the Shawano County Fairgrounds is leading to canceled games, practices and fundraisers.

"It's been a known issue that the roof needs to be replaced on this facility for many years," Gafner said. "It was probably the ultimate disappointment when I walked into the rink — it's basically raining in the facility, for lack of a better term."

That day, and for a few days before and after it, the area was deluged with rain that wouldn't seem to stop.

"Games are being canceled. Practices are being canceled," Gafner said. "This weekend (Oct. 28-29) is the biggest fundraiser of the year. That's been canceled."

Gafner coaches the co-op hockey team — with players from Bonduel and Clintonville — has children in the youth hockey league and is a financial support of the hockey organization through his employer.

He said maintenance on the building has been postponed too many times.

"This roof's been not working for over a decade. For whatever reason, it's been put off and put off and put off again," he said. "What's going on in this facility is unacceptable. We're paying almost \$85,000

a year for a rink we can't use. The amount of volunteer time that's going into this — you actually have one of your employees who's my assistant coach — he and I have been there every single day. It's just wrong.

"I've looked at every lease going back 20 years. It is the responsibility of this county for the exterior of the building. Now that the bill's due, it's basically the youth league needs to pay for the roof, or we're going to extort you in a different way to get you to pay for it."

Pat and Ruth Crawford paid for the building's construction, then sold it to the county for \$1 to benefit area youths, Gafner said.

"If we can't invest back into our own community for children, which was the whole point of the building in the beginning, it's disheartening," he said. "It's been put off for years."

Gafner said the youth league has no place else to go as no other facility is close enough. Hundreds of youths are affected, and thousands of dollars in revenue was lost this past weekend.

"I don't know what else to say, but it's getting to a point where we're almost going to have to go to court with the county," he said. "It shouldn't need to go there. We're all adults. We should be able to work through this. But, we're paying for a lease for a building we can't use."

At the end of the meeting, when supervisors had a few minutes to comment, Supervisor Mart Grams said he favored the county getting rid of the Crawford Center.

"It's nickel-and-diming us," he said.

Supervisors support vets transitioning to civilian life

Shawano County will once again support the Green Light for Veterans program.

Supervisors on Oct. 25 approved a resolution declaring that each year, the second week of November is a time to salute and honor the service and sacrifice of American men and women in uniform transi-

tioning from active service.

County officials also encourage residents to recognize the importance of honoring all those who made sacrifices to preserve freedom by displaying a green light in a window of their place of business or residence.

The resolution notes that veterans continue to serve their communities in the American Legion, Veterans of Foreign Wars, religious

groups, civil service and by functioning as county veteran service officers in 29 states to help fellow former service members access more than \$52 billion in federal health, disability and compensation benefits each year.

About 200,000 service members transition to civilian communities annually with an estimated 20% increase of service members transitioning to civilian life in the

near future.

Studies indicate that 44-72% of service members experience high levels of stress during transition from military to civilian life.

Active military service members transitioning from military service are at a high risk for suicide during their first year after military service.

Noriega-Avila still without an attorney

Three months after previous counsel's departure, 1,161 attorneys contacted to take on case

The hunt for a second attorney for Pedro Noriega-Avila, the Pulaski man charged in 2016 with child sex assault charges, is proving to be as difficult as the first search.

Noriega-Avila was initially charged in 2016 with one count of sexual assault of a child under age 13, two counts of sexual assault of a child and two counts of incest with a child by stepparent. Court records show that Noriega-Avila appeared for his initial hearing in June of that year, paid a \$5,000 cash bond and then did not return for the next hearing.

Noriega-Avila was missing from the court for almost five years until his arrest in Arizona in 2021. Law enforce-

ment responded to a U.S. Border Patrol station on March 13, 2021, regarding the warrant issued by the Shawano-Menominee County Circuit Court for Noriega-Avila, and the defendant was already in custody

when officers arrived. Noriega-Avila was brought back to Shawano County in July 2021.

Noriega-Avila remains in the Shawano County Jail on a \$500,000 cash bond. He has been incarcerated for over two years, mainly because of the difficulty in finding an attorney the first time around. It took until late 2022

before Sara Stertz was found to defend the case.

The defendant's trial was set to start in August, but the day before it was due to commence, Stertz withdrew from the case for two reasons — disagreement on defense strategies and the fact that she was in the late term of pregnancy.

Shawano-Menominee County Circuit Court Judge William Kussel Jr. said during an Oct. 26 status conference that Stertz believed there would be other attorneys willing to take on the case in her stead. According to court records, at least 1,161 attorneys have been contacted to take on the case to no avail.

"The public defenders office filed their report about the search for a subsequent attorney," Kussel said.

"They indicated that, while the defendant is still eligible for their attorney, they haven't been able to appoint an attorney yet."

Kussel reiterated, as he has with many other cases, that the search for available attorneys handling criminal cases continues to be a slow process, even as the state has recently increased the pay for appointed attorneys.

"This is a very significant and, perhaps, difficult case for an attorney," Kussel said. "The difficulty in finding an attorney is probably due to the type of case."

Another status conference has been scheduled for 10:15 a.m. Dec. 21 in Branch II of the Shawano County Courthouse.

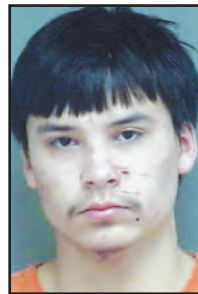

LaRock case going to trial in early 2024

Attorneys unable to reach deal in Shawano attempted homicide matter

Attorneys have been unable to reach a deal in the case of Royce LaRock, a 21-year-old Shawano man who allegedly stabbed another man earlier this year, so defense attorneys

asked for the matter to move forward to a trial.

LaRock is charged with one count of attempted first-degree intentional homicide, one count of aggravated battery, one misdemeanor

count of resisting or obstructing an officer and one misdemeanor count of disorderly conduct.

LaRock's trial is scheduled to begin Feb. 26, 2024, in Branch II at the Shawano County Courthouse

and is expected to last four or five days. A final pre-trial conference has been scheduled for 1 p.m. Feb. 8 in Branch II.

It took some time for court officials to find a date suitable for all parties, attorneys and witnesses. When the suggestion of a trial in late April came up, defense attorney Richard Jones agreed to juggle some of his other cases to allow the February trial.

"I don't want Mr. LaRock to sit in jail until he's 55 years old," Jones said.

According to the criminal complaint, Shawano police officers were dispatched April 25 to Acorn Street for a reported stabbing. When officers arrived, a victim was allegedly laying

at a neighbor's front step with a stab wound to the stomach area, with intestinal protrusion from a stab wound. The victim allegedly said LaRock was the person who had stabbed him.

If convicted, LaRock faces up to 60 years in prison for attempted first-degree intentional homicide, \$50,000 in fines and 15 years for aggravated battery, \$10,000 and nine months for resisting or obstructing an officer and \$1,000 and 90 days for disorderly conduct.

LaRock is currently being held in the Shawano County Jail on a \$500,000 bond.

Public silenced in school board levy vote

Menominee Indian votes for levy that's \$231K higher but well below state's revenue limit

Over 40 taxpayers filled the room where the Menominee Indian School Board held a special midday meeting Oct. 24 to approve a tax levy, hoping to voice their opinions on the matter. However, the board made it clear that the decision no longer rested with the people.

The board unanimously approved a levy of almost \$5.56 million, which puts the tax rate at \$8.63 per \$1,000 of equalized valuation, meaning that property worth \$100,000 could expect to be taxed \$863 by the school district. It was \$231,314 more than it had requested at the district's annual meeting on Sept. 27, which was voted down by the taxpayers present.

A number of property owners wanted answers as to why the board was going to approve a higher levy instead of the original one, which would have put the tax rate at \$8.27. However, when the meeting started, Superintendent Wendell Waukau made a statement that the meeting was one for board discussion, not an additional meeting of the electorate, so public comment was not going to be taken.

"The board, under its powers, is taking action to approve the levy, which is part of the powers of the board," Waukau said. "It is not a regular meeting, which includes public comment, and that is in our policy. The purpose today is to have a review of the levy, which relates to our budget. The board will discuss that among themselves, and then they will proceed with the action item."

Kyla Davis, the district's business manager, noted that Menominee Indian School District's actual revenue limit is over \$8 million, and if the district had opted to levy to the maximum, the district's tax rate would \$12.68, because the funding

would be a 44% increase over last year.

Davis noted that final state aid numbers were not made available until Oct. 15, and it turned out the estimates were off, which is why the board was looking at the \$5.56 million levy instead of the \$5.33 million presented at the annual meeting.

"Unfortunately, we did not get good news with our aid estimates," Davis said. "We received \$1.2 million less than we expected on our estimated budget, which means the budget looks different than what we previously presented."

MISD did not receive any sparsity aid from the state, according to Davis, because it did not meet the threshold of having a student count below 745. Also, some of the aid loss

is due to private school voucher programs with the reservation bordering Shawano County, where there are several parochial schools available to families wanting a different type of education for their children.

"In our general fund, compared with what we presented before, we're reducing by \$566,000 compared to the 2022-23 general fund budget," Davis said.

Underlevying is a way to reduce taxpayer burden, she noted, and the district has underlevied by \$13 million in the last decade. However, it is an impact to school resources, as well.

"We're decreasing the number of staff we can have for our students," Davis said. "We reduce the

resources for our classrooms, which can lead to outdated materials. It also leads to fewer extracurricular activities, because it reduces the amount of money we can use for after-school programs."

That piece of news concerned board member Regina Washinawatok, who asked what was being cut from the general fund this year.

"Are we going to have to eliminate some programs, have larger class sizes?" Washinawatok said.

Davis pointed out that most of the cuts come from proposed capital improvement projects, including building updates and renovations.

"It doesn't directly impact the classroom this year," she said.

District may hire agency to fill sub posts

Teachers on Call expected to relieve burden on existing staff, fill more vacancies

Shawano School District, like most other districts, is having difficulty finding substitutes whenever a teacher or paraprofessional must be gone for a day, week or even several months.

Currently, the district has an in-house substitute teacher coordinator who makes calls to available substitutes to fill the gaps, but oftentimes, schools must ask regular staff to help during their preparatory periods when there's not enough subs rising to the call. That has led the district to look at utilizing a service called Teachers on Call, which has access to a broader pool of subs from around northeast Wisconsin and could help relieve the burden on existing staff.

The Teachers on Call has been helpful to the Marinette School District, according to Nicole Hartlaben, Shawano's human resources director. She told the district's finance and facilities committee Oct. 25 that it would cost the district \$2,500 for setup and then a fee for each substitute teacher the agency gets.

"Essentially, it works the way a temp agency works," Hartlaben said. "We get billed an upcharge of 30% on what we're paying for our subs. They do all of our recruitment, hiring, and they maintain all of the unemployment tax, workers' comp."

Using Teachers on Call will be like having a targeted marketing effort, according to Hartlaben, and the agency will have better resources than what the district currently has.

"They already have a pool of subs that they'd be able to use in Shawano," she said.

Rosie Thiel, the district's current

substitute coordinator, often finds herself putting in a full day as a sub herself but often has to get up early in the day and find people to fill in for other staff first.

"She actually gets up at 6 o'clock and does all this," Hartlaben said. "She'd go back to being a permanent sub for the district. She wouldn't lose any pay."

Teachers on Call uses the same automated system, Front Line, that the district uses for teachers to call in when they're not able to be at the school that day, Hartlaben said, so there would be little difficulty in transitioning. If approved by the board, it would take effect in January at the start of the second semester.

School board member Christine McKinnies noted that when she subbed as a paraprofessional, she'd get messages through Front Line to her phone several times daily letting her know what vacancies there were for the day, and then she'd select which ones she was interested in.

McKinnies questioned if it wouldn't be better for the district if it just raised the pay for substitute teachers. Currently, sub paraprofessionals get paid \$11-\$12 an hour, while sub teachers get \$150 per day for working one or two days in a classroom, \$170 if they sub for at least a 30-day period, and \$230 for long-term subbing that lasts a semester or longer.

"When I worked at the middle school as a para, and when I went subbing as a para, my hourly rate went down \$3," McKinnies said. "That's currently \$14 an hour, but if we paid the subs plus the upcharge we'd pay this company, that would be \$18.20."

Hartlaben reiterated that the 30% upcharge would be negated by the

fact that Teachers on Call would handle all the bookkeeping in terms of unemployment tax and other accounting measures for the subs, which is currently being handled by district office staff.

"One other advantage is that we can bring in retired teachers (through Teachers on Call), because they're not working for a public entity," Hartlaben said. "We have somebody working at the middle school as a long-term sub who is going to have to take a six- to eight-week break because of WRS (Wisconsin Retirement System)."

Board member John Arens was not confident that raising pay rates would be enough to attract substitutes to work in Shawano.

"We have to look at this as, is this the cost of doing business?" Arens said. "You can raise the rates of pay all you want. You're not going to attract the people."

Hartlaben noted that the district had 64 open teaching or paraprofessional days during one pay period.

Out of those, 31 had to be filled by staff at the school, because there are not enough substitutes available to help.

"That's just very alarming to me to have half of our sub openings to be filled by certified staff who are giving up their prep time to do that," Hartlaben said.

Hartlaben estimated that the district could expect to pay about \$100,000 per year for Teachers on Call to fill vacancies. The proposal will go to the full board for a vote in November or December.

McKinnies noted that, in the end, she was more concerned about teacher burnout from having to work extra to compensate for missing staff than she was about having to pay a little more.

"If this is going to save our teachers having to scramble and spend a part of their lunch period or a prep period trying to cover for a missing teacher, I'm all for helping our teachers," McKinnies said.

New counseling center open for business

Patients can get treatment in person or through telehealth

For anyone who has tried to get mental health services recently, the fact that there is often a very long wait to receive those services does not come as a surprise. Fortunately, an opportunity for counseling has come to Shawano, and at the moment, clients can be seen within a week.

Kim Smith offers telehealth and in-person sessions at Northwoods Counseling and Wellness LLC.

Born and raised in Wisconsin, Smith studied psychology with a specialization in community counseling from UW-Milwaukee. She enjoys spending her time outdoors by hiking and camping and recently moved to

the area after spending summers near Lulu Lake for 20 years. She brings a wealth of experience in inpatient and outpatient mental health and teaching as an adjunct psychology professor. When not working, she keeps busy with her five adult children and black lab, Cooper.

"The mental health system can be very confusing for people who aren't familiar with the different types offered," Smith said. "Sometimes, people can get very confused and frustrated.

"Psychotherapy is important, in addition to the medication piece," she continued. "Insurance can be confusing for people, and it can be really challenging to get into that first appointment."

She works predominantly with adults, and treatment typically lasts six to 12 sessions, but it really depends on individual needs.

With training in a variety of therapies, she is able to individualize and tailor a treatment program geared

toward an individual client instead of taking a one-size-fits-all approach.

"My experience includes working with individuals who struggle with depression, anxiety, trauma, grief, relationship issues and phase of life challenges," said Smith. "I've completed advanced training through Postpartum Support International (PSI) and have experience supporting women and couples coping with pregnancy and postpartum depression/anxiety, pregnancy loss and the transition to parenthood.

"In addition, I work with professionals who are dealing with compassion fatigue. Health care workers, therapists, teachers and counselors often experience vicarious or secondary trauma. Compassion fatigue can affect the most dedicated workers and can lead to total exhaustion of one's mental and physical state."

Smith is quick to point out that regardless of the profession, be it veterinarians, first responders or teachers, everyone is human, and

sometimes that can result in struggles. It is important to reach out for help and support when needed, and prospective clients do not have to wait until they are in a bad place to seek treatment.

Smith is very happy to be in private practice and to see what the future holds.

"For me, it's the best fit at this time of my life," Smith said. "I'm much more flexible with clients, and I'm happy that I can offer help."

Smith's office is on the second floor of the Total Fitness building at 116 N. Main St., Suite B, Shawano. Appointments can be scheduled by calling 715-600-6037, and additional information such as accepted insurance, services offered and fees can be found at www.northwoodscounselor.com.

"I strive to provide a safe, warm and nurturing environment for patients to heal and grow," Smith said. "Once you have decided to reach out for support, you have begun your healing journey."

Rewriting recipes helps Indigenous tribes

So this is a slightly different food column. Don't worry; there is still a recipe to follow, but this one includes a couple Menominee chefs helping other indigenous community kitchens feed their elders and members.

Leah Husby and I were asked to write healthy recipes and do some hands-on training for some indigenous community kitchens. Fifty recipes in total were created and handed to the communities. They included indigenous ingredients combined with some contemporary techniques. With the recipes, they also did in-person training with the community cooks.

Now I want to clarify that we are not the ones in the kitchens doing all the hard work. We just assisted with some helpful recipes and tools they have the option to use or not. The community cooks are the real heroes here. They are the ones who show up day in and day out and create the community meals. So we always make sure to tip our hats to them.

This project took months in the works. Rewriting 50-plus recipes for communities is no easy task. We made a wide variety to try to cater to most communities. We have to factor things in, like availability to product, community sizes, and also each community food preferences. We can't just write up some type of grilled squid dish and believe communities will recreate it. So we made dishes that we thought would actually work — soups, braises, rubs, sauces, breads, teas, and also added in some recipe terminology.

What really helped with this project is when we spoke to the community cooks. We had the opportunity to ask them questions, like what are popular food items in their communities, what type of product do they have availability to, are the recipe templates going to be easy to follow, and what traditional dishes are important to them and their community.

Along with speaking to the cooks, we had a chance to meet them in person for hands-on training. During the training we showcased a seasonal soup, the one shown in the recipe today, and a quick bread along with a tea and a sauce. Also what was important is we showed how to properly do recipe conversions.

As a chef, I feel recipe conversions should have a paragraph of its own. We all can pretty much double or reduce a recipe by half, right? Well, what about if you want to take a recipe that yields 40 portions at 8 ounces per person and make it into 145 at 6 ounces

per person? What about volume versus weight measurements? Things like this are what we taught them. We shared a formula for this type of conversion, which then any recipe size will work, now due to the fact that this formula makes it possible to convert the recipe to the size of your audience.

So, the winter squash. Yes, we have an abundance of them this time of year. Let's not forget to add pumpkins to that list. This recipe is a soup puree, which everyone has probably made some type of squash soup before, but how many of us had made a pureed soup? Squash has been a part of indigenous cuisine for thousands of years

BUTTERNUT SQUASH SOUP

1 butternut squash
2 apples
1/2 onion
1/2 cup leeks (white parts only)
1/2 cup apple juice (sauce)
1/4 cup brown sugar (sauce)

1/4 cup apple sauce (sauce)
1 tablespoon melted butter (sauce)
1/2 teaspoon of sage, garlic powder, rosemary, cinnamon, and black pepper
1 quart and 1 cup of vegetable stock

- Preheat the oven to 425 degrees. In a cooking sheet or casserole dish combine the squash, apples, onions and leeks. Set aside. In a small bowl combine the apple juice, melted butter, brown sugar and spices. Pour over the squash and bake for about 1 hour or until the squash is fork tender. Scoop out the softened squash from the skin and the vegetables and add to a large soup pot.
- Add in the stock and cook for 15 minutes, stirring occasionally. Using an immersion blender or a regular blender or a food processor, puree the squash/vegetable/stock blend until completely smooth. If using a regular blender, do not seal the lid. Blending hot liquids with the lid on can cause the heated product to expand, risking injury from the hot liquid. No blender? Use a potato masher.
- Return pureed contents to the soup kettle. Heat for 10 minutes over low heat. Ladle into bowls.
- Tips, can save and roast the seeds for added nutrients and a garnish.

Availability is pretty easy for all of us to find. Try the local Save A Lot in Keshena, any local grocery store or try local farms. Try growing some.

Elephants fascinating, despite bully's taunts

Back in sixth grade, we had a bully in our class who loved to torment me. I was a chunky kid, and he took every opportunity to remind me, dubbing me "Elephant." One of the more torturous times in my sixth-grade life was "Height and Weight Day." Why in the world would they pull a scale out to the front corner of a sixth-grade class is beyond me. But there it was, the dreaded scale, with its big measuring weight on one end which measured in 10-pound increments and a smaller one on the other for fine-tuning pound-for-pound.

Stepping on, I didn't want the school nurse to push that big one up toward the middle. Hearing her sigh as that's exactly what she did, while on the scale I'd hold my breath, thinking that if I didn't breathe it might reduce the scale by a pound — or 20. To her credit, she didn't broadcast her finding, just quickly scribbled a note in her chart and told me to get down and put my back up against the wall to see if I'd grown.

Once a week, we had an instructor come in to teach the class French. She was a little bit of a thing, all of 4-feet, 4-inches, always smiling and waving as she entered, "Bonjour mes amis!" (Good morning my friends!) "Comment vas-tu?" (How are you?) We'd always respond, "Tres bien, et toi?" (Very good, and you?) and she'd reply with a smile, "Tres bien!" It warmed my heart to see her.

One day my tormentor raised his hand and, trying unsuccessfully to hold back a nasty laugh, sputtered, "How do you say elephant in French?" Oaks last trees to show their colors

As the autumn spectacle begins to wind down, the painted oaks put on their incredible show. The oaks are among the last of the trees to turn and transform into their incredible autumn dress.

Here in our area, we are blessed with large forests of oaks and mixed hardwoods that create mile after mile of painted colors that reach from horizon to horizon. The oaks, especially, dominate many areas here locally, showcasing their full spectrum of colors during mid to late autumn.

Some of the most complex colors of the season dress the mighty oaks. In just one leaf, you may find gold, green, scarlet, chestnut and orange.

An entire tree is like an artist's palette.

Here in our area we have five common species of native oaks. These are the white oak, swamp white oak, red oak, black oak and bur oak. Other species may be planted as garden hybrids or non-native varieties; however, these are our common native oaks. All can be found right here in our own backyard.

To distinguish the species is easier than most might think. Simply looking at the leaves, we can identify just about all of the native oaks.

The white oak family has rounded leaf edges, while the black oak family has pointed tips to the leaf edges. The white oak family includes the white oak, the swamp white oak and the bur oak.

The white oak has fairly deeply cut leaves, with lobes going well toward the center vein. The swamp white oak

has very shallow cut leaves, barely scalloped along the edge. The bur oak has a distinct, deep cut almost all the way into the central vein about two-thirds of the way down the leaf.

The black oak family includes the black oak and the red oak, as well as the less common pin oak. The black oak has deeply cut lobes that reach nearly to the central vein. The red oak has much shallow or cuts and lobes, barely reaching into the broad leaf surface.

Don't rely on color when it comes to identifying oaks, especially red oaks. Many varieties of oaks may be red during the transformation season. Others may be orange and gold and chestnut brown. The array is simply breathtaking.

In addition to the vibrant leaves, the oaks, of course, also generate large numbers of acorns. This year, especially, has been a heavy mast year, likely due to the drought we experienced through much of summer. Trees respond to stress often by overcompensating in fruits and nuts.

Enjoy the beauty of the painted oaks over the next few weeks as they begin to fade with the coming of November.

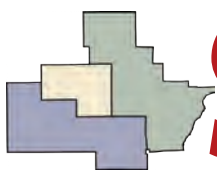

Goal line stand sends Chargers to Level 3

Wittenberg-Birnamwood will take on Wrightstown

How fitting of an end was this? Already with one goal line stand in a 27-22 victory over Amherst during the regular season, the top-seeded Wittenberg-Birnamwood Chargers squared off with the Falcons on Oct. 27 with a spot at Level 3 on the line.

In a game that saw both offenses struggle to move the ball as a combined 310 yards were gained by both offenses, it was the Chargers defense that came through once again.

After picking up a safety early in the second half to take a 9-0 lead, W-B's Owen Dickman came away with an interception in the fourth quarter and returned it 71 yards for the pick six to put the Chargers in front 16-8.

The Falcons put together one last drive at the end and came away with an 18-yard touchdown with 37 seconds remaining to set themselves up with a chance to force overtime.

Connor Groshek intercepted the two-point try to seal the deal for Wittenberg-Birnamwood as they took down Amherst with another goal line stand, 16-14.

"We have relied a lot on our defense all season, and we had to again tonight," said Bryson Schmid, the Chargers running back and defensive back. "I didn't see much of the interception, as I was on the other side of the field guarding my guy. All I know is that Connor (Groshek) came through with a big play when we needed it and helped seal the game."

After a scoreless first quarter that saw next to nothing in terms of yards, it was Wittenberg-Birnamwood getting on the board first as they put together a drive that lasted more than nine minutes and spanned parts of the first and second quarters. The ground attack from Nathan Waupekenay, Schmid and Marshall Fraaza started to wear down the Falcons defense.

It appeared as if Fraaza scored the first points of the game by getting outside and outrunning the Falcons defense for 62 yards. However, a block in the back nullified the touchdown and forced the Chargers to go back to work offensively.

Leave it to Waupekenay and the passing game as he hooked up with Jett Rogowski three times on that drive and four times in the first half for 70 yards to move the ball inside the Amherst 10. Schmid took care of things from there and plowed into the end zone from two yards out to give the Chargers a 7-0 lead.

"It's always nice to score first, and I was happy I was able to put

us in front for good," Schmid said. "We had our chances in this one but just couldn't move the ball when we needed to."

Schmid continued to do his thing on the offense late in the first half, coming away with a 19-yard run to move the chains while Waupekenay tried to connect with him on a flea flicker, only to overshoot him. The clock would run out on the first half shortly after as the Chargers took a 7-0 lead into the break.

As the second half got underway, it was the defense coming up huge once again for the Chargers as a big Waupekenay run was once again called back due to a holding call and forced the Chargers to

punt it away. With the ball pinned inside their own five, Amherst went back to pass only to get hammered in the end zone for a safety, as the Chargers extended their lead to 9-0.

"We played well as a team, but our defense was exceptional to-night," Schmid said. "I feel this was one of our better defensive performances of the year, and had it not been for their effort, we may not be standing here with a win."

Forced into another tough position, and needing points in a hurry, Amherst finally started to put together something offensively. Luke Hoffman played a role in that after missing three games due to an injury, but it was the arm of Michael Benjamin that got things rolling as he hooked up with Cannen Hodges for a 45-yard completion to move the ball inside the Chargers red zone.

Amherst would convert on a fourth and short later in the drive before scoring a TD a few seconds into the fourth as they pulled within 9-8.

With all the momentum on their side, the Falcons defense started to make plays as they held the Chargers offense in check most of the game apart from that lengthy TD drive. Set up with great field position again after a short punt, it was the Chargers defense coming up huge again as Benjamin saw his third down pass tipped up in the air and Dickman came down with the interception as he took it 60 yards to the house for the pick six and extended the Chargers lead to 16-8.

"I am at a complete loss for words," coach Jason Rieck said. "I'm glad we don't have to prepare for that team anymore. They are such a well-coached team and make great adjustments."

"Our defense has come up huge all season, and they did that again tonight. They play with a bend-but-don't-break mentality that works in our favor, but does cause some stress at times. I'm so happy for all our kids tonight as we live to see another day."

Wittenberg-Birnamwood will advance to Level 3 to take on No. 3 seed Wrightstown Tigers.

Bonduel bows out to SMC in four-set thriller

Emotions ran high for both teams when No. 2 seed Bonduel faced off against No. 1 seed St. Mary Catholic in the first round of sectional volleyball action Oct. 26.

The Bears fell to the Zephyrs 3-1, but all four sets came down to the final moments with none of them being decided by more than five points.

After falling behind 2-0, Bonduel rallied to take the third set 25-20 and was leading 15-10 in the fourth set and on the verge of forcing a decisive fifth set. That is when the Zephyrs turned things on as they outscored the Bears 15-7 down the stretch to come from behind to close out that final set 25-22 and end the Bears season 3-1 by scores of 25-21, 25-21, 20-25 and 25-22.

"Both teams played a really great game," Bears coach Abby Krull said. "We spent the night trading blows. SMC is a great team, and I felt we matched up pretty well. They would go on a run, I'd take a timeout, then we would get a little run, and they'd have to take one."

In what seemed like a home game at times for the Bears, the atmosphere in Neenah is what every player dreams of for tournament volleyball as both sets of fans came ready to roll.

That helped the overall play of the match reach new heights as both sides traded blows early on, but it was the Zephyrs grabbing a 7-4 lead following a Lauren Fischer kill.

That was when Audrey Weier took over as the junior not only made life difficult from an offensive side but was relentless on defense as she finished the match with 18 kills, 12 digs and seven blocks.

"We showed up knowing this team was beatable, even though we lost to them twice in past tournaments," Weier said. "Our team's energy was up, and we were just pumped to be there and make it past regionals for the first time in a while. Mistakes always happen in volleyball games, and I think we did a great job shaking it off and going to the next play. Didn't end how we wanted, but I'm proud of what we accomplished this year."

Weier was the one that not only got things rolling for the Bears in the

first set, but she played a role in four straight points to help the Bears pull even 8-8 before the Juliana Jacobs block gave the Bears a 14-12 lead midway through that first set.

The remainder of the first set was a back and forth affair as both sides continued to exchange blows only to have the other match them point for point before a strong finish capped off by the Audrey Norville kill gave the Zephyrs a 1-0 set lead with the 25-21 win.

Eager to turn things around in the second set, the Bears came out on fire as Jacobs and Makayla Gray picked up several kills early on to give the Bears an early 7-3 lead. That lead would grow to 11-6 with Hailee Thompson coming away with several aces as the Bears were in complete control early.

Their lead wouldn't last long as the Zephyrs haven't played from behind a ton this season, but they know how to battle back as Norville and Eliana Brenn started to have their way with the Bears and went on an 8-1 run to put SMC back in front 14-12.

Things only continued to get worse from there with Fischer pushing the lead to 20-15 with a couple of aces before a thunderous rally of kills from Josie Anvelink and Weier pulled Bonduel within 20-19. That was as close as they would get as once again it was the play of Norville finishing things off to hand Bonduel their second set loss of the night 25-21.

Knowing set three was a do or die set for the Bears, they didn't get off to the start they were hoping for as they trailed 3-0 early and then again 5-3. After battling back to tie things up 6-6, Anvelink took over with a series of blocks and kills to put the Bears in front 10-7 with another kill by Gray making the score 12-9.

Bonduel wouldn't trail the rest of the way, but they did let the Zephyrs tie things up a few times. However, each time they found a way to battle back as the front line presence of Weier and Gray was proving to be too much in this one as Bonduel kept their season alive with a 25-20 set three win to make things 2-1.

"I felt our girls responded well after going down 2-0," Krull said. "They battled hard to earn a fourth set and continued to battle no matter what the odds looked like for us."

Already with one do or die set

under their belt, the Bears were trying to do the unthinkable, which was not only to force a fifth set, but to perhaps find a way to win that fifth set.

Getting off to 6-3 lead certainly helped instill confidence as Jacobs set the tone with an early block that led to a couple of tip shots from Thompson for easy points. That was followed by blocks from Anvelink and another tip by Gray as the Bears had all the momentum early, 9-5.

Despite holding a 15-10 lead in the fourth set and seemingly in control the entire time, no lead is safe against this Zephyrs squad and the Bears were about to find that out first hand.

Whether it was the play up front from Fischer and Norville, or the serves from Samantha Weiss and Olivia Noel, Bonduel found their lead slipping away as their season was now in jeopardy of coming to an end.

The Zephyrs closed out the match on a 15-7 run to take set three 25-22 and end the Bears season.

"Overall, this season was a lot different for me as a player than my two other years playing varsity," Weier said. "Starting the season, we had to

move around players and really find out who we were as a team before we actually started playing our best. We went to many tournaments that really pushed us and forced us to see our weak spots. Volleyball is always really fun when it's challenging and the rallies are really long, which happened to us a lot this year."

With the loss, Bonduel ended their season with a 32-5 overall mark including a 7-0 conference mark as they claimed the 2023 Central Wisconsin East Division championship this year.

Bonduel was led by Weier and her 18 kills, while Anvelink and Jacobs added eight kills and five kills, respectively. Thompson set things up for the offense as she came away with 39 assists and 12 digs, while Jayla Reinke added 17 digs in the defeat.

"We may have fallen a little short of the ending we wanted, but our girls fought for every point and left everything on the floor," Krull said. "I am so proud of the season we have had and am sad to see it come to an end."

"I'm so grateful for my team this year, and I hope to accomplish more next year," Weier added.

Will Schmidt be stalwart against censorship?

For some reason, given the makeup of Shawano County and much of northeast Wisconsin, I figured that when a book issue at the library made headlines, it would be something considered “woke” or something involving gays and lesbians, as a lot of these brouhahas have been springing up around the country. If I’d placed money on that and not on Christian books with crosses, I would have lost.

Currently under debate by the Shawano County Library Board is where Christian fiction belongs. Previously labeled as faith books, they’ve moving them to the inspirational books section and removed the cross. That brought a few people out to protest the idea at the last board meeting Oct. 9, and if the meeting hadn’t been held in the middle of the day, I’d imagine there would be more people gnashing their teeth on the subject.

The issue has even caught the attention of Rep. Peter Schmidt, who took a stand against the idea in his weekly email blast letting folks know what’s going on at the capitol. Schmidt said that a constituent brought the issue to him, and he plans to take steps to keep the matter from moving forward. He is also vowing to work closely with the Wisconsin Library Association and said he has already met with its representatives on the matter.

“It is a slippery slope when we as

a society begin to ban or burn books,” Schmidt said in the email. “Whether it’s the Holy Bible, Hindu scriptures or ‘Fahrenheit 451,’ everyone should have uncensored access to books in our state-funded libraries.”

It’s refreshing when a public official comes out in favor of enlightenment, especially when it’s a Republican. Unfortunately, when it comes to censorship, there are many cases where conservatives are the ones banning, censoring or torching books. In Mississippi, a mayor threatened to withhold \$110,000 from his town’s library until staff removed “homosexual material” because it offended his Christian beliefs. In Virginia, two school board members suggested taking the banned books and holding a public burning “so we can identify within our community that we are eradicating this bad stuff.”

Back to the local issue, it makes no sense to label Christian fiction inspirational when you still have books of other faiths like Judaism, Hinduism

and the like that still are under the faith category. Not all inspirational stories from Christian roots, and not all Christian fiction can be deemed inspiring.

The Shawano County Library is claiming that it’s adhering to American Library Association guidelines, which opposes the use of a cross on Christian fiction. However, the ALA’s Association for Library Services to Children decided about five years ago to pull Laura Ingalls Wilder’s name off an award for outstanding children’s literature authors because her books, written about life in the late 19th century, don’t fit in the political correctness of today. Therefore, I wouldn’t place much faith in the organization’s guidelines.

If it’s the cross that’s the issue, it does seem unfair that only Christian faith books are identified separately. However, instead of covering up the crosses, why don’t we have symbols on other books of faith. A Star of David icon on Jewish-themed books might look nice. The ALA’s website objects to a cross when other religious fiction does not have such a designation, so maybe instead of eliminating the crosses and moving the books into inspiration limbo, we should figure out how menorahs and nativity scenes can coexist on our library shelves.

The fact that this is coming up now, when the main branch in Sha-

wano is practically falling in on itself, seems particularly ridiculous. Removing the crosses just in time to lock the doors when the health hazards get to be too much shows faulty priorities.

When you ban a book, you’re curtailing people’s freedoms. When you burn a book, you’re curtailing those freedoms and adding barbecue sauce. When you resort to censorship through hiding books under a different category, you’re curtailing freedoms while wearing a fake cloak of inclusivity, and that’s not what libraries should stand for.

I’m glad the matter is catching attention at the state level and that Schmidt is willing to fight against censorship. Of course, it’s easy to get upset and fight back when you’re a member of the discriminated party — in this case, Christians.

I hope Schmidt’s fervor is just as solid when — and I say “when” because it will happen eventually — people push to ban LGBT materials, books about race, classic novels with themes that cause certain snowflakes to melt and other pieces of literature in our local libraries. It’s easy to have righteous fury when the issue impacts you, but true character comes when you channel that fury for a cause that has nothing to do with you.

Politicians trying to erase rule of law in Wisconsin

To the editor:

As a retired lawyer, who practiced for 42 years, I find it frustrating that politicians promote agendas which erase of the rule of law governing our democracy.

Assembly Speaker Robin Vos continues to suggest that Justice Janet Protasiewicz may be subjected to impeachment proceedings for stating her views on redistricting and abortion during her successful campaign for Wisconsin Supreme Court, which she won by 11 points. This is despite the fact that months ago the Wiscon-

sin Judicial Commission absolved the justice of complaints filed on these very subjects. In fact, Justice Protasiewicz made the complaint decisions public.

In addition, former Justice David Prosser, who supported Daniel Kelly in the election and whose opinion was solicited by Vos, opined that there are no grounds for impeachment of Protasiewicz based on what she has said.

The stake in the heart of the GOP impeachment canard is the United States Supreme Court case, *Minnesota Republican Party v. White* and the Minnesota Board of Judicial Standards, None other than Justice Antonin Scalia, the late dean of the conservative wing of the court, wrote

the majority opinion which is exactly on point.

The decision states that the Minnesota judicial code prohibiting candidates from announcing their views on disputed legal or political issues is a violation of the First Amendment as an interference with a candidate’s free speech. Therefore, the views expressed by Justice Protasiewicz are protected speech. Attempting to interfere with her election by impeachment is an unconstitutional transgression.

It is reasonable to believe that the state GOP knows this. Let us consider what could happen if the U.S. Supreme Court validated rule of law is ignored. The Assembly impeaches

and the Senate fails to take up the trial leaving the justice in limbo. Arguably, Wisconsin is the most gerrymandered state. The next election cycle goes forward without addressing maps, which could put a minority in the super majority in the legislature allowing the GOP a veto-proof majority. This ignores the Fair Maps resolutions passed by 57 of 72 counties and effectively sidelines the governor.

Say goodbye to democracy in Wisconsin. Justice Protasiewicz is exonerated, but her right to protected speech was violated. Every person, man or woman, who voted for her has had their vote discounted and, therefore, their democratic rights lost.

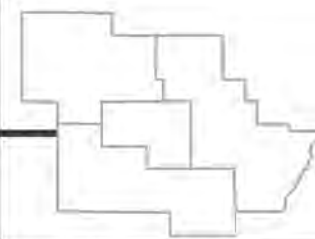

Unidentified human remains found on reservation

Menominee tribal authorities announced that human remains were discovered in the Menominee forest by a hunter Oct. 30.

A joint investigation is currently being conducted by the Menominee Tribal Police Department, Federal Bureau of Investigations, Menominee Tribal Enterprises, Menominee Tribal Conservation, Menominee Town Fire Department, Menominee Emergency

Management and the Menominee County Medical Examiner's Office.

The identity of the person and the cause of death are unknown at this time. Authorities report the investigation is ongoing, and more information will be released as it becomes available.

The authorities have claimed that the reservation community is not at risk.

ThedaCare mammography tech helps women prepare for screenings

While 2D (two-dimensional) mammograms were the standard breast cancer exam for years, 3D mammograms now provide a more effective screening for most patients.

"3D mammography is the better screening choice for all women," said Miranda Parson, a mammography technologist at ThedaCare Regional Medical Center-Neenah. "It can offer an increased cancer detection rate. In particular, women with dense breast tissue will likely benefit from 3D exams because tumors are more difficult to detect in dense tissue. A 3D mammogram combines multiple X-rays of the breast to create the 3D image, providing a clearer image of the breast tissue."

In March 2023, a Food and Drug Administration rule change requires health care facilities to notify patients if they have dense breast tissue, which

slightly increases a woman's chance of developing breast cancer. It's estimated half of all women have dense breast tissue.

In Wisconsin, a bill currently moving through the state Senate (Senate Bill 121) would require insurance companies to cover enhanced testing, such as 3D mammograms, for those with dense breasts.

Most insurance companies, including Medicare and Medicaid, cover 3D mammogram for the initial exam. If you are unsure whether your insurance provider does, contact them before your appointment to confirm your coverage. Most mammography centers, including all ThedaCare locations, are now using 3D mammography.

Parson advised that before a mammogram, patients should provide a full medical breast history prior to the screening.

Broeffle gets 40 months for hurting elderly woman

84-year-old got caught in middle of brawl with defendant, 4 others at Keshena residence

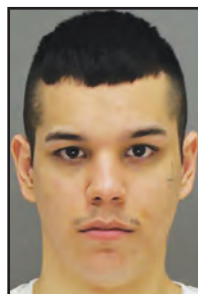
A Keshena man who struck and severely injured an 84-year-old woman was sentenced Oct. 27 in federal court to three years and four months in prison.

According to court documents, Edmond S. Broeffle, 24, was at a “run-down house” last March near Keshena when a melee broke out among Broeffle and four other individuals, who all were drunk, high or both.

A sixth person, Virginia Waupoose, 84, was struck by Broeffle which caused some dental injuries, lacerations and bleeding on the brain.

Waupoose was taken to the hospital, where she spent two days before being released.

She died on Oct. 7, but court records didn’t link her death to the injuries Broeffle caused. She was 5

feet, 2 inches tall and weighed 105 pounds.

Prior to the fight, a person left to get more drugs, which made Broeffle angry because he didn’t want his girlfriend using them. He threatened to call the police, which may have caused the fight, according to court documents.

Police were summoned, and one person admitted to beating Broeffle about the head with a pot or pan. Others saw Broeffle hit back and throw someone to the ground.

Accounts varied among the intoxicated participants; however, only Waupoose was sober and she had been watching TV in her bedroom when the fight began.

She came out of her room and

tried to stop the fight. Waupoose told authorities that Broeffle swung and she got in the way of a punch intended for another and was hit in the face.

Broeffle tried to leave but was followed outside by the brawlers. On a 911 call, a woman said, “We’re going to go outside and finish him off.”

Broeffle was hit over the head with a bottle and then stabbed with the broken bottle.

Authorities found Broeffle on the road near the house and a broken bottle in the snow.

He was treated for a broken nose, cracked ribs, cuts to the head and back that required 14 staples and 20 sutures to close.

Broeffle’s attorney, Thomas Philip, asked for a two-year sentence contending that his client didn’t intend to hit Waupoose and feels terrible for causing her injuries.

Broeffle’s conduct has already resulted in his conviction in Menominee Tribal Court for abuse of an elderly person and has served several months in jail.

Broeffle pleaded guilty in federal court after being indicted for assault resulting in serious bodily injury.

He faced statutory maximum penalties of 10 years in prison but District Judge William Griesbach consulted advisory sentencing guidelines, which called for a prison term of 30 to 37 months.

Phillip argued that, combined with the months Broeffle served in the tribal jail, a two-year sentence would put his client’s sentence within the advisory guideline range.

Broeffle has significant treatment needs for his overuse of alcohol which Phillip wrote is “deeply connected to his history of being abused. One doesn’t happen without the other.”

Wilber elected president of state veterans service officer association

Menominee County veterans service officer Bruce A. Wilber Jr. on Oct. 12 became the president of the County Veterans Service Officers Association of Wisconsin, making him the first Native American to serve in that position in the association’s 87-year history.

Wilber also serves as the tribal veterans service officer for the Menominee Tribe, so his election is doubly historic since no tribal veterans service officer previously served as president of the association.

“Bruce’s election as president of the County Veterans Service Officers Association of Wisconsin is something we can all be very proud of,” said

Menominee County Board Chairperson Elizabeth Moses. “It is testament to how credible he is as an advocate for veterans and their families, given that his colleagues have asked him to represent their collective interests statewide. Moreover, Bruce’s achievement is proof positive that no matter how small we are as an organization, it is possible to make outsized contributions that have far-reaching effects.”

Wilber has served as the county and tribal veterans service officer since August 2016. He is a veteran of the U.S. Army, former tribal judge and has served in numerous other capacities as a public servant.

Maino bringing veterans’ stories to Shawano

Broadcaster, author and veterans rights advocate John Maino is coming at 6 p.m. Nov. 7 to the Shawano Public Library, 128 S. Sawyer St., Shawano.

Maino will speak about his book “Fifty Strong: four decades of US veterans and families share their combat and post-war experiences.” The event is being sponsored by Friends of Shawano County Libraries Inc.

Maino has been a popular broad-

caster for more than 35 years in television and radio. His early career was spent as an embedded reporter in the Army. CMN teacher education program gets \$2.9M

College of Menominee Nation (CMN) received funding for a new project titled, "Growing Head Start Teachers' Capacity, Confidence and Culturally Responsiveness in the Classroom."

The funding comes from the Administration for Children and Families, the Office of Head Start, for \$2.9 million and will cover a five-year period. The purpose of this competitive grant is to establish or enhance partnerships with Head Start programs that effectively increase the

number of qualified education staff working in American Indian Alaska Native Head Start and Early Head Start programs.

"We are so excited about this opportunity to partner with the Head Start Centers on the Menominee, Oneida and Stockbridge-Munsee reservations to support and grow the number of culturally responsive and qualified teachers to work with our youngest learners," said Kelli Chelberg, assistant professor in the teacher education department. "We

know more now than ever the importance of early learning and teachers on the growth and development of young children."

CMN is working in partnership with Menominee Early Childhood Services-Head Start/Early Head Start on the Menominee Reservation, Stockbridge-Munsee — Electa Quinney Head Start on the Stockbridge-Munsee Band of Mohican Reservation and Oneida Head Start Centers on the Oneida Reservation.

The goal of the program will be

to provide education, professional development and financial support for teachers, assistant teachers and potential new teachers to complete their childhood development associates credential, associate degree in early childhood or bachelor of science degree in 4K-ninth grade education.

CMN will aim to train highly qualified, culturally responsive teachers to fill positions in the local Head Start Early Childhood Centers beginning in January 2024 and continue to build on their capacity through May 2028.

New project deals with mental health, substance abuse

The College of Menominee Nation's Department of Continuing Education announces a new project, Building Menominee Teen Resilience.

In addition to everyday adolescent issues, young people in tribal communities have to deal with historic trauma passed down through generations. Building Menominee Teen Resilience will put tools in the hands of the service providers, but it will also put them in the hands of the teens that go through this project;

therefore, they can assist their peers in preventing overdoses and suicides.

Participants will be ages 13-18, focusing primarily on 15-18 to receive the training so they can mentor the younger participants as they age out.

The program will be a three pronged approach utilizing Teen Mental Health First Aid (an established curriculum from the National Council for Mental Wellbeing), Discovery Dating (a culturally, evidence-informed curriculum facilitated by Wise Women Gathering

Place, a local nonprofit) and Trauma Informed Care.

The project is funded by the U.S. Department of Agriculture National Institute of Food and Agriculture Children, Youth, and Families At Risk with the objective that teens involved will demonstrate knowledge, skills, attitudes and behavior necessary for fulfilling and contributing lives and will span five years.

The community sites for which this will take place will be the College of Menominee Nation in

Keshena and the Woodland Boys and Girls Club in Neopit, in partnership with Maehnowesekiyah Wellness Center, Menominee County/Nation UW-Division of Extension, Menominee Indian School District, Students Against Destructive Decisions (SADD), Menominee Tribal Clinic and Menominee Youth Services.

Cowles applauds passage of snowmobile trail aids enhancement bill

Senator Robert Cowles (R-Green Bay) released a statement after Senate Bill 136, which he authored with Sen. Mary Felzkowski (R-Irma), Rep. Calvin Callahan (R-Tomahawk) and Rob Swearingen (R-Rhineland), passed the Senate on a voice vote during the Oct. 17 floor period.

"Snowmobiling is not only a Wisconsin pastime, but it's a large economic generator in rural areas

throughout our state," Cowles said. "In the 2nd Senate District, many communities enjoy beautiful trails that attract snowmobilers from across the Midwest. However, this recreational activity depends on ample and well-maintained trails, and keeping up with trail maintenance costs has become a challenge for snowmobile clubs in Wisconsin.

"Through the changes to the cur-

rent supplemental snowmobile trail aids program under Senate Bill 136, snowmobile clubs will be able to better maintain our most scenic trails without requiring the allocation of additional funds."

Under current law, the Department of Natural Resources uses revenue generated by snowmobilers to reimburse local governments and snowmobile clubs for eligible trail maintenance

expenses. Clubs may receive \$300 per mile in the initial payment, and up to an additional three times the per-mile payment for expenses over the initial \$300.

As some clubs have incurred expenses exceeding this initial payment plus the supplemental reimbursement of up to \$900, Senate Bill 136 raises the per-mile reimbursement cap to five times the initial payment, or \$1,500.

To assist customers with their preparations for the upcoming busy holiday shopping and shipping season, the U.S. Postal Service is providing 2023 holiday shipping and mailing deadlines. The information below covers domestic, international and military shipping destinations to allow for the timely delivery of cards, letters and packages by Dec. 25.

The Postal Service will not have a peak, or demand, surcharge this holiday season, offering increased predictability in pricing for customers.

2023 holiday deadlines are as follows:

Within the lower 48 states

- USPS Ground Advantage — Dec. 16
- First-Class Mail (including greeting cards) — Dec. 16
- Priority Mail — Dec. 18
- Priority Mail Express — Dec. 20

Alaska

- USPS Ground Advantage — Dec. 16
- First-Class Mail — Dec. 16
- Priority Mail — Dec. 18
- Priority Mail Express — Dec. 20

Hawaii

- USPS Ground Advantage — Dec. 16

Postal Service proposes rate increases for January

The United States Postal Service filed notice with the Postal Regulatory Commission (PRC) of mailing services price changes to take effect Jan. 21, 2024. The new rates include a 2-cent increase in the price of a first-class mail forever stamp, from 66 cents to 68 cents.

The proposed adjustments, approved by the governors of the Postal Service, would raise mailing services product prices approximately 2%. If favorably reviewed by the commission, the price changes would include:

- 1-ounce letters, from 66 cents to 68 cents.
- Metered 1-ounce letters from 63 cents to 64 cents.
- Domestic postcards from 51 cents

to 53 cents.

- International postcards from \$1.50 to \$1.55.
- International 1-ounce letters from \$1.50 to \$1.55.

There would be no change to the additional-ounce price, which is at 24 cents. The Postal Service is also seeking price adjustments for special services products including certified mail, post office box rental fees, money order fees and the cost to purchase insurance when mailing an item.

The PRC will review the changes before they are scheduled to take effect. The complete Postal Service price filing, with prices for all products, can be found on the PRC website under the Daily Listings section at prc.gov/dockets/daily.

Packers can't get out of their own way in 24-10 loss to Vikings

Packers averaging 15 points per game over four-game losing streak

Green Bay drops to 2-5 after loss to Minnesota

The Packers once again got off to a slow start Oct. 29 as the team dropped a divisional matchup to the Minnesota Vikings to record its fourth loss in a row.

With the loss, the Packers fall to 2-5 on the season, dropping to third place in the NFC North, holding just a 12% chance to make the playoffs and currently slotting in for the sixth pick in the 2024 NFL Draft.

As has been the case with numerous games involving Green Bay this year, the matchup was filled with mental mistakes — including twice turning the ball over on downs, deep in Minnesota territory, and racking up 11 penalties for 99 yards.

The real kicker for the Packers though, in this game, was the defense's inability to get off the field on third down. In total, the Vikings converted 10-of-18 on third downs.

Not only were the penalties and the inability to stop Minnesota's third down offense a problem for Green Bay, the receiving corps had close to 10 combined dropped passes throughout the game, limiting Packers quarterback Jordan Love's ability to properly lead his offense. In total, Love finished the game 24-of-41 with 229 yards, one touchdown and one interception.

That interception came when Vikings defensive back Josh Metellus ripped the ball out of Jayden Reed's hands on a deep seam route in the middle of the second quarter.

"That was obviously tough to watch," said Packers coach Matt LaFleur. "Just way too many mistakes — penalties, drops, not being able to convert on third down and conversely not getting off of the grass on third down, struggles in the red zone, starting the game out with four three-and-outs. It is hard to get into a rhythm offensively, and then

when we needed a stop, we weren't able to do that."

Love spoke on what happened on the interception, saying that the defender made a good play on the ball, but that Love wished he could have put the ball in a better position for his receiver Reed.

"I wish that I could have put it a little bit more in front of him, you

know. There was a DB playing a cover 2 look over the top, so I didn't want to put it too far out there in front of him, but I gave him an opportunity. But the DB made a great play and was able to just rip it out of his hands," said Love. "Those are the things that we can look back and say, 'I wish I would have thrown this ball a little farther,' but it comes down to execution, making those plays, me making better throws, and guys just going out there competing and winning."

Once again, though, Green Bay was able to make the game interesting in the second half, as it held many opportunities to come back and put points on the board.

Down 24-3, with 7:48 remaining in the third quarter, Love marched down the field to the tune of a 14-play drive. That drive included passes of five, 10, 31, 10, six, five and a one-yard gain. The drive ultimately culminated in Love connecting with Packers wide receiver Romeo Doubs for a one-yard touchdown.

Later in the third quarter, up 24-10, the Vikings marched all the way down to the Green Bay 13-yard line. On second down, Vikings quarterback Kirk Cousins was sacked by Packers linebacker Preston Smith, to set up a third-and-19. On the ensuing

play, Cousins was once again sacked but came up limping. Minnesota was forced to try for a field goal. That field goal attempt was ultimately blocked by Packers defensive lineman Karl Brooks to keep it a two-score game.

Cousins was eventually ruled out of the game with an apparent ankle injury, but upon further tests after the game, it was determined that he had torn his meniscus, virtually ending the Michigan State alum's season. That left Vikings rookie quarterback Jaren Hall to succeed Cousins.

On Green Bay's ensuing drive after the blocked field goal, Love completed passes of 17 yards (to Christian Watson), 11 yards (to Dontayvion Wicks) and 10 yards (to Reed) to set up a first-and-10 from the Vikings 15-yard line. From there an Aaron Jones five-yard rush was followed up by three straight incompletions, resulting in a turnover on downs and giving the ball back to Minnesota with 7:15 left in the game.

With Hall in the game, the Packers defense jumped on the young quarterback quickly, with Smith recording his second sack of the game, this time forcing a fumble. Packers defensive tackle Devonte Wyatt jumped on the loose ball, and Green Bay took over possession at Minnesota's 15-yard line.

After an A.J. Dillon one-yard rush, Love was sacked for seven yards and Green Bay all of a sudden faced a third-and-16 from the Vikings' 21-yard line. Love's third-down pass attempt to Watson was incomplete and his fourth-down scramble attempt only picked up 15 yards, as Green Bay once again turned the ball over on downs, basically ending the team's chances at winning the game.

Looking at the positives after a game like this, LaFleur said that the team has to continue to fight to keep hope alive, something that the team has been doing in every game through the losing streak.

"I do see a group of men that continues to fight," LaFleur said. "If there is anything to hang your hat on, we have to continue to fight and scratch and claw and try to find ways to improve."

Packers, Rams both going through transition years

Packers offense vs. Rams defense

The Rams defense gave a glimpse of what could be in store for the Packers on their first series against the Dallas Cowboys. The Rams sacked Dak Prescott on three of the first four plays. One of the plays didn't count because of a penalty, but that is the effect that their front can have.

Dallas' offensive line has been better in protection this season than Green Bay's to this point.

The Packers benched Rasheed Walker against Minnesota for Yosh Nijman. Walker would return to the game after Nijman left with a foot injury.

The Nijman and Walker situation puts even more uncertainty around an offense that does not have a semblance of an identity at this point of the season.

Jordan Love was the Packers leading rusher against the Vikings. AJ Dillon and Aaron Jones were unable to find any room to roam, which contributed to their first-half struggles.

That's where the Packers biggest issues lie. Matt LaFleur said after another lifeless performance Sunday that they need to find a way to move the chains to establish a rhythm offensively.

The Packers have been outscored 73-9 in the first half since Week 3.

That falls on everyone. Love's passing attempts that went to Jones or Christian Watson, his two most talented playmakers, went for a total of 50 yards.

"He has some plays he'd like to have back, but we have to make some plays for him," LaFleur said after the Packers third consecutive game where they scored less than 20 points.

The Packers have not scored 20 points in a game since they played Detroit, and 17 of those points came in garbage time after the Lions built a three-score lead.

They continue to search for answers but have been unable to find any to date.



A pass thrown for Jayden Reed was ripped away by Josh Metellus, who returned the interception for 43 yards. Coach Matt LaFleur said he believed the Packers had at least six drops, and a few were critical missed opportunities. Almost any time there was a big spot for a receiver or a 50/50 ball, the Packers lost. The quarterback was far from perfect but his receivers made very few plays for him.

Packers defense vs. Rams offense

Green Bay's run defense was good against Minnesota, giving up less than three yards per carry to Alexander Mattison and Cam Akers.

They did, however, give up the Vikings first rushing touchdown of the season.

The more concerning issue, though, was Green Bay's struggles against Minnesota's passing game. Justin Jefferson did not play Sunday, and it did not seem to matter. Jordan Addison had a big day, catching all three of his targets against Jaire Alexander, including a 20-yard touchdown that made the score 24-3.

KJ Osborn and TJ Hockenson

made their share of plays as well.

Overall, the Vikings converted 10 of 18 third downs, eight of which required more than eight yards to convert.

They did have three sacks, including two from Preston Smith. The Packers need more from their pass rushers not named Rashan Gary. Going into Sunday's game, Gary had as many pressures as the rest of the edge rushers combined.

Smith's big performance would be a welcome sight for a group that is looking for more of a collective effort when it comes to rushing the passer.

That will be a key against Matthew Stafford. Stafford's arm is as

talented as anyone's, but he has struggled when he's been pressured throughout his career.

Stafford did leave Sunday's 43-20 loss to the Dallas Cowboys with an injury that could put his availability in doubt for this week's game.

If Stafford cannot go, Brett Rypien will be under center for the Rams. He was 5-for-10 for 42 yards in mop-up duty against the Cowboys.

The Rams run game has been struggling to find its primary runner since Kyren Williams was lost to injury. Royce Freeman and Darrell Henderson split duties Sunday. Their approach will likely be by committee against the Packers as well.

The strength of the Rams is in their receiving corps. Cooper Kupp is one of the best receivers in football. He's back and healthy.

Rookie Puka Nacua proved plenty capable in Kupp's absence early in the season. Nacua has 795 yards receiving on the season. That is nearly four times the amount that Green Bay's leading receiver, Romeo Doubs, has to this point.

The Rams have a prolific group of receivers that Green Bay will be tasked with slowing down.

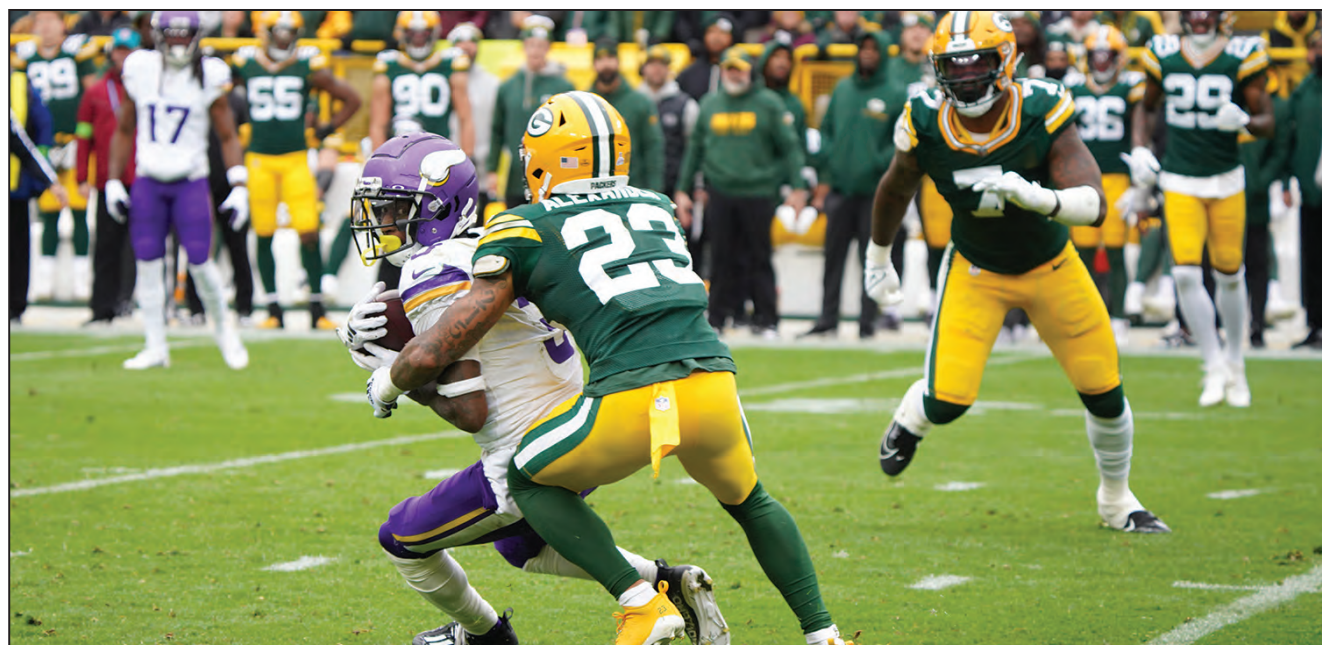
Special teams

The Packers have to be pleased with Anders Carlson to begin this season. One miss in seven games is much better than his up-and-down training camp would have suggested he might have been at this point of the season.

Keisean Nixon took over punt return duties midway through the second quarter of the Denver game but did not return a punt against Minnesota, with Jayden Reed resuming those duties.

Nixon said late last week that he hoped there would be more opportunities to return kickoffs with the weather turning for the worse.

Nixon was right through one

The Rams special teams finished 29th in Rick Gosselin's special teams rankings from 2022.

Like the Packers, the Rams were breaking in a new snapper, holder and kicker to start the year. They're a

team in transition.

The results have been poor. The Rams are ranked 32nd in the NFL in ATS' special teams rankings for the year.

With two teams in transition, this could be a spot where the Packers have an advantage.

Packers have potential to defeat Rams

The Green Bay Packers' losing streak swelled to four games after another lifeless performance against the Minnesota Vikings on Oct. 29.

The Packers dug themselves another hole they could not dig out of. They were outgained 94-15 in the first quarter. The most exciting play of the first quarter was a kickoff return by Keisean Nixon that couldn't get them past their own 30-yard line.

The Rams are coming into town after digging a hole of their own against the Dallas Cowboys. Dallas raced out to a 33-3 lead and coasted to a victory that same day.

The Rams are 3-5 coming into Lambeau Field, but they have at least looked competent at times. The Packers cannot say that at this point.

The team continues to say they're searching for answers but have yet to find any.

Here are some potential answers as the Rams roll into town.

Interior offensive line vs. Aaron Donald

Losing David Bakhtiari was a sting the Packers have been unable to overcome thus far. Rasheed Walker has had some nice moments but has looked like a seventh-round rookie at times as well. That was to be expected.

There are ways to get around a tackle who is struggling. It's not ideal, but it's doable. The Packers are searching for answers there as Yosh Nijman replaced Rasheed Walker midway through the second quarter in the loss to Minnesota.

It's harder to work around immediate pressure up the middle.

That's something the Packers are going to potentially face this weekend.

When discussing greatest defensive players of all time, there are three names that surface the most. Lawrence Taylor, Reggie White and Aaron Donald.

Donald will be facing the Packers again this Sunday and has to be lick-

ing his chops seeing how much the Packers interior offensive line has struggled.

Through their first seven games, the preferred interior offensive line of Elgton Jenkins, Josh Myers and Jon Runyan Jr. have given up 22 pressures. Runyan has given up 10 by himself.

The passing game is having enough of its struggles down the field. Those struggles will be even more exaggerated if the Packers are unable to keep Jordan Love upright.

Donald isn't at the peak of his powers anymore but is still very productive. He only has 2.5 sacks on the season but 35 total pressures. Those numbers tend to even themselves out over time.

The Packers need to ensure that Donald doesn't start getting on a roll this Sunday.

Packers secondary vs. Cooper Kupp and Puka Nacua

The Packers cornerback room, thought to be a strength of the team, is in an interesting spot.

Last week, they made three moves at cornerback including signing Robert Rochell off the Panthers practice squad.

Jaire Alexander was active for Sunday's game against Minnesota, but he is truly going to be week-to-week with a back injury.

When asked about the severity of the injury, LaFleur replied, "It's a back."

That's as ominous as it sounds. Alexander returned from the injury to face Davante Adams and the Raiders after a two-game absence but missed the following week against Denver.

The Rams offense for its faults boasts a dynamic receiving tandem of Cooper Kupp and Puka Nacua. Kupp is one of the top receivers in football.

Nacua helped pick up the slack when Kupp missed the first four games of the season with a hamstring injury.

With both healthy and operating at full potential, the Rams offense can be dangerous.

Alexander hasn't traveled much to the slot since arriving in Green Bay, but he may have to with Kupp coming into town, as that's where he primarily likes to operate.

Whether the Packers will shadow Kupp with Alexander remains to be seen as well. They typically haven't done that but may have to because of the matchup problem that Kupp presents to any defense.

At some point, the defense has to attempt to match their strength against the opponents and make them play differently than how they would like.

The best way to do that is to let Alexander cover Kupp, if he is operating at full capacity.

That, however, will remain in question.

Aaron Jones vs. Rams defense

Aaron Jones is the straw that stirs the drink for the Packers offense. He's been fully healthy going into one game this year, the season opener against Chicago. Perhaps coincidentally, or perhaps not, the Packers scored 38 points that day.

That's a full 14 points more than they've scored in any other game this season.

The Rams defense is still able to get after opposing quarterbacks with Donald anchoring their pass rush. If there's one thing they sacrifice to get that pass rush, it's defending the run. The Rams rank 20th in defensive DVOA against the run. The Packers run game has struggled this season but had been finding some semblance of its footing this year. AJ Dillon had a strong showing in Denver, and Jones should be as close to 100% as he's been all season going into this game. They struggled again against Minnesota, but the Packers may not have much of a choice than to try and establish their run game



Running back Aaron Jones has only been fully healthy going into the home opener against the Bears, a game in which the Packers scored 38 points, more than at any other time this season. Seemingly healthy again, he was used only sparingly against the Vikings, which has many fans wondering why he wasn't used more. The Packers need to make things easier for Jordan Love. One way to do that is get the run game going at the rate it was expected to when this season began.

The Green Bay Packers signed cornerback Robert Rochell to the active roster from the Carolina Panthers practice squad Oct. 25.

Rochell (6-0, 193), a third-year player out of Central Arkansas, was originally selected in the fourth round (No. 130 overall) of the 2021 NFL Draft by the Los Angeles Rams. In two seasons with the Rams (2021-22), he played in 28 games with five starts, recording 15 tackles (12 solo), an interception and four passes defended. Rochell also registered four tackles and two fumble recoveries on special teams.

After being released by the Rams following the 2023 training camp, he spent time on the practice squads of the Seattle Seahawks and the Panthers.

Crazy 24 hours, right?

Everything happened so fast, but it's a part of the process of staying down and believing in yourself at the end of the day. Just thankful to be here for the opportunity. Hopefully

I'm able to step into a role to help the team win.

Two years with Rams, so easy transition with a similar system?

Yeah, for sure. What's a little different is the verbiage on what they call things and how they run it. For the most part, yeah, it's the same scheme and the same with how they run things structurally. The learning curve will be quick.

You've done this a few times this year. How is the learning process?

When I went to Seattle, they had a whole different type of scheme. So, getting over there, I was just trying to get acclimated fast, and that's when I ended up going to Carolina, where my old coaches were. My old coaches from the Rams were in Carolina, and they run the same system, so I got right in and blended in. I was hoping to get up playing at some point over there, and then I got the call here yesterday. They run the same scheme, so it's working in my favor of staying in the same type of defense. I'm thankful for that.

Green Bay has an uphill battle the rest of the way

Mistakes oftentimes lead to undesired results, and for this Green Bay Packers team, those mistakes have been plentiful this season.

It is no secret that not performing at your best ability will likely result in a loss in the NFL, and this Packers team has found that out, as it is in the midst of a four-game losing streak. While mistakes are to be expected, the frequency that this team makes simple mistakes — like a false start on third-and-short or a dropping a pass with no one around — has become frighteningly frequent.

The 2023-24 Packers season was expected to be a transition year. Aaron Rodgers is no longer in town, the offense is the most inexperienced in the NFL and there had been a litany of injuries heading into the season. Losses were expected, but nobody expected those losses to come as a result of Green Bay continuing to shoot themselves in the foot.

In Sunday's loss to the Min-

nesota Vikings, the Packers found themselves deep in Vikings' territory twice late in the game. Down 14 points, any score would have been a great opportunity for Green Bay to keep themselves alive in the game, but just as many times as the team was down there, it turned the ball over on downs.

Penalties, turnovers, missed tackles, missed blocks and not getting off the field on third down, among other inadequacies, have severely limited Green Bay's season. While some fans and writers want to blame that on inexperience (which is fair), Packers coach Matt LaFleur is not so quick to do so.

"Yeah, we aren't even talking that game — the young guy game," said LaFleur, when asked about the youth on the team. "We are focused on whoever is out there, the expectation is the same. We have played seven games now, and I am not interested in that. I think that that is an excuse; we will never do that. We are going to continue to find ways to keep improving, and it starts in practice."

LaFleur talked about seeking ways to get better as a team, but as anyone who has watched Green Bay Packers football over the last few weeks can tell, this team does not really seem like it is improving. That is not for lack of effort or talent, though; it is due to those aforementioned mistakes.

Whether it is coaching, players not knowing the rules or players not buying into the system, a change needs to happen in practice and in meetings. It does not necessarily need to be a coaching change or a front office change, but something needs to happen.

That probably starts with the first-half offense. Against Minnesota, Green Bay once again could not score a first-half touchdown, making it five straight games in which the team has not scored a first-half touchdown. Getting off to a hot start will undoubtedly give Green Bay the momentum and energy it desperately needs to work itself through a 60-minute game.

"It is those little plays that we

are not making and not capitalizing on," said Packers quarterback Jordan Love, when talking about the first-half struggles. "It is obvious. It is not like, 'What are we doing wrong?' It is obvious on the film. We are just executing, not capitalizing on these opportunities that we have and I think that is the biggest thing. As an offense, we have to find a way to stay on the field, move those chains, make those big plays and help our defense out."

The good news, though, is that Love believes that his offense is right on the cusp of displaying what the highest level of its game actually is.

"We are too inconsistent on offense right now; we aren't making plays," said Love. "We have (opportunities); we just aren't capitalizing, and that's everybody. But we pretty much said that we are right there. If we make those plays, if the ball is bouncing the other way, and we are making those plays instead of not making those plays, these are totally different games. I feel like we are right there (to figuring out the offense)."

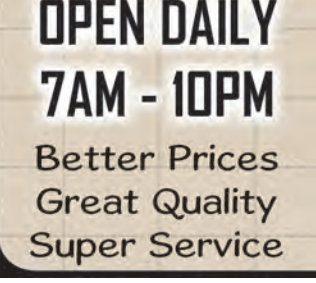
