Proposed levy \$3M above limit

Shawano County may borrow to balance budget

Shawano County department heads have been told to trim 5% of their proposed 2025 budget or face the wrath of the county's executive committee. That was the decision of the committee when it gathered Aug. 21. The proposed \$18 million tax levy is about \$3 million over the limit. A 5% savings will knock \$900,000 off the total, and the county is preparing to possibly borrow the remaining \$2 million. Carrie Buntjer, finance director, said she received an initial indication of 6% interest for short-term borrowing. "If we do a 5% cut across the board, we're still in a borrowing position," she said.

The county's capital improvement plan, any borrowing and a final budget all need to be decided in October, so preparations for borrowing, if it would occur, need to be made now so the County Board can take action at the September meeting. The \$2 million in borrowing would be a maximum.

Board Chairman Tom Kautza is concerned that some department heads may think the whole problem can be solved by borrowing, so they may not make any cuts.

"They're not going to have a choice of whether they're cutting their budgets," Supervisor Randy Young said. "We're going to say to bring back a budget that is 5% less."

"They won't do it," Kautza said. "Then we'll do it," Young responded. "As leaders, we're giving them the chance to do it themselves. They know their budget better than we do."

Jim Davel, county coordinator, asked about departments that already came in under the threshold. Would they still need to trim?

"Yes," said Supervisor Kathy Luebke. "We're Shawano County. This is a Shawano County budget."

Young suggested department heads also hold off on any immediate rehires if an employee retires or resigns.

All positions will be reassessed to see if the work can be shifted to other employees, automate or otherwise performed without rehiring.

Sponsorship proposal gets school board approval

Officials looking to get sponsors at county fair

The Shawano School Board signed off Aug. 21 on a proposal for sponsorships at Shawano Community High School, just in time for the Shawano County Fair.

Acknowledging critics of a November referendum are not keen on certain projects listed in the \$51.2 million capital campaign, the proposal would allow businesses and individuals to sponsor the turf field at the football stadium, the orchestra pit in the auditorium and all of the bells and whistles needed to make those projects functional. Ranging from \$300 to sponsor an auditorium seat to \$500,000 to sponsor the turf field and get naming rights to the stadium, officials hope that if enough community giving surfaces, they'll be able to borrow less for the remaining

referendum projects. Initially brought up a week earlier, board members expressed concern on how long the sponsorships would last. Superintendent Kurt Krizan presented an update where things like audio and lighting could be sponsored for 10 years, while seating and acoustic shells could have a sponsorship of 20 years. He told the board that the district will be using the same contract as it did for when it got sponsorship for the new scoreboard in the SCHS gymnasium, but he added that the proposed sponsorship contract for the future did not have a non-compete clause. "It says that exclusivity can be used, but it won't necessarily," Krizan said. Board member Jeana Winslow expressed satisfaction about the new contract. "I don't want that to be in there, because with the scoreboard one, there was something in there like, two chiropractors couldn't be on the thing," Winslow said. Krizan noted that there would be a

right of first refusal at the end of the contract term, which means that businesses interested in continuing their sponsorships could do so. Board member Bobbi Lemerond was in favor of the sponsorships but was dubious about the terms on some of the projects. She said it looks odd that the higher-money sponsorships have a term of 10 years while some of the smaller items get 20 years. "It just didn't make sense to me that you get your name on a wall for 20 years, but the people who have a million only get 10 years," Lemerond said, specifying the two \$500,000 sponsorships for the stadium and auditorium that would pay for the turf field and the orchestra pit. "I think we should make them all 10 years, but the ones that are under \$100,000 maybe make five years." The school district will have a booth at this year's county fair, where officials will talk with people about the details of the referendum.

Pay differential argued again, knocked down

County aims to add staffing instead

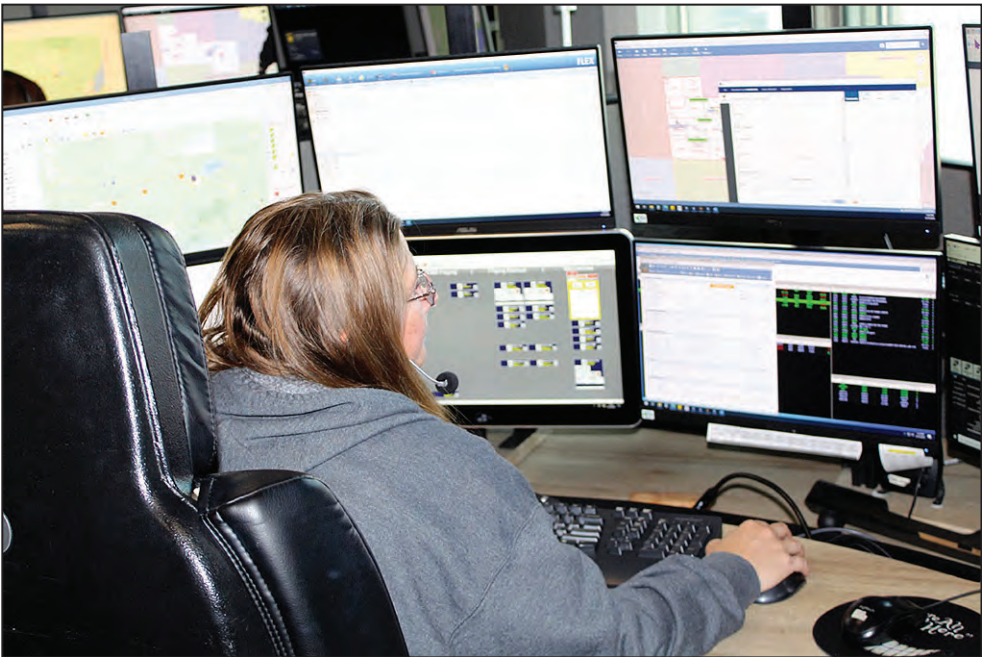
Reiterating that the sheriff's department would rather offer a 50-cent per hour pay differential for second shift and weekend working dispatchers and correctional officers, Supervisor Tess Serrano urged the Shawano County Executive Committee to make that part of the proposed 2025 budget.

The committee denied the request at its Aug. 21 meeting. Instead, the committee added funds to pay for one more jailer and one more dispatcher.

"But if you can't get qualified candidates to fill positions, why wouldn't you go with retaining the people that you have at a 50-cent shift differential?" Serrano said.

"The question came up about the long-term solution vs. the 50-cent thing, and this committee discussed it's really not something that's going to make a huge difference," said Jim Davel, county coordinator.

"There's no use getting

into all that discussion today, because then you'd have to give 50 cents to everybody," added Shawano County Board Chairman Tom Kautza.

Supervisor Kathy Luebke asked if the two new positions were in the proposed budget.

"Yes, and if they make it, they make it. If they don't, they don't," Kautza said. "We didn't vote to pass it, so that means it's a no. You gotta watch what you guys discuss at your meetings, because you can't just bring stuff up. That wasn't on your agenda, Tess."

"It was in the sheriff's comments," Serrano said, noting that the information was presented by Chief Deputy Ty Raddant in place of Sheriff George Lenzner, who was out of town at a conference.

"We did build in the position. I wouldn't argue that it's going to be tough to fill, but you got your long-term solution," Davel said.

He said the county has already given jailers and dispatchers an increase in paid time off, one bonus for corrections officers and adopted new pay scale that gave raises to

all employees.

"We need to get after finding those people," he said.

"They don't want two positions; they want 50 cents," Supervisor Ken Capelle said. "These two positions are costing us a lot of money. Why don't we take them out of here?"

"The two positions would be an answer to the problem," said Kautza. "The problem they have is that the people that are given their time off can't use their time off because they have to come in because there aren't enough

people to work the extra hours.

"It's not a matter of giving them an extra 50 cents to work second shift. That's not going to solve nothing. The problem is the number of people you have working there.

"We threw money at the jailers — \$3 an hour — didn't solve the problem. We (gave them) a 6% pay raise. They didn't the full 6% because of the three bucks an hour. Then we did a full reevaluation of the whole thing, and everybody got raises again then. Didn't solve the problem. So, what's throwing more money at it going to do?"

He added that a recent survey showed only 10% of employees quitting at the county did so due to pay.

"Yes, it will be hard to fill," Davel said. "We shouldn't stop trying to do the right thing because it's hard. Nobody said it was easy. If you look at the amount of pay raises that has been given and the amount of PTO and accrual rate from everybody over there that gets higher than anybody in the county, and they can't take the time, do you really think 50 cents is going to make a damn difference? I don't believe.

"They've got to start

doing more effort in recruitment."

Kautza asked if anyone had approached the employees recently laid off at the Mattoon lumber business.

"What's the recruitment that's being done?" he said. "They take out a little ad. Well, we put it in the website. There ain't nobody looking at that website."

Serrano said many applicants can't make the cut for background checks.

"What do you think's going to happen with 42 people who probably, and I'm just saying probably because I don't know exact figures, 25 of them are Hispanic nondocumented workers?" she said. "You're not going to get them in the sheriff's department."

"Well, you got to get documented ones," Kautza said. "You've got to make more of an effort to reach out.

"You already have people willing to come in second shift and third shift. So, paying them more to come in second shift and third shift is only going to get you to have more people that are willing to work second shift and third shift."

Within the seven vision areas of the Menominee Tribe Strategic Plan, workgroups are collaborating, strategizing and making headway on their initiatives.

One workgroup focusing on the Economic vision area have made big accomplishments that have granted the team a Focus on Energy Energy Efficiency Excellence Award.

The economic vision area focuses on business development, overall economic growth, and ways to save costs and create more sustainable practices and facilities.

"The tribal maintenance and facilities team has been instrumental in making updates to our buildings that can save the tribe money and provide us all with more energy-efficient

options," said Gena Kakkak, tribal chairwoman. "Since day one of the current strategic plan, this team has been diligently working to find long-term solutions."

James Corn, facilities director, along with his team, were presented with the 2024 Energy Efficiency Excellence Award at the Tribal Offices on Aug. 8 by members of the Focus

on Energy Program. Each year, the program selects 10 Wisconsin entities, ranging from businesses to farms, to be honored as champions of finding not just lower-cost energy solutions but ways to reduce energy use all together.

"We are so proud of the work that Jim and his team has done under the Strategic Plan," said Brenda Tomow with the

Wisconsin Department of Administration. "It's even more exciting to see their work be recognized among the other great initiatives happening across the state of Wisconsin."

The maintenance and facilities team set out to centralize purchasing/expenditures for cost-efficiency and procurement cost-savings. The team has been updating tribal office

buildings with LED bulbs in every light fixture which has allowed for a large reduction in operating costs and increase in energy savings.

Pertussis cases found in Shawano County

The Shawano-Menominee Counties Health Department has announced that cases of pertussis (whooping cough) are circulating in Shawano County.

Pertussis is caused by a bacteria and easily spreads from person to person through contact with droplets of saliva expelled by an infected person when they talk,

cough, or sneeze, etc. Initially symptoms may be similar to the common cold — runny nose, sneezing, low-grade fever, and mild occasional cough.

Individuals can further develop uncontrollable, violent coughing that makes it hard to breathe. After coughing, someone with pertussis may need to take deep breaths causing a "whooping" sound.

Infected people can spread pertussis up to three weeks after the cough begins if they are not treated with the appropriate antibiotics.

Pertussis can affect people of all ages. However, it can be very serious, even deadly, for babies less than 1 year old. Many babies who get pertussis are infected by older siblings, parents, or caregivers who might not even know they

have the disease.

The health departments are recommending anyone should contact their healthcare provider about any respiratory illness with a cough, that's greater than two weeks duration, that's violent and uncontrollable, includes an inspiratory whoop/gasping, that has gagging/vomiting after coughing, or is worse at night.

It is imperative for people to stay home and isolate while awaiting test results to prevent potential spread, according to the health department. Residents should be mindful of being distant from others in the household while waiting for results, especially those at higher risk for such as babies less than 1 year old, those who are pregnant, and indi-

viduals with compromised immune systems.

The best way to prevent pertussis among babies, teens, and adults is to get vaccinated. To check if you and your loved ones are up to date on your vaccinations that protect against pertussis, check the Wisconsin Immunization Registry at <https://www.dhs.wisconsin.gov/immunization/wir.htm>

French gets 12 years for drug death

Family of Julian Bourdoin tells judge that they want maximum penalty for reckless homicide

Stephany French will remain in prison for close to a decade for her role in giving Ho-Chunk man Julian Bourdoin a fatal dose of fentanyl believed to be heroin in 2021.

Shawano-Menominee County Circuit Court Judge Katherine Sloma sentenced French on Aug. 20 to 12 years in prison for first-degree reckless homicide involving drugs and four years for theft of property from a corpse for taking Bourdoin's phone after the fact. Sloma ruled that the two sentences will run concurrently.

Given that French has already spent over 1,000 days in jail, that means she'll be in prison until 2033. Once her prison term is complete, French will be on probation for another eight years.

The 12-year sentence for the homicide was recommended by the pre-sentence investigator. The state wanted French to serve 15 years in prison on the homicide charge and another five for the theft. The defense asked for six years between the two charges.

Over 20 of Bourdoin's family members were in the courtroom for the sentencing, with many of them attending multiple court hearings over the last three years waiting for justice. Among them was Bourdoin's daughter, who at one point had to be consoled by family members, as others in the family argued that French should get the maximum sentence possible for taking their loved one from them and not doing anything beyond dousing Bourdoin with water to save his life, despite having Narcan in her vehicle.

The maximum sentence for the reckless homicide, according to state statutes, is 40 years in prison with up to 25 years of supervised release.

Bourdoin was found dead Sept. 3, 2021, at the North Star Mohican Casino Resort in the Town of Bartelme. His autopsy lists cause of death as fentanyl, methamphetamine and ethanol toxicity, which resulted in pulmonary and cerebral edema.

French shows no change

District Attorney Greg Parker pushed for a longer sentence partially because of French's behavior while in jail. He noted that there have been 30 conduct reports filed by the Shawano County Jail since she was arrested in February 2022, including two incidents where French overdosed while in custody. French also has not availed herself

of the Narcotics Anonymous meetings available in the jail, he said.

"The defendant has been in jail for a long time, and on numerous occasions, has been uncooperative with staff, violent toward other prisoners and those kinds of things," Parker said. "The substance abuse history is pretty much consistent with what we've heard today."

Parker also noted that, in two Brown County cases, French had her probation revoked due to additional infractions.

Video from North Star showed how French left the hotel quickly after housekeeping arrived at the room shortly after 11 a.m., as well as showing when French and Bourdoin went into the hotel room in the early morning hours of Sept. 3.

"The images are worth a thousand words," Parker said. "She's nonchalantly walking out of the hotel and fleeing to her car. As Detective (Chris) Gamm

said, there was Narcan within the vehicle, and that leads a person to question, if she had the Narcan, why didn't she try to use it to save Julian, even if it wasn't possible?"

Calling French "clueless" with no regard for Bourdoin, Parker noted that her drug use started at age 21. The defendant will be turning 30 in November.

French victim of addiction cycle

Defense attorney Eric Maciolek painted a different picture of French, saying that her mother was also addicted to drugs, which led to French being in the foster care system until she was 11. She's undereducated and unnurtured, he said, which contributed to the cycle of drug abuse in the family.

Maciolek argued against claims from Bourdoin's family that French has no remorse for her criminal acts.

"Stephany has always been remorseful through-

out the time that I have known her, which is close to three years," Maciolek said. "She never wanted Julian to get hurt. She certainly didn't want him to die."

Maciolek said that six years imprisonment was more fitting for French, arguing the recommendations from Parker and the pre-sentence investigator were more fitting for drug dealers than drug addicts.

"Persons addicted to or dependent on controlled substances should, upon conviction, be sentenced in a matter most likely to produce rehabilitation," Maciolek said. "Stephany French is an addict. She is the victim of overprescribed opiates. She is a victim of her own genetic propensity for addiction, like her mother. Her propensity toward drug use was facilitated to her access to free money. She was handed \$150,000, and unfortunately, a substantial portion of that went to her local drug dealer to sell her opiates."

French provided the drugs to Bourdoin, Maciolek said, but thought what she gave was heroin when it was actually fentanyl. Maciolek pointed out the seriousness of drugs and feels that efforts should be focused on the makers and distributors instead of the addicts.

"The fact that drugs are getting into the jail here is probably more of a problem than saying that somebody in the jail used them," Maciolek said.

Family feels French should pay

Family members were more concerned with the fact that Bourdoin was gone, and that French was responsible for that reality.

April LaMere, Bourdoin's mother, described the difficulty in having to explain to her granddaughter that her "dada" was no longer in her life, and that the child has had "outbursts, depression and instability" due to her father figure being taken away. LaMere noted that French's family members still have her in their lives, while her family members must live with a hole in their hearts that Bourdoin used to occupy.

"I have feelings of anger and sadness and frustration as we have been to this courtroom time and time again, taking time off of work and traveling distances without compensation to sit through lengthy hearings with no resolution," LaMere said. "I would hope that the court would find it suitable for a maximum sentence possible so that this doesn't happen to anyone else's child."

Ariana Bourdoin described how there is now a piece missing from her life because of the death of her brother, and that losing him has produced the biggest heartache she has ever known. She also pointed out how her niece, Julian Bourdoin's daughter, has a hole in her heart because of her father's death, saying the two had the greatest father-daughter relationship.

"How dare you rob her

of that love," Ariana Bourdoin said to French. "The image painted of how you carelessly left my brother will stick in my mind for the rest of my life. To be abandoned in the greatest time of need is not only incredibly selfish but insane. I pray you remember all of our faces and how you made us feel. What you do in this lifetime you will answer to God for."

Bruce LaMere, Julian Bourdoin's uncle and a retired officer with the Wisconsin Department of Corrections, said that French, who has also been known as Stephany Webster and Nativia Thundercloud, gave the drugs to his nephew on purpose. He also expressed disgust at French taking Bourdoin's cell phone, deleting the information on it and selling it to others.

"You have not done anything to improve your life," he said. "While in jail, you have not made any apologies to Julian's parents. You have not made any attempts to earn your HSED (high school equivalency diploma) or GED (grade-equivalency diploma)."

Avoiding trial mercy to family

In passing sentence, Sloma pointed out that while family members might not be happy with the 12-year prison term, the fact that French chose to end the case without a trial was the more merciful solution for grieving relatives.

"She entered into a plea," Sloma said. "I know the family didn't like coming for all those pre-trial hearings, and I thank you for doing that. I know it was very hard. She entered a plea and avoided a trial, which would have probably been a week of additional pain."

Sloma added that while Maciolek had a point that the court should look at sentences that include chances for rehabilitation, it was also necessary to look at French's character and the fact that she has not made the decision to seek help.

Citizens Police Academy starts in September

This is an interactive class where you get to see how law enforcement officers train and see how they deal with different aspects of their jobs.

Experiences will include the opportunity to see what it's like to make a traffic stop, do some building clearing where a suspect may be, learn some

defense and arrest tactics including handcuffing, tour the Shawano Fire Department and do some hands-on activities, tour the Shawano Ambulance and their ambulances, as well as many other activities.

Class will be held from 6-9 p.m. Wednesdays from Sept. 11 through Nov. 6.

Residency can be in Shawano or Menominee County. If you live somewhere close to Shawano County and don't have a class in your area, reach

out anyway as you might be able to get signed up.

Residents must be 18 to participate. There is no cost to attend the program.

model for young girls.

"Showing that women can do stuff and you don't have to be afraid if you're a little different," Gilmeister said. "How many women are now welders? Times can change. If you love something and it's your passion, go for it."

Spending time outdoors and having hands-on work experiences are a couple of things that attracted Gilmeister to pursue an electric utility worker career.

"I'm not the type of person who likes to sit at a desk all the time," she said. "Having that hands-on thing and trying something that most people don't really do is something that I think sets me out and will be something that will carry me on for a

long way."

Gilmeister has been accepted to the electrical distribution program at NTC in Wausau, but she is on the waiting list to start the program.

Receiving the CWEC Utility Worker Scholarship is something for which Gilmeister is thankful.

"It's just absolutely amazing to me that I was able to receive it," she said. "It will allow me to pay off my debt sooner and have a more fulfilling life — hopefully, even give back to other people who need help."

CWEC established the scholarship to help address a forecasted shortage of electric utility employees and to encourage students to consider a career in an electric utility.

Honey bee colonies increase in number in Wisconsin

Honey bee colonies for operations with five or more colonies in Wisconsin as of Jan. 1 totaled 31,000 colonies. This was up 15% from 27,000 colonies on Jan. 1 last year but down 37% from 49,000 colonies on Oct. 1, 2023.

The maximum number of colonies during the January-March 2024 quarter was 55,000.

Honey bee colonies lost for operations with five or more colonies for the January-March 2024 quarter was 1,600, or 3%. This was down eight percentage points from the same period last year and down 10 percentage points from losses reported during the

October-December 2023 quarter.

Varroa mites was the No. 1 stressor for operations with five or more colonies in all of 2023.

Honey bee colonies for operations with five or more colonies in the United States on Jan. 1 totaled 2.71 million colonies, down 1% from Jan. 1, 2023. The number of colonies in the United States on April 1, 2024, was 2.71 million colonies.

During 2023, honey bee colonies on Jan. 1, April 1, July 1 and Oct. 1 were 2.73 million, 2.71 million, 2.92 million and 2.82 million colonies, respectively.

Honey bee colonies lost

for operations with five or more colonies from January through March 2024 was 396,820 colonies, or 15%. The number of colonies lost during the quarter of April through June 2024, was 288,190 colonies, or 11%. During the quarter of April through June 2023, colonies lost totaled 378,190 colonies, or 14% — the highest number lost of any quarter surveyed in 2023.

The quarter surveyed in 2023 with the lowest number of colonies lost was October through December, with 254,520 colonies lost, or 9%.

Honey bee colonies added for operations with

five or more colonies from January through March 2024 was 404,100 colonies. The number of colonies added during the quarter of April through June 2024 was 617,420.

During the quarter of April through June 2023, the number of colonies added were 618,350 colonies, the highest number of honey bee colonies added for any quarter surveyed in 2023. The quarter of October through December 2023 added 118,840 colonies, the least number of honey bee colonies added for any quarter surveyed in 2023.

Honey bee colonies renovated for operations with

five or more colonies from January through March 2024 was 215,070 colonies, or 8%. During the quarter of April through June 2024, the number of colonies renovated were 521,790 colonies, or 19%.

The quarter surveyed in 2023 with the highest number of colonies renovated was April through June 2023 with 485,640 colonies renovated, or 18%. The quarter surveyed in 2023 with the lowest number of colonies renovated was January through March 2023, with 113,440, or 4%.

Renovated colonies are those that were requeened or received new honey bees through a nucleus

(nuc) colony or package.

Varroa mites were the No. 1 stressor for operations with five or more colonies during all quarters surveyed in 2023. The period with the highest percentage of colonies reported to be affected by varroa mites was April through June 2023 at 52%. The percent of colonies reported to be affected by varroa mites during January through March 2024 and April through June 2024 are 43.3% and 54.8%, respectively.

Officers train in responding to mental illness calls

Earlier this month, officers from the Shawano Police Department, Shawano County Sheriff's Office, Shawano County Jail, Shawano County Dispatch, Menominee Tribal Police Department, Black Creek Police Department and Clintonville Police Department completed a five-day crisis intervention team (CIT) training hosted by the Shawano Police Department at Shawano Community High School.

Shawano Police Officers Sam Ferg-Meshnick and Officer Mequon Frechette organize and run this class. This is the fourth year this class has been held in Shawano. There is a lack of mental health crisis services across the United States. Because of this, law enforcement officers are serving as first responders to most crisis type situations. A CIT program is an innovative, community-based approach to improve the outcomes of these

encounters. During this training, officers learned about major mental illnesses, how to identify people in crisis and how to de-escalate situations they may come to face as well as improving responses to people in crisis. This training also helped officers improve their communication ability and learn how to better identify mental health resources for assisting people in crisis as well as keeping them out of jail. CIT can reduce arrests

of people with mental illness while increasing the likelihood that individuals will receive mental health services. CIT programs create connections among law enforcement, mental health providers, hospital emergency services and individuals with mental illness and their families. Through collaborative community partnerships and intensive training, CIT improves communication and identifies mental health resources for those

in crisis and ensures officer and community safety. Research shows that CIT is associated with improved officer attitude and knowledge about mental illness. According to the National Alliance on Mental Illness (NAMI), CIT programs give officers more tools to do their job safely and effectively. Research shows that CIT is associated with improved officer attitude and knowledge about mental illness. The training also helps

keep law enforcement's focus on crime. Some communities have found that CIT has reduced the time officers spend responding to a mental health call. This puts officers back into the community more quickly. CIT training can produce cost savings. It's difficult to estimate exactly how much diversion programs can save communities. But incarceration is costly compared to community-based treatment.

School board bumps paraprofessional sub pay

Board members question if amount enough to attract fill-ins to Shawano

The Shawano School Board voted Aug. 21 to give a pay bump to substitutes serving as non-teaching staff, even though some board members felt the bump wasn't really enough. Teachers on Call presented to the board on Aug. 12, and in that presentation, they noted the

disparity in pay for aides and paraprofessionals. Comparable school districts pay \$15.56 per hour for paraprofessionals, \$16.53 if they're serving as aides in special education classrooms and \$16.34 if they're subbing long-term, and Shawano's pay was less than those figures. A survey from Teachers on Call showed 25% of substitute paraprofessionals with the Shawano School

District are not happy with the pay. Nicole Hartlaben, human resources director, told the board that the district was planning to offer pay to substitutes similar to what is the starting pay for the positions. She proposed paying \$13.50 per hour for recess and lunch aides, \$15 for instructional paraprofessionals and \$17.12 for special education

paraprofessionals. Board member Christine McKinnies questioned if the district would get enough buy-in from substitutes for the aide and paraprofessional vacancies. She suggested that the \$13.50 for recess aides would not do much to convince substitutes to come to Shawano for work. "We're short, and we often need subs for the

paraprofessionals that are SpEd (special education)," McKinnies said. "Just working as a recess aide, lunchroom supervisor or playground supervisor before, you have a lot of occurrences where you need subs for that. Being at \$13 an hour for a recess aide, I don't think you're going to get much more buy-in for \$13 than you did at \$11." With that in mind, McKinnies said she would vote for the increase because the current substi-

tute pay is unacceptable. Board member Bobbi Lemerond agreed that any pay bump from the current amount is good, but she felt the district could do better. "I think we need to review this again, but I'm glad we're starting somewhere," Lemerond said. "Any raise we give is a good thing, but we should look into it a little bit more and possibly bring this up a little bit higher."

USDA releases its latest crop production report

Wisconsin corn production is forecast at 538 million bushels, down 3% from the previous year, according to the latest USDA, National Agricultural Statistics Service – Crop Production report.

Based on conditions as of Aug. 1, yields are expected to average 183 bushels per acre, up seven bushels from last year. Corn planted acreage is estimated at 3.75 million acres. An estimated 2.94 million of the acres planted will be harvested for grain.

Soybean production is forecast at 112 million bushels, up 7% from the previous year. The yield is forecast at 53 bushels per acre, two bushels higher than 2023. Soybean planted acreage is estimated at 2.15 million acres with 2.12 million acres to be harvested.

Winter wheat production is estimated at 15.2 million bushels, down 13% from the previous year. The yield is forecast at 80 bushels per acre, up one bushel from the July forecast and up four bushels from 2023. Winter wheat planted acreage is estimated at 265,000 acres with 190,000 acres to be harvested for grain.

Oat production for grain is forecast at 5.03 million bushels, up 10% from the previous year. The expected yield is 67 bushels per acre, up one bushel from the July forecast and up six bushels from 2023. Oat planted acreage is estimated at 145,000 acres with 75,000 acres to be harvested for grain.

Production of alfalfa and alfalfa mixtures for hay is forecast at 2.48 million tons, up 44% from the previous year.

Yield is expected to average 3.1 tons per acre, up 0.4 tons per acre from last year. Production of other hay is forecast at 820,000 tons, up 62% from last year. Yield for other hay is expected to average two tons per acre, up 0.7 ton per acre from last year.

The forecasts in this report are based on Aug. 1 conditions and do not reflect weather effects since that time. The next crop production forecasts, based on conditions as of Sept. 1, will be released Sept. 12.

Corn production for grain is forecast at 15.1 billion bushels, down 1% from 2023 — which, if realized, would be the third-highest production for grain on record for the United States.

Based on conditions as of Aug. 1, the yield is forecast at a record high 183.1 bushels per acre, up 5.8 bushels from last year's final estimate of 177.3 bushels. Total planted area, at 90.7 million acres, is down 1% from the previous estimate and down 4% from the previous year. Area harvested for grain is forecast at 82.7 million acres, down 1% from the previous forecast and down 4% from the previous year.

Soybean production for beans is forecast at a record high 4.59 billion bushels, up 10% from 2023. Based on conditions as of Aug. 1, yields are expected to average a record high 53.2 bushels per acre, up 2.6 bushels from 2023.

Area harvested for beans in the United States is forecast at 86.3 million acres, up 1% from the previous forecast and up 5% from 2023.

Winter wheat production is forecast at 1.36 billion bushels, up 1% from the July 1 forecast and up 9% from 2023. As of Aug. 1, the United States yield is forecast at 53.2 bushels per acre, up 1.2 bushels from last month and up 2.6 bushels from last year's average yield of 50.6 bushels per acre. Area expected to be harvested for grain or seed totals 25.6 million acres, down 1% from the acreage report released on June 28 but up 4% from 2023.

UW-Extension holding soybean field day next week

Soybean growers need to manage weeds, diseases, insects, weather impacts, and the grain market. Any one of these can create headaches and they can add up to lots of lost income, especially in an already tight margin year such as 2024.

University of Wisconsin-Madison Division of Extension is sponsoring a field day Sept. 4 designed to help soybean growers navigate the current marketplace, as well as improve their pest and agronomic management decision-making.

The field day is being hosted by McAllister Farms, N1448 Laney Road, Seymour. Beginning at 10 a.m., attendees will view research and demonstration plots regarding waterhemp control, fungicide selection and timing, and foliar fertilizer and biological products. Discussions will take place regarding waterhemp management; grain marketing update and tactic considerations; white mold management; dairy ration building based on fatty acid profiles of feeds; soy agronomics; and soy nutrient management.

Discussion leaders include John Heinberg with Total Farm Marketing by Stewart-Peterson, Extension Ruminant Nutrition Specialist Luiz Ferraretto, Extension Crops/Soils Educator Scott Reuss, UW Nutrient and Pest Management Program Manager Dan Smith and Nutrient Management Outreach Specialist Chris Clark. CCA CEU's will be available for attendance at the event.

McAllister's is growing plenish soybeans at the field day site, which are high-oleic soybeans meant for livestock feed.

Alex Weldon with Pioneer/Corteva Agriscience will be on the agenda to discuss management specifics for these cultivars and how they can fit into a farm's rotation. The event is free, including lunch, due to financial support provided by Pioneer, Seed Concepts, and USDA-NIFA through Award Number 2021-70027-34694. A tent will be set up to ensure the event will occur whatever the weather brings that day.

All farm personnel and agricultural professionals are invited to attend this free event, which is being sponsored by the Extension Offices of Brown, Door, Kewaunee, Langlade, Marinette, Oconto, Outagamie, Shawano, and Winnebago counties. Pond, clubhouse aids challenged sportsmen

Challenge the Outdoors provides fun opportunities at Peter's Pond near Pulaski

Challenge the Outdoors (CTO) Inc., a small volunteer organization with big ambitions to help physically challenged folks enjoy hunting, fishing and other outdoor fun, never knows who might discover them and lend a helping hand.

Some volunteers help with deer, turkey and pheasant hunting events, sporting clays fundraisers, trips to Shawano Lake or Lake Michigan for fishing or serve on the board of directors. Those who love the outdoors don't want to see physical impediments get in the way of a beautiful day outside sharing the adventures they all love.

But this 225-member group literally hit the jackpot when philanthropists Steve and Kristi Nooyen of Sturgeon Bay took an interest in helping.

The Nooyens' generosity was obvious to the dozens of volunteers, supporters and family members who visited the open house and dedication of Peter's Pond in Angelica near Pulaski — the official new home and headquarters for CTO — on Aug. 18.

The 13 acres of land — which includes a 3 1/2-acre fishing pond and 2,200-square-foot clubhouse — was paid for through a \$1.5 million donation by the Nooyens' Home Instead, a Green Bay-based senior care franchise that operates in four states.

CTO, a nonprofit organization founded in 1998, currently uses Home Instead's Green Bay office as its main office but will soon use the new facility.

Home Instead, with 10 franchises in Wisconsin and the remainder in Alabama, Kentucky and Tennessee, donates 20% of its corporate profits to charities, said Steve Nooyen, the company president and owner.

"God is our CEO," Steve Nooyen said at the open house.

While the new facility certainly will see plenty of use by the physically disabled — as evidenced by the number of folks in wheelchairs and walkers already reeling in panfish and a few bass at the multiple wheelchair-accessible docks — the clubhouse also will be open to civic groups, hunter and boating safety classes and other activities, Steve Nooyen noted.

"We want the property to be used," he

said. "We want the property to be used often."

CTO officials, RJM Construction LLC of Black Creek and the Nooyens broke ground in November 2021, and the building construction was completed in the winter of 2023, CTO President Carl Gierke said. RJM Construction has assisted Shadows on the Wolf with similar projects to help the disabled access fishing areas.

The building has a spacious meeting room, full kitchen, restrooms and a covered patio. The pond has full aeration and is about 12 feet deep to help keep the panfish, bass and other species alive. Gierke said they hope to eventually remove as many of the carp and bullheads as possible.

Additions to come include a 60-foot

Historical society presentation looks at lumberjacks

The Oconto County Historical Society will begin its fall speaker series Sept. 5 by looking at northeast Wisconsin's lumberjack history.

The program "River Rat: Real Life and Romantic Legend" begins at 6:30 p.m. in the meeting room of the Beyer Home and Carriage Museum, 915 Park Ave., Oconto.

Kathleen Marsh will tell the story of tens of thousands of unsung heroes, lumberjacks who extended their seasonal employment during the Big Pine era.

Singing on as log drivers, these legendary men were also known as river pigs or river rats. They skillfully navigated a series of dams and rivers to deliver millions of sawlogs that would be turned into lumber to build America.

Marsh's program was inspired by "Breakfast in Hell," a song recorded by Slaid Cleves. Written by Robin Frederick, as "The Ballad of Sandy Gray," the song immortalized a valiant log driver who lost his life clearing a logjam on Ontario's Musquash River in

the early 20th century.

Owned by the historical society, the Holt and Balcom Depot Camp in Lakewood was an integral part of this water highway from 1881 to after the turn of the 20th century. River crews assembled there every spring to prepare for a log drive utilizing McCauslin Brook and branches of the Oconto River to float white pine and hemlock logs to the company's sawmill in Oconto.

The program is free. Light refreshments will be served.

by 80-foot storage building, archery and crossbow range, and wheelchair-accessible walking path, Steve Nooyen said.

The donation includes 10 years of maintenance for the facility.

Nooyen, who also runs Wheelchair Whitetails (a group that helps the disabled hunt deer on 500 acres of woods in Florence County), said he bought the land for Peter's Pond in 2016. He told CTO of his intentions to build the new clubhouse and amenities in 2020.

Gierke, president of CTO for the past six years after joining the board, said he went to the group's sporting clays fundraiser many years ago and soon joined the helping-hand agency. It was a similar story for Keith Pamperin, CTO director,

who attended a Green Bay outdoors show one year and ran into some CTO folks manning a booth.

Pamperin, who suffered debilitating injuries 57 years ago in a motor scooter accident, got help by CTO to try kayaking for the first time. He soon found himself on the board and then became vice president before taking the reins as director.

No matter a person's physical abilities or disabilities, CTO is happy to help. It costs \$20 to become an annual member, \$30 for a family, \$100 for lifetime membership (individual) or \$150 for a family.

Members are welcome to use the pond and facilities.

Hot weather can affect heart health

Summer is a wonderful time to embrace the pleasures of the season — spending time at the pool, enjoying a barbecue or taking the opportunity to exercise outdoors.

For those who are exercising outdoors, it's important to understand how hot weather can stress their heart.

"Extreme heat can increase health risks for people with chronic conditions, including heart disease," said Dr. Ameer Kabour, ThedaCare cardiologist. "Taking precautions can help keep you safe and well."

2023 was the hottest year on record, according to www.climate.gov. In addition, the 10 most recent years were the warmest on record.

The temperature danger zone kicks in around 100 degrees Fahrenheit, according to the American Heart Association (AHA). However, even temperatures in the 80s with high humidity can lead to an increased risk of heart problems.

"Heat and dehydration cause the heart to work harder, trying to cool itself by shifting blood from major organs to underneath the skin," according to the AHA. "This shift causes the heart to pump more blood, putting it under significantly more stress."

Extreme heat also can lead to blood clots and electrolyte imbalances that can contribute to cardiovascular disease, according to the Centers for Disease Control and Prevention. These factors may worsen heart failure and lead to acute coronary syndrome,

acute myocardial infarction, arrhythmias and stroke.

"Anyone can experience heat-related illness," Kabour said. "Heat exhaustion and heatstroke are two common types."

People with heat exhaustion should take steps to cool down and watch for worsening symptoms. Heat stroke, on the other hand, is a medical emergency.

Heat exhaustion symptoms include heavy sweating; cold, pale or clammy skin; rapid pulse, muscle cramps, nausea, weakness or tiredness; and headache.

Those experiencing symptoms should move to a cooler place and apply cool compresses. Medical care should be sought for symptoms that don't improve.

Heat stroke occurs when a person's core temperature exceeds 104 degrees F, producing more heat than the body can release. Symptoms can include flushed, hot and dry skin without sweating; rapid pulse and breathing; throbbing headache; upset stomach with nausea, vomiting and/or diarrhea; and dizziness, confusion, irritability or loss of consciousness.

If you suspect heatstroke, call 911. While you wait, move yourself or the affected person to a cooler place. Use cool cloths or ice packs to try to bring down body temperature. A cool bath also can help. Don't give someone suffering heatstroke anything to drink, as they can't safely consume anything while their consciousness is affected.

Certain groups are at more vulnerable to heat-related illness. In addition to

people with heart disease, those at high risk include children under the age of 5, pregnant women, adults 65 and older and individuals with other chronic health conditions such as diabetes or mental health conditions.

Some medications increase the risk of heat-related illness, according to the U.S. Department of Health and Human Services. These include beta-blockers, diuretic medicines (sometimes called water pills), antihistamines (including many allergy medicines) and many antipsychotic medicines used to treat psychiatric and neurologic illnesses.

"Heat-related illness can be preventable if people are taking the proper precautions," Kabour said. "Those in high-risk groups should be especially mindful."

These steps should be taken:

- Stay hydrated. Talk to your doctor about guidelines for staying hydrated if you have heart disease. Some people with certain cardiovascular conditions are sensitive to fluid intake.
- Exercise safely. Exercise is important for people with heart disease, but make sure to play it safe. Move your workout to a cool indoor environment. Alternatively, exercise outdoors early in the morning or later in the day, when it's likely to be cooler.
- Dress smart. Wear lightweight and light-colored clothing. Protect yourself from sunburn with a hat, sunglasses and sunscreen.
- Keep taking medications. If you have concerns about how your heart medications will interact with heat, talk to your doctor.

"Knowledge and awareness go a long way in keeping yourself and your heart safe during hot weather," Kabour said. "We hope everyone can take care and enjoy the warm months."

Competing histories make finding truth hard

Shortly before Christmas 1864, my great-great-aunt Margarethe Walter said a tearful goodbye to her husband, Johann, certain she would never see him again. A Sheboygan County German immigrant farmer, Johann was forced to leave her and their baby daughter to join the Union Army during the Civil War. Margarethe's premonition was spot on, but in a way she could not have imagined.

Johann's infantry unit was charged with guarding supply trains. Constantly on the move, communication with loved ones was sporadic. They trained in Kansas, marched to Tennessee, then Alabama, Louisiana, and finally Green Lake, Texas. Though the war was winding down, they did see limited action. Fortunately, Johann was not wounded; however, most casualties were caused by disease, not gunfire. In August 1865, Johann was stricken. He lay near death, felled by sunstroke, thousands of miles from home.

Then suddenly his wife was there, conjured up in a delirious dream, holding Margarethe and giving him strict orders not to die. He rallied and was on his way to recovery when he got the letter. Posted months earlier, it was from his brother-in-law John George Holzschuh. Reading the contents, Johann collapsed with grief, struggling to absorb the news. Margarethe had died on June 19.

What happened was not explained, just that he was needed at home to attend to his farm and daughter. The letter did contain a bit of comfort. His daughter was living with Anna Maria and John George, my great-great-grandparents who had accepted that responsibility by being named Margarethe's godparents at her baptism.



On Sept. 20, 1865, Johann was granted a 30-day furlough "on account of the death of his wife and helplessness of his child(ren)." Once back in Lima, he arranged for his daughter to continue staying with the Holzschuhs and for John George to run his farm. Even after that proved unnecessary as the war ended, Margarethe continued to live with John George and Anna Maria, who had just given birth to their eighth child.

The next April, Johann married Maria Schuessler. He and Maria had 11 children so obviously it was his first wife who had the infertility issues. This is where things get problematic. Johann's family lineage is well documented, but his marriage to Margarethe is not included anywhere.

The only record of them having a child was the reference in his military record and his daughter's baptismal certificate. She is not listed in the 1870 Census so she must have died by then. Indeed, Johann's grandchildren always maintained that any children by his first marriage must have died young because they had always heard there were none.

There is a troubling something else. In Johann's second family's history, his descendants write that Johann and Margarethe were married in Germany and came to Wisconsin together with an eloping couple. The eloping part is correct; the bride-to-be was Johann's sister. The rest cannot be true. There are copies of immigration papers in the Holzschuh

family book that show Johann came in 1855 while Margarethe came with John George and Anna Maria in 1856. Documentation of their double wedding on June 29, 1856, is also included there.

How do we account for these competing stories? Did Johann's and Maria's children deliberately erase the first part of their father's marital history? That can never be known, but what is certain is that Anna Maria opened her loving arms and heart to Margarethe. She stayed with her adopted family, and her untimely death must have hurt my great-great-grandmother as much as if she herself had given her life. I like to imagine Anna Maria using the iron pot to make comfort food to soothe her grieving family when the little girl died.

Like almost all women of her time, Anna Maria was no stranger to heartache. In 1861, she buried her sixth child, Katherine, who lived just a few weeks. I once asked Dad if I was named after Katherine because he affectionately called me Katrina if I had done something praiseworthy. He shook his head. My name was Kathleen because of a favorite song, "I'll Take You Home Again, Kathleen." That was a pleasant thought until he explained that his Irish pals would sing it during their merry-making when the whiskey and beer flowed freely.

As I write this, my thoughts turn to Anna Maria. I picture her clutching her prayer book as clods of dirt thud against tiny caskets. Was she beseeching God for this to be the last time she must deal with loss of a loved one cruelly ripped out of her life? If so, it's a blessing she had no idea what anguish lay ahead.

Natural Resources Board approves elk plan

The Wisconsin Natural Resources Board (NRB) approved the Wisconsin Department of Natural Resources' (DNR) 2024-34 Elk Management Plan and the associated administrative rule package.

The plan is intended to guide elk management at a statewide level to ensure a healthy, robust and sustainable elk population that provides ecological, social, economic and cultural benefits while minimizing elk-human conflicts in Wisconsin.

The DNR and the Wisconsin Elk Advisory Committee, consisting of the DNR, Tribal Nations representatives, external agencies and stakeholders,

developed the 2024-34 Elk Management Plan to align elk management strategies with the current state of Wisconsin's elk population, the interests of different user groups and the cultural significance elk provide.

The DNR collected and considered a variety of input throughout the development process.

Key updates to elk management in Wisconsin include:

- Managing the statewide elk population using an adaptive management approach.
- Renaming the management zones to include regional distinctions (Northern and Central).

- Creating one continuous elk hunting season.
- Expanding the boundaries of the elk management zones.
- Establishing elk hunting units within and adjacent to elk management zones.

Wisconsin's elk herds reside in northern (Ashland, Bayfield, Sawyer, Rusk and Price counties) and central Wisconsin (Jackson County). The state's elk population is projected to reach more than 500 animals after this year's calving season.

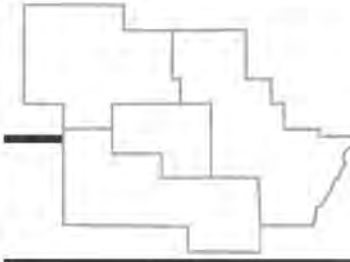

COURT NEWS

- On Feb. 1, a jury found Tim J. Sasman, 42, Bear Creek, guilty of first-degree sexual assault of a child younger than 13. On Aug. 19, Judge William Kussel Jr. sentenced Sasman to 12 years in prison, followed by 10 years of extended supervision with conditions. Kussel gave him credit for 200 days already served.
