

Man, 34, rescued from river after alleged burglary

A 34-year-old Bonduel man had to be rescued from the Wolf River after he was initially scared off from an alleged attempted burglary at a nearby home on Thanksgiving Day. Justin M. Wilber faces one count of burglary and two counts of bail jumping after being pulled from the river by local fire and EMS personnel. Shawano County Sheriff's Deputy Ayden Hale responded to an attempted burglary call at 6:54 a.m. Nov. 28. According to the report, the homeowners first saw someone on the property on their security camera, then found a man in the garage who fled when confronted. The door to the homeowners' truck was found to be open as well. While searching the area, Hale said he heard a voice from an area of thick brush near the water's edge. Following the sound of the voice, Hale located Wilber 10 to 15 feet from the shoreline. Wilber said he fell through the ice; he was stuck and said he was too cold to walk out of the water.

Hale called the fire department for a boat rescue. An EMS crew was also paged due to hypothermia concerns. Once apprehended, Wilber told deputies he was trying to get across the river and fell through the ice. He resurfaced and tried to hide from the deputies and homeowners, as he also tried to get back to dry land. According to the report, Wilber said that the night before, he was driving down back roads and listening to music when his car got stuck on a dead end road. He then walked for two hours, was cold and tired and went into the unlocked garage to warm up. Wilber made an initial appearance in Shawano County Circuit Court on Dec. 2. Cash bond was set at \$100. His next court date is Feb. 4, 2025.

VFW breaks ground on new home

Organizers hope to be in new clubhouse by Veterans Day 2025

Members of Shawano's VFW are on the move – at least they hope to be soon. After more than 72 years at the clubhouse at 204 W. Lieg Ave., plans are underway to relocate Herbert E. McLaughlin Post 2723. "Veterans from the Korean War, Vietnam War, Desert Storm and Global War on Terror, as well as other peacekeeping and security missions around the globe, have passed through our doors and found a place both familiar and comfortable to them when they returned home," said Post Commander Tom Hoffman. Post members gathered Dec. 9 for a groundbreaking at the

recently purchased site at the southeast corner of South Olson Street and East Richmond Street. The local post was formed March 31, 1933, and the clubhouse was dedicated Oct. 1, 1952. The clubhouse has served as a gather-

ing place for veterans as well as a facility open to the public for parties and other social events. "While it has served our community well, it has become difficult to keep up to the maintenance, accessibility requirements and updates that are required," Hoffman said. "A new clubhouse has become necessary, and as a nonprofit veterans organization, we are soliciting funds to assist us in this goal, so that we may continue to serve our community long into the future." The preliminary budget is \$1 million. This includes site preparation, foundation, utilities, the new clubhouse with interior furnishings, a storage building and a paved parking lot. Plans are to have the new clubhouse completed by Veterans Day 2025. Post members serve other veterans and the community by having honor guards at funerals,

Committee wants new county facilities

Decision follows tours of other counties' government centers

Citing a need for improved security, technology and efficiencies, members of the Shawano County Ad Hoc Building Committee agreed to recommend the county build new facilities rather than renovate or maintain existing buildings.

The decision came Dec. 2 after members toured government centers in Green Lake and Waushara counties.

"We had a good discussion with the other county employees who went through the process," said Supervisor Randy Mallmann, chairman of the ad hoc committee. "They talked about the good, the bad, what they would have done different."

All committee members present agreed with the recommendation, which will be forwarded to the county's public property committee. From there, it will go to the full county board.

Ad hoc committee members were Supervisors Tom Kautza, Mallmann and Matt Pleshek; employees Grant Bystol, Scott Frank, Ty Raddant and Ethan Schmidt; and citizen

members Sam Crawford, John Jacobs Jr., Regan Mongold and Greg Strayer. Kurt Berner, of Samuels Group, was the facilitator.

Jacobs was absent from the Dec. 2 meeting.

Members first toured the Green Lake County Government Center in Green Lake. After lunch, they toured the Waushara County Courthouse, where they then met to discuss and decide on their recommendation.

"We're recommending the county focus on building new and possibly combining some buildings," Mallmann said. "The location, the time frame, phases, etc., would be determined by the county board."

Which buildings to be affected have also yet to be determined. The ad hoc committee took in-depth looks at the courthouse, sheriff's department and jail, and the public library.

The Green Lake County Government Center, at 158,000 square feet, is home to more than 30 county departments, a sally port and a 100-bed jail to accommodate Huber, medium and maximum security inmates.

In Waushara County, the courthouse combines

all of the county's general government, courts, court-related departments, human services and the public health department into a 135,000-square-foot, two-story free-standing building connected to the

current county jail. The committee was tasked with choosing among three options – maintain existing structures as is, make necessary renovations or build new. Mallmann said one of

the considerations that played a part in the committee's recommendation was the efficiency of shared resources. "If we can combine our major facilities as much as possible, we can see sav-

ings in some shared areas and even some shared employees," he said. "It's all about making everything more functional and efficient."

Licenses, insurance among suggested ATV requirements

Shawano County Sheriff George Lenzner said he hasn't received any negative feedback on earlier proposals to ban ATV and UTV drivers from drinking and driving on county roads. However, a few other suggestions might not be seen in the same light.

Lenzner told the county's public safety committee on Dec. 4 he will soon sit down with corporation counsel to craft the exact wording of proposed ordinance changes.

"There are getting more and more on the roadway ... so I think we need to make some changes and make stuff a little safer so that we don't start having more issues," he said. "I don't think we should wait like we do with (state Highway) 29 and (County Roads) MMM and U,

where we have to have six, seven fatalities before the state will come in and fix the roadway."

He suggested four changes:

- Anyone 16 or older must have a valid driver's license to operate a UTV on county roads.
 - Children ages 12-15 must be accompanied by an adult with valid driver's license to operate ATVs on roadways. State law prohibits these younger children from operating UTVs on roadways.
 - No open intoxicants would be allowed while an ATV or UTV is operated on a road.
 - ATV or UTV users on county roads must have liability insurance coverage consistent with that required for automobile operators. They must also carry proof of insurance.
- "The majority of them (ATV and UTV users) don't cause us a problem.

We're not really up in ATV/UTV calls here," Lenzner said. "It's always that 10% that cause the issues, and a lot of them are the same people that caused the issues before we allowed them on the roadway."

He reiterated the chang-

es would only govern those using the vehicles on county roads. They would not be in effect for drivers on trails or private property.

The sheriff said he scoured several other counties' ordinances, and some were even

more restrictive than his suggestions.

The city of Shawano is also considering changes to its laws, and the two government entities will work together to coordinate their proposals.

"It would be nice if we both are the same, so that you're not changing the law if you're in the city or going out of the city," Lenzner said.

He reminded committee members that ATVs and UTVs are recreational vehicles, and DNR laws are based on that. It's only when municipalities began allowing them on roadways that non-recreational vehicle laws began to be made.

Lenzner said he would also talk with corporation counsel about changes to county ordinances to allow for citations for such things as speeding, operating after revocation, operating without a valid

driver's license, etc. "If we have a UTV in a 35 mph zone going 70 mph ... you can't give them a speeding ticket, because it's not a motor vehicle," he said. "Our ordinance says they have to conform, but our ordinance does not state that you're going to get a fine for it or anything. You could give a DNR citation for failure to obey a regulatory sign, but I was thinking you'd create a county ordinance."

When questioned by Supervisor Jeremy Gretzinger, Lenzner said the proposed ordinance would not affect ATV or UTV drivers on roads for agricultural purposes.

Lenzner said he hopes to have the proposed ordinance ready for the committee's February meeting, with the county board to act on it before trails open in the spring.

Farmland rental workshops scheduled for Dec. 17-18

If you own or rent farm land in Wisconsin, how much do you understand about the process of renting that land? Do you need a contract? What should be in the contract? How much is the land really worth? These and other questions that surround the process of renting farm land are the focus of workshops being conducted in the area in mid-December.

University of Wisconsin-Madison, Division of Extension is providing the opportunities for owners of farmland and agricultural producers to find

out about land rent realities and options. These free, in-person workshops are sponsored by the Extension offices of Langlade, Marinette, Oconto and Shawano counties. Registration is not required, and all interested persons are encouraged to attend.

There are two more options to attend this discussion.

- Dec. 17, 3 p.m., Pound Town Hall, W8484 County Highway B, Coleman.
- Dec. 18, 12:30 p.m., Town of Antigo Town Hall, W9291 State Highway 64, Antigo (adjacent to the Langlade County Airport).

If in doubt about weather is-

sues for these meetings, contact either the Marinette County Extension office at 715-732-7514 or Scott Reuss at 715-701-0966.

Reuss, crops and soils educator, will lead the discussion of the details that should be considered when negotiating a farm rental contract, and why having a contract is important. He will also detail some of the advantages and disadvantages of various types of annual or multi-year leasing contracts.

Current data regarding land rental rates in the multi-county area will be shared and discussed as well.

Although a written contract is not a legal requirement, it does allow for protections for both parties and allows the producer involved to more readily access crop insurance and governmental programs. Many factors can go into a contract, but the most important center on timing, payment processes, restrictions and opportunities for flexibility when unusual cropping conditions occur.

Contract templates of multiple types will be available as handouts, ranging from extremely simple to more complex arrangements. However, it is

important to make sure they match legal needs and the true needs and desires of both parties. The discussion will focus on basic cropland rental situations but can expand to building leases, grazing land and other situations attendees are interested in discussing.

Get a Discount on Your TDS Service

If you think you can't afford service, think again. You could qualify for a discount on your service through a low-income telephone assistance program called Lifeline Assistance. Lifeline Assistance credits reduce monthly service charges.

Who's Eligible?

Packers Foundation invests in new pageant

The Green Bay Packers Foundation chair's message to grant recipients was succinct. On Nov. 21, Wilson Jones told the 398 grantees gathered in the Lambeau Field Atrium that "the Green Bay Packers appreciate what you do."

Wilson conveyed that the foundation was created in 1986 by Judge Robert J. Parins "as a vehicle to assure continued contributions to charity," with its goal being "to assist the many nonprofit organizations across the state that impact the well-being of Wisconsin residents."

In 2024, they awarded \$1.5 million to help meet their charge.

There were 459 grants submitted this year, with each seeking funding for eligible projects in arts and culture, athletics and education. Wilson noted: "This was the largest number of applications we've ever had."

He added that all the organizations that applied shared something in common with the foundation.

"We have the same mantra — everybody matters," he said. "We want to encourage you to keep doing what you do to inspire others in our state."

I attended the luncheon event with pageant stage manger Melinda Cook to accept a check on behalf of the Menominee Pageant Players Guild. Our group stages a theatrical production in the



Woodland Bowl every summer on the Wednesday before the Menominee Contest Pow Wow, as well as a dinner theater evening on the Menominee Restoration Act in late December.

While a Dec. 19 show at Menominee Indian Middle School will mark our next production, the Packers Foundation grant will help finance our summer 2025 endeavors.

Menominee people have been inviting guests onto their land to hear performed oration since the 1800s, with their pageant productions running from 1937 into the 1970s. The latter shows are a mixture of recorded dialogue, pantomime and live music and dancing under theatrical lights in the majestic Woodland Bowl in Keshena.

Since 2016, the College of Menominee Nation has answered elders' requests to revive the shows, staging classic pageant scripts from the 1940s through the 1960s. Celebrated by both the community who created

them and those who travel from throughout the state to witness, the shows have inspired our turn toward a new chapter in Menominee theater history.

The Green Bay Packers Foundation grant funds the creation of new pageant scripts that will carry the productions forward for the next few years. Drawing from both written and oral Menominee stories, the new show will aim to reflect the messages that 21st century pageant patrons need to hear. The charge to write new shows has been a goal of our revival team since day one.

After our 2016 production, our late master of ceremonies Richie Plass said, "Look at these people, these young ones. Fifty years from now, they'll be great, these young ones, carrying this on. And maybe even make new stories, make them their stories. And that's what our culture is about. It's forever changing as much as it is staying as it was."

In 2023, the Pageant Players Guild answered the call to produce new stories by adding a new scene to enhance a collection of past work in a show called "Onkow." In 2024, we created and staged the short intermission show, "How Muak Got Their Necklace." In 2025 and beyond, we aim to stage all new productions.

Packer alumnus Dorsey Levens concluded the foundation

gathering stating, "It's amazing what you can do to change someone's life. All you have to do is show them you care and give them your ear."

Hunter shares 'Late Season Deer' reality show

I love reality shows that aren't fake, or at least appear not to be fake. Shows like "Naked and Afraid," "Life Below Zero" and "Survivor: SOS" show actual survival tips that could save a life or at least get you through a few days on some remote island or longer in Alaska.

If I had a chance to make my own reality TV show, I'd call it "Late Season Deer." The goal is to put some venison in the freezer by any legal means possible while avoiding frostbite, amputated toes, hair-pulling boredom and a padded room with clipboard-holding observers.

When the last few shots of the nine-day gun deer season fade into the distance and the first few days of the 10-day muzzleloader deer season begin, those lingering doubts about gathering fresh venison begin to solidify. But I now had someone new to share my misery and pop-up blind with.

Scott Krebs, of Oshkosh, the spouse of one of my wife's best friends, lost his hunting spot last season and briefly shared my blind last season at Fox Valley Muzzle Loaders Club in New London. Although no deer fell, I convinced him to join the club because he was anxious to learn more about muzzleloading rifles and enjoy hunting on the club's 40-acre woods.

He purchased a new CVA Optima V2 .50-caliber muzzle-loading rifle with Vortex scope combo online (one huge benefit of trying the sport is that you can purchase most muzzleloaders through the mail). It took us two sessions to get the rifle dialed in for his load of two 50-grain White Hots pellets and a Hornady 240-grain bullet. The light-



weight rifle had an exceptionally light trigger, and he got to shoot at a doe Nov. 29 (muzzleloaders are legal for all gun deer seasons).

He missed. But our spirits were revived, because we had seen several deer that day. I chalked it up to rookie frontloader nerves and that hair trigger. Muzzleloaders take a little getting used to.

"It's different than a regular rifle, because you don't have a fast second shot," Krebs said.

I've taught him how to load his rifle by first dropping two White Hots down the barrel, then inserting the pre-greased bullet and working it down a few inches with the short-starter (a short rod with a ball of wood on one end for a nice grip) before using the rifle's ramrod to seat the bullet on top of the powder pellets. Open the hinged rifle to put a 209 shotshell primer into a hole in the breech plug, close the gun, cock the hammer and you are ready to fire. Elapsed time: a minute with practice.

They also make muzzleloading pistols, and they can provide a quicker follow-up shot. Note that blackpowder revolvers are not legal during the muzzleloader-only season, because they can be loaded from the rear. (I use a single-shot pistol that must be loaded from the muzzle.)

Although inline muzzleloaders like the rifles we were using are generally more reliable than the older sidelock rifles that

some still use (inlines have caps that put the ignition fire directly in line with the powder, while sidelocks have caps that send the

spark at an angle to the powder), both versions can fail. I had a small forkhorn buck come in to within about 25 yards of my blind on opening morning, and the 209 primer didn't fire. The buck walked off as I struggled to figure out what happened. I believe I left too much oil in the breech and it saturated the primer, the powder or both.

Modern muzzleloader hunters, like their buckskin-wearing forefathers, need to carry a bunch of gear in a "possibles" bag, either of traditional or modern design. I've swapped out my fringed leather bag with shoulder strap that I carried years ago with my CVA mountain rifle for a nylon zipper pouch that tucks in my hunting coat pocket. Krebs chose a flat dark earth nylon tactical pouch with zipper for his necessities.

"You need a lot of stuff with a muzzleloader," Krebs said. "You need bullets and powder and caps and a short starter and a ramrod and"

Rather than stuffing a rifle magazine with sealed, water-tight metallic cartridges, you are essentially creating your own powder-bullet-primer combo with each loading.

When the muzzleloader season ends Dec. 11, the four-day antlerless season (Dec. 12-15) gives muzzleloader and regular firearms hunters another chance for a deer. Then Krebs and I can return to our blind with crossbows or vertical bows to wrap up our "Late Season Deer" reality show. By the time the Jan. 5 finale rolls around, it will resemble "Life Below Zero."

YOUR RIGHT TO KNOW

A fund to fight government secrecy

In 2022, the Wisconsin Freedom of Information Council created a designated fund to help cover legal costs associated with fighting to pry records into the public domain. Called simply the WFOIC Legal Fund, it has never had more than \$4,000 in its coffers. The council, of which I am a member, has put what money that is there to good use.

The council last year awarded a grant to The Badger Project, which together with a watchdog group known as the Invisible Institute, is suing the state Department of Justice for refusing to release records about police officers. That case remains pending.

The Legal Fund also helped cover some expenses in journalist Daniel Libit's suit against the University of Wisconsin-Madison and UW Foundation over access to records about publicity deals for student athletes. A Dane County circuit judge dismissed the lawsuit in September on technical grounds, and Libit did not appeal, but the

suit ultimately prompted disclosure of the requested information.

The council in 2022 provided funds to an individual who successfully sued the La Crosse Police Department and the Holmen Police Department for records related to criminal investigations.

The council's goal in establishing this fund, which began with a \$1,700 contribution from a citizens group grateful for the council's guidance, is to help individuals and journalists who are confronting improper government secrecy. We are focused on funding lawsuits that are likely to succeed, could help clarify and strengthen the public's right of access to government meetings or records, or that involve clear or egregious violations of law. We also consider the financial need of the applicant.

There are some strings attached. Cases must involve Wisconsin's public records or open meetings laws, and the requester must be represented by an attorney with a valid license to practice law in the state. Expenses eligible for grant funding include

fees for filing, process service, depositions and expert witnesses. At present, attorney's fees are not covered, and in cases where the plaintiff prevails and wins recovery of litigation costs, the money contributed by the council must be returned.

Down the line, the council hopes the fund can be substantial enough to cover at least some attorney fees in cases that do not lead to successful outcomes or for actions in which no financial restitution is possible, such as letters from attorneys contesting denials. We're not there yet.

The legal fund is a new dimension to the council's existing efforts to advocate for access to government information. In addition to public education and legislative engagement, we have long been a voice for the public's right to know in Wisconsin courts by filing friend-of-the-court briefs.

This year, the council joined the Milwaukee Journal Sentinel and Wisconsin Institute for Law and Liberty in a brief in Wisconsin Voter Alliance v. Secord at the Wisconsin Supreme



Court involving the public records law.

The council also joined the Wisconsin Newspaper Association, Wisconsin Broadcasters Association and the Society of Professional Journalists in a brief

to the Wisconsin Court of Appeals in Oitzinger v. City of Marinette involving the open meetings law.

Preliminary figures show hunters registered 189,622 deer during the 2024 gun deer season, including 89,787 antlered and 99,835 antlerless deer, according to the Wisconsin Department of Natural Resources. Compared to 2023, the gun season harvest total is up 5.2% statewide, with the antlered harvest up 3.6% and the antlerless harvest up 6.6%. CONTRIBUTED

Gun deer season harvest up 5.2% from a year ago

Preliminary numbers from the 2024 Wisconsin gun deer season show an increase in deer licenses and the number of deer killed compared to 2023. The Wisconsin Department of Natural Resources (DNR) said that as of Dec. 1, sales for deer hunting privileges (which include gun, archery, crossbow, conservation patron and sports licenses) reached 791,023, up from 788,697 for the same time period last year. Of those, 553,652 were for gun privileges only, up from 553,479 in 2023.

Deer hunting license and harvest authorization sales will continue throughout the remaining deer hunting seasons. Final license sales figures will be available in January, when DNR staff will perform a thorough analysis and interpretation.

Preliminary figures show hunters registered 189,622 deer during the 2024 gun deer season, including 89,787 antlered and 99,835 antlerless deer. Compared to 2023, the gun season harvest total is up 5.2% statewide, with the antlered harvest up 3.6% and the antlerless harvest up 6.6%.

Since the opening of the bow and crossbow seasons, Wisconsin hunters have registered 289,361 deer. This harvest is 8.7% ahead of the same time last year.

Adams County in the Central Farmland Zone led the state with 12.4 deer registered per square mile. Vernon County led the Southern Farmland Zone with 7 deer registered per square mile. Adams County also led the Central Forest Zone registering 4.2 deer per square mile. Finally, Florence County led the Northern Forest Zone with 2.9 deer registered per square mile.

The DNR's Wisconsin Deer Harvest Summary webpage (<https://dnr.wisconsin.gov/topic/WildlifeHabitat/harvest/deerharvest>) contains more information regarding preliminary harvest registration totals, including county-level numbers.

In Shawano County, there were 5,380 deer harvested, including 2,702 antlered and 2,678 antlerless. In Oconto County, the harvest was 3,826, includ-

ing 1,823 antlered and 2,003 antler less.

The regular gun deer season ran from Nov. 23 through Dec. 1 and is followed by the statewide muzzleloader season (Dec. 2-11), the statewide antlerless-only four-day hunt (Dec. 12-15) and the antlerless-only holiday hunt in select farmland zone counties (Dec. 24 to Jan. 1, 2025).

The DNR reports only one nonfatal firearm-related hunting incident during the 2024 gun deer season.

That happened in the Town of Wheatland in Vernon County. About 4 p.m. Nov. 29, a 14-year-old boy was sitting in an enclosed tower stand with his father, hunting on private property. The father heard what sounded like a gunshot in the distance. Shortly after, the boy felt pain in his feet and found that he was shot through both the left and right foot. He was transported privately to a hospital and received medical treatment for his injuries. The shooter has been identified, and an investigation is pending.

Early ice covers unsafe, DNR warns

The Wisconsin Department of Natural Resources (DNR) urges the public to practice early-winter ice safety on all of Wisconsin's waterbodies, and remember that no ice is safe ice.

The temperature swings that mark the final weeks of every year can create ice covers.

"After we have the first cold nights, we start to see the early ice. It may look solid to the naked eye, but it's not," said Lt. Jacob Holsclaw, DNR off-highway vehicle administrator. "There can be, and often are, cracks and changes in the ice thickness that you will not see."

The ice covers hide the currents, debris and underground springs still feeding lakes and rivers.

"These factors and more are why no ice is ever considered safe – no matter the month," Holsclaw said.

The DNR does not monitor ice conditions, but they are monitored locally. Local fishing clubs, outfitters and bait shops are the best sources for local current ice conditions.

However, the best idea for safe winter fun is to enjoy outings without travel over ice.

If the outing does involve travel over a waterbody, remember every waterbody has its own characteristics. Check if

the lake has inlets, outlets or narrows, is spring-fed or has currents, which can thin the ice.

Some smaller lakes can have aerators that are run throughout the winter either covering a large area towards the center of the lake or may have smaller aerators placed by private property landowners adjacent to their shore or piers.

Equally as important is to stay alert for pressure ridges or ice heaves. These can be dangerous due to thin ice and open water and often are created, move or grow with changes in temperatures and high winds. This can happen on Wisconsin's largest lake – Winnebago, a popular home to sturgeon spearkers – and the Bay of Green Bay.

Here are more safety tips:

- Carry a cell phone, and let people know where you are going and when you'll return home.
- Wear proper clothing and equipment, including a personal flotation device or a float coat to help you stay afloat and to help slow body heat loss.
- Take an extra pair of mittens or gloves so your hands can remain dry and warm.
- Wear creepers attached to boots to prevent slipping on clear ice.

PACKERS DIVISION TITLE HOPES PUT ON HOLD

GREEN BAY LOSES TO LIONS ON BATES' LAST-SECOND FIELD GOAL

For the second time this season, the Green Bay Packers were unable to beat Detroit, as they lost 34-31 on a last-second field goal.

With the game tied at 31-31, the Lions marched down to the Packers' 21-yard line and were faced with a third-and-one. On the third-down play, Packers backup safety Zayne Anderson stopped Lions running back David Montgomery short to force a fourth-and-inches with 43 seconds left.

Instead of attempting a field goal on the fourth down, Lions head coach Dan Campbell called another Montgomery run, which Detroit converted to run the clock all the way down and kick the game-winning field goal.

"That is how Dan (Campbell) has done it throughout the course of his career, so it doesn't necessarily surprise me," said Packers head coach Matt LaFleur, on whether he was surprised about the Lions going for the fourth-and-inches. "That gave us an opportunity there. Hats off to them; they executed it, and we didn't."

While Detroit came away with the victory, Green Bay was just as good on offense as Detroit.

The strength of Green Bay's offense in the game was on the ground. Josh Jacobs registered another great game, as he picked up 66 yards on 18 carries and scored three touchdowns. Jacobs surpassed 1,000 rushing yards on the season during this game.

Jordan Love complemented Jacobs well in the game, as he completed 12-of-20 passes for 206 yards and one touchdown. Tight end Tucker Kraft was on the receiving end of Love's touchdown pass, as the South Dakota State alum finished the game with 41 yards on three receptions. It was Christian Watson, though, who led the team in receiving, picking up 114 yards on four receptions.

As for Detroit, quarterback Jared Goff continued his run for the NFL most valuable player award, completing 32-of-41 passes for 283 yards and three touchdowns. He also threw one interception.

Jameson Williams was the main benefactor of Goff's big day, catching five passes for 80 yards. Tight end Sam LaPorta added another 54 yards on five receptions. Green Bay did



Behind a strong game from defensive tackle Kenny Clark (eight tackles, one tackle for loss), the Packers turned away the Lions on a fourth-down run and got a big interception from Keisean Nixon. Tucker Kraft caught a 13-yard touchdown pass from Jordan Love to begin the comeback, which was ultimately derailed when a Packer go-ahead score was wiped out on a penalty. With the loss, the Packers fell three games behind Detroit with four left in the regular season, but with their 9-4 record, Green Bay still has a 97% chance of making the playoffs, per [PlayoffStatus.com](#)

a solid job in limiting Lions superstar Amon-Ra St. Brown, holding him to just 43 yards on five receptions. Tim Patrick, however, was the X-factor for the Lions, catching six passes for 43 yards and two touchdowns.

On top of limiting St. Brown, Green Bay was also somewhat able to limit Detroit's dynamic run game, holding them to just 111 yards. Coming into the game, the Lions were averaging 154.4 yards per game running the ball. Montgomery was the leading rusher for the team, taking

14 carries for 51 yards and a touchdown. Jahmyr Gibbs added another 43 yards on 15 carries, registering a receiving touchdown.

While the play of the game saw the Lions converting on fourth-and-inches to essentially seal the victory, a key turning point of the game arguably came much earlier. Down 7-0 at the start of the second quarter, Love connected with Watson on a crossing route in which Watson turned up field. To avoid being tackled, Watson fumbled the ball, which

was recovered by Detroit. The Lions were immediately able to turn the turnover into points, converting a Bates field goal to go up 10-0; eventually, they won the game by three points.

Another key part of the Lions' success was converting third and fourth downs, especially when compared to Green Bay's success in those situations. On third down, Detroit went 7-for-15, while Green Bay converted just one out of five attempts. While the Packers were never faced with a fourth-down conversion

attempt, Detroit converted four of five chances to help prolong drives and dominate the time of possession 36:06 to 23:54.

With the loss, Green Bay stays the sixth seed in the NFC playoff picture behind the Minnesota Vikings, who occupy the fifth seed. The Detroit Lions continue to dominate the NFC with a 12-1 record as the No. 1 seed.

While there are still four games yet to be played this season, it is becoming more apparent that the Lions are going to host at least one

playoff game. The same can't be said for Green Bay, but there is a possibility these two teams will meet up again in the later rounds of the NFC playoffs.

"That is one thing where we have to continue to take it a week at a time, like we always talk about," said Love, on a possible third matchup. "Obviously we have a couple of games left here, and we are trying to finish on the right note and win out these last couple games. We will see what happens in the postseason time."

KEYS TO THE GAME

Packers must play better situational football

The calendar has turned to December, and the Green Bay Packers are coming off a tough loss in Detroit against the Lions. The Packers were good enough to stay with Detroit but made too many mistakes in key situations to beat a team as good as the Lions. That included giving up four fourth-down conversions, two of which resulted in touchdowns. The Packers will be able to get a mini-bye with 10 days off between their game against Detroit and the next one against Seattle.

The Seahawks are not a pushover by any stretch. They currently lead the NFC West and would be Green Bay's playoff opponent if the season were to end today. It does not end today, and the Packers need to win to ensure they have a spot in the postseason. Here are the keys to doing just that.

Packers' DBs vs. Seahawks' receivers

Last week, it was the dynamic backfield of Jahmyr Gibbs and David Montgomery that was the primary focus for the Pack-

ers' defense. This week, they face a trio of receivers that are as good as any in the sport. Former Packers' draft favorite, Jaxon Smith-Njigba, leads the Seahawks in receiving and is likely to top 1,000 yards on the year. He operates mostly from the slot. On the outside, the Seahawks have DK Metcalf and Tyler Lockett who can give a defense fits at any given moment of a game. The Packers' defensive backfield is tattered and in flames at the moment. Jaire Alexander has struggled with injuries all season and re-aggravated his PCL tear against Chicago in early November. He has not played since then and has only practiced twice. Without him, the Packers' cornerback group is being held together with bubble gum and sticky tack. That was before Javon Bullard and Evan Williams left Thursday's game with an ankle injury and a concussion, respectively. Williams may be able to return, but concussions are not predictable. Bullard was seen leaving Ford Field in a walking boot and with crutches. He's unlikely to be able to suit up. Green Bay's secondary full of reserves just got beaten up by Tim Patrick. No disrespect to Patrick, but he's not near the level of the guys they will see on Sunday night. The defensive backs need to play better, and the guys up front need to help them out.

Pass rush vs. Geno Smith

Green Bay's pass rush looked like it was finding the form from earlier in the summer in their Thanksgiving Day win over the Miami Dolphins. They had five sacks that night and kept Tua Tagovailoa from ever getting comfortable. Rashan Gary notched another sack against Detroit. He has at least half of a sack in four of his last five games, but the rush as a whole, was not good enough. The rest of the edge rushers hardly sniffed Jared Goff for a majority of the night, and he made them pay. That was a big reason he was able to complete all 10 of his passes in the fourth quarter. Geno Smith can be prone to mistakes if you are able to put him under pressure. The Packers have not been able to do that for most of the year, but the Seahawks have given up 40 sacks on Smith going into Week 14. This is an opportunity to be a get right game for Green Bay's pass rush. Time is running out for them to assert themselves. They'll need to if they're going to make a playoff run.

Situational football

When you get into December, and playing against better teams, sometimes a play or situation can decide who wins or loses. Against Detroit, the Packers were horrendous in situational football. The Lions were 4-of-5 on fourth down. They scored two touchdowns on fourth downs. They have four touchdowns on fourth downs against the Packers just this season. As if that was not enough, a fourth-down conversion essentially iced the game for the Lions. Goff was stepped on while trying to get the ball handed off to Montgomery. Goff got the ball away, and Montgomery picked up seven tough yards. The conversion essentially allowed the Lions to bleed out the rest of the clock before kicking a short field goal.
