Future awaits for Shawano's class of 2025 graduates

155 get their diploma just before Memorial Day

It was the end of a big chapter May 23 for 155 graduates at Shawano Community High School as they received their diplomas and prepared for what came next in their lives.

Co-valedictorian Teagen Thompson noted that her fellow graduates might see the commencement ceremony as the finish line for the long race they've run, completed with caps, gowns and fancy pieces of paper. She knows better, though, saying that graduation is merely a milestone, and there's much more to be accomplished.

"We've faced so many challenges getting to this moment, and it feels like it should be the end, but the truth is we may have reached a milestone, but we're far from finished," Thompson said. "This moment isn't the end of our journey but a step toward what comes next."

Remains of man killed at Pearl Harbor identified

Local VFW Post named after McLaughlin

The remains of a Shawano man killed in the attack on Pearl Harbor on Dec. 7, 1941, have been identified more than 80 years after his death.

The Defense POW/MIA Accounting Agency announced May 20 that U.S. Army Air Forces Pvt. Herbert E. McLaughlin, 31, of Shawano, was accounted for on Dec. 17, 2024.

During World War II, McLaughlin was assigned to Headquarters Squadron, 17th Air Group at Hickam Airfield on the island of Oahu, Hawaii. On Dec. 7, 1941, following the attack on Pearl Harbor, Japanese aircraft expanded to Hickam Field, targeting U.S. aircrafts, ships, barracks, supply buildings and the base chapel. The attack lasted four hours. McLaughlin was reportedly killed during this time.

McLaughlin, who enlisted in the Army in October 1940, was an aerial photographer at Hickam Field. He was stationed there in December 1940.

Shawano VFW Post 2723 is named after McLaughlin, the first Shawano County casualty of WWII. The son of Mary A. McLaughlin, he was a 1928 graduate of Shawano High School.

In the days following the attack, Navy personnel recovered the remains of U.S. Army and U.S. Army Air Forces casualties, which were subsequently interred in the Schofield Barracks Cemetery on Dec. 9.

In August 1947, tasked with recovering and identifying fallen U.S. personnel from World War II, members of the American Graves Registration Service (AGRS) disinterred the remains of U.S. casualties from the Schofield Cemetery and transferred them to the Central Identification Laboratory at Schofield Barracks.

The laboratory staff was unable to confirm the identifications of 12 men from the Hickam Field attack at that time. The AGRS subsequently buried the unidentified remains in the National Memorial Cemetery of the Pacific, known as the Punchbowl, in Honolulu.

On Jan. 5, 1949, a military board classified those who could not be identified, in-

Referendum projects for school district begin

Groundbreaking for elementary, middle schools takes place

What has been on paper for a couple of months crossed over into reality May 20 as the Shawano School District broke ground on renovation and expansion projects at Olga Brenner Intermediate School, Shawano Community Middle School and Hillcrest Primary School.

The ceremony was the start of a two-year clock for the work from a \$51.2 million referendum to be completed. Work for Shawano Community High School will start this fall.

Most of the work this summer will involve updates to lighting systems, repairing damaged outdoor surfaces, addressing accessibility issues and replacing major infrastructure, such as electrical panels and boilers. Also, the district office will build a new facility at Olga Brenner and move away from the offices currently at SCHS so that work in the fall can take place as scheduled.

Superintendent Kurt Krizan called the groundbreaking a “momentous day” for the school district and for the community and indicated better days were ahead.

“This has been made possible through your support, your trust and your shared vision for the future of our schools,” Krizan said. “Today, as we break ground on this exciting

referendum project, we are not just turning soil. We are turning a new page in the story of our district. This project represents a whole investment in our students, our teachers and the values that define our community — excellence, equity and opportunity.”

Krizan said the work being done will make the schools safer and more inspiring.

Shawano School Board member Mike Musolff sees the referendum project as a vision becoming reality. “This is a milestone

moment,” he said. “This moment belongs to all of you, the people of Shawano — our Shawano staff, our Shawano kids. Your overwhelming support for this referendum speaks volumes. It’s more than just a vote of confidence in a building project. It’s a

commitment to our kids, our educators and the future of this community.”

Musolff, who is also Shawano’s police chief, said the referendum projects will serve as one piece of a larger renaissance for the Shawano area, which includes downtown improvements as well as better city infrastructure and public services.

“One thing that I’m most proud of is this incredible teamwork we’ve seen throughout the process between the school district, city officials, community leaders and local organizations,” Musolff said. “It’s been nothing short of inspiring, whether it’s been about planning, communication or problem solving. We’ve shown that we can come together with one common goal. There’s no limit to what we can accomplish.”

Hoffman Planning and Design has been working with the school district for the past two years. Jody Andres, Hoffman’s K-12 specialist, said he enjoys closely working with school officials and community members to make projects like Shawano’s happen.

“With the passage of time, we gain a perspective on a school in a community,” Andres said. “We get the privilege of building great relationships, we get to help school districts improve, and we get to see communities develop important things that’ll continue to draw families and children to special areas of the state like Shawano.”

Andres noted that Shawano’s transparency and accountability has improved, while building pride and excitement in the public school system.

“We look forward to getting these projects completed and letting these children, teachers and staff to benefit from the community’s and Hoffman’s support,” Andres said.

Projects at the high school including expanding technical education areas, family and consumer sciences classrooms, the auditorium and athletic facilities.

“As we’ve said from the beginning, this project has touched every building, and every student will be impacted,” Krizan said.

Progress made on Cellcom outage

The CEO of Cellcom said progress continues to be made to restore full service to its customers who were the subject of a cyberattack in the middle of May.

SMS texting has been restored, and all Cellcom customers can make and receive voice calls with one another.

“We experienced a cyber incident,” said Brigid Riordan, Cellcom CEO. “While this is unfortunate, it’s not something we were unprepared for. We have protocols and plans in place for exactly this

kind of situation. From the start, we’ve followed those plans — including engaging outside cybersecurity experts, notifying the FBI and Wisconsin officials, and working around the clock to bring systems safely back online.”

Customers not seeing service restored should turn on airplane mode for 10 seconds and then turn it off. The phone should reconnect to the network.

Customers who try this and still do not have service should restart their phone.

There is no evidence that personal information related to customers, their

names, their addresses or their financial information is impacted by this event.

The incident was concentrated on an area of the network separate from where customers’ sensitive information is stored, Riordan said.

Voice service is expected to be return by the end of the week, but the company said no guarantees can be given.

As a gesture of accountability and appreciation, Cellcom is covering outage-related service fees for customers who choose to stay with them. The amount will be automatically applied to a future service bill.

Menominee County 10-hour standoff ends peacefully

A 10-hour standoff with police in Menominee County on May 20 was resolved peacefully despite several shots fired at law enforcement.

According to the Menominee County Sheriff’s Department, officer were executing a search warrant at about 7:05 a.m. at a property on Spirit Island Road as part of an ongoing investigation. During the deputies’ initial attempts to secure the

property, a subject inside the structure opened fire on them.

Officers from several nearby agencies, including two SWAT teams, were called in to assist. Throughout the day, officers were fired upon several times.

At about 5:25 p.m., the suspect, a 60-year-old Keshena man, was taken into custody. No injuries were reported.

Criminal charges will be referred to the Shawano/Menominee District At-

orney’s Office.

Assisting at the scene were the Menominee Tribal Police, Menominee Tribal Conservation, Shawano County Sheriff’s Department, Shawano Police Department SRT, Brown County SWAT, Green Bay Police Department SWAT, Bureau of Alcohol, Tobacco and Firearms (ATF), Department of Criminal Investigations, Menominee Tribal Ambulance Service and Shawano Ambulance Service.

County hires new zoning administrator

The Shawano County Board is expected to approve hiring another new zoning administrator when supervisors gather May 28.

Members of the county executive committee approved hiring Kyle Waelchli when they met May 21 and forwarded the recommendation on to the full board.

The position has been vacant since March when Kimberly Gierach resigned. Gierach had

only been on board seven months. According to her LinkedIn profile, she is now the planning services manager for the city of Oshkosh.

When Gierach was hired in the fall, she replaced Jessica Van Buren.

Personnel issues arose in the planning department in the spring and summer of 2024, leading to the first change in leadership.

Waelchli earned a bachelor of arts degree from UW-Green Bay with a major in urban and regional studies, an emphasis in

environmental design and double minors in geography and political science.

Waelchli has more than 15 years of related experience in a variety of private and public sector positions, such as urban planning, director of facilities and maintenance, and land use enforcement. Most recently, he was Shawano County's land enforcement coordinator/associate planner.

He will be paid \$86,507.20 per year.

Buildings, land to be sold by county

Sealed bids accepted until middle of June

Several pieces of property recently acquired by Shawano County will be sold through sealed bids.

The properties were seized by the county after more than four years of delinquent taxes went unpaid.

County Treasurer Debra Wallace said the properties were taken through a court process known as "in rem" and is regulated by state law.

"After four years of not having taxes paid on the property, the county begins this in rem process," she said. "Usually in early December of the fifth year, the judge will give possession of the property to the county."

Sealed bids for several properties are due to the county treasurer's office by 2 p.m. June 17. Each property has a minimum bid amount.

Successful bidders will be given a quit claim deed to the property from Shawano County upon full payment. Payment in full will be due no later than July 18.

All land and buildings will be sold "as is."

Properties include:

- 23.5-acre lot on North Airport Drive and Lake Drive in the Town of Wescott. \$3,200 minimum bid.
- 8.26-acre lot at W18776 County Road Z in Aniwa. \$8,000 minimum bid.
- Lot and building at 519 Flint Ave., Mattoon. \$12,000 minimum bid. Open house from 8:30-10 a.m. June 3.
- Lot and building at 502 S. Andrews St., Shawano. \$10,000 minimum bid. Open house from 1:45-3:15 p.m. June 3.
- Lot on Weed Street in

Shawano. \$3,000 minimum bid.

Wallace said the minimum bids are based on the costs the county has invested in each property. These costs include back taxes, liability insurance, mileage for staff to inspect and secure the property, and wages of office staff to process the seizure and sale.

Reasons for people not paying the taxes include death of the property owner, a refusal or otherwise unwillingness to pay the taxes, the owner moved away or simple abandonment. Wallace noted that most of the in rem properties are in poor shape, and the county is lucky to get its costs back from the sale.

If a property sells for more than the costs the county has incurred, officials must make a good-faith effort to contact the owner or their families to pay them the difference.

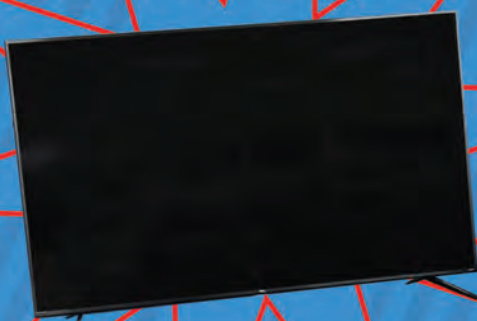

Donations will now renovate downtown building

The Wittenberg Area Historical Society (WAHS) is moving ahead with its capital campaign, but with a different purpose due to a generous donation from the Take a Step Back in Time (TASBIT) Foundation.

"This generous gift is an incredible opportunity to preserve a piece of Wittenberg's history while creating a space that supports our museum's growing needs," said John Powers, WAHS board member. Menominee Indian School District awarded \$700K grant

The Menominee Indian School District received a \$700,000 grant to help it develop a charter school for middle school students, using Menominee culture and language as a foundation for learning.

The Wisconsin Depart-

ment of Public Instruction awarded \$9.8 million in federal subgrants to support the planning, opening, and expansion of 10 charter schools across the state.

The district currently has a charter school in place for elementary age children,

Kaehkenawapahtaeq, which was started three years ago. Officials hope to have the new school in place by 2028, when Kaehkenawapahtaeq's founding kindergarten class would be transitioning from fifth grade to sixth.

SMART approach to learning in Birnamwood classrooms

Kindergarten students develop education skills while in motion

Stimulating learning in young children can be a challenge — Kendy Frame, a kindergarten teacher for Birnamwood Elementary-Middle School, knows that firsthand.

However, Frame and others at the school are taking a SMART approach to learning, with SMART standing for Stimulating Maturity through Accelerated Readiness Training. This action research shows that sitting or being held can have an impact on a child's ability to learn, so Frame has been using the SMART methods of motion training to better stimulate the mind and help her students better learn things like the alphabet, sounding out words, counting and more.

"When we have our kindergartners come, we want them ready to learn," Frame said.

Frame has 33 years of experience with 4-year-old kindergarten, standard kindergarten, Head Start and first grade. She started using SMART in her classroom six years ago when she saw one of her students having difficulties.

"I had a little boy who was sitting on the rug, and he just kept falling over," Frame said. "He didn't have core strength, so he couldn't listen to the stories I was reading. I did a lot of research and digging to see about having some behavioral regulation in my classroom. I wanted to use the technology that I had to build up the core strength so he could learn and make some solid academic growth."

This year, there were 30 kindergarten students for Birnamwood, with four having no prior kindergarten experience at all and another five who did not attend 4K in the Wittenberg-Birnamwood School District. She noted the academic knowledge of the students at the beginning of the year was low, with limited abilities for self-help.

"They weren't carrying their own

backpack in. They weren't tying their own shoes. They weren't buttoning and doing things like that," Frame said. "We had been doing pre-teaching, re-teach-

ing, things like that."

Frame said she set a "vigorous" goal of having 95% of the students performing at grade level for identifying upper-case and lower-case letters, recognizing word sounds and being able to count up to 20.

"The big thing with SMART is looking at your brain, looking at when they start as a baby," Frame said. "What are those basic skills that they need to know so, when they're 6 and they're in kindergarten, they have those readiness skills so they're ready to learn the harder things that we want."

She noted that babies, when they crawl, are learning to move around and over things to better improve their motion. Babies who spend more time sitting in car seats and play pens or being held don't get that basic core maneuvering, which makes it more difficult to stimulate their brains once they enter school.

To that end, Frame has set up various challenge courses in her classroom, in the adjacent hallway and on the playground for her students to practice basic things. The courses show how to pronounce words while crawling, learning balance by jumping on simple patterns,

reciting the alphabet on a designated hopscotch area, balancing on flat sticks and more. There are about 140 yards of movement activities in any designated spot.

"These kids did them, and they wanted more because it was fun," Frame said. "We made it right into our curriculum. We made it academic, and they're doing the skill and not even realizing that their brain stem is working double time."

There are key factors that make SMART a success, according to Frame. Frequency is a factor, and the students engage in the SMART activities every day. Intensity is another issue, and just playing and going through the motions is not enough, so Frame makes sure they're doing something specific like

with your desirable plants for water, nutrients and sunlight. Many weeds also serve as hosts for insect pests and diseases. Removing them improves the look and health of your garden beds.

Once weeded, consider spreading a layer of organic mulch like leaves, ever-green needles or shredded bark over the soil surface. Organic mulches help keep plant roots cool and moist, suppress weeds, conserve moisture and, as they break down, improve the soil. The finer the mulch, the thinner the layer needed, and generally, it should be no more than 2 to 3 inches deep.

Edge planting beds as

farmer and craftsman, included a cross fashioned from 130-year-old drift-wood taken from Norrie Lake. Over 375 people were in attendance.

reciting letters or counting numbers.

"As long as the movement is paired with some academics, they're increasing the time that they're doing them," Frame said. "The attention in class increases. It also decreases anxiety. We're seeing a lot less behavior problems when the kids are doing those things."

Adding the playground course has been beneficial schoolwide, Frame said, as even eighth grade students

time allows. You'll define the space, make it easier to mow around and slow the infiltration of grass and weeds into the garden. have enjoyed helping the younger children navigate through the various items.

"They truly wanted that movement," Frame said. "They truly wanted that structure."

The results of the Fastbridge Test done on the students showed that Frame got very close to her goal, with just over 90% of them performing at grade level or above on average for the various tasks. Frame believes that continuing to set up motion activities that help to teach basic skills will allow future students to reach grade-level goals.

"They came in with very low readiness skills, and now at the end, they're phenomenal," Frame said. "They are all readers in our classroom."

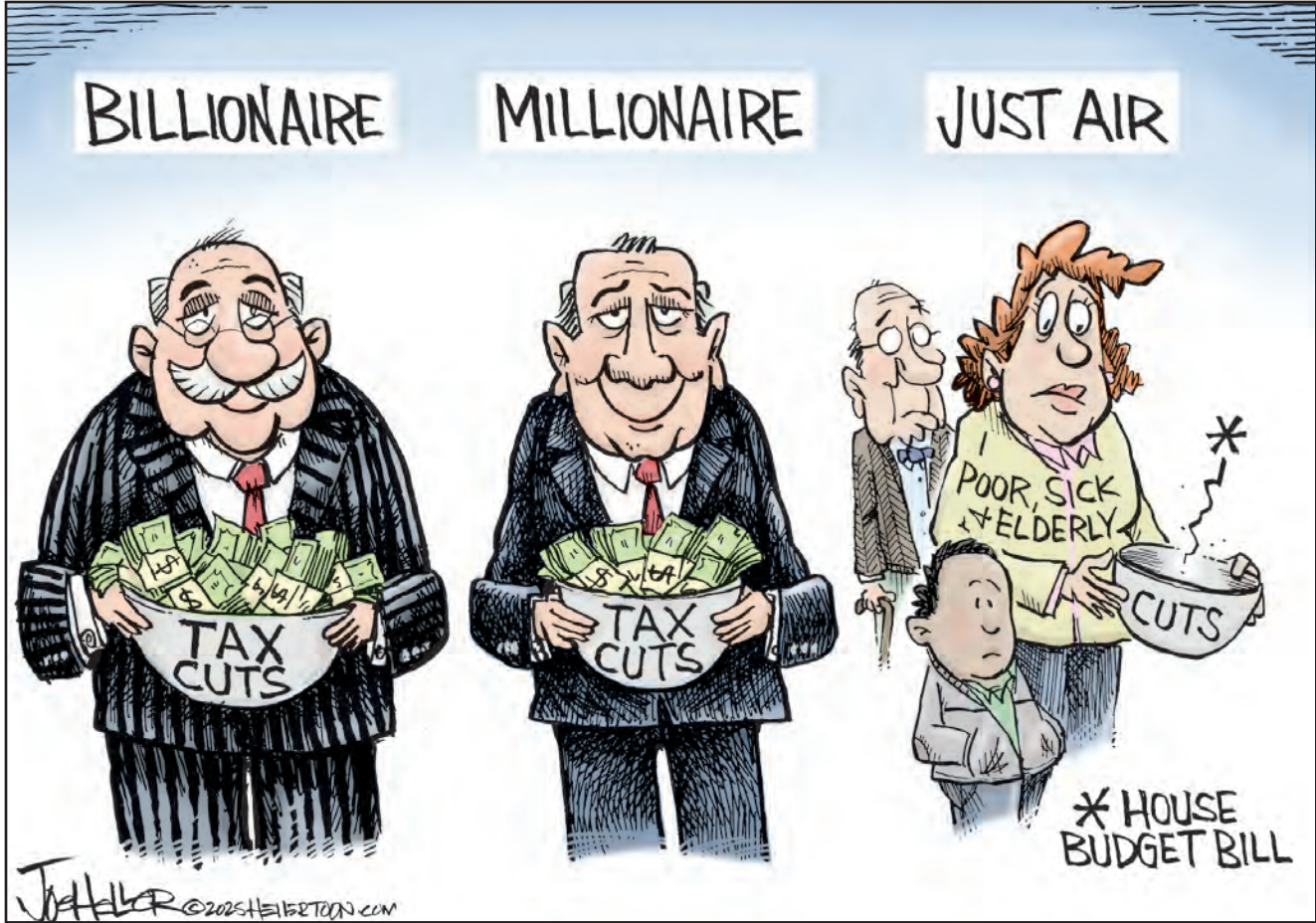

YOUR RIGHT TO KNOW

When people die, openness matters

In any community, the role of the medical examiner is vital.

Medical examiners — or coroners, in the nearly half of Wisconsin's 72 counties that have them as an alternative — determine the cause and manner of death, support the criminal justice system and track data to identify trends that can impact public health and safety.

For me and other Milwaukee-area journalists, the insights provided by the Milwaukee County Medical Examiner's Office are integral to our coverage, providing crucial details and important context. Among the recent examples where the level of openness has played a key role are the COVID-19 pandemic, the tragic deaths of three men due to extreme cold last January and the high-profile case of D'Vontaye Mitchell last June.

Traditionally, the office has supplied "demographic reports" as well as "narrative reports." Demographic reports include information such as the name of the deceased, where the death occurred and the name of a family member who was notified. Narrative reports, in contrast, delve into the circumstances surrounding each case.

"Narrative reports are particularly illustrative when compared to other available public information," wrote David Clarey in the Milwaukee Journal Sentinel in March. "Contextual information, such as whether a driver ran a red light or if a homicide resulted from a heated argument, is often missing (from demographic reports) and requires time-consuming requests from media and families alike."

The media in Milwaukee were pleased with the level of openness we experienced from Karen Domagalski, the longtime operations manager for the Milwaukee County Medical Examiner's Office. But when Domagalski retired on Feb. 19, the county's medical examiner, Dr. Wieslawa Tlomak, announced a change in policy. Henceforth, she said, the office would stop sharing narrative reports until investigations were concluded and cases closed. She acknowledged that this shift represented a significant change in past practices.

Concerned by the change in policy, several news executives — including me — sent Tlomak a letter on April 4. It read, in part:



"The decision to curtail access to these preliminary findings poses a troubling scenario for our news organizations and, more importantly, for the residents of Milwaukee County. Withholding this essential information may leave the public waiting weeks, months or even longer for basic insights into the circumstances surrounding the deaths of community members. This delay not only hampers our ability to keep the public informed but also undermines trust in the transparency of governmental processes."

The letter noted that having access to narrative reports helps "clarify the circumstances" surrounding deaths and fosters "a better understanding among citizens about the events that impact their safety."

Tlomak replied to our letter nearly three weeks later on April 23. Her response read, in part:

"I recognize that this shift in operational policies and procedures is new to members of the media that cover death investigations and public safety matters in Milwaukee County. After an internal review of operational policies and procedures, it became apparent that it is not within the ME's Office mission and purpose to provide inaccurate and/or incomplete information to the public, as the disclosure of these draft details have the potential to cause significant harm to family members most affected by a death."

Here's my response to that: Dr. Tlomak, if your concern is releasing inaccurate information, the appropriate next step would be to correct the information rather than stopping its release altogether. I urge you to work with the journalists who rely on the reports provided by your office to develop a solution that ensures timely access to vital information without compromising the integrity of ongoing investigations.

Transparency is crucial for maintaining public trust.

Mexico has sued numerous American manufacturers and distributors for arming the drug cartels, which run the human trafficking and fentanyl operations on our southern border. The Mexican government can document almost every firearm seized from cartel members as coming from the U.S. It should be obvious that blaming the Mexicans for a criminal enterprise, which is armed by American business, is rather hypocritical. Consider further that if U.S. troops were deployed south of the border, they would be fighting criminals armed with American weapons.

Finally, on the world



stage, American grievance is a complete fraud. The U.S. has 5% of the world's population and consumes 25% of the world's resources. If that's not a good deal for us, then what is?

Schools robbing children of their innocence

To the editor:

What are our children being taught, and who approves it? As a father who has homeschooled for 19 years and participated in public schools for the past seven, I'm more concerned than ever. The illusion is that public education is official, approved and therefore trustworthy. My experience says otherwise.

On April 14, a concerned grandfather contacted me. His granddaughter, a fourth grader at Suring Public School, was rehearsing a play in which two boys get married. The play was halted only after a parent raised the issue. Why did it take a parent to intervene? Who is truly monitoring what children are exposed to?

It turns out a first-year teacher rewrote the play

without administrative review. Had it been approved, the situation would be even more troubling. The district claims curriculum is developed by a teacher administrator committee, aligned with state standards, and approved by the school board. Supplemental materials are typically vetted by administrators.

Where is that oversight in practice?

The Suring School District has a troubling history. In the past six years, two former teachers have gone to federal prison for sexually abusing students. State laws on strip searches have changed, and the district has

paid out major settlements.

Do I blame the teacher for using inappropriate content? Yes, but the larger responsibility lies with the curriculum coordinator, principal and school board. These officials are paid to protect and educate our children. Are they unwilling — or unable — to do so?

The sexualization of grade-school children must end. This failure to enforce age-appropriate curriculum robs children of their innocence. In any other profession, such dereliction would have consequences. Why should public schools be any different?

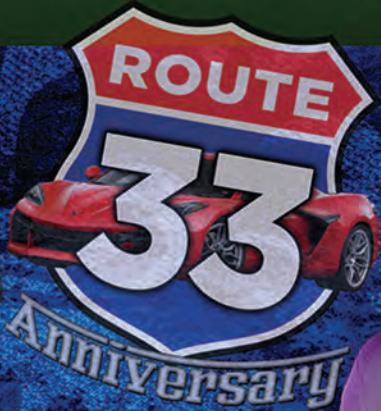

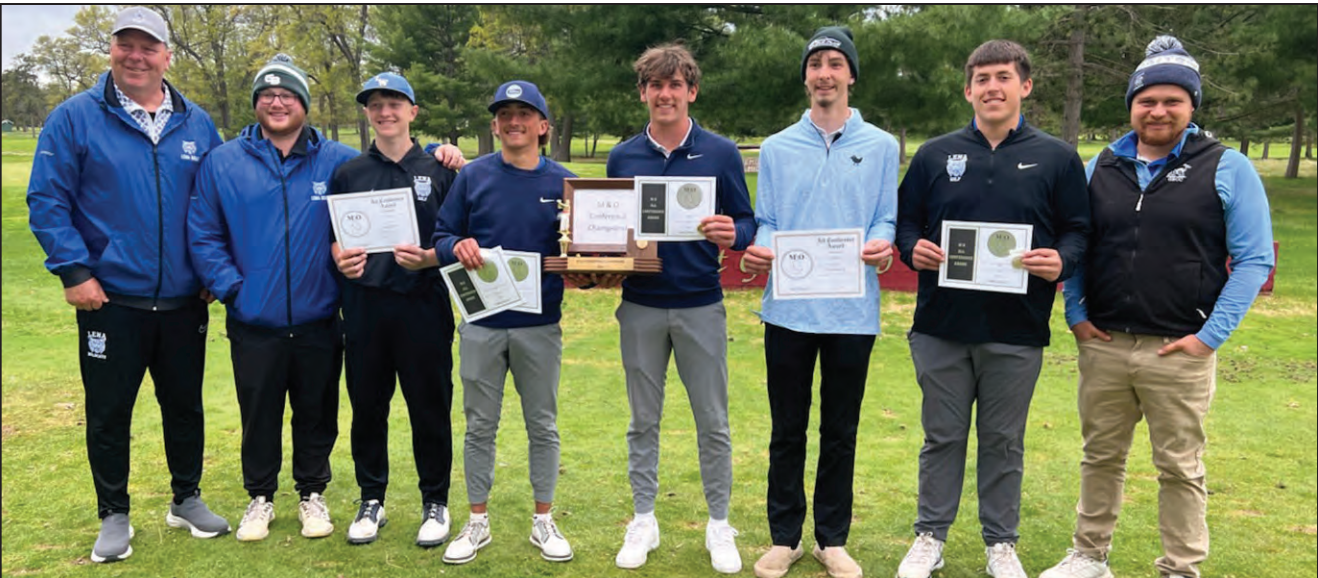

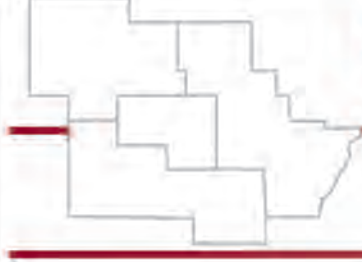

lieve we’re falling behind or that we’re not good enough or not strong enough,” Thompson said. “We question whether we’re truly cut out for the challenges ahead, wondering if we’re just pretending to have it all together. The truth is, we’re not alone in feeling this way, and more importantly, those doubts don’t define who we are.”

Once the doubts are shaken off, it can be easier to see the path in life, Thompson said.

“Even if we question our strength in the process, it’s always been there, quietly building within us because we are capable of more than we think, capable of growing into better people, capable of

building the lives that we want — not the lives other people expect,” she said. “This capability wasn’t something we were born with. It was built.”

Co-valedictorian Bailey DeFere pirated her speech, but in a good way, donning a pirate hat and comparing life to the “Pirates of the Caribbean.” She noted that the film is about navigating the high tides of life, and for SCHS students, that includes late-night cramming for exams, music rehearsals, sporting events and time with friends — not to mention juggling all those things at once.

“Just like Jack (Sparrow), we found our crew — our classmates, teachers, coaches, friends and family who have supported us, challenged us and helped us become who we are today,” DeFere said. “We learned that success isn’t about going through life alone. It’s about leaning on each other when times are tough and, more importantly, celebrating each other’s victories.”

The “next great adventure” — whether it’s college, the military or the world of work — is similar to being a pirate, as well, according to DeFere.

“Remember, not all treasure is silver or gold,” she said. “The real treasure we found is in the friendships built, the memories reflected on, the wisdom gained. It’s even in the dreams we had to chase. We must keep a weathered eye on the horizon, for it represents the future, the unknown and the promises waiting to be seen.”

cluding McLaughlin, as non-recoverable.

In June 2019, DPAA personnel exhumed the 12 Schofield Barracks Unknowns from the Punchbowl for analysis.

To identify McLaughlin’s remains, scientists from DPAA used anthropological analysis, as well as circumstantial evidence. Additionally, scientists from the Armed Forces Medical Examiner System used mitochondrial DNA and Y-chromosome DNA analysis.

McLaughlin’s name is recorded in the Courts of the Missing at the Punchbowl, along with the others who are missing from WWII. A rosette will be placed next to his name to indicate he has been accounted for.

A narrative in McLaughlin’s personnel file indicates that the Japanese destroyed the Hawai-

the ground. Others tried to get planes into the air. By then though, the attack was over.

Ninety-one men died at Hickam Field that day. McLaughlin was killed during the attack on Hickam Field, but the exact circumstances of his death are unknown.

McLaughlin will be buried in Shawano on a date yet to be determined.

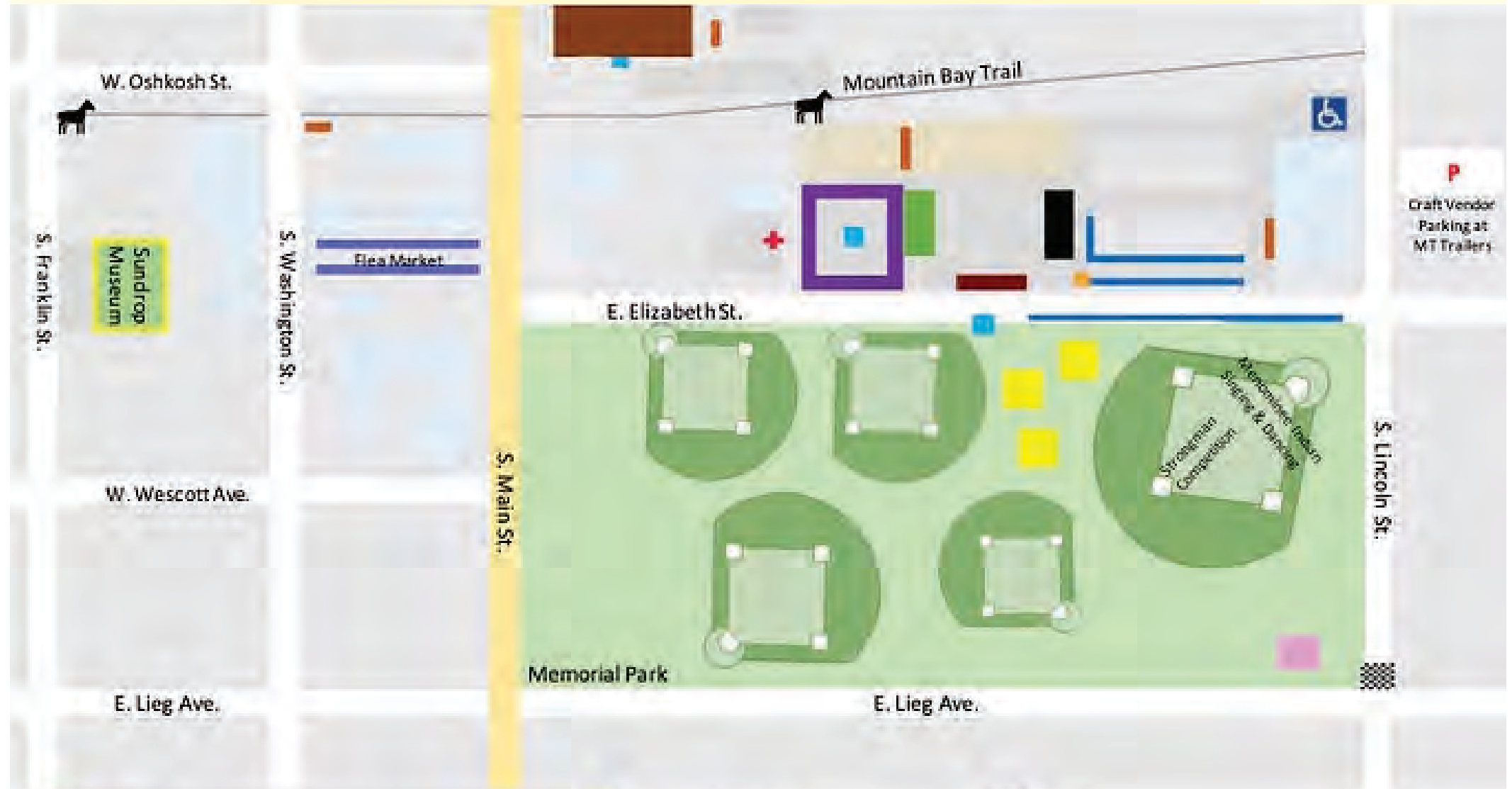

Starting out slow, Floyd would sell a case of soda and buy his family a loaf of bread.
