Local bar part of Wisconsin's Elite Eight

What's so special about Straight Home Bar & Grill? Apparently, it's their burgers. Amanda and Drew Schmidt have owned Straight Home for eight years, and for the past seven years have won several categories from Best Bar, Best Happy Hour and Best Wittenberg in the yearly readers' poll of the Wittenberg Enterprise & Birnamwood News.

Last year, they were also nominated to a new contest created by the Wisconsin

Beef Council and found themselves in the Elite Eight of Wisconsin's Best Burger Contest. Although they did not take home the trophy for Best Burger, this year they are back in the inner circle of the Elite Eight hoping to get the trophy and bragging rights of coming in first place.

Tammy Vaassen, executive director of Wisconsin Beef Council, said the contest is based off a similar one in Iowa and fits in well with its mission to grow demand for beef.

"May is Beef Month, and the trophy will be awarded to the winner on May 1," Vaassen said. "There is no monetary prize

to go with the title, but it's a pretty cool burger trophy."

The Wisconsin Beef Council is funded by farmers to increase awareness of the benefits of beef from consumer to grocery stores and restaurants. They also work with dietitians and others in the health care field to make sure they understand the value of beef in a healthy diet.

To be eligible for the contest, the bar needs to be nominated between Feb. 21 and March 21, it needs to use an all-beef patty, and the bar needs to be open all year long in a set location.

After the Elite Eight is chosen, the Wisconsin Beef Council sends out secret judges to make the determination of

Catholics prepare for new pope

The Rev. Edward Looney, pastor of Sacred Heart Catholic Church in Shawano, joins the other 1.4 billion Catholics across the globe in praying for the soul of Pope Francis, who died April 21. He was 88.

"I had gone to bed the night before thinking about him after seeing him on the news make an appearance in the papemobile," Looney said. "I thought what a wonderful recovery he's made and what stories he would tell about it in the future."

"When I woke up at 4:30, I was really shocked and surprised. Social media was flooded with stories."

Looney said he expected direction from the Green Bay Diocese on any special Masses or prayers to be scheduled for the late pontiff.

"We, of course, are in the beginning of the Easter Octave, so I'm not sure how that is handled with the planning of the Holy Father's funeral," Looney said.

The Easter Octave is a period of eight days, beginning with Easter Sunday and ending on the following Sunday (Divine Mercy Sunday), which are celebrated as solemnities of the Lord. Each day of the octave is treated as a mini-Easter, with special readings and prayers focused on the Resurrection of Christ.

"The church will enter a nine-day period of mourning," Looney said April 21. "Pope Francis made some modifications for the funeral of a pope, but he will lie in state."

Looney said many friends of his were due to travel to Rome for the April 27 canonization of Carlo Acutis, a British-born Italian teenager, who would become the first millennial saint.

However, that canonization has since been postponed, according to the Vatican.

"Now, many will still travel to Rome but to pay respects to Pope Francis," he said.

Following the funeral of the pope, the church's cardinals will gather for a conclave to select the new leader of the Catholic church.

"There will be a week or so of meetings beforehand when the cardinals will discuss issues and concerns before the conclave begins," Looney said.

To select the next pope, the cardinals will vote in secret four times each day until a candidate gets the necessary two-thirds majority.

marketing businesses, he started A&W Farms and Potato World Packaging in the late 1970s with industry friends.

He served on many potato industry boards at both state and national levels, including the Wisconsin Potato and Vegetable Growers Association and the United States Potato Board. Jerry also used his entrepreneurial skills and keen financial knowledge to expand into the banking industry. Ultimately becoming involved with several community banks, particularly First Southeast Bank, located in rural Minnesota, serving the agricultural industry in that area, once again bringing Jerry's love for the farmer into full view.

Jerry is survived by his loving wife, Barbara; his children, Derrick

(Tammy) Bushman, Bevent, Mitchell (Dawne) Bushman, Bevent, and Tia (Paul) Go, Plymouth, Minnesota; grandchildren, Nicolas (Stephanie) Bushman, Taylor Bushman, Madison Bushman, Maverick Bushman (fiancé Nina Galang), Lauren Bushman and Raphaela Go. which burger will be declared the best in Wisconsin. The judges get to chose which burger, on the menu, to try. Considerations include

flavor, appearance, correct temperature and bar atmosphere. The contest rules state that once you win the top honor, you can never win

again. You can, however, always be nominated to the Elite Eight. "Because the contest covers the whole state, we get a lot of business

off the nomination," Amanda Schmidt said. "Even last year our business was raised considerably from those who heard about it."

She also noted that customers came from Illinois, Michigan and Minnesota because of the contest.

"By far, the top burger is the Wisco Beer Burger, which includes Nueske bacon, American cheese, beer cheese and cheese curds served on pretzel bun," Amanda Schmidt said.

She prefers the salty, sweet combo of the Apple Maple Bacon Burger which features Nueske bacon, Swiss cheese, topped with an apple bacon maple jam.

She always features Nueske bacon and feels it's worth the price, and it's a local business. The buns are made fresh twice a week by the in-house

bakery at Wittenberg Sentry Foods. They also make the rye bread for the Friday fish fries.

"Sometimes it's still warm when we pick it up," Amanda Schmidt said. "People really like that rye bread."

Amanda Schmidt cooks and her husband, Drew, tends bar, covering most of the work at this business they purchased with Drew Schmidt's parents, Sue and Steve Schmidt. By expanding the menu with specialty burgers and expanding the Friday fish fry options, they doubled their business in the first two years and then tripled it after that. They added staff due to the popularity of the burgers. Most of the staff have been with them more than five years, which helps add to the consistency of the food and service.

"Kathy Kristoff, who cooks on Friday, has been

here the whole time, having worked for John for 30 years," said Amanda Schmidt, who is allergic to fish.

John Wolff owned the bar, then called Wolff's Den, for 42 years before retiring and selling to the Schmidts. He was well known for his Friday fish fries and old-fashioned. Amanda Schmidt kept his recipe for beer batter, coleslaw, potato salad and tartar sauce.

Straight Home Bar and Grill is located at 184060 State Highway 153 in Elderon and is open Wednesday and Thursday at 4 p.m., Friday at 11 a.m. and Saturday at noon. The kitchen closes at 9:30 p.m. On Sunday, they are open from 9 a.m. until 2 p.m. serving breakfast and lunch and featuring a "build your own Bloody Mary bar."

Sheriff prepping for new communications contract

Officials weighing options offered through Motorola

A new 10-year contract between the Shawano County Sheriff's Department and Motorola is in the works, and it could mean significant changes on the back end.

"The new contract would move us over to a system that Motorola would technically own and operate as part of WIPSN (Wisconsin Public Safety Network). Currently we own the 'core system' of our radio, referred to as a K-Core system," Lt. Chris Madle said.

"The new contract would switch us over to a M-Core system that Motorola would technically own, and we would operate on this network within Shawano County. There would be obvious updates that would come to some of our current equipment to make everything functional on the new system."

Equipment covered under the current contract, signed in 2018, includes dispatch console equipment (the equipment used at each dispatch position), as well as equipment housed within the radio room at the sheriff's department and some tower equipment.

"This equipment is what we would call the backbone of our system (K-Core). It

is the meat and potatoes of what makes everything work together," Madle said. "All of our portable radios for officers and squad radios are purchased separately and then programmed to our radio channels."

The current contract will expire in 2028, but officials want to get an early start on negotiations for a new deal.

In 2025, the sheriff's department will pay about \$154,000 for the operational and maintenance costs of the radio system. By the end of this contract in 2028, the cost will be about

\$174,000 for the year.

"The reason we started to look at this contract at this time has been due to other contracts we have with Motorola for things such as our body cams, squad cams and dispatch systems," Madle said. "We want to have a long-term plan for the future for all these contracts. We have been told as a department to plan for and look to the future and not just operate year to year."

The department received pricing from Motorola on a new 10-year contract that provided

some cost savings long term, on the contract cost itself.

"There were some other costs that were brought up at a later time by Motorola for equipment that made us hesitant on the whole picture of this project," Madle said. "There is also a substantial 'implementation cost' that would need to be paid, but long term, based on the projected amounts they gave us to continue our current contract past 2028, the new contract would save us approximately \$20,000 per year."

While there are other

companies out there, the sheriff's department is sticking with Motorola.

"They have by far the best radio communication equipment, and with the rural side of our county, it is vital to have high functioning equipment to ensure communication between dispatch and our first responders," Madle said. "I don't want to bash other department or companies, but some other local agencies do not use Motorola and it is very apparent on the radios."

The department has numerous other contracts

with Motorola, so officials are trying to get everything wrapped up into one long-term plan.

"We will still need multiple contracts as they are for different things, but we want a long-term plan for all these contracts together instead of just looking at them the year before they become due," Madle said.

The make or break of this contract will be the "extras" the sheriff's department would be able to take advantage of with the WIPSN system.

"The actual cost of the base contract itself isn't anything to balance or overcome. But on this new system, we would be able to take advantage of higher functioning portable radios, which would provide a huge safety benefit to our officers and the community," Madle said. "These radios obviously come with a cost, but I feel it would be in our best interest to take full advantage of all these radio capabilities for our officers and community."

"There is also a significant implementation cost. Both of these items we would seek grant funds for, but grant funds aren't guaranteed. So we would still need the funds in case grant monies aren't obtained."

There are other hurdles, but cost is always the big one to overcome. Aside from some of the additional costs, there are many benefits to this switch if it were to happen, Madle said.

Shawano School Board purchases 33 acres of land

Land could be used for future middle school

A special meeting of the Shawano School District electorate April 14 paved the way for the Shawano School Board to purchase 33.58 acres of land near Shawano Community High School that could be used in a few years as the new home for Shawano Community Middle School.

The age of the existing school, built in the 1950s, is making it more expensive for the district to keep the building together and operating, and officials had briefly considered including it in the 2024 referendum that failed in April 2024 but passed in November. However, survey results showed more favoritism for Shawano Community High School expansion and upgrades at the other three schools. With results indicating a \$70 million referendum was the high-

est voters would go for, and the expected price tag for a new middle school being around \$55 million, that project was put on the back burner.

The board approved purchasing the Magee Family Farm, located at W4742 state Highway 22 in the Town of Belle Plaine, for \$550,000 and using its fund balance to pay for the land. Superintendent Kurt Krizan told the board that

the purchase would still leave about \$11.5 million in its fund balance.

"We are really looking at this as an opportunity for investment of our fund balance," Krizan said. "We are sitting at a place right now where our district fund balance, our savings account, is at a healthy place and looking at options to invest for future use."

The school district had previously looked at

buying 20 acres of land owned by Mike Zingler and his siblings for \$531,000 in December, but members of the electorate voted 15-10 against the proposal. At the April 14 meeting regarding the Magee land, the electorate was unanimous in its approval.

Krizan said that home values in the area have doubled in the last 10 years, and if that trend holds, the land could be extremely

valuable to the district if, for some reason, it decides to sell the land instead of using it for a new middle school. Comparatively, investing the district's fund balance in CDs has only increased funding by an average of 0.5%, he said.

"We're looking at using the land for a brand new building or to replace our existing middle school," Krizan said. "Really, we're at no opportunity right now to grow in the district, so having that growth opportunity is well."

Krizan noted that any plans to build a new middle school won't be finalized until 2031. He also said that the money in the fund balance to purchase the Magee land is coming from surpluses in budgets from the past two school years, and the fund balance will still hold the equivalent to 33% of the district's annual budget.

Brian Magee, spokesman for the family, said that he and several siblings own the existing land and are interested in seeing it turned into a school in the future.

"I think our parents would be very happy," Magee said. "When they left

it to us, they hoped it would potentially have a school on it someday or be used by the school district."

Magee noted the \$550,000 selling price is similar to what farmland is currently being sold for, and the family wants the school district to be on the land.

"It's a very solid thing for the future, for our kids and grandkids," Magee said.

Marcia Yaeger, former school board member, praised the idea and noted that the district didn't have such an opportunity available to it when the board made plans to build Hillcrest Primary School more than 15 years ago. The school is on Waukechon Street, away from the closer proximity of the three remaining schools on Union Street and County Road B.

"It's a great move, because you never know what the future is with land," Yaeger said. "We didn't have the opportunity because we didn't get the land we wanted to get. I think this is a great option for the school district right now. Once it's gone, it's gone for good."

Tariff shakeup of markets impacting school bonds

\$27.3M gets approval from Shawano School Board, but closing date to be determined by when interest rates stabilize

The turbulent stock market shifts from the Trump Administration's tariff implementations have found a way to impact the Shawano School District's capital referendum projects.

The Shawano School Board voted unanimously April 14 to approve over \$27.3 million in bonds to help pay for construction and renovation projects at the public schools over the next two years. The bonds would be paid back over a 20-year period, with a maximum interest rate of 5.25%.

That interest rate is not what officials wanted, however, according to business manager Bryan Kadlec.

"We thought we had a great opportunity when the markets were really pretty stable," Kadlec said. "As you know, the stock markets took a little interesting turn here. Thankfully, we have some flexibility because of the fact that the district's reorganization is in May, and we have a later closing."

Eric Kass with PMA Financial Network noted that the deadline to close on the bonds is May 22, and

the district has the option to enter the stock market with the bonds by the end of April. He noted that the first set of bonds approved had an interest rate of 3.8%.

Kass said that he'd discussed with the district's finance committee about "executing the competitive sale" on the day of the school board meeting and presenting board members with final resolutions and rates at the meeting.

"Unfortunately, last week hit, and we needed to take a little bit of a pivot," Kass said. "The stock market took a plunge. Normally, when the stock market drops, we see municipal rates drop equally, but we saw the inverse, and what that tells us is a lot of people that normally would look at the stock market dropping and flood into fixed-rate investments like tax-exempt securities like the one we're talking about this evening, but we didn't see that. Popular opinion is a lot of people are sitting on cash, not knowing exactly what's going to happen."

There's been a 90-day pause on the tariffs until July, which is generating a lot of buzz as 150 countries

are expected to be impacted, according to Kass. He said trying to lock in interest rates while the stock market is so volatile can be a risk.

The turbulent markets have also prompted a lot of people to pull back on their investments, Kass said, so it's best to take a little time to see if interest rates improve.

"We're going to try to meet your obligations of cash flow, maintain the levy that we're projecting out," Kass said.

Previously, the school district had closed on over \$14.7 million in bonds at the end of December 2024. Almost \$10 million in bonds is expected to be approved in the future.

Kass said that, in the worst case scenario, the district could use the \$14.7 million already authorized to pay for projects happening over the next few months, although the money was supposed to be gaining interest to help give the district a start on repaying the debt. The \$27.3 million would not be authorized until interest rates stabilize.

Boardwalk to be built at lake in Belle Plaine

A 2,000-foot boardwalk near Pine Lake in the Town of Belle Plaine is in the works on land owned by the town.

Town officials received approval from the Shawano County Board of Adjustment on April 10 to move forward with the proposal.

A crushed limestone walking path, compliant with the Americans With Disabilities Act (ADA), will be built from the wetland boardwalk to the west side of the island between Grass Lake and Pine Lake.

This new addition will measure 2,025 feet in length, 5-6 feet wide and 2-4 inches deep.

"It will begin at the end of the boardwalk, will cross the isthmus, follow the shoreline on the east side of the island past the steep hill, then cut inward and continue to the boat dock/monument area," according to the application for vari-

ance filed with the county. "The path will then continue inland to the west and north to an elevated viewing/turn-around area on the west side of the island. (A total of) 1,030 linear feet of this path will require a variance permit."

Alvin Bartz, town chairman, told the board the project would improve handicapped access to the island, shore up the eroding isthmus and alleviate the erosion of the current walkway.

Shanda Hubertus, Waterways Association of Menominee and Shawano Counties (WAMSCO), said the ADA-compliant boardwalk would provide access all the way to the boat dock.

Bartz said most of the trail is 75 feet from the ordinary high water mark of Pine Lake, but due to topography, there is a portion of the trail that is currently 4 feet from the high water mark.

County regulations

require the project to be at least 75 feet from the ordinary high water mark of the lake unless a variance is granted.

The isthmus shoreline on Pine Lake will require new riprap along 450 feet of shoreline. Woody native vegetation will be planted within the riprap.

Additionally, a 790-square-foot area on the eastern hillside will be planted with deep rooting native plants to stabilize the hill from erosion and washouts.

The land is a 19.93-acre island with an isthmus leading to the property with access from Cloverleaf Lake Road. There is an additional 5.67 acres of land adjoining, immediately to the west.

The trail area is already compacted by foot traffic by the general public. The cursed limestone would benefit those who use electric wheelchairs or scooters.

Shawano is celebrating 31 years as a Tree City USA national member and a 13th year Growth Award. The city is also celebrating its 22nd year as a Tree Line USA award recipient with support of Shawano Municipal Utilities. Patricia Lindquist, Wisconsin Department of Natural Resources regional representative, will present the awards to the city.

In this show, it's all about the sauce

Twin brothers star in 'Spaghetti Western or Mission Im-pasta-ble'

Audiences should not expect anything mellow about the melodrama "Spaghetti Western or Mission Im-pasta-ble," which Pulaski High School will be performing the last weekend in April.

In this show, audiences find Grannie Smith and her granddaughter, Petunia Pearl, running a restaurant and hotel with the fun name of the Hoot 'n' Holler, but they're behind on the mortgage, which is held by the dastardly Duke Dreadful, who plans to take it from them with the assistance of his dear Saucy Sally. While the hero, Kirk Ketchum, and his sidekick, Harriet Holdem, are doing their best to lead the effort to save the business, Grannie and Petunia decide to enter a spaghetti sauce contest in the hopes of winning the prize money and getting out of debt.

The show is family friendly, which means that all audiences should get a kick out of it.

While melodramas are entertaining enough on their own when reading the script, the PHS show has an additional twist with the hero and villain being played by twin brothers Cooper and Hayden Witte.

"This might be my experience talking, but I feel the production is going very smoothly," said Cooper Witte, who plays Kirk. "I like a lot of the humor that is displayed within the play, and I really like the people I am cast with."

He finds it interesting to be facing off against his brother in the show.

"It was a thought that popped into my mind when I first saw the casting for the play, and it had come to realization that me and my brother were really two of the only senior boys with a lot of experience under our belts, and there was going to be a specific male lead and a specific male villain," Witte said. "I didn't think that it was going to happen. Being able to perform as a lead with my twin is just another experience I don't think I'll ever be able to forget."

Amy Tubbs, the show's director, noted that "Spaghetti Western" is a newer show in the pantheon of theater productions, and she liked the pasta theme.

"That was not a theme we had for a melodrama yet," Tubbs said. "We just thought it would be something different

and something fun, and it has been."

In the tradition of far-out names and characters, Tubbs said the show has a dirty character named Dusty, whose sauce has a raccoon tail and tree branches in it. However, it might not be a match for the sauce Grannie and Petunia come up with, which has a secret ingredient, especially after Duke Dreadful sells Dusty some snake oil that makes his sauce less than palatable.

"It's a melodrama, so everyone's got to go down," Tubbs said.

Greater prairie-chickens booming once again

I cringe as I set my alarm for 4 a.m. I am not a morning person, but on the rare occasion when the benefit far outweighs the unwelcome blare of my alarm clock, I make the sacrifice. In this case, there was no doubt that it would. I hope to witness one of the most remarkable displays in all the birding world — the early morning “booming” of the greater prairie-chicken.

The adult male greater prairie-chicken is a barred brown-and-white chicken-like grouse with a small head, rounded wings and short tail. He doesn’t sound very interesting, but for a few weeks in the spring, when the male wants to establish his territory and attract a mate, he is nothing less than spectacular. With his head low and wings held stiffly by his side, he clicks his tail and raises ear-like plumes on his head. Then he blows up bright orange air sacs on his neck, transforming himself into a dazzling performer, all the while drumming with his feet in double time.

When the orange air sacs inflate, they produce a booming vocalization that can be heard up to a mile away. It is a resonant three-noted “who, who, whooooo” along with whoops and cackles. Males clash relentlessly at these gatherings, chasing each other, leaping into the air and striking with wings, feet, and bills. As they pass, females they perform “flutter jumps” — leaping into the air while flapping their wings, all part of their courtship display.

The booming ground

where the males “perform” is called a lek. Leks usually are on higher ground and have little to no vegetation. During the courtship displays, only a few males, mostly experienced older males, are accepted by females for mating. The males with the largest eye combs, longest legs and best territories (nearest the center of the booming ground) appear to have the best breeding success.

No pair bond is formed during mating. While the

female proceeds to select nest sites and rear young, the male continues his spirited ceremony to charm more females. After the breeding season, they all gather in flocks.

Greater prairie-chickens are non-migratory. In winter, they create horizontal tunnels in the snow which insulate them from the freezing temperatures. Feathers on their legs and feet help keep them warm. During winter months, they can be observed perched in trees feeding on buds.

The greater prairie-chicken is listed as a threatened species in Wisconsin. According to the Wisconsin Department of Natural Resources (DNR), the statewide population of

this species has decreased dramatically over the last 50 years. This year, the DNR reported 288 male prairie chickens on 37 leks. These leks are primarily located on four state-owned properties in central Wisconsin, with a majority concentrated on the Buena Vista Grasslands.

The Wisconsin DNR manages over 30,000 acres as greater prairie-chicken habitat. They have written a 10-year greater prairie-chicken management plan in cooperation with the greater prairie-chicken advisory committee and approved by the Natural Resources Board. The Society of Tympanuchus Cupido Pinnatus, scientific name for greater prairie-chicken,

is a nonprofit organization also dedicated to protecting prairie chickens.

Threats to our Wisconsin greater prairie-chickens include habitat loss and fragmentation as well as a new threat, a 7,109-acre solar project planned to directly adjoin the Buena Vista Wildlife Area grasslands. The project will be four times larger than any previously approved solar facility in the state and will be the second largest solar project in the nation. While many conservation groups support solar energy, they oppose how close the project will be to the greater prairie-chickens and their habitat.

Jim Keir, a former 20-year Buena Vista Wildlife

manager and DNR prairie chicken expert, stated: “In my professional opinion, the current greater prairie-chicken population is alarmingly low, and any significant negative impact to the birds and their habitat may be the tipping point that leads to endangerment and extirpation from Wisconsin.”

Birdwatchers from around the world travel to Wisconsin in April to attend the Central Wisconsin Prairie Chicken Festival. The festival includes birding tours, observation blinds, nature walks and exhibits. While the festival has already taken place this year, you can still enjoy seeing prairie chicken videos on the Wisconsin Prairie Chicken Festival YouTube page. UW-Stevens Point also offers prairie chicken tours and information at <https://www3.uwsp.edu/wildlife/pchicken/Pages/default.aspx>.

When my alarm buzzes in the dark of night, I rise without hesitation and drive to central Wisconsin. As a sunbeam peeks over the horizon, I begin to make out chicken-like birds with wings stiff, tails clicking and ear plumes erect suddenly breaking the silence with the beating of their feet. Like little orange suns appearing across the prairie, their air sacs inflate with a “who, who, whooooo.” As their melodic booming fills the air, joy fills my soul. Let the show begin.

Planting trees can make difference for communities

Trees provide many benefits to the environment and our health and well-being. These long-lived members of our landscapes and communities provide shade, help reduce energy costs, clean the air we breathe, prevent soil erosion and stormwater runoff, and attract and provide homes for birds and pollinators. National Arbor Day, celebrated on the last Friday of April, recognizes the important role trees play in our environment.

Spending time among the trees also helps boost our immune system. Studies reveal that tree-filled landscapes help decrease domestic conflict, as well as aggression and violence at schools. A mindful walk through the woods, known as forest bathing, helps reduce blood pressure and stress. It increases focus and energy levels, improves sleep and much more.

When planting new trees, make sure to select

one that will fit in the space when mature and thrive in the growing conditions. Plant tags and catalog descriptions can provide you with this important information. Consider including trees that provide multiple seasons of beauty with flowers, fruit, fall color and form. Look for those that also support birds and pollinators as they deliver many other environmental benefits.

Select a planting location away from overhead and underground utilities to avoid future conflicts. Avoid plants that eventually could grow into wires or structures that may interfere with utilities and power transmission, creating a real hazard.

State at least three business days before putting the first

shovel in the ground. When your request is received, this nonprofit group contacts all the appropriate underground utilities. The utilities’ locators will then mark the location of the underground utilities in your work area. Contacting them first reduces the risk of injury, the inconvenience of accidentally knocking out power, cable or other utilities, and the potential cost incurred to repair a utility you damage when skipping this step.

Once the location is cleared, you’re ready to start planting. Locate the tree’s root flare (where the roots curve away from the trunk) by gently pulling the soil away from the trunk as needed. Dig a hole two to five times wider and the same depth as the distance from the root flare to the bottom of the root ball. Set the tree in the hole, carefully remove it from the container and loosen or prune off any circling roots. Cut back burlap and

wire baskets when planting balled and burlapped trees.

Plant the tree so the root flare is even with or slightly above the soil surface. Roughen the sides of the hole and backfill with the existing soil. Water thoroughly and spread a 2- to 3-inch layer of mulch over the soil surface, keeping the mulch away from the tree trunk.

Continue watering throughout the growing season, the following year and as needed once established. Check the soil moisture and thoroughly water the root ball and surrounding soil when the top few inches of soil are crumbly and slightly moist. Apply 10 gallons of water for every inch of the trunk’s diameter at 4 1/2 feet high.

The show includes a fight scene between the hero and villain and the hilarious scene with a batch of dynamite, which are staples in many melodramas. There is also the threat of tying someone to the railroad tracks, although it is not seen on the stage.

"They're doing a great job," Tubbs said, referring to the student actors. "They're creating some really awesome characters

"I think melodramas let them be more physical in

their roles, because everything is really exaggerated," Tubbs said. "You don't do a dainty trip; you fall flat on the floor. Everything is just big and bold and ridiculous. That's more fun for them, because it's so silly."

Tubbs noted that having twin brothers in the show also adds to the fun.

"I don't think I've ever had that before," she said. "It's not quite an evil twin thing, but it kinda is."

Evie Decker, who plays Saucy Sally in the show, enjoys being able to perform the bad girl role.

"When I got the role, and the cast list came out, I was really excited because I've always wanted to play a villain," Decker said. "I've never played a bad role before, so figuring out the ins and outs of the character, what she wants, what drives her, that's been really exciting."

Decker said she enjoys the western style of the show and listening to her fellow actors' accents.

"All of the characters are really different," Decker said. "I really like it."

Besides the main show, the student actors have written several skits to be performed at intermission with a pasta theme, including one with vampires.

Milwaukee, and Box in the Wood will be the first troupe in Wisconsin to perform it.

“She’s fairly local,” Demaskie said. “Her publishing company’s on the border of Wisconsin and Illinois. It’s a fairly new show, too. It was written in 2022.”

Demaskie added that Beverly, one of The Bean Shack’s customers, was specifically designed to be a Midwestern woman, but a lot of the characters have the Midwestern accent that everyone knows and loves.

“That’s all in the script, too,” Demaskie said. “I think it’s been fun.”

Choosing a murder mystery was an easy decision for Demaskie, who was part of a classic mystery for Box in the Wood a few years ago.

“I really wanted to do a murder mystery in general,” Demaskie said. “Murder mysteries are my favorite genre. I was in ‘And Then There Were None’ (by Agatha Christie) when we did it, and that’s my favorite play of all time. As soon as I knew I was directing something, I wanted to do a murder mystery, and my assistant director showed me the show.”

Demaskie said that audience members won’t have to worry that the show’s limited to one corpse on the stage.

“In ‘Café Mocha Murders,’ people start dropping,” Demaskie said. “Starting with Steven. We

don’t know what happened to Steven, and we’re not talking about Steven.”

Despite the spectre of death that hovers over all murder mysteries, Demaskie feels that “Café Mocha Murders” will touch audience members’ hearts.

“Even though this show is a murder mystery, I think it has a lot of heart, and there’s a good message to it, and there’s a lot about family and camaraderie,” Demaskie said.

As part of marketing efforts, Demaskie and her crew did an interview with Strasse to get her take on why she wrote the play. In the interview, Strasse reiterates the “heart” of the show.

“She never really wanted to write a comedy,” Demaskie said. “That wasn’t really her deal. She liked the dramas with a lot of intricate, inter-spliced characters, but people just kept telling her. ‘Write us a comedy. Write us a murder mystery.’ So, she decided to write this, and she was very adamant that she wanted to include a moral, a message, something for the audience to take away, and I think she did a really good job with that.”

Having that moral in place makes putting together the show — whether its the lights, the set pieces or the actors’ performances — a piece of cake, according to Demaskie.

“It really helps you with designing the show,” she said. “If you know what you

want the theme to be and you know what you want the audience to take away, you can make sure that, from everything from how people do their characters down to how we build the set, you can make sure that everything encompasses and helps drive home that moral.”

To that end, one set piece might be very familiar to Shawano residents. The bar where the cast makes their coffee concoctions was obtained after Angie’s Main Café closed a few years ago. Demaskie further created the warm coffee shop feel by getting furniture from the Habitat Restore, which included a table in the shape of a coffee cup.

Another unusual step with the show is VIP seating at some tables that are part of the set, allowing some audience members to be immersed in the show.

The excitement for the show is not limited to the director. Jennifer Maglio, who plays Beverly, likes how the cast has been able to bond with the playwright, something atypical in most shows because the writer is either far away or has passed.

“I like how excited the writer is for this particular performance because she’s from Wisconsin, but this hasn’t been played in Wisconsin,” Maglio said. “Her family hasn’t seen it yet, and she’s so excited that it’s being played near her family for the first time.”

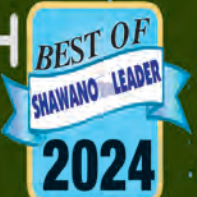

DNR spring hearing in Shawano re-elects CDAC delegates

There were few fireworks or discussions April 14 during the Shawano County spring hearing hosted by the Wisconsin Department of Natural Resources and state Conservation Congress.

A total of 13 people attended the annual hearing at Shawano Community Middle School, according to Duane Beyer of Shawano, who was re-elected to a two-year term as chairman of the county's five-member Conservation Congress. Mark Conradt of Shawano was re-elected to a three-year term as vice chairman.

Beyer and Conradt hold the same posts on Shawano County's Deer Advisory Council, which will hold its next meeting at 7 p.m. April 29 in Shawano Community Middle School. Other county delegates are Andrew Heinz and Bob Bohardt of Shawano and Mark Heidemann of Marion.

The council determines how many free antlerless deer tags are issued for each paid archery and gun deer tag. They also determine whether they want the county to maintain, increase or decrease the deer population. In virtually all Central Farmland Zones, because of continually growing herds, most CDACs choose to maintain or decrease the herd.

Those attending the 72 hearings (one in each county) were al-

lowed to vote in person on ballots that covered a variety of DNR hunting and fishing management questions, as well as topics for the Natural Resources Board and Conservation Congress. None of the votes (other than delegate votes) are binding but serve to advise the state and Conservation Congress about the views of sportsmen and other wildlife lovers. Residents also could vote online for three days.

Results will appear at <https://dnr.wisconsin.gov/about/wcc/springhearing>.

Topics that probably most interest Shawano County and surrounding residents include a plan to reduce the overall daily panfish limit from 25 to 10 on Shawano Lake and dozens of other lakes in the state, allowing CDACs to extend the archery season to Jan. 31 even if they do not authorize a Holiday Hunt (antlerless only hunt during the Christmas holiday), using technology like cellular trail cameras to monitor

traps, allowing fall turkey hunting in northern Zones 6 and 7 and requiring bear baits on public land to be labeled with a person's name and address or DNR number.

Beyer said he welcomes the chance to offer an extended bow season without necessarily offering a Holiday Hunt. Some landowners who hunt their own property may not welcome a Holiday Hunt, because they can't shoot bucks during their last few days of bow or crossbow season. Beyer noted that several snowmobile clubs have fought against the Holiday Hunt, because they need to log trail maintenance hours to obtain state funds but may be doing so during the last week in December. He added that although some snowmobilers didn't want hunters in the woods while they rode trails, poor snowfall during most of the past 10 winters doesn't support that argument.

He encouraged those of all interests to attend the April 29 CDAC meeting and share their thoughts.

One topic not on the spring questionnaire is the state's process of distributing spring turkey tags. This is one of my hot-button topics for several reasons. First, with today's computerized processing that can do thousands or

even millions of data computations in seconds, why are we still applying for turkey tags by Dec. 10? Since I buy a patron license every year, I am applying for my 2026 tags in March or April of the previous year. That's the way it works. But most of us are not thinking about turkey hunting in December, and it's easy to forget to apply.

What boggles my mind is the number of surplus tags left for the bonus tag sales in mid-March. This apparently got the attention of DNR conservation warden Jake Donar, who is also a member of the DNR Turkey Advisory Committee.

According to a Milwaukee newspaper, Donar told the committee April 2 that many hunters were having trouble drawing their first or second choice.

Donar's questions prompted the DNR to analyze license data from 2022 to 2024, which revealed an astounding fact: an average of 26% of those drawing a tag never purchased them. The DNR has speculated that some hunters may not be able to hunt on the season dates they originally drew, but the long lag between notification of getting drawn (usually in December or January) and the turkey season is likely a factor, too. Some hunters may simply forget they drew a tag

and just buy one during the bonus tag sales. Or some patron license holders may apply for a turkey tag even if they aren't sure they will hunt (because the application fee is included in their licenses).

The DNR is now considering a complete revision of the process.

Legislators want state funds for safety during draft

Local legislators are making a pitch for the state to help pay for some of the safety needs associated with the NFL draft taking place in Green Bay on Aug. 24-26.

“Ensuring the success and safety of an event of this size requires an enormous amount of public resources,” said state Rep. David Steffen, R-

Howard. “As about 2/3 of the estimated \$96 million economic benefit of this event occurs outside of Green Bay, it’s appropriate for the state to cover a portion of the costs, especially relating to public safety.”

The vast majority of the more than \$10 million in hosting-related expenses are being covered by businesses, sponsors and the Green Bay Packers. However, many of the costs associated with core services such as safety and

sanitation are the responsibility of local and county government.

Steffen and state Rep. Ben Franklin, R-De Pere, are seeking \$1.25 million through the state budget process to be directed to the Ashwaubenon Public Safety Department (\$75K), Brown County Sheriff’s Department (\$500K), Green Bay Police Department (\$475K) and Green Bay Metro Fire Department (\$200K). It is estimated that these

allocations will address approximately two-thirds of anticipated public safety expenses associated with the draft.

At this time, police protection will most likely be handled by Brown County personnel, and they have not reached out to surrounding counties or departments.

“I have heard they plan on staffing the event with Brown County agencies only,” Shawano Police Chief Michael Musolff

said. “At this time, the Shawano Police Department was not asked to assist.”

Shawano County Sheriff George Lenzner said his deputies won’t be there either, unless there is an emergency request.

“There was talk of them asking for our assistance months ago; at that time they could not guarantee that our officers would be reimbursed for their time,” he said. “I feel with our size of department that

we really don’t have the manpower to send over to Green Bay anyway. I think we will be busy enough around here to keep our own people busy.

“As usual, if an emergency situation occurs and they request mutual aid, we will do whatever we can to help them out.”

Steffen said the state expects to collect at least \$4.5 million in sales tax revenue from the draft.

Protect voting rights by opposing 'safeguard' act

To the editor:

Millions of Americans could be forced to jump through new hoops just to cast a ballot next year if the U.S. Senate passes the Safeguard American Voter Eligibility (SAVE) Act. The House of Representatives has already passed this act. Wisconsin voters must presently show a legal ID to vote, but this bill would additionally require proof of citizenship.

This is a dangerous step toward voter suppression. The new law could block millions of eligible voters from voting. Despite inten-

sive scrutiny, non-citizen voting (fraud) has not been demonstrated to be a significant issue in our elections.

The bill would force voters in-person to provide proof of citizenship — like a passport or birth certificate — just to register or update their voter registration. It would especially burden military voters, survivors of natural disasters and married women who have changed their names. Eight in 10 married women have changed their surname, and don’t possess a birth certificate that matches their current legal name.

Rural voters, working class voters, voters of color, and disabled or older Americans are less likely to hold a

passport or accessible birth certificate, Tribal citizens would be unable to register using their Tribal ID alone, unless this included their place of birth in the United States.

Every time a voter moves, they must re-register to vote. Also, under the SAVE Act, voter online registration and mail-in registration would be banned as well.

Our freedom to vote is one of the most sacred in a democracy, and we must take action to protect it. Call Sens. Ron Johnson (202-224-5423) and Tammy Baldwin (202-224-5653) today and tell them to vote no on the SAVE Act.

TOWN OF WITTENBERG, Shawano County Pursuant to Wis. Stat. § 70.45, the assessment roll for the Year 2024 assessment will be open for examination **starting on the 21st day of May, 2025** by contacting the town clerk at (715) 253-3222, Tuesdays and Thursdays, between 9:00am - 1:00pm.

Additionally, the assessor shall be available at the Wittenberg Town Hall on the 21st day of May from 11:00am to 1:00pm. Instructional material will be provided at the open book to persons who wish to object to valuations under Wis. Stat. § 70.47.

Notice of Board of Review Two-Hour Meeting

a. Notice is hereby given that the Board of Review for the Town of Wittenberg, Shawano County, Wisconsin, shall hold its first meeting on **Wednesday, May 28, 2025, from 5:00pm to 7:00pm**, at the Wittenberg Town Hall. Please be advised of the following requirements to appear before the Board of Review and procedural requirements if appearing before the Board of Review:

b. After the first meeting of the Board of Review and before the Board of Review's final adjournment, no person who is scheduled to appear before the Board of Review may contact or provide information to a member of the Board of Review about the person's objection, except at a session of the Board of Review. Open book shall occur no less than 7 days prior to the Board of Review. The Board of Review may not hear an objection to the amount or valuation of property unless, at least 48 hours before the Board of Review's first scheduled meeting, the objector provides to the Board of Review Clerk written or oral notice of an intent to file an objection, except that upon a showing of good cause and the submission of a written objection, the Board of Review shall waive that requirement during the first 2 hours of the Board of Review's first scheduled meeting, and the Board of Review may waive that requirement up to the end of the 5th day of the session, or up to the end of the final day of the session if the session is less than 5 days, with proof of extraordinary circumstances for failure to meet the 48-hour notice requirement and failure to appear before the Board of Review during the first 2 hours of the first scheduled meeting.

c. Objections to the amount or valuation of property shall first be made in writing and filed with the Board of Review Clerk within the first 2 hours of the Board of Review's first scheduled meeting, except that, upon evidence of extraordinary circumstances, the Board of Review may waive that requirement up to the end of the 5th day of the session, or up to the end of the final day of the session if the session is less than 5 days. The Board of Review may require objections to the amount or valuation of property to be submitted on forms approved by the Wisconsin Department of Revenue, and the Board of Review shall require that any forms include stated valuations of the property in question. Persons who own land and improvements to that land may object to the aggregate valuation of that land and improvements to that land, but no person who owns land and improvements to that land may object only to the valuation of that land or only to the valuation of improvements to that land. No person may be allowed in any action or proceedings to question the amount or valuation of property unless the written objection has been filed and that person in good faith presented evidence to the Board of Review in support of the objections and made full disclosure before the Board of Review, under oath, of all of that person's property liable to assessment in the district and the value of that property. The requirement that objections be in writing may be waived by express action of the Board.

d. When appearing before the Board of Review, the objecting person shall specify in writing the person's estimate of the value of the land and of the improvements that are the subject of the person's objection and specify the information used to arrive at that estimate.

e. No person may appear before the Board of Review, testify to the Board of Review by telephone, or object to a valuation if that valuation was made by the assessor or the objector using the income method of valuation, unless no later than 7 days before the first meeting of the Board of Review, the person supplies the assessor with all the information about income and expenses that the assessor requests, as specified in Assessor's Manual Under Wis. Stat. § 73.03(2a). **Town of Wittenberg** has an ordinance for the confidentiality of information about income and expenses that is provided to the assessor under this paragraph that provides exceptions for persons using information in the discharge of duties imposed by law or the duties of their officer or by order of a court. The information that is provided in this paragraph, unless a court determines that it is inaccurate, is not subject to the right of inspection and copying under Wis. Stat. § 19.35(1).

f. The Board of Review shall hear upon oath, by telephone, all ill or disabled persons who present to the board a letter from a physician, physician assistant, or advanced practice nurse prescriber certified under Wis. Stat. § 441.16(2) that confirms their illness or disability. No other persons may testify by telephone unless the Board of Review, in its discretion, has determined to grant a property owner's or their representative's request to testify under oath by telephone or written statement.

g. No person may appear before the Board of Review, testify to the Board of Review by telephone, or contest the amount of any assessment unless, at least 48 hours before the first meeting of the Board of Review, or at least 48 hours before the objection is heard if the objection is allowed under Wis. Stat. § 70.47(3)(a), that person provides notice to the Board of Review Clerk as to whether the person will ask for the removal of a member of the Board of Review and, if so, which member, and provides a reasonable estimate of the length of time the hearing will take.

h. No person shall be allowed to appear before the board of review, to testify to the board by telephone or to contest the amount of any assessment of real or personal property if the person has refused a reasonable written request by certified mail of the assessor to enter onto property to conduct an exterior view of the real or personal property being assessed.
