100+ Men Who Care hold launch meeting

First donation presented to Lakeland Industries

Members voting at the inaugural meeting of Shawano County's 100+ Men Who Care awarded Lakeland Industries a donation of more than \$5,000 May 7. The group, with 51 men at the first meeting, is based on the locally popular 100+ Women Who Care group. "We all believe in the community," said Jim Meyer, one of the organizers. "We all believe in giving back and doing good, and the nonprofits in the area. This is such a great way - everybody is so busy, and this is a way for one hour a quarter that we can have a tremendous impact for a nonprofit without a lot of time commitment." The setup is simple. Members donate \$100 each quarter. At a meeting, they

hear presentations from three organizations. After a vote is taken, the group with the most votes gets all the money that night. "We have zero administrative fees. Every dime that's donated goes to that nonprofit," said Kai Jensen, another organizer. "It doesn't take any real time. You're not doing 10 fundraisers a year. If you get 100 guys, it's \$10,000 a quarter, it's \$40,000 a year that stays in the local community." Nonprofits are nominated by members and are vetted. All of the names are put in a bucket, and three groups are drawn to give five-minute presentations at the next meeting. The nonprofits must be in Shawano County. National groups can be nominated, but the funds must be used only for Shawano County programs. "The money has to be used in Shawano County, not for salaries or things, but for program expenses," added Jeff Brady, who, along with Michael Johnson, Jensen

and Meyer, round out the current leaders of the group "We have 10 (nonprofits) that are vetted right now. The women have 43 on their list. We're always looking for more nonprofits to go through our vetting process. They all are worthy of donations." Making presentations May 7 were the Bonduel Bat and Ball Club, Lakeland Industries and Shawano Has History. Jensen recalled a couple of years ago when he set up his digital photobooth business at a Women Who Care event. "I was so impressed that I asked why there wasn't a guys thing," he said. Nothing happened, but then he ran into Women Who Care organizers at a Shawano Country Chamber of Commerce event. He asked again about a group for men, and the next day, he had three emails who wanted to start organizing. "If we can get to 100 men by the end of the year, I'll be thrilled," he said.

Businesses prepping early for 2028 road closure

Main Street closing in downtown area for much of 2028

With the road reconstruction for Shawano's Main Street less than two years away, the Business Improvement District is looking at taking steps now to make sure local businesses don't suffer when the road is closed to traffic. The BID board discussed the Main Street 2028 project at its May 7 meeting and threw around ideas about what needed to be done to get businesses ready when the heavy equipment comes in. The project will be in two phases, with the first phase including downtown businesses south of Main Street all the way to Zingler Avenue. The second phase will impact businesses north of Main Street to the bridge for the Wolf River channel. City officials are already looking at making sure that rear entrances for downtown businesses are easily accessible during road reconstruction. City Clerk Lesley Nemetz said she and BID coordinator Lindsay Johnson planned to check the alleyways in May and see if the city needed to make improvements there. "We're just looking at some of those things that we can plan for and potentially getting in touch with businesses that butt up to those alleys," Nemetz said. "A lot of times, we can work with those businesses to get their rear entrances repaved at the same time, and then it's a lot less costly for that business owner if we have things up and ready." The alley work would need to be done in 2027; if the project is expected to get on the city's budget for that year, it would need to be solidified this summer, when the city starts planning for the next year. The Main Street work is expected to start in May 2028, so doing alley fixes that year would likely be too late, according to Nemetz. Board member Chelsea Gilling encouraged the examination of alleyways, noting that hers has a number of potholes. "It is bad by us," Gilling said. "You could do a hot tub in one of them." Nemetz said she and Johnson were going to put together information to give to businesses to help prepare them to stay open during the road work. The Main

Counties wait on disaster funds

Snow, ice, flooding costs mount into hundreds of thousands of dollars

From blizzards to ice storms to flooding, Shawano and surrounding counties have seen it all this spring. And the cost to deal with those severe weather situations has mounted into the hundreds of thousands of dollars for cities, towns, villages and counties.

Shawano County Sheriff Lt. Chris Madle, also the county's emergency management director, said the Wisconsin Disaster Fund is what the state uses to reimburse municipalities for costs associated with severe weather cleanup.

Blizzard Elsa, which occurred March 15-16, was considered a major event of the county.

"I ended up getting 28 applicants," Madle told the public safety committee May 6.

That included 20 towns, seven villages and the county itself.

"They haven't released what the

actual reimbursement amount would be, as far as what we'll get back, but the total amount we applied for was just over \$502,000," he said.

The amount includes wages and equipment.

The county's share of that was just over \$205,000, because much of their work is for towns and the state, which are reimbursed through other measures.

The ice storm of April 2-3 resulted in \$30,000 claims from Central Wisconsin Electric Cooperative and village of Tigerton.

It was also noted that county dispatchers answered 784 calls from 8 a.m. April 2 to 2 p.m. April 3. As a comparison, during that same time in 2025, they answered 200 calls.

Heavy rains and flooding of April 12-13 and beyond led to several culverts being washed out and roads closed due to high water.

He said the state is still determining how the costs will be reimbursed, as FEMA is also involved and

federal funds may be available for some areas.

He said the worst case in Shawano County was the Balsam Row Road Dam on the Wolf River.

"We were very, very close to that breaching," he said. "When I got up there that night, they were about an inch below the water going up over the top of the dam."

With the help of the county highway department and surrounding landowners, sand berms were created on both sides of the dam to direct the water over the dam instead of flooding the embankment on each side.

"That ended up working," Madle said. "The water went up over 6 inches in the two hours I was there. Within 48 hours, we were back down to where we were."

He said the highway department is working with dam owner Wolf River Hydro Limited Partnership to recoup its costs from that night.

Sheriff's department wants new boat

Last purchase for boat was in 2010

It's been nearly two decades since the Shawano County Sheriff's Department bought a new boat for patrolling county waters, search and rescue efforts, and recovery cases.

That may change soon.

Dana Ritchie, office manager, presented the case for a new boat to the public safety committee May 6. The committee agreed to forward the request to the capital improvement projects committee for consideration.

Ritchie said the current boat was purchased in 2010. It was bought with a Wisconsin Department of Natural Resources grant that reimbursed the county for the cost of the boat over the next five years.

The money now rests in a designated boat replacement fund, but nothing has been added to the fund since then. The balance of about \$18,000 is far short of the projected cost of \$71,500 for a new boat.

"Prices have gone up quite a bit," she said. "There's no extra funds that go into (the) replacement fund."

Sheriff George Lenzner said money should probably have been set aside each year for replacing the boat, but replacing squad cars was a higher priority. Even then, those costs were often cut from the county budget instead of cutting staff.

Being forced to replace several old squads at once led the county to create a vehicle replacement fund that resulted in new squads every four years and new administrative vehicles every six years. Lenzner and Ritchie said something similar should be considered for the boat.

Ritchie said quotes are in from dealers in Shawano and Appleton. The boat and its trailer have a trade-in value of \$8,500, she said.

"If we don't do this, we have a 2010 (boat) that's

going to depreciate out and have no trade-in value," she said.

Lenzner said the boat will be used much more in the future that it has been in the past several years.

"They'll be used a lot more in the future, too, because the DNR did purchase us Sea-Doos, also, but the program is going away, so we won't have those in another year or two," he said.

The DNR reimburses the county for up to 80 hours of wages when deputies patrol the waters, but Lenzner said a couple of lake associations want more patrol time.

"We're also going to be working with the Shawano Lake association and Cloverleaf, because they're always requesting more than the hours that we have available," Lenzner said. "They're going to be paying wages, also, to have officers out there are critical times for them."

The Cloverleaf Lakes group has done this a few years, and Shawano Lake will add it in 2026.

"As you know, in the summer with the tourists, we have a lot of boat traffic and a lot of complaints to follow up on," the sheriff said. "And the DNR just doesn't have the manpower to do that, so we concentrate on the people out waterskiing and stuff. That gives the DNR more time to focus on just the fishing-related incidents out there."

The lake associations will pay the county \$90 per hour for additional patrol.

Lenzner said the department is required to have the boat for search and rescue and recovery efforts. Ironically, it is not required to patrol and enforce boating laws.

"It's not a requirement that we go out there and enforce the laws, but we do, do that; otherwise, it's just going to be total chaos out there," he said.

1 dead in Shawano house fire

One person died as the result of a fire that occurred May 6 in the 200 block of East Center Street in Shawano.

Emergency personnel responded shortly before 7 p.m. to reports of a structure fire. Upon arrival, crews observed smoke coming from the home.

Firefighters worked to extinguish the fire and conduct search efforts within the residence. During those efforts, a person

was located inside the home.

Despite lifesaving efforts by the Shawano Ambulance Service and ThedaCare Medical Center-Shawano, the individual was pronounced dead at the hospital. The identity of the victim is being withheld pending notification of family members.

The cause of the fire remains under investigation by the police and fire departments, as well as the Shawano County Coroner's Office.

Rodriguez seeks to continue Evers' work

Candidate wants to turn state government blue

Sara Rodriguez has been Wisconsin's lieutenant governor for the last four years, but now she's hoping to move up.

With Gov. Tony Evers declining to run for a third term, a number of Democrats are facing a busy primary season to lay claim to the seat, criss-crossing the state to make it happen. Rodriguez's journey brought her to the Town of Wescott on May 4, making her case to the Shawano-Menominee Counties Democratic Party at Docker's.

Rodriguez said that service to the community was mandatory in her family, and that her life as a nurse was dedicated to helping others, especially during her stint in the Peace Corps. She had no aspirations for politics.

That changed in 2016 when Donald Trump made his first bid for the White House and brought up the broken immigration system and what he'd do regarding people in the U.S. illegally. Rodriguez and her husband, a U.S. citizen born in Mexico, have a son who was 8 at the time, and when her son asked if his father was going to be sent back to Mexico, she knew she needed to take action in the political arena.

"I told myself I was never going to feel that way again," Rodriguez said. "I had not done enough to make sure that man was not elected, and I relied on other people — probably some of you in this room — to advocate for families like mine."

She said she went to the Democratic headquarters in Waukesha County and asked to be put to work. After the 2020 pandemic and all the "misinformation" and "disinformation" that surrounded it, Rodriguez said she ran for the Assembly and

flipped the red seat to blue. Then in 2022 she joined Evers on the ticket for lieutenant governor.

With Trump getting a second term as president in 2024, Rodriguez knew she needed to make sure the next Wisconsin governor was a Democrat to counter the Republican's actions.

"If Gov. Evers was not going to run for a third term, I was going to run for governor, because we needed somebody who was going to stand strong and tall against the Trump administration, someone who was ready day one to get their agenda across the finish line and continue the good work of our (state) administration," Rodriguez said.

On her agenda is making it easier for Wisconsin residents to afford to buy homes. Rodriguez said that the average

age right now for buying a first home in the state is 40.

"They're telling me they're doing everything right, but they're still feeling squeezed," Rodriguez said.

She also plans to push for better access to child care if elected. To do that, it needs to be treated as infrastructure.

"The federal government says, for child care to be affordable, it should be no more than 7% of your income," she said. "The average cost in Wisconsin, a family would have to be making \$185,000 a year to afford one child in child care, and I had two under the age of 5."

Rodriguez also wants to see Wisconsin catch up with neighboring states and regulate marijuana. She noted that Illinois Gov. J.B. Pritzker is constantly ribbing her for the Wisconsin traffic that crosses the border to

purchase the drug in his state. Regulating it would help address issues with fentanyl and other dangerous drugs being mixed in and killing people, she said.

"Marijuana is not harm-free just like alcohol is not harm-free," Rodriguez said. "I firmly believe we should regulate and legalize marijuana in this state so we can get that tax revenue."

Rodriguez could face a challenge pushing her agenda if the Assembly, Senate or both chambers remain under control of the Republicans. However, she sees an opportunity with the newer district maps of getting the legislature back under Democrats' control, noting liberals only need to flip two seats in the Senate and five in the Assembly.

"We have an enormous opportunity in 2026 to have a trifecta that we have not seen in almost 20 years," Rodriguez said. "We have got to be ready. If we do not make a demonstrable difference in people's lives, if we do not show them what it looks like when Democrats govern, they will not allow us to keep that trifecta moving forward."

Besides concern about control in the legislature, Rodriguez said it's also important not to let Rep. Tom Tiffany, who represents Wisconsin's 7th Congressional District and is the only Republican currently running for governor, get the seat, noting Tiffany sides with Trump on many issues.

"There is no daylight between those two men," Rodriguez said. "He has said that tariffs are a good thing — tariffs that make our beer and cheese manufacturers raise their prices here in Wisconsin."

Rodriguez would push to require Immigration and Custom Enforcement agents to be unmasked and wear body cameras for any action within the state, a stark contrast to Trump's policy.

"We're just so excited the community has welcomed us in," she said. "We're so excited to bring to the community and all the procedures and things we'll be able to do now."

She said the new, larger office would allow the staff to offer more services and conduct more procedures for patients.

The new building will be about 9,100 square feet

and sit on about 2.8 acres of land at South Airport Road and Engel Drive.

Stevens thanked everyone for joining her family and staff on this journey.

"It's a long time coming here," said her husband, Andrew Stevens. "There's a lot of hangups along

the way, and we're happy we got through all the challenges."

The couple purchased the dental practice four years ago from the retiring Dr. Ralph Horsens.

Rebecca Stevens is originally from the West Coast and attended Marquette

University's dental school in Milwaukee. Her husband is from Racine, and the family moved to Shawano from Hartford.

"The biggest thank you is to our team, day and day out," Andrew Stevens said. "Without them, we couldn't do anything."

County Road BE construction underway

Road construction is underway on County Road BE between Shawano and Bonduel, complete with detours drivers will need to plan around in the coming weeks.

The road will be closed to through traffic until June 1, with access limited to local residents and businesses along the route. County Road BE is not meant to be used as a corridor, only for people who live there or need to reach businesses.

Instead, motorists from

Shawano should drive to Cecil on state Highway 22, then turn south on state Highway 117 to Bonduel.

Drivers will be impacted by closures along state Highway 29. The eastbound on and off ramps into Bonduel are temporarily closed as the Wisconsin Department of Transportation completes work in that area. Anyone traveling east toward Green Bay will need to pass the exit, turn onto River Road and loop back to access the village.

Also, Highway 29 from County Road M to Highland Road will be under construction through Oct. 20.

The purpose of this project is to repair concrete joints, replace sections of deteriorated concrete pavement, mill and overlay the asphalt shoulders and replace the guardrail.

Inside lanes are closed.

Finally, there is a work project on eastbound Highway 29 from County Road J to County Road M.

Crews will replace

existing guardrail, repair concrete pavement, replace concrete pavement in five areas and replace a culvert under westbound Highway 29.

Inside lanes are closed.

Highway 29 traffic will be relocated to the eastbound lanes using temporary crossovers. Motorists will encounter two-way traffic on the eastbound lanes of Highway 29 from County Road J on the western end of the project to Old 29 Road.

Using existing foundation not option for library

The Shawano County Library Board's fundraising subcommittee is looking at ways to generate funding to help build or relocate its main branch in Shawano, but the path to a new facility is not an easy one.

The library has been planning for years to relocate from its existing building on South Sawyer Street due to the aging infrastructure. This has included recent inquiries about the First Presbyterian Church and Peace United Church of Christ, although the Presbyterian building became the new home for the two churches, which merged earlier this year. The possibility of utilizing the Genex building for a library has also been discussed.

Efforts to make the library part of Shawano County's government offices in the future have faded as the potential costs for that building have jumped above \$100 million.

Before the library can consider moving, it needs to have the money to do so. The library board has considered partnerships with entities like the Shawano Area Community Foundation, specifically within its Agency Fund. However, library director Staci Rubenzer told the subcommittee May 7 that the foundation does not work with fundraising efforts, instead being more focused on helping endowments grow.

"After a phone call and an email and another email ... it was indicating that she can't do it," Rubenzer said, referring to

her contact with Raquel Strayer, SACF board chairwoman. "Other libraries list them for endowments."

Fundraising through the county could be possible, according to Rubenzer, but she said that could be an "iffy" situation.

Rubenzer noted that current donors for the library give through the Friends of the Shawano County Library, but she wondered if library officials should focus more on money for a new building at the current time as opposed to the programs that the Friends provide.

"Maybe that's a different type of donation that people will give," Rubenzer said. "Do we have the jar out for the Friends, or do we have it out for the new building? I just wonder how that looks. We want both to happen."

Gina Shatters, a library board member who sits on the subcommittee, recommended that officials continue searching for a way for the library to form a foundation or find some method to help create a new facility, noting that the longer the board waits, the more expensive that facility becomes.

Even though the main branch is in Shawano, Shatters said what happens with the facility directly impacts the other libraries in Wittenberg, Birnamwood, Bonduel, Tigerton and Mattoon.

"If the facility is deteriorating, that could mean there's no Bonduel or there's no other branches in the years to come," Shatters said. "Shawano is the main one. That's where everything comes from."

If she tries to eat out of another slot, the door

will not unlock since that's not hers.

Posbrig is a senior at Pulaski High School and a member of the Tiger Tribe 4-H Club.

"Being able to spend a few hours looking at the monuments at night was also really fun," she said. "The lights made it more enjoyable to see. During the time we were there, the cherry blossoms were in full bloom, and they were very beautiful and smelled amazing."

The Shawano County 4-H Livestock Group and the Shawano County 4-H Leaders Inc. helped fund this 4-H opportunity.

"This trip truly was a game changer," Posbrig said. "It allowed me to explore things that I never would have thought I would like to dig deeper about, and it gave me a new perspective on many aspects of being a leader. I would highly recommend this trip to anyone that is wanted to get out there and learn more about involving youth, growing as a leader and branching out to meet new people."

Packers use first 3 draft picks for defense

Size and depth added to the roster

The NFL draft is in the books, and the Green Bay Packers will now set their sights to getting their rookies acclimated while trying to get healthy for a chance to chase their 14th world championship.

Their draft class this year was different than any in the recent past, because they did not have a first-round pick – thanks to the trade for defensive end Micah Parsons.

Brian Gutekunst expressed no regret over the trade for Parsons but knew that his work was going to be cut out for him with only eight picks coming into the draft. He also had big needs at defensive tackle and cornerback. With limited capital, there were no

surprises for Gutekunst with his two highest picks. He started his draft with a cornerback and finished Day 2 by trading up for a defensive tackle.

His first pick came from South Carolina in the form of 20-year-old Brandon Cisse.

Cisse should join the Packers as competition for a starting position with the trio of Keisean Nixon, Carrington Valentine and Benjamin St. Juste in front

of him. He may not be a Day 1 starter like some are hoping for, but there is enough competition in that room to the point that Cisse's explosiveness and ability to affect the ball in the air could find its way onto the field.

After looking in the secondary, Gutekunst looked to the front of the defense when he traded up seven spots to select Missouri's Chris McClellan.

McClellan was available in addition to players like Florida State's Darrell Jackson Jr. or Iowa State's Dominique Orange.

Gutekunst took McClellan, who he believes could be someone that plays nose tackle but also has the versatility to move up and down the defensive line in the mold of Javon Hargrave and Devonte Wyatt.

Gutekunst talked about McClellan's ability to affect the game as a pass rusher, which gave him the nod over other defensive linemen in this class. "Obviously he played in

the SEC. He's a huge man. He has excellent length, and I think for me, the combination of being able to play the nose, the 3 and actually rush the passer," Gutekunst said. "There's a lot of these guys that don't do that. He can. That was I think what set him apart a little bit for us."

Speaking of pass rushers, Gutekunst grabbed one with his first pick on Day 3, and it may have been the steal of the draft. Penn State's Dani Dennis-Sutton was someone who was expected to be off the board by the end of round three at the latest.

Instead, Gutekunst was able to grab him in the fourth round to give the Packers' pass rush a boost on the edge while Parsons continues to rehab his knee injury.

One other interesting tidbit about Dennis-Sutton is his ability to affect the game on special teams,

Golden progressing in Packers system

Much is always expected from a team's first-round draft pick. Such was the case in 2025 when the Green Bay Packers selected Matthew Golden in the 23rd overall spot.

But, has he materialized into what the fans – or the coaching staff – expected?

Golden signed a four-year, fully guaranteed \$17.58 million rookie contract. The deal included a \$9.42 million signing bonus, with more than \$10 million in total cash paid during the 2025 season and a fifth-year team option.

The last wide receiver selected by the Packers in the first round before Golden was Javon Walker in 2002. Walker was taken with the 20th overall pick out of Florida State.

When Golden was selected, the Packers already had a ton of wide

receivers, knowing some would be gone in the near future.

Already on board were Christian Watson, Jayden Reed, Dontayvion Wicks, Malik Heath and Romeo Doubs, as well as Bo Melton in a pinch. The Packers also picked up Savion Williams in the second round of 2025 draft.

"It was kind of a unique deal," coach Matt LaFleur said. "Not many rookie players, especially first rounders, come into a situation where there's a bunch of guys that have established themselves. It feels like each game there's a different guy that's going to lead us in receiving."

Beyond the depth chart, the Packers head coach noted physical setbacks played a significant role in stalling the speedy

as he had three blocked punts for the Nittany Lions in 2025.

After focusing exclusively on defense for the first three picks of his draft class, Gutekunst moved to the other side of the ball with his fifth-round pick.

Jager Burton started 47 consecutive games in college, moving between center and both guard spots. Burton could compete on the interior of Green Bay's offensive line, which has uncertain futures with Aaron Banks, Sean Rhyan and Anthony Belton all having various questions surrounding them.

In the sixth round, they grabbed another cornerback to add competition to the weakest position on the roster with Domani Jackson, a former high-level sprinter in track and field.

Jackson's speed is an intriguing trait for the Packers to have bet on, and he could contribute on special teams where he played 160 snaps across four seasons. An interesting note on Jackson is that he was mentored by former Packers' safety Ha Ha Clinton-Dix.

The final pick of the draft came via trade as Gutekunst moved back into the sixth round, trading away both of his seventh-round picks to select Florida kicker Trey Smack.

Smack has a big leg as one of three kickers to make five or more field goals of more than 50 yards a season ago.

It's the smallest class they've had since 2004.

wide receiver's early momentum.

"I think MG's done an outstanding job," LaFleur said. "I thought he was on track and unfortunately had to deal with a little bit of injury that just kind of made it a little bit more choppy, I would say, in regards to his ability to get in there and have meaningful snaps."

LaFleur's assessment reflects Green Bay's approach to rookie development, allowing young players to grow within the system.

How has that approach paid off? Golden only has to look down the line of scrimmage to see Jordan Love taking snaps to see.

This year, Wicks, Heath and Doubs are gone, so Golden will likely see more action.

In the 2025 regular season, Golden recorded 29 receptions for 361 receiving yards (12.4 average) over 14 games, with a long reception of 46 yards. He added 10 rushing attempts for 49 yards.

What happened to the class of 2022?

The NFL draft is come and gone, and the Green Bay Packers are hoping for a class that can help push them over the top of the NFC and into the Super Bowl. While they are looking for help from their rookies, usually a draft class takes a few years to fully develop, and it is previous draft classes that need to have players develop into stars.

The 2022 draft class was on deck last year for that burden, and after four full years, the class is a bit of a mixed bag.

The Packers entered the 2022 draft armed with two first-round picks thanks to a trade of Davante Adams to the Las Vegas Raiders. They used both picks on Georgia Bulldog defenders.

Quay Walker and Devonte Wyatt have both been a combination of injuries and inconsistency through four years. Wyatt had his fifth year option picked up prior to the start of last season and could be in line for a contract extension if he plays well again alongside Micah Parsons.

Walker did not have his option picked up, even though the Packers insisted they wanted to keep him in the fold for years to come. That did not come to fruition; as Walker noted during the year, the team stopped talking contract with him by midseason. Ultimately he was allowed to leave

in the offseason, signing a three-year, \$40.5 million contract with the Raiders.

That marked back-to-back years that Green Bay's highest pick was allowed to leave in free agency when his contract expired. Ironically enough, the year prior it was Eric Stokes who also signed with the Raiders.

The middle rounds of this draft class are where general manager Brian Gutekunst made his hay. He had two second-round picks in this class with the extra coming via the trade of Adams to the Raiders, but he moved both in a big move up the board to draft North Dakota State's Christian Watson.

Watson is playing on a deal that is set to expire at the end of 2026, but he is someone the Packers would like to keep in the

fold. Watson has been up and down during his career due to injuries and inconsistency, but he really came into his own in 2025 and emerged as the team's most explosive playmaker.

He has the combination

of size and speed the Packers covet, and he likely will be a top priority to get re-signed before his contract expires next March.

Sean Rhyan looked like he was set to hit free agency and be on his way out the door at midseason. Rhyan entered the year as the starting right guard, but the Packers had never fully been comfortable giving him a full-time job without looking to replace him.

When Elgton Jenkins went down with a lower leg injury, however, that was Rhyan's opportunity. Rhyan took over as the starting center and parlayed his audition into a three-year deal with \$33 million before he was able to hit free agency. After years of having to fight for his job, Rhyan should finally feel some stability.

The fourth round was Gutekunst's best in this class, even if he only kept one of the two players he picked in that round.

Romeo Doubs was a solid receiver in Green Bay for four years. He finished with two 100-yard receiving performances in his Packers career, both coming in the postseason. Had the Packers held on to beat Chicago at Soldier Field in the postseason, Doubs' one-handed catch likely would have been played on highlight reels for years to come. Instead, it became the final big play he made for Green Bay as he left in free agency for New England on a four-year, \$68 million deal.

His other fourth-round pick was the best of this class, and arguably one of the best in his career. Standout tackle Zach Tom is going to be Green Bay's right tackle for years to come after signing a hefty contract extension last off-season. The goal for Tom needs to be to get healthy and stay healthy. He's the linchpin that keeps everything together for the Packers' offensive line.

Kingsley Enagbare, Gutekunst's fifth-round pick, turned into a solid rotational pass rusher and de facto starter in 2025 before being allowed to leave in free agency. He signed with the New York Jets on a one-year deal worth \$10 million.

The final two rounds of the draft did not yield much as Tariq Carpenter never developed into the special teams ace the Packers were hoping he could become for Rich Bisaccia's units, and Jonathan Ford has been a journeyman in the NFL.

Oddly enough, Ford was signed away from the Chicago Bears last year when the Packers' defensive line faced significant injuries before the season ended.

Ford was re-signed this offseason and will have a chance to win a job as a rotational defensive lineman in Green Bay.

Overall, this class four years later has become a key part of Green Bay's core, with potential for more to come as these players grow further into their careers.

Husband, wife bring taste of Puebla to Shawano

It's all about the food and love at Ignacio's Puebla Street Food, a new Mexican restaurant near downtown Shawano.

Ignacio Ramirez-Juarez's love for the food he grew up with in Puebla City, Mexico, inspired him to open the restaurant in early March.

"I just follow my heart," Ramirez-Juarez said. "When I was a child watching my grandma, my mother, my aunt cooking, that's my way to cook."

"There is no place around here that makes the food that he makes," said Tiffany Ward-Ramirez, his wife and co-owner.

Sharing their combined love of this type of cuisine with the community is important to the couple.

Puebla is well-known for "street food." Ward-Ramirez said that street food has a long cultural history.

"That doesn't mean it's sold out of a truck," she said. "The concept of our street food comes from the women who cook at home, sometimes through the night, so that they can sell it the next day to support their families."

This cuisine is food that takes a long time to prepare, featuring various flavors and textures. Great care and loving hands result in meals that reflect the rich culinary heritage of Puebla.

Ignacio's is where customers can experience authentic and original food in Shawano that Puebla has been known for.

The most well-known food from Puebla, which is 80 miles southeast of Mexico

City, is Tacos Arabes, which is on Ignacio's menu. The main ingredient is pork that has been marinated for 24 hours before being put onto the trompo, a vertical rotating roaster.

"The recipe is a secret," Ramirez-Juarez said.

Ward-Ramirez said that the pork recipe comes from the influence of Lebanese who emigrated to the Puebla region.

Talking about other menu items, Ward-Ramirez said that the brisket is cooked for six hours.

"It's our top-seller here," she said. "We go through a brisket a day."

She believes local customers might just be comfortable with the "brisket" name.

None of the food is overly spicy, although there may be a few of the salsas that have a kick.

Salsas are made fresh daily.

Ignacio's serves Mole poblano, a dish that has deep roots in Puebla.

"We don't make that here, though," Ramirez-Juarez said, noting the Mole poblano has about 25 ingredients. "It's possible to make it here, but there would be no time to cook anything else."

Wild turkeys seldom follow experts' playbooks

The magazines and the internet trolls make it sound so easy, but it's a rare hunt that goes down simply and quickly.

Wild animals are never predictable, and wild turkeys never seem to do what they are supposed to do, according to those experts.

The internet is now full of "what if" hunting scenarios, and a recent one that caught my eye said, "A gobbler hangs up at 50 yards and you have tungsten shot. Do you shoot?"

Most of the answers said it was an easy shot with tungsten, and even possible with copper-coated lead, depending on shotgun gauge. Many hunters have switched from their heavy 12-gauge guns to "subgauges" like the 20, 28 or even .410.

Tungsten loads, which are about 60% more dense than lead, allow smaller shot sizes (as small as 9, but often a blend of size 5 to 9) to create a denser pattern that can kill far beyond 50 yards.

Little did I expect that two somewhat confused toms would come calling on me May 1 and create a few dilemmas as well as some fast action. In a perfect world with a rangefinder scope (yes, some hunters go that route) or perhaps an AI-assisted camera to calculate odds, we'd never mess up another shot. I've long since sold my pocket rangefinder as another gadget I didn't want to carry, although I am seriously now thinking of using some stakes to create a few distance markers.

I was a few minutes late to the blind on that 35-degree, sunny Friday and hurried to put up my decoys.

From the time I left the SUV, I heard a gobbler calling. At 5:45 a.m., I saw him approaching from the north, just at the top of a large picked cornfield. Could this be a textbook hunt? Of course not.

He was with another bird, or possibly two. He strutted as I shot still photos and video into the rising sun, but I later realized it was actually at least two toms. He answered my box call and seemed to be coming.

I had the 20-gauge single shot ready, but then he disappeared into the woods to the west of my blind.

His calls continued, so I zipped down the back port window and kept watching. He finally went silent.

Roughly 45 minutes later, I saw three turkeys milling about in the cornfield near the road. It's hard to tell if it was the same three birds that disappeared behind me but very possible. Turkeys don't have many identifying marks like antlers or great size differences to tell them apart.

It soon became apparent two were toms and one was a hen. Once a tom gets with a hen, it's usually tough to call the boys in for a shot. The hen walked close to the toms, but they seemed more intent on strutting with each other and ignoring the hen.

Perhaps getting frustrated that these two puffed-up gobblers weren't interested in courtship, the hen made a beeline toward my decoys. It's hard enough to call a tom, but it's rare indeed to call in

“Everything that we serve here is what you would find traditionally in Puebla,” Ward-Ramirez said. “It’s important to us to share that piece of the culture. Our concept is real, authentic, fresh food.”

Their Facebook page, Ignacio’s Puebla Street Food, teased the opening of the restaurant starting in December 2025 with photos of their dishes and stories of Ignacio’s family. They garnered more than 1,000 followers even before the restaurant opened.

The only time Ramirez-Juarez worked as a cook before opening Ignacio’s was for Corina’s in Cecil, which was his brother’s restaurant.

“My dad was a chef,” Ward-Ramirez said. “I grew up in the restaurant business.”

Her parents owned a small restaurant in Pound at one time.

When Ramirez-Juarez lived in Puebla, he worked in a few upscale restaurants.

He was required to make things table-side for customers, such as crepes or Caesar salad and dressing, in his role as a server.

He emigrated to Shawano in 2000. He knew the family who had owned Flamingo’s in Shawano and worked there before working for Luigi’s Pizza and Pasta in Shawano in 2008.

The love story of Ward-Ramirez and Ramirez-Juarez started as friends while they both worked the front of the house as servers at Luigi’s.

“We started dating,” Ward-Ramirez said. “Everything else is history. We’d go out to

Mexican restaurants together, but it’s not that we could ever find food like where he grew up.”

For customers familiar with Mexican food, there are slight differences with what is offered at Ignacio’s.

She explained that a lot of Mexican dishes are Americanized, using a lot of ground beef. Ground beef isn’t used in the dishes at Ignacio’s.

“A lot of the misconceptions is that every Mexican restaurant has the same food,” Ward-Ramirez said. “It’s like ribs. If you go to Texas, they’re different than the Carolinas and different than Kansas.”

“I like to experiment a little,” Ward-Ramirez said. “But we’re keeping the core of what they serve in Puebla. Ignacio likes to go to the core of where he grew up.”

Ignacio’s is keeping its menu small to start. They create daily specials, which are posted on their Facebook page.

Their extended family’s love and support help Ignacio’s to succeed.

Ward-Ramirez’s daughter, Trama Kay, 26, and son, Ryan, 19, work in the restaurant when they can. Ramirez-Juarez’ daughter, Alexis, 24, also fills in. He has three other daughters who live in Puebla. Ward-Ramirez’s sister, Tabatha, also works when not at her regular job.

Ramirez-Juarez’s brother, Saul, cooks at Ignacio’s when not at his job at Novolex in Shawano. He helped contribute recipes from Puebla to the restaurant.

The love that Ramirez-Juarez has for his hometown is evident from the large mural that covers the interior west wall. It shows the two volcanoes that surround the valley where Puebla is located. Ward-Ramirez and Ramirez-Juarez noted the mural shares the love, heritage, legends and beauty of the area that inspired Ignacio’s.

a hen. She set up camp in the grass just past my blind, perhaps 30 feet away. Now I had a live decoy. This is getting good.

I continued to call and the two toms continued to ignore me. They struck a path about 60 yards from my blind, headed north across the cornfield toward the area I’d first seen those early birds. With tungsten shot in my shotgun, I might have a chance.

When the two birds were directly across from the blind, I saw both had decent beards. I put the bead on the first tom’s neck and touched off. He shook a bit and then dashed off 50 yards to the left. The other bird stopped. At some point, I noticed the first bird had stopped and was acting hurt.

I left the blind with only the shell in the gun and walked briskly toward the bird. The second one trotted away. I saw the tom’s head was up, but it looked like at least one wing and leg were broken. Taking no chances that a turkey with one leg could outrun a fat guy with two, I took aim at 40 yards and put him down.

The adult tom was 20 pounds, 12 ounces on my Normark digital scale, with a 10-inch beard and impressive 1 3/8-inch spurs. I gave the dressed bird to my hunting buddy Scott Krebs, of Oshkosh, and we were back in the blind May 7 for more early morning fun. This time, the lone tom stayed out of gun range.

With a deep interest and appreciation in growing things, the Erbs were dairy farmers when their place went the way of a lot of small farms.

Being a fourth-generation farm, their desire was to stay at the farm.

"My husband told me do what you always wanted to do, so we broke ground in December 2020 to start building our greenhouse and by the following April we'd grown a full crop in the greenhouse," Terri Erb said. "We finished and put together the shop – all situated in the area which used to be the medium-age calf pen – and opened up."

Along with family trials and happy times, including the emotional aspect of saying goodbye to the cows, the entire family helped plant.

"Working alongside family – especially that first traumatic year – planting together was bonding and a grieving release, which is very therapeutic," Terri Erb said. "March, with the snow and cold outside but cozy and warm in the greenhouse, makes us feel extremely grateful and happy this is what we're doing now."

Terri Erb credits her faith helping her along, especially after the family sold the cows and branched out into the greenhouse and shop.

"God has his hand on us, absolutely – walking ahead in blind faith, knowing in my heart this is what I wanted to do," Terri Erb said. "When an industry like farming completely reshapes itself, despite my husband being a man of traditional, stick-through-the-hard-times farmer guy, it wasn't a matter of toughing out a few years. We needed to make a change."

Terri Erb appreciates the support from surrounding communities and customers.

"They come in as new people and eventually become friends," she said. "Beyond just having a customer purchase plants from us, our goal is for everyone to become very successful with their

growing and not to feel that they don't have a green thumb. We're so happy to answer questions and to guide them."

Everything Erb Farm and Flower carries has been heavily researched. Erb spends winters pouring over trial garden results, new introductions and evaluating things for ease of growing and reliability.

In January, Erb posts plant previews and pictures on their Facebook page, commenting on what's unique about them. Customers peruse the posts during the winter, looking forward to spring. The visitors come in with an actual shopping list.

"Whether they're just a little bitty gardener or an extravagant gardener, we love it. We're here for them," said Erb.

A full greenhouse of starter plants such as herbs, tomatoes, vining vegetables, peppers, cucumbers, kale, lettuce, and strawberries are offered for sale, with plants grown onsite – started from seeds or rooted cuttings – about March 1st. Also for sale are various hanging floral baskets and an extensive selection of unique flower varieties hard to find elsewhere.

The shop is stocked with gardening items such as seeds and seed potatoes, gardening tools and lawn art, but also full of cozy décor, fun finds and jewelry, varying by season.
