Trout cooperate with anglers at 36th annual Eland Fisheree

Jacob Pliska didn't mind getting up early June 20.

It had something to do with fishing, which was right up the Rosholt 13-year-old's alley.

Pliska was one of hundreds of people – from young kids to senior citizens – to show up in Eland for the 36th annual Eland Fisheree. They tried their luck at catching one of the Eland Millpond's stocked rainbow trout, many of them more than a foot long.

Although Pliska had yet to land a trout by 9 a.m., he was hopeful that one would fall for his worm on a hook like the one that he almost caught earlier.

"Catching trout, eating trout and winning prizes," he said when asked why he and his family made the short trip from home. "It's one of the last years I'm going to be here."

The fisheree is open to children 14 and younger and disabled anglers as well.

None of the millpond's trout were as big as the 35-inch-long northern pike Pliska caught while ice fishing.

"I'm pretty sure I like ice fishing better," he said. "I don't mind being cold."

Mike Roe is president of Eland Fisheree, the organization that makes the fisheree a reality each year.

"It's for the kids, and it's a lot of fun when you watch these kids run up with their fish," he said.

The fisheree began at 7 a.m. and ran until 3 p.m., but people arrived at the park long before the sun rose.

"There are people setting up at 3, 4 o'clock in the morning," Roe said. "They'll be down here getting their canopies and chairs set up."

Besides catching trout, anglers could have their fish cleaned by Eland Fisheree volunteers, win a prize or go home with one of more than 50 donated new bicycles.

"We have a good group of people, but the donors and donations make it all happen," Roe said. "We wouldn't be able to put this on. We're up to 53 bikes now. We have basket raffles, a Packers game raffle and 50/50 raffles. There's a lot of planning. We start in February or March with meetings and get donor lists ready, make calls and get the fish ordered."

"We have a good core group of people that are out there all the time to set up, clean up and get things planned. This

Kautza denies Steffen spot on board

When Tess Serrano resigned from the Shawano County Board last month, she acknowledged that finding a replacement in her district would be difficult.

Board Chairman Tom Kautza told the executive committee June 17 he still doesn't have a resident to fill the seat.

"One individual did ask me if he could take her place, and I told him no," he said, referring to Tim Steffen. "There's been nothing but issues and problems, and that individual's been involved in it."

Over the last several months, Steffen and others have been critical of Kautza when it comes to ethics complaints against former Supervisor Lowel Hammett, a request for a forensic audit of the county's books to determine if \$1 million was indeed missing as asserted by Hammett, the search for an alternative location for a new courthouse and government complex, and his overall leadership of the county board.

Steffen is the chairman of the Shawano County Republican Party, another reason cited by Kautza to not appoint him to the remainder of Serrano's term.

"So then what happens next? Next time around somebody goes off of the board, then I have to find somebody from the Democratic Party to put on there? It's endless," Kautza said. "Counties are supposed to be nonpartisan."

As the meeting adjourned, Steffen asked to be able to respond to Kautza's comments.

"I didn't want to interrupt you in the process of the agenda, and you did not ask for comment," Steffen said to Kautza, as he was getting up to leave. "You didn't tell the executive board the entire story. You never asked for public comment."

Kautza told Steffen he could talk all day, but he was leaving.

"That's one of the reasons not to appoint you," he said. "You don't understand the rules. We can't go back and make up what's on the agenda."

Steffen also alluded to a phone conversation between the two, which ended when he said Kautza hung up on him.

Serrano represented District 27, which includes all of the towns of Hutchins and Almon, the village of Mattoon and Ward 2 in Bowler.

Contingency funds will be used for updating dispatch center

Shawano County officials agreed to use the county's contingency fund to pay its share of a grant that will update several pieces of equipment in the dispatch center.

Members of the executive committee voted June 17 to pull \$70,582.90 from its coffers, its share of a \$705,829 grant received from the Wisconsin

Department of Military Affairs Office of Emergency Communications.

Kasey Cross, communications supervisor, said the grant money will help cover the costs of upgrades to the dispatch radio consoles and back-up consolettes, upgrades to the phone system and an online subscription to improve the efficiencies of mutual aid fire dispatching.

Upgrades to the

dispatch consoles will better incorporate the tools that are available with the radio upgrade the sheriff's department did in January.

The dispatch center phone system currently operates on the Motorola Callworks platform and has about five years left on a contract with the company.

Motorola has decided to discontinue development of the Callworks

system, but it is contractually obligated to honor the contract.

Cross said Motorola will credit the county for all money paid to purchase the Callworks program if the county upgrades now.

Within five years, the county would need to update the system, but the grant money must be used this year, she said. Costs are expected to be significantly higher if the

county waits five years to upgrade the system.

"I think it's just more common sense to invest in this now than wait four years down the road and pay so much more money, because we know prices are going to go up, and we're not guaranteed the grants," Sheriff George Lenzner said.

Finally, the grant would cover a subscription to the HIEBA software application specifically

related to mutual aid for fire dispatching.

The software would replace a series of three-ring binders dispatchers must manually page through when calling out mutual aid equipment and manpower requests.

The county's public safety committee agreed May 6 to accept the grant and forward it to the executive committee.

Native American Plant Medicines Walk set for June 30

Community members are invited to explore the healing plants growing along the Mountain-Bay State Trail during a Native American Plant Medicines Walk led by author and herbal educator Misty Cook from 6-7 p.m. June 30. A rain date is scheduled for July 1.

Participants will meet at the Red Bridge, 310 W. Rollman St. in Bowler, for a guided half-mile round-trip walk focused on traditional Native American medicines used by the Stockbridge- Munsee Band of Mohicans Tribe.

Cook, author of “Medicine Generations: Natural Native American Medicines Traditional to the Stockbridge-Munsee Band of Mohicans Indian Tribe,” will share the history, identification, gathering, drying,

preservation and traditional uses of medicinal plants found throughout the area. Attendees will learn how local plants have been used for generations in teas, tinctures, salves, and poultices to support healing and health.

Drawing on more than 20 years of experience working with traditional medicines, Cook has documented 58 Native American herbal medicines passed down through oral tradition within her family’s Wolf Clan lineage. Her book highlights the cultural significance of these plants and provides guidance for their identification and traditional preparation.

This special program is part of the yearlong celebration marking the 30th anniversary of the

Mountain-Bay State Trail. The anniversary celebration includes a variety of educational, recreational and family-friendly events taking place throughout the summer and fall across the trail corridor.

The walk offers a unique opportunity to learn about the natural resources growing along the Mountain-Bay State Trail while gaining insight into Indigenous knowledge and traditions.

Indiana teen charged for sex with girlfriend

An Indiana teen claimed he could not be arrested for sexual assault with a girl under age 16 because of Romeo and Juliet laws in his state, but he was arrested anyway and could wind up spending much of his adult life in prison.

Clinton Joseph Lawler Bradley, 17, who lives in Groverton, Indiana, was charged with one count of second-degree sexual assault and two counts of child enticement after a Shawano police officer approached his vehicle and learned that a sexual act had taken place in a vehicle in front of Klee-man Family Park with a 14-year-old girl.

The incident took place on the afternoon of June 4, according to the criminal complaint, and a neighbor claimed a green vehicle was parked in front of the park on Alpine Drive with two people having sex. The vehicle allegedly pulled away as the officer approached, but when emergency lights were flashed, the vehicle stopped. The officer reported seeing a torn condom wrapper inside the vehicle.

Bradley allegedly claimed that this was the first time he'd engaged in sex.

The neighbor reported that a teen girl had walked away from the scene prior to the officer's arrival and believed that something "not nice" had taken place, according to the criminal complaint.

Prior to the arrest, Bradley allegedly told the officer that he had been dating the girl for six months, but the encounter in Shawano was the first time he'd met her face to face. The two had allegedly started communicating via Snapchat but then switched to text messaging, according to the complaint.

The officer told Bradley he believed the teen had been having sex and

placed Bradley under arrest. When that happened, Bradley claimed he didn't know what he'd done was illegal and that there were Romeo and Juliet laws in his state, so he couldn't be arrested.

Indiana law, specifically statute 35-42-4-9, allows for a close-in-age exemption protecting teens in consensual sexual relationships from statutory rape laws when the age of the parties is within four years. This only applies to teens who are 14 or 15, as the age of consent in Indiana is 16. The law does not apply to anyone under the age of 14, and it is designed to ensure young people are not automatically labeled as sex offenders.

Wisconsin, on the other hand, does not have a Romeo and Juliet law, and the age of consent is 18. There is no close-in-age exemption, but a marital exemption exists if either of the parties is 16 or 17 years old.

The vehicle was owned by Bradley's father, who was contacted by police and claimed Bradley was driving to Wisconsin to see his girlfriend.

The victim allegedly told a detective that Bradley had forced her to kiss him and repeatedly asked

to do something, indicating sex. She said she agreed so Bradley would stop asking about it, but after the intercourse, she quickly walked away from the scene so it wouldn't happen again.

The victim allegedly claimed Bradley said the vehicle was his father's, but the father was taking a walk so the two could hang out. She told the detective that seemed odd because it doesn't take an hour to go for a walk.

The sexual assault charge comes with a maximum sentence of 40 years in prison and fines of up to \$100,000. The same fines apply to the child enticement charges, but the maximum sentence is 25 years for each charge.

Bradley, who turns 18 on June 24, according to court records, and was assessed a cash bond of \$15,000 on June 10, which has been paid. He is allowed to return to Indiana but must return in person for future court hearings.

A preliminary hearing is scheduled before Shawano-Menominee Circuit Court Judge Katherine Sloma on July 31 at 1:15 p.m., and he has an attorney listed.

Historic church repurposed

Antique goods share space with stained glass windows

Bethany Baptist Church, a historic building located in rural Shawano County, has been repurposed with a new title and mission, thanks to owner Karen Benishek.

The Vintage Church Mouse is a vintage and antique store located at W12902 State Highway 29 in Tilleda. The historic church dates back to 1912 and is graced with original stained-glass windows and charming woodwork throughout the building. The ambience was maintained during the remodeling efforts.

Offered for sale is a variety of antique and vintage items curated by vendors who rent their space.

Previously owning coffee shops, the Benisheks sold them and, deciding to take a break from that pursuit, checked out places to sell antique and vintage items.

Benishek's husband, Jim, is handy with carpentry and remodeling. The couple discovered Bethany was for sale. Having an appreciation for old buildings, one thing led to another and they purchased the building as is, with nothing guaranteed.

"Deciding to purchase the property, there were risks involved," said Benishek. "We knew that, but we took the chance, leaving it in God's hands that whatever worked out would be for our good."

The couple noted the building was structurally sound.

"We purchased the building in November 2025 and opened June 1, 2026," said Benishek. "In the meantime, my husband had retired from his job as a maintenance director in nursing homes, so he had more time to work on the building. He constructed the booths and sanded the stairs and choir loft floors. The rest remain as we bought it. He hired help to build a wheelchair accessible ramp. I have the vision, he has the skills. I help, but he can do it so much better."

With a heartfelt vision, Benishek had

in mind finding a space where vendors with unique skills can express their creativity, presenting their style and display their unique finds to the public. Most of her vendors are from Shawano and Waupaca counties.

Some of the contributing vendors have more a boho (bohemian-style) hippy, funky kind of vibe. Various booths offer a unique mix of things such as furniture refinishing, painting furniture, and upcycling. Other booths offer kitchen-cottage core, granny core, with vintage clothing upstairs in the choir loft.

"Also featured are various dark, moody décor, dark furniture, more of a library-type, man-academia booths. I also have a mixed, early-Americana, pioneer-woman type booth," said Benishek.

Everything offered for sale is required to be vintage, which in the shop's definition, is 20 years old at least.

There is a books booth called Flut-terby Nook, which offer vintage and used books utilizing a credit/exchange interaction.

"You can bring books in and get credit to buy other books, which encourages fresh stock coming in," said Benishek.

Even when Benishek was younger, she resonated with the traditional way of life, admiring the old ways.

"As a teenager I'd always loved antiques and even wore vintage clothing. My mom was into antiques. I love the nostalgic feel of that era," said Benishek.

Wanting the name vintage in the title – not antique, because not everything is antique – Benishek settled on The Vintage Church Mouse.

"I wanted the word 'church' in my

Five North American native shrubs for the garden

Here are a few of the many North American shrubs you may want to include in your landscape. As always, make sure each is suitable for the growing conditions, hardy for your location and will fit the available space once mature.

and songbirds with buttonbush (*Cephalanthus occidentalis*), which is native to much of North and Central America. It grows 5-8 feet tall, prefers full to part sun, moist to wet soil and is tolerant of heat and compaction. It is late to leaf out but your patience is re-

warded when the 1-inch diameter, fragrant white flowers appear in summer, attracting a variety of pollinators. The flower heads mature to red and the round seed heads provide food for songbirds.

Consider including one or more of the North American native roses to your landscape. Look for those species native to your area and ones that complement your garden design. Grow them in a sunny location with plenty of space and good air circulation for the best flowering and fewest disease problems. Enjoy the flowers and many pollinators that visit and the colorful fruit (rose hips) that songbirds enjoy.

When looking for a drought tolerant shrub consider ninebark, *Physocarpus opulifolius*. Watch for white or pinkish flowers and visiting pollinators and songbirds dining on the seeds. Place the plant where you can appreciate the exfoliating bark which reveals layers of reddish to light brown inner bark and looks great against a winter sky. Hardy in zones 2-8, it prefers full sun in northern locations and benefits from a bit of afternoon shade in the south.

Plant common elderberry (*Sambucus canadensis*) if you need a vigorous plant to control erosion, support pollinators and songbirds and naturalize large spaces. Hardy in zones 4-8, it tolerates both wet and dry soil and is often included in rain gardens. The fragrant white flowers appear in summer and are used to make elderflower

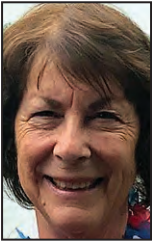

Marsh presentation looks at Townsend history

Kathleen Marsh will be the featured speaker in Lakes Country Public Library's Speaker Series on July 15 at 5:30 p.m. in a presentation that includes rare photos and fascinating facts that might have been lost to history.

The Town of Townsend, originally known as Johnson Siding, was born in the late 19th century. A tiny, tenacious logging settlement, it was a rough and tumble remote outpost with a bad reputation. At its founding, no one could have imagined that one day Townsend would be home to million-dollar mansions and find itself in the top two assessed value municipalities in Oconto County.

It could not have happened without Chicago and Northwest Railway

using it as a transportation hub. The railroad shipped millions of sawlogs to the mills in Oconto and provided passenger service for decades, selling the last ticket in 1950. The route later became a corridor to facilitate construction of state Highway 32.

Townsend's unique history was recounted by Marsh in three volumes of "The Truth About Townsend" and "Townsend Time, a 2016 Centennial Tribute." All are available at Lakes Country Public Library, 15235 State Highway 32, Lakewood. A limited supply of free copies of Volume II and III.

title, and thought I should have a mascot so I thought of 'poor as a church mouse' or 'quiet as a church mouse,' well-known sayings," said Benishek. "We decided 'The Vintage Church Mouse' would be appropriate."

At this time Benishek runs the shop by herself.

"I have no helpers. A vendor I'm in the process of training is learning, but as of now there is no one but me," said Benishek.

Celebrating the opening of The Vintage Church Mouse, Benishek plans on holding a ribbon cutting ceremony June 30 at noon, with the Shawano County Chamber of Commerce promoting the event. The public is welcome to attend.

"I'm hiding a dozen mice throughout the store for the ribbon cutting event. For every mouse you find, your name will be placed in a drawing for a free gift

basket," said Benishek.

Karen and Jim Benishek have been married for 41 years and have seven adult children and four grandchildren, with one on the way.

"I have customers that stop in and tell me they looked up to admire the church and seeing that it's a store, decide to stop in," said Benishek. "I want my place to be welcoming and comfortable, where people are encouraged to bring friends, bring kids, or come alone — to find something that they enjoy and what they'd like in their home, or just to browse. I feel God closed other doors for me and then opened a window and especially these stained-glass windows. I trust God and know His good hand is on me always."

water. The purple-black fruit is used to make jams, jellies and wine and is eaten by birds.

The fruit of another native elderberry (*Sambucus nigra*) is also black and not considered as tasty as those of the common elderberry. Always cook or ferment the fruit of both as eating uncooked fruit can cause nausea, diarrhea and vomiting. The flowers are edible and can be eaten raw or cooked.

Give elderberries plenty of space as they quickly grow and spread. Regularly remove suckers and seedlings if you need to contain the size of these vigorous plants.

Add year-round greenery along with shelter and food for songbirds by growing one of the North American native junipers. They tolerate full sun and well drained to dry soil once established. Songbirds and small mammals

feast upon their fleshy cones that have also been used to flavor gin and season some foods.

Check with your local garden centers and plant nurseries as more of them are selling native plant species. You will also find cultivars of native plants being bred for unique features or more compact growth to better fit into urban and suburban landscapes. Find out more about native plants at the Lady Bird Johnson Wildflowers Center website, www.wildflower.org, and from your local extension service.

Spring migration ends; memories remain

As spring bird migration comes to an end, I feel a hint of melancholy. The season's excitement, anticipation and daily discoveries give way to quieter days. Still, this year's migration left me with a set of experiences and memories that will linger long after the last migrants have passed through to their northern breeding grounds.

Many of my migration adventures come through field trips organized by the Natural Resources Foundation of Wisconsin. This year, they offered 280 educational excursions across the state, all aimed at supporting conservation, connecting people with nature, and promoting stewardship.

My migration season began at Wyalusing State Park in Wisconsin's southwest corner. I had never visited before and was hoping to see a Kentucky warbler, one of the state's most sought-after "forest phantom" warblers known to breed there.

Like most birding trips, the day began early, when birds are most active. The forest was filled with song as males sang vigorously to establish territories and attract mates. There was more going on than just singing.

Throughout the morning, males of various species pursued females

through the trees in aerial chases resembling fighter jets weaving and diving through the canopy. Females darted and maneuvered to evade their suitors while determined males followed closely behind. Watching this seasonal drama unfold was every bit as fascinating as spotting the birds themselves.

As our group explored the park, we walked along Sentinel Ridge overlooking the confluence of the Wisconsin and Mississippi rivers. There we learned about the Native American mounds that overlook the valley and the area's connection to one of North America's greatest conservation tragedies: the extinction of the passenger pigeon.

The ridge once lay along a migration corridor traveled by immense flocks of passenger pigeons. Once numbering in the billions, the species vanished in the early 20th century, the last dying in captivity in 1914. A monument overlooking the river honors the species and serves as a reminder of what can happen when wildlife is taken for granted.

Although the Kentucky warbler never appeared, the trip still delivered highlights. A striking cerulean warbler descended from the tree tops for close

views, and a black-billed cuckoo posed with a worm dangling from its beak. Baltimore orioles seemed to be flitting everywhere. It was as if a clown hidden in the canopy was juggling oranges between the branches.

The next NRF trip took me to Door County, where favorable winds had concentrated migrating warblers. Our group recorded 19 species including a Canada warbler hopping between shrubs so fast I couldn't keep up, a Nashville warbler foraging among catkins, and a black-throated green warbler whose buzzy song helped us track him down.

The only warbler with a tubular tongue, a striking Cape May warbler was sipping nectar from flowering buds. Alexander Wilson first observed the species in Cape May, New Jersey, giving it its name, though it was not seen there again for more than 100 years.

American redstarts appeared to be singing everywhere, fitting for a species whose males may hold multiple territories. We also were ecstatic to see a Blackburnian warbler unusually low in the canopy, its flame-orange throat flashing in the spring light. Did you know they are the only warbler in North America with an orange throat?

On the drive home, I stopped at Ken Euer's Nature Area in Green Bay, where birds were fully

engaged in the business of spring — establishing territories, attracting mates, building nests, and a couple of tree swallows in the process of, well, filling those nests.

Wilson's phalaropes swam in tight circles while northern waterthrush patrolled the shoreline. Nearby, short-billed dowitchers rapidly probed the shallows for food, sometimes plunging their entire heads underwater. The entire landscape buzzed with activity.

My final NRF trip took me to Wisconsin Point, the narrow sandspit between Superior and Duluth. There, birders can scan Lake Superior for waterbirds, search

mudflats for shorebirds and explore nearby woods for songbirds, all within a relatively small area.

While seeing a great crested flycatcher up close and an American bittern in the open were memorable, the true highlight was learning from our guide. His unique and creative lessons on bird identification while they are flying, swimming, and at rest, were both entertaining and unforgettable, leaving me a better birder and deeply appreciative of the experience.

As spring migration winds down, I feel both gratitude and a touch of wistfulness. The season

offers a chance to witness nature's most remarkable spectacles and, briefly, to feel part of them.

The passenger pigeon remains a sobering reminder of how quickly abundance can vanish when stewardship is neglected. By learning from the past and supporting conservation efforts today, we can help ensure future generations continue to experience the wonder of spring migration for years to come.

COURT NEWS

SHAWANT-MENOMINEE CIRCUIT COURT

• Chelcia Rose Cloud, 36, Redby, Minnesota, pleaded no contest June 16 to possession of narcotic drugs and a misdemeanor charge of possession of an illegally obtained prescription. Judge William Kussel Jr. levied fines and sentenced her to 110 days in county jail, time deemed served.

• Brandon J. Chagnon, 25, Rhinelander, pleaded no contest June 16 to intimidating a domestic abuse victim and felony bail jumping. Judge Katherine Sloma withheld sentencing and placed him on five years of probation with conditions.

• Maria J. Pecore, 37, pleaded no contest June 11 to possession of methamphetamine, possession of THC (second or subsequent offense) and a misdemeanor charge of possession of drug paraphernalia. Kussel imposed and stayed a prison sentence, then placed her on two years of probation with conditions consecutive to any other sentence she is currently serving.

• Joshua L. Slewinski, 36, Shawano, pleaded no contest Feb. 20 to exposing himself to a child and child enticement. Kussel sentenced him June 15 to seven and a half years in prison followed by five years of extended supervision with conditions.

• Shane J. Schreiber, 46, a Shawano man serving a sentence at Redgranite Correctional Institution, pleaded no contest June 19 to two counts of manufacturing with intent to deliver amphetamine, possession of drug paraphernalia to manufacture or store methamphetamine, possession with intent to deliver heroin, possession of cocaine (second or subsequent offense) and maintaining a drug trafficking place. Sloma sentenced him to 10 years in prison

followed by seven years of extended supervision.

• Dakota L. Tomow, 37, Wausau, pleaded no contest June 18 to battery or threat to a judge, prosecutor or law enforcement officer, six counts of misdemeanor bail jumping and a misdemeanor charge of disorderly conduct. Kussel withheld sentencing and placed her on four years of probation with conditions.

• Destiny M. Spruce, 45, Bowler, pleaded no contest June 17 to first-degree recklessly endangering safety, fleeing an officer in her vehicle, possession of an electric weapon, battery or threat to a judge prosecutor or law enforcement officer, two counts of misdemeanor bail jumping and misdemeanor charges of operating a motor vehicle while intoxicated (third offense), criminal damage to property, and possession of drug paraphernalia. Kussel imposed and stayed a prison sentence, then placed her on three years of probation with conditions.

• Samantha M. 2 Revolutionary War veterans buried in northeast Wisconsin

Both members of Stockbridge tribe

Forty veterans of the American Revolutionary War have their final resting place in Wisconsin, with two of them in Outagamie County.

Both were members of the Stockbridge Tribe, which did not officially merge with the Munsee community until 1836, at which time both men had already died.

According to the Wisconsin Society of the Sons of the American Revolution, the 40 veterans moved to the Wisconsin Territory later in life and are buried in 25 cemeteries across the state.

The gravesites for Hendrick Aupaumut and Jacob Konkapot Jr. are impossible to locate. They are buried in the old Stockbridge Cemetery on the former Frank Thelen farm, near Kaukauna in Outagamie County.

The Thelen farm no longer exists, and the area is now a residential development.

A historical marker, in tribute to Konkapot and Aupaumut, is located in Thelen Park, nearly where the cemetery existed.

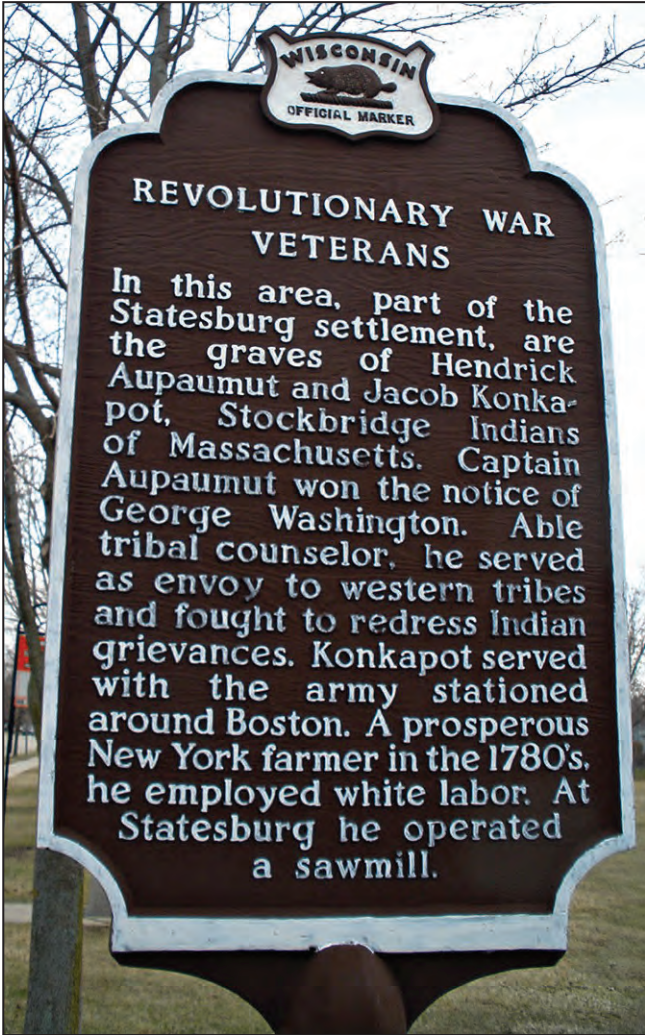
The Wisconsin Society of the Sons of the American Revolution provided biographical sketches of the veterans based on the accounts given by the soldiers in their pension applications and, in some cases, their military service records.

Hendrick Aupaumut (c. 1757-1829)

the son of a chief sachem, was born in Stockbridge, Massachusetts. He enlisted in the Continental Army at age 18 on June 23, 1775. By August of that year, he was serving as a private in Capt. William Goodrich's Company of Indians, Col. John Paterseon's Regiment, during the siege of Boston.

During the 1777 Saratoga campaign, Aupaumut acted as the lieutenant of Native American scouts under Capts. Nimham and Mtohsin. In 1778, he survived the massacre of Stockbridge tribal members in the Bronx, New York, and took command of the Indian company on the death of his captain.

In 1779, Gen. George Washington promoted Aupaumut to the temporary rank of captain. He enlisted regularly and remained in the service through 1782.

Aupaumut reenlisted with the Army during the War of 1812 and served under Gen. William Henry Harrison, who would go on to be elected president of the United States in 1840.

In 1829, he moved to tribal lands on the Fox River near Green Bay. Late in life, Aupaumut translated religious texts into the Mohican language, wrote a traditional history of the tribe and, after 1811, became chief sachem of the Mohicans.

Aupaumut died in 1830 at the age of 72.

A bicentennial marker about Aupaumut is located on a traffic island near the intersection of Reaume Street and Hendricks Avenue in Kaukauna.

Also, near and south of the Calumet County village of Stockbridge, south of Kaukauna on state Highway 55 is another Stockbridge cemetery. An engraved stone in that cemetery lists Aupaumut.

Jacob Konkapot Jr. (?-1835)

The birth date of Jacob Konkapot Jr. is not known, but he was also a scout in the American War for Independence.

He enlisted May 2, 1775, for an eight-month term in the same company as Aupaumut.

Konkapot served at the siege of Boston for three months and seven days.

He moved to Wisconsin with the first migration of Stockbridge members around 1822 and established a small sawmill on a creek near Kaukauna, which today is known as Konkapot Creek.

Today, a highway marker can be found on the bridge over the creek.

Konkapot bled to death as the result of an accident felling timber.

'Doc' keeps Harley-Davidson brand going strong after 50 years

Multiple businesses spring from repair shop

What started as a motorcycle repair shop in a rented Shawano garage almost 50 years ago is now a motorcycle mecca that draws visitors and customers from throughout the world.

The person behind the venture is 75-year-old Stephen "Doc" Hopkins, who can usually be found at Doc's Harley-Davidson off of state Highway 29 between Bonduel and Pulaski.

"I started April 1, 1979," Hopkins said. "I rented a tiny little stall in a half-garage in Shawano. Five years prior to that, I was working for the Harley-Davidson dealer in Shawano, which is what S&S Marina is today. I asked him if it was OK if I started a little repair shop. I wasn't a Harley dealer yet, but we had quite a following of people and I was extremely busy.

"Two days before I opened my door, I was fixing the place up, painting and putting my tools away and a man came to me and said, 'I need my bike fixed, I have to have it for work

in the morning, can you fix it right now?' I said, 'Sure,' so I dropped what I was doing and fixed his motorcycle. I made 75 (dollars) on the parts and labor. That was my month's rent, so I knew I'd be there at least a month.

"I was working in my little workshop and I had a lot of work to do myself. There was also a Harley dealer in Manawa, and he had three mechanics working for him. They had all the tools and equipment, but they had no way of knowing how to use them. They could not build motors and transmissions.

"The fellow that owned the Harley shop was bringing me all of his heavy engine and transmission work twice a week, dropping it off and picking it up. One day, I said, 'Hey, if you ever want to sell your Harley franchise, let me know.' He walked out the door and I thought he doesn't want to. Two weeks later, the phone rang and he said he has all the figures together. I ended up buying it from him and moving it back to Shawano. By then, I had moved over to Shawano's industrial park. Once I got going with Harley, I had to open a 5,000-square-foot showroom. We outgrew that three times and added on when we could."

Fast forward to the late 1990s, and Hopkins started thinking of expanding his business and relocating again. He purchased 72 acres of farmland

along Highway 29 in 1997 and opened Doc's Harley-Davidson of Shawano County in April 1998.

"Harley recommended that we get out of the industrial park and get out on a major highway where we could be seen," he said.

Besides a showroom and repair shop, the business has grown over the years and now includes a classic car and motorcycle museum, Timeline Saloon and BBQ, Timeline Antique Mall, Doc's Full Bore Outdoor, Hog Barn Banquet Hall and Doc's Zoo.

"I never thought it would get quite this big," Hopkins said. "Once I moved out here, I had plenty of room to expand. I've always loved animals, so I made room to put my animals out here. Now, we have camels, kangaroos, tortoises and alligators."

Hopkins' love for cooking led to the Timeline Saloon and BBQ, which opened in 2010.

"I brought all my homemade recipes to the restaurant," he said. "I didn't really have that vision for a long time, but I decided that if I could come up with a good recipe for baby back ribs, I'm going to do that. I built my own rib-cooking machine and fine-tuned and worked on my recipe for three years. I figured it out."

Branching out into

other ventures has worked out for Hopkins, who said he's met visitors from all over the world.

Harley-Davidson Inc. began manufacturing motorcycles in Milwaukee more than a century ago and the brand is as popular as ever, according to Hopkins.

"I think it's the fact that it's made right in Milwaukee," he said when asked about the brand. "It's an American thing and the Harley has a certain sound. You can't reproduce that sound, and people love the sound of the Harley, the size of the Harley and the fact that it's made in America. It's always been an iconic motorcycle that people have followed for many, many years."

However, Hopkins has noticed a shift over the years.

"It seems like all the baby boomers were the ones that really wanted to be in the Harleys, get Harleys and couldn't get enough of them," he said. "For years, we could not get enough motorcycles from the factory. Over time, we were able to get more. We used to sell 250 motorcycles a year. Now, we're down to 47. It's not just Harleys. It's the motorcycle industry across the board."

"They are not selling like they used to. Maybe the moms have got the

youth freaked out about how motorcycles are not safe. It seems like the younger generation would rather be on their cell-phones or playing a game pretending they're riding a motorcycle instead of actually riding a motorcycle."

On the other hand, Harley-Davidson merchandise — everything from clothing to gear to dartboards to plush animals — remains popular.

Although he missed it last year, Hopkins will ride in Bonduel's upcoming Fourth of July parade.

He doesn't have any special events scheduled for America's 250th celebration at his business but expects plenty of visitors and customers during the weekend.

"My gal Joy (Tuminic), she and I are going to drive a 1924 four-cylinder

Henderson motorcycle that we're going to doll up with 250th flags and drive it to the Bonduel parade," he said. "I have some pretty cool flags ordered, and that'll be a fun event. We didn't do it last year, but we'll be back at it again this year."

Although Hopkins is 75, he doesn't see a day in the near future when he'll stop showing up at the business he spent almost 50 years building from scratch.

Once he does, however, it'll free up more time for him to take a ride in the brand of motorcycle he's been loyal to since he was a teenager growing up in Algoma.

"It's a freedom of being out on the road," Hopkins said. "It's a feeling you can't really describe. You have to experience it."

Who parked an army tank at a Shawano city park?

Children played on it instead of a swing set. Adults drove past it day after day, most likely not giving it a second thought.

For those who did wonder, how did a World War II Sherman tank end up at the corner of Lieg Avenue and South Main Street in Shawano?

According to the Shawano County Historical Society, in the late 1940s and early 1950s, as the U.S. military was modernizing its hardware, and there was lots of WWII surplus.

At the same time, communities around the nation and organizations like AM-VETS, American Legion and the VFW were looking to build memorials to WWII.

Shawano's Sherman tank arrived in July 1953 through the efforts of VFW Post 2723 and the TACOM group of the U.S. military. The tank was named by the British for American Civil War Gen. William Tecumseh Sherman.

"It was acquired by the VFW post in 1953 for display in town," Joe Dillenberg with the VFW told the historical society. "Technically, it is still on loan from the federal government. It seems that quite a few veterans' organizations in Wisconsin and Minnesota secured tanks for display in the mid-1950s from TACOM."

TACOM is the United

States Army Tank-automotive and Armaments Command, and they have a program where organizations can request surplus military equipment to display.

The program still exists but when contacted, TACOM, which is based in Michigan, doesn't have any records of this Sherman arriving to Shawano. However, the Sherman tank was built by Ford and was turned over to the military on May 19, 1943. Its serial number is 12236, and registration number is 3054391. These numbers and dates are still on the tank today.

According to Pierre Olivier, a tank expert with the Tank Encyclopedia group, "I think this Sherman tank served for training state-side during WWII. It was later rebuilt and upgraded in the 1950s and most probably served with a National Guard unit or was simply kept in storage before being sold as surplus."

Technically, it's an M4A3 Sherman where the A3 designates that it's built by Ford. The Sherman was the most widely used medium tank by USA and Western Allies in WWII. The total number of M4s produced was more than 49,000 with 1,690 by Ford.

The following account is from Danny Staub. His grandfather, SSGT Reuben Staub, drove the tank from Madison to Shawano.

"My grandfather, SSGT Reuben P. Staub, from Shawano, was the head of the local VFW. He was given a police escort from an army base by Madison, up the highways and what is now Interstate 41 as he drove it alongside on the shoulder of the highway. He talked of this journey until the day he passed in 1969. He stated on how the tracks ripped up the roadways. At that time, the tank still had an engine, it and can be fully functional, which was part of the deal when it was donated.

"My grandfather owned Stauby's Refrigeration after he got out of WWII. He was MIA presumed KIA for 15 months at age 20. He and his B24 bomber crew were ordered to bail out over Ploesti Romania on D-day June 6, 1944, as his squadron, the 98th bomb group 415th division, was on an easy mission out of Lecce, Italy, to bomb the oil yards in Romania as they were supplying the Germans with fuel.

"After their plane was shot up and hit by flak, the right engine caught on fire. The pilot gave the order to the six guys in the back to bail out over Romania. My grandfather never jumped out of a plane before that. He had his shoes and socks off as he was the belly gunner, and they needed the traction to kick the big gun around in a circle

underneath the plane.

"Just prior to being hit, my grandfather was asked by SSGT Celestino H. Garcia from Bexar, Texas, if he would like to switch gunner positions for the day as Grandpa had the best view of the country below. Grandpa Reuben obliged, and before he was able to get his socks and boots on, they came under fire from the enemy.

"The back crew all bailed out. My grandfather was a bit slower and drifted away from his crew mates that were picked up by friendly civilians in a communist-occupied Romania. Grandpa, with a map and

coordinates in his pocket started walking, but only at night, through enemy territory at 20 years old. He walked from Romania to Turkey, more than 1,500 miles in 15 months. He escaped being captured twice by German officers.

"My grandfather never spoke of his war time days except to his sister immediately after he got home. Her name was Ardis Staub from Shawano. Grandpa told her that the day he jumped from the plane that his best friend had asked him to change gunner positions, and we all know that my grandpa did. SSGT Celestino H. Garcia from Bexar, Texas, was

the only fatality that day. He died from an enemy airship gunshot to the head as he sat in the glass bubble under the plane where my grandfather had just been seated a moment before.

"I cannot imagine what my grandfather must have endured. I know that he traded my grandmother's Shawano High School class ring for a pair of sandals from a farmer. I also know that Romania is a very mountainous area that would not be easily traversed in summer and frigid winter. Grandpa Reuben died of brain cancer at the King Veterans Hospital in 1969."

Oconto County history traced back 12,000 years

Museums offer unique look at the past

Oconto County is a significant historical and cultural center in northeastern Wisconsin. Its history reflects its importance as a blend of ancient indigenous cultures, European settlement and industrial development.

Archaeological sites indicate that Paleo-Indians settled in the area 10,000-12,000 years ago. About 6,000 years later, the Old Copper culture began. The Oconto Archaeological Site contains burial grounds and artifacts, including copper tools that highlight their early metalsmithing practices.

Oconto County has been governed by four political entities in its recorded history: the Menominee, before European contact; the French, who claimed the Great Lakes region in 1671; the English, who took possession in 1763; and the United States, which claimed it in the 1783 Treaty of Paris that ended the Revolutionary War.

The county's name is derived from Oak-a-toe, an early Menominee settlement. In 1669, Jesuit missionary Father Claude Allouez introduced Christianity to local tribes. French traders followed, bartering knives, axes, beads and blankets for prime fur pelts, and a mostly peaceful coexistence ensued.

In the early 1800s, wealth-seeking adventurers arrived to harvest the region's majestic white pines, creating a logging industry that attracted European immigrants. Settlement began in earnest when John P. Arndt established Wisconsin's first commercial sawmill and lumbering

operation on the Pensaukee River in 1826.

In 1851, Oconto County was formed by carving it from Brown County. There wasn't a single regular road in the county, only trails that led from nowhere to nowhere. The sawmill settlement of Oconto, which lies at the mouth of the Oconto River, was chosen as county seat.

By the 1860s, the city of Oconto had become a major industrial and commercial center with more than 1,000 residents and 12 sawmills operating simultaneously. Industrial growth swelled again when the Chicago and Northwestern Railroad reached Oconto

in 1871. Largely escaping the Peshtigo Fire that year, Oconto's economy continued to thrive on lumber, trade and, later, diversified industries. Marinette County was separated off in 1879.

Fueled by the country's insatiable demand for sawlogs, lumber barons like Farnsworth, Holt and Stephenson acquired fame and fortune. Immigrant laborers flooded into the area, which soon served as a hub for the logging industry. Steadily marching north and west, logging crews systematically sawed down the Northwoods.

For a first-hand account, read "A Wisconsin Lumberman Looks Backward" by W.A. Holt (available online). Holt's book recounts events as the logging boom went bust. Ruthless "cut and run" practices decimated the pines; a second cutting took out the hardwoods. Thankfully, the Civilian Conservation Corps, a key part of FDR's New Deal, restored much of the woodlands. The Forest Service, founded in 1905, has been tasked with preserving them.

The first newspapers published in the county were the Oconto Pioneer in 1859 and The Lumberman in 1864.

The Oconto Reporter was founded in 1871, gradually absorbing other publications and operating as the Oconto County Reporter. The Oconto County Times Herald was created in 1952 by combining the Oconto Falls Herald, founded in 1899, and the Gillett Times, which published its first issue in 1927.

Over the past century, Oconto County has flourished and flourished. Major employers like Bond Pickle, Carver Yachts and Suring Even-Flo closed, but the beat goes on with employers like ST Paper in Oconto Falls and Nicolet Plastics in Mountain.

There are two first-rate hospitals, Bellin Health in Oconto and HSHS St. Clare Prevea in Oconto Falls. Quality public schools operate in Gillett, Lena, Oconto Falls, Oconto and Suring. Six exceptional independent libraries meet the demand for 21st century services.

All of this and so much more happens despite unique geographic and demographic challenges. Shaped like three steps, Oconto County is composed of three distinct regions. The most densely populated is the southern part, the center for

government services. Residents find work locally and in the Green Bay area.

The middle section is rural-agricultural, with small towns, farms and a mega dairy operation in Suring. The northern portion is forested with natural and man-made lakes. It relies on retirees, logging and tourism for economic survival.

Despite these divergences, close-knit communities provide essential services and help to those in need.

Wisconsin Veterans Museum anchors state's contribution to time capsule

As part of the America250 national celebration, a time capsule will be buried on July 4 at Independence National Historical Park, in Philadelphia, Pennsylvania.

America's Time Capsule contains objects from all 56 U.S. states and territories and the three branches of the federal government. The Wisconsin Veterans Museum contributed items that represent the state of Wisconsin and its many people.

Wisconsin's submission includes items related to Old Abe the Civil War eagle: a feather of Old Abe's, a photocard of Old Abe sold at the 1876 Philadelphia Centennial Exposition and a military badge with his likeness.

In addition to the Old Abe materials, letters from Wisconsin's Gov. Tony Evers, Lt. Gov. Sara Rodriguez, Secretary of State Sarah Godlewski, State Supreme Court Chief Justice Jill J. Karofsky, Wisconsin Sen. Dianne Hesselbein and Wisconsin Veterans Museum director Chris Kolakowski were sent.

Rounding out the submission are items from Native nations within the state. Two of those nations, the Oneida and Stockbridge-Munsee, fought with the colonies during the War of Independence.

"It is an honor to help assemble this message for generations 250 years in the future," Kolakowski said. "As we considered what to include, Old Abe was a stand-out choice. He was a star of Wisconsin's contribution to the Centennial Exposition in 1876 and remains an enduring symbol of the state to this day."

As an official America250 project, America's Time Capsule creates a national record of the United States at 250 that will not be seen again until 2276.

About Old Abe Orphaned in the North Woods, the eaglet was captured by Ogi-maa Weigiizhig, Chief Sky, of the Lac du Flambeau Band of Lake Superior Chippewa Indians in 1861. The eaglet was sold and later offered to a militia company in

Eau Claire. The company organized with the 8th Wisconsin Infantry Regiment for service to the Union Army.

The eagle was named Old Abe after President Abraham Lincoln and became the regiment's mascot. Old Abe survived many Civil War battles as he rallied the troops. His service to the Union resulted in widespread fame, and his life after the war reflected the esteem with which Wisconsin and the nation held him.

As a well-loved veteran, he lived with a caretaker in the Wisconsin State Capitol when he wasn't touring the nation in support of veteran causes. Today, a statue of him overlooks the State Assembly Chamber.

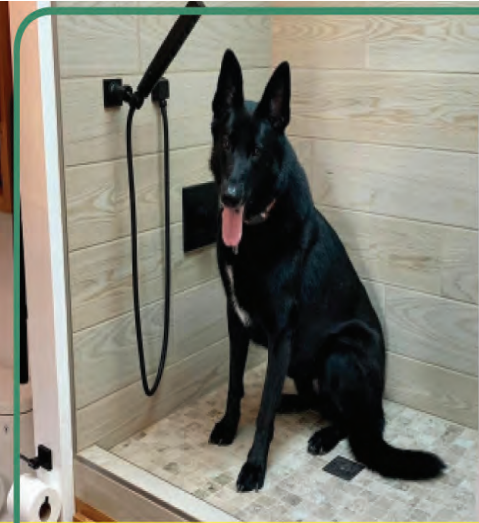
A feather from Old Abe is included in the capsule. When Old Abe died in 1881, his body was preserved in taxidermy and remained in the State Capitol. Unfortunately, in 1901, a fire destroyed the building and Old Abe's remains.

However, the eagle was such a celebrity that Wisconsin governors would present his feathers as gifts to dignitaries and citizens. These many feathers were returned to the state after the fire to represent Old Abe and are now in the care of the museum.

A card with a photograph of Old Abe from the 1876 centennial celebration is also included.

Old Abe toured the nation for the centennial and was exhibited for six months at the Centennial Exposition in Philadelphia. The card is signed by Wisconsin Gov. Harrison Ludington, himself a descendent of the American Revolution, with one ancestor who was one of George Washington's aides-de-camp, Sybil Ludington.

A badge from the 101st Airborne Division is the third Old Abe related item included. Created in 1921 as the 101st Infantry Division in Milwaukee, the division used Old Abe on their insignia as a nod to the state's military tradition.
