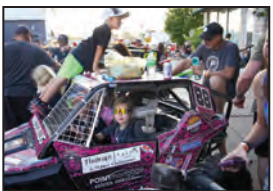

DRAMA AT THE COURTHOUSE

Pollock named to District 27 seat

Steve Pollock is the new representative for District 27 on the Shawano County Board, following a contentious nomination process at the July 22 meeting. Pollock, a retired We Energies employee, was nominated by Chairman Tom Kautza and approved by the board with 19 in favor, five against, one abstention and one member absent.

Voting against Pollock's appointment were Jeremy Gretzinger, Curt Korth, Randy Mallmann, Joe Miller and Mike Wizner. Collin Pomplun abstained, and Matt Pleshek was absent. The drama - a word used often by supervisors - began immediately after the Pledge of Allegiance. Miller requested a change in the order of the agenda to place public comment and the reading of letters to the board before the appointment of Pollock.

Kautza had set the agenda with the appointment to immediately follow the opening of the meeting. "We have public comments and also communication pertaining to this that the supervisors should hear before ...," Miller said.

"Does somebody have something against Steve?" Kautza interrupted, to which Miller responded, "That's so narrow-minded it's pathetic."

And so it began. Enough supervisors agreed with Miller to change the agenda. Kautza, as is his

prerogative as board chairman, limited public comment to five speakers at two minutes each. Only two members of the public addressed the board. Tim Steffen, the only District 27 resident to actively seek the appointment, spoke first. Kautza refused to nominate him, first due to him being chairman of the Shawano County Republican Party (the county board is non-partisan) and then because Kautza viewed him as the cause of too much drama in the past year.

"I never expected the kind of reaction that I received from the chairman," Steffen said. "It's been a long time since I have been so disrespected and so slandered by this man. It's unbelievable. What we have just witnessed here is the manipulation of an agenda to avoid public comment."

He said when residents can speak out, it leads to suspicion and loss of trust in government.

"When we lose that trust, we have chaos," he said.

As Steffen's two minutes expired, Kautza said, "Tim, your two minutes are up. This isn't a movie. We're not making 'Shawano As The Days Turn.'" "Why are you making comments like that?" Gretzinger immediately asked. "Be a professional." Mallmann agreed. "Tom, you don't help yourself when you make comments like that," he said. "I never heard or got a phone call from a member of the public telling me that I'm doing something wrong," Kautza said.

Mallmann reminded him that he talked to Kautza in person about this issue. "We need a leader that has to act professional," Mallmann said. Miller said Kautza's refusal to consider Steffen due to his GOP leadership role was discriminatory. "You cannot discriminate against anybody, a member of the public or any one of us, for political affiliation," he said. "You can't do that." Kautza said his decision to pass on Steffen was not the first time he

overlooked an interested candidate for a seat on the board. He cited the case when he chose Dick Olson over Al Kuhn (a current supervisor) for a vacant District 17 seat a few years ago. "I knew Dick Olson personally, so I picked him," Kautza said. "Nothing personal." He also said he wasn't initially in favor of then-Supervisor Raymond Rigsby being appointed to the vacant county clerk position. He said Rigsby had a set of predetermined conditions.

"Why weren't we informed of that?" Miller asked. "Why didn't you ask?" Kautza responded. Jackie Miller also spoke. She said she was appalled by what she has witnessed at this and the previous meeting. She also filed a written complaint against Kautza. "It concerns the selective enforcement of public comment rules, the suppression of discussion on a matter of significant public concern, and the

Koreans, Menominee trade cultures

Food, talents key to understanding each other

Exchanging traditions and gaining knowledge of other cultures has been a tradition between several Native American tribes in Wisconsin and a group of Koreans based in Silver Spring, Maryland, and the latest exchange took place over three days before culminating in a public showcase July 23 at the Omaeqnomenewak Wetohkatikamek Center in Keshena.

The Korean delegation presented a feast to its hosts that included rice, marinated beef and other cultural delicacies, and after that, everyone gathered in the gymnasium as the visitors showcased talents that encompassed both their Korean past and their modern ties in the United States. The youngest in the visiting group of almost 90 people was 8 years old, and the oldest was 84.

The 84-year-old, Jung Hong Kim, wowed the audience with a saxophone rendering of "Amazing Grace" as others in the group did skits, performed in the orchestra, sang in the choir and more.

Chun Hi Roh, the delegation's arts and crafts director, said that providing a place for knowledge and cultural exchange to flow is important, and

the majestic beauty of the Menominee Nation helps to facilitate that.

"It is a great honor and a privilege to serve you, Menominee Nation," she said. "This year, we have 89 people, all from Maryland at the same church. We came to learn from you, and we did. We had cooking demos, hair weaving, finger weaving and the history museum of Menominee."

Because the use of tobacco in sacred ceremonies is important to the Menominee, the Korean delegation presented an original Korean tobacco pipe to Menominee representatives. Roh said it was important that the visitors leave with more of an awareness and appreciation for the Menominee tribe.

"This year, we especially go away with more awareness and thankfulness for the preservation of Menominee culture,"

she said. "The herbs and the plants and everything, they explained to us the Menominee is the only tribe that preserves their traditions for thousands of years. They withstood government and won. They're preserving the culture, and we applaud you for that effort. We go away honored, Menominee Nation, that we can be a part of your nation."

Menominee Tribal Legislator Samantha Grignon said she felt she got a lot from having the Koreans visit the "beautiful reservation that we call home" and teach about the similarities and differences between the two cultures.

"You're welcome to come to the Menominee Reservation and visit us anytime," Grignon said.

Jay Yoon, 74, is in his fifth year visiting the Menominee and feels there's more to learn every year. He said it's worth the 20-hour bus ride from

Maryland to Wisconsin.

"One of the main reasons why we like to share our love to the different people," Yoon said. "Without any conditions, we just show our love. We like to share our cultures, and we like to learn about culture from you. That's one of the main reasons we come here."

He added that the Korean delegation was welcomed the afternoon of July 20 with an assortment of Menominee food. He said the food made the newcomers who hadn't visited the Menominee Reservation before learn about the hospitality the Menominee provide to visitors.

Yoon noted that some of the younger people in the delegation had been corresponding with Menominee counterparts for about a year before meeting each other in person. Everyone soon discovered there were many similarities between the two cultures, including the deep respect for elders.

"Some of them would say that we have similar difficulties so that they can share each other and feel they're more understandable with others," Yoon said. "It's one of the ways they can begin to heal their wounds."

Besides the Menominee, Korean visitors also spent the week on the Stockbridge-Munsee, Ho-Chunk and Potawatomi reservations.

Families skirting residency rules a problem

Bonduel School District dealing with fraudulent claims

insurance statements and immunization records.

Bonduel School District's star is ascending, with enrollment numbers defying state trends, but popularity is causing problems with families skirting the district's residency requirements.

Superintendent Joe Dawidziak said via a Facebook post July 22 that there has been a problem for the last couple of summers with families coming to the schools to enroll and claiming they're living in the district when they don't. Currently, the school district encompasses the villages of Bonduel and Cecil, along with some or all of the towns of Angolica, Green Valley, Hartland, Lessor, Maple Grove, Navarino, Washington and Waukechon.

Parents and guardians are required to sign a form certifying they are residents in the district, and Dawidziak warned that anyone who tries to pass off themselves and their children as residents of the district could be charged with perjury and/or fraud in court. If they're found guilty, they will have to reimburse the school district for the expense of educating their children, he said.

Dawidziak pointed out that the average cost to educate a student in Bonduel public schools is more than \$12,000 per year, and he doesn't like that local taxpayers are footing the bill to educate non-residential students. The state of Wisconsin has open enrollment windows that allow students from outside the district boundaries to apply to attend schools here, and if the applications are accepted, Bonduel gets state funding via the students' home districts.

Families that register with Bonduel schools have to provide an original birth certificate or passport and proof of residency to enroll their children. The proof of residency includes closing statements on property sales or property tax bills, or signed lease/rental agreements and verification forms, along with current utility bills or

In a phone interview, Dawidziak said he doesn't have firm numbers on how many families have tried to skirt the system, but he said it usually starts the second week in July each year, and there are usually one or two families per day that try to do this.

"Whether that's somebody who calls or emails or stops in, it's been almost daily," Dawidziak said.

He believes the families doing this were unable to get in through open enrollment, with their applications rejected for any number of reasons. Some might have realized that even before attempting an open enrollment application, he said.

"A common theme has been marital problems," Dawidziak said. "One of the parents will call and say, 'We're having marital problems, and our son's going to move in with Grandma, who lives in our district. Then we'll find out later that they never moved to Grandma's house and probably never had marital problems. There's a lot of that.'"

It is unfair for taxpayers to pay for students that don't live within the district, Dawidziak said, and it has become enough of an issue to prompt him to put out the Facebook post. He noted that Bonduel is one of only a handful of school districts in the state dealing with this problem at such a level.

"Basically, our taxpayers have been paying for students who don't live there," Dawidziak said. "In doing some research and talking with law enforcement, they seem to think that if you put this (statement) out there ahead of time ... later, when someone gets caught, it holds a lot more teeth."

He added that two families were caught in June, over a month before the residency requirement statement was posted, and if the statement had been in place, those families could have been prosecuted for fraud.

Early impressions of county pleasing to Cicero

Administrative coordinator settling into role at courthouse

Butterflies are nothing new for anyone changing jobs, but when your new co-workers genuinely welcome you, it makes your first days go a lot smoother.

That's what Stacy Cicero said when she started just weeks ago as the new administrative coordinator for Shawano County.

"The one thing that really pleased me when switching jobs ... I cannot speak more highly of the staff here," she said. "They've been very welcoming. They've been very supportive. They're excited to have new energy, new direction, and I am really impressed with the quality of staff in this building. They really know their work, and they care about the community and want to do right by it."

Her first day on the job was June 29. She's met all department heads and is working to having sit-down meetings with each of them.

"I am really impressed with the work that people are doing, the ideas that they have, the passion that they have for their work, how they want to better the county and do good

things for the people that are in their community," Cicero said.

For 20 years, Cicero worked as executive director of Safe Haven in Shawano, which serves victims of domestic and sexual violence.

"The shelter building itself had been just built, so I had to hire all the staff, create all the policies, do the whole opening," she said. "When I started, there were three employees, and when I left, we had 19 full- and part-time."

Those two decades with Safe Haven brought her into regular contact with local law enforcement, the district attorney's office and the courts.

"Working at Safe Haven, I was in the courthouse

a lot, in the courtroom," she said.

Now that she's on the inside, she can see many of the safety issues brought up when discussing plans for a new courthouse — escorting inmates across Third Street from the jail to the courthouse, courtroom security for contentious cases and close contact in the halls between the victims and the accused.

"This was a great building 75 years ago, but it wasn't built for the type of technology that we have today," Cicero said. "The courthouse has grown in staffing. We also want to potentially have another judge. We have more ADAs (assistant district attorneys). We just need

more space."

She's also more aware now of the space constraints and ADA compliance issues.

"I don't know all the different aspects, but I can tell you that the team that has been working on the plan and the building have put a lot of thought, a lot of studying ... a lot of time and energy and thought went into where they are now," Cicero said.

In 2021, she resigned from Safe Haven and took a job with the Wisconsin Department of Children and Families.

"It was very difficult to leave an organization that was my baby," Cicero said. "I built it from the ground up, with a lot of help."

While at Safe Haven,

she had worked with her predecessor at DCF.

"It was managing the domestic violence grants for programs around the state of Wisconsin," Cicero said. "It was a natural progression."

She worked from an office in her home's basement, while using the Green Bay office as her base. She also traveled the state for site visits and drove to Madison for meetings.

Earlier this year, a friend suggested she consider applying for the administrative coordinator position. Her three children are now adults, so she opted to once again work in her local community.

Her older son lives and works in Chicago, while the younger son works in Shawano. Her youngest, a daughter, is studying to be a pilot at Fox Valley Technical College.

Working at Safe Haven, DCF and Shawano County are each unique experiences.

"I think the biggest difference I'm going to have to learn is county government work," she said.

There are some things in common as well.

"I'm used to state work, state statutes, working with that type of thing, writing grants, reading proposals, budgeting, monitoring, all of those types of things, so that will come in very handy in this role," Cicero said.

Budgets, collaboration and troubleshooting

have been consistent themes in her career, as is communication.

"I think communication is going to be key," she said, "but that's a two-way street. If you put out events or meetings, you want the public to attend. We want input."

Cicero has called Shawano home since 1994. Her grandmother lived in the city, and her mother grew up here. Her parents moved to Shawano in 1986 when Cicero was in college.

She studied psychology and sociology in college.

"The social work aspect was always something that I was going to go into," Cicero said.

When her children were in school, she was involved in the parent-teacher organization. She has served on the Salvation Army board the past 20 years or so.

"It's a nice community. It's a great place to raise your kids," Cicero said. "You have the low crime rate, and you don't have to worry about driving across town in traffic. And you're close enough to places like Green Bay, Appleton, Milwaukee, Chicago if that's where you want to go."

Today, she is also the chair of the Shawano-Menominee Resiliency Coalition, which operates Rise Wellness, a center for people in recovery, and is treasurer for the Behind the Badge nonprofit group that organizes Ball of the Badges each year.

Sunny's health improving since harrowing ordeal

Dog has forever home on horizon once he recovers from injuries

A dog found with multiple bullet wounds and other injuries is making a slow but steady move toward a happy ending but is not out of the woods yet, while the Shawano County Sheriff's Department is still investigating who might have caused him harm.

The 35-pound brown mixed-breed dog, named Sunny by the folks at the Shawano County Humane Society, has found a forever home as many in the community have provided an outpouring of support in the days since he was brought in for treatment. Sunny was found July 15 in the Town of Maple Grove near Cedar Drive and Maple Road and was transported to Specialized Veterinary Care of Shawano for treatment.

An initial examination of Sunny showed eight gunshot wounds and a broken leg, all appearing to have occurred two to four days

before he was found. Pam Nowak, humane society executive director, said that a ninth gunshot wound has since been discovered along with broken ribs and heavy bruising around the stomach area.

"He is moving around. He is walking around the clinic a little bit," Nowak said.

She added that the bruising seemed to indicate Sunny had been kicked by someone.

While the humane society regularly cares for abandoned and injured dogs, Sunny's case has been one of the more heartbreaking ones, according to Nowak.

"I've lost so much sleep over this," she said. "It's so sad, so heartbreaking for all of us."

Nowak said there were a lot of offers to provide a permanent home for Sunny, but it appears one of the people who helped Sunny the day he was found will be the one to care for the dog once he recovers. She said the man let her know

as soon as Sunny was brought in for treatment that he was interested in being the dog's new owner.

"He was high on the list, has everything he needs," Nowak said. "He'll be able to care for Sunny all during the day at his work. He'll be able to take Sunny to work with him."

Despite what has

happened, Sunny has been showing a positive attitude, according to Nowak.

"This dog that has been through so much will still wag his tail and greet and try to get up," she said. "It's really amazing. It doesn't seem to have to broken his spirit or his will to survive."

Sunny's story has seemed to galvanize the

Shawano community, as donations and other forms of support have been pouring in.

"The support has been wonderful — the care, the concern, the phone calls, the letters we get," Nowak said. "It has impacted us and shown how many people really, truly care and want to help and do

everything can to make sure the person who did this is found and make sure we have all the support we can to care for Sunny."

The Shawano County Sheriff's Department has not reported any developments in the investigation, but a \$2,500 reward has been offered for information that leads to the arrest of anyone responsible by The Center for a Humane Economy and the Wisconsin Puppy Mill Project. Anyone with information on Sunny or who might have been responsible for hurting him can contact the dispatch center at 715-526-3111 or email Deputy Josh Heider at josh.heid@shawanocountywi.gov.

"It's a huge help, because, even though we're covering all of Sunny's medical bills, we are a nonprofit, and everything is from donations," Nowak said.

DOT rep gives update on road projects

Frontage road considered by Harley dealership

"Your county has a lot of orange barrels and cones." Tony Kemnitz, of the Wisconsin Department of Transportation, made that understatement of the year when he summarized the road construction projects underway in Shawano County this summer.

Kemnitz spoke at the July 21 meeting of the Shawano County Highway Safety Commission.

First he addressed the state Highway 29 project from County Road J to the area of Spruce Road.

"My understanding is they've extended (it) so that's one long 19-mile project," he said. "I think there's about 26 miles of Wisconsin 29 under construction right now."

All of the projects are similar.

"They remove and replace the failing concrete panels. They are all placing new asphalt shoulders," Kemnitz said. "Then obviously when all that's done, we'll dress that up with pavement markings."

Single-lane closures will continue.

He said the project should be wrapped up by mid-September.

Also, state Highway 29 from County Road M to Highline Road near Bondel will feature 11 miles of pavement improvements.

This work includes ramp closures and making improvements to the park-and-ride lot on state Highway 117.

This work will also continue into the fall.

Five miles of pavement resurfacing on state Highway 156 in the towns of Lessor and Maple Grove is substantially complete. What remains is finishing work that will take a few more days.

Of course, the County Road BE repaving was completed in early June, and work on County Road D is nearly complete.

"It's a county project, but DOT has involvement with it as far as oversight and funding," he said. "That removed a bridge and replaced it, installed a new 28-foot wide bridge."

It is substantially complete with the exceptions

of adjustments to the guardrail.

Kemnitz also provided updates on several safety and operation reviews of select roads.

A DOT study determined there is a need for stoplights at County Road BE and state Highway 22 near ThedaCare in Shawano.

"I understand the city has agreed to take control of the intersection; however, instead of a signal, they would prefer a roundabout," he said. "But then the funding is going to be up to the city to figure out."

Kemnitz said funding is available at a 90/10 split for the lights (10% being the city's cost), but no funding is there for a roundabout.

At County Road F and state Highway 29, crash data shows 12 accidents from 2020-24; none were fatal crashes.

"Enough of a crash history that it would support us applying for federal safety money to get that intersection rebuilt in some manner," Kemnitz said.

He said a design team would have to evaluate several alternatives, including an R-cut intersection similar to the new one at County Road MMM.

"I like the County U one a little better than the MMM," noted Shawano County Highway Commissioner Grant Bystol. "It has that turn-lane separation."

The project could be funded by the federal government at a 90/10 cost share. Kemnitz will submit a request for money in September.

Kemnitz also noted the hot spot for crashes, including fatalities, between Broadway Road and

County Road F on state Highway 29. This includes the area in front of Doc's Harley-Davidson.

One alternative is creating a frontage road and an improved interchange at County Road F, also fundable through federal dollars. This would result in no direct access between Doc's and the highway.

"That will be submitted as well in September," Kemnitz said. "I'm excited about that one, making it safer on 29."

He will also submit a request for funds to improve the state Highway 47 and Landstad Road intersection, also the site of a fatal crash.

A single-lane roundabout at state Highway 117 and County Road E is expected. Federal safety money has been applied for to complete the project.

Bystol said the county will reinstall rumble strips on westbound County Road E approaching state Highway 117.

"They are on eastbound approaching 117," he said. "I think they used to be on the westbound, but since it got resurfaced, they were never reinstalled."

Paving on County Road M from Range Line Road to Pond Lane east of Caroline will be completed by the end of July, and the road will open Aug. 7.

Coming up the second week in September will be an asphalt resurfacing of County Road H from Stark Road to County Road HH, north of Shawano Lake. Bystol said the work will be done while the road remains open to traffic.

Motorcycle driver dies in head-on crash in Town of Wescott

A 39-year-old Shawano area man died July 22 as the result of a two-vehicle crash on Hillcrest Lane in the Town of Wescott, according to the Shawano County Sheriff's Department.

At 9:22 a.m., the dispatch center received a report of an accident involving a motorcycle and FedEx delivery truck. Initial reports indicated the driver of the

motorcycle was not wearing a helmet and had possible head injuries.

Multiple Shawano County sheriff's deputies responded to the scene along with fire and EMS units. When deputies and EMS arrived on scene, they provided medical attention to the driver of the motorcycle, but he pronounced dead at the scene.

The driver of the FedEx truck was identified as a 25-year-old man from the Green Bay area.

Preliminary investigation indicates the FedEx truck was traveling northbound on Hillcrest Lane. The motorcycle was traveling southbound on Hillcrest Lane when it crossed into the northbound lane and struck the FedEx truck head on.

The FedEx truck came to rest in the northbound lane of traffic, and the motorcycle came to rest in the east ditch line.

The sheriff's department was assisted by Wescott EMS, Shawano Ambulance and Shawano Fire Department.

No more details, including the names of the individuals, are being released as the investigation continues.

Folk music festival set for Aug. 7-9

Daytime and evening shows, quilt raffle, dance, children's programs make up schedule

About to celebrate its 48th year, the Shawano Folk Music Festival is set to return to the Mielke Park and the Mielke Arts Center on Aug. 7-9.

Co-directors for the 2026 festival are husband and wife Linda Blohowiak and Mike Stiefvater. The two had been crossing paths at the festival for more than 30 years without realizing it. A few years ago, they met up at a house concert, and their mutual love of live music – and each other – resulted in an exchange of wedding vows July 20, 2024.

“Our wonderful, hard-working committee has been working and playing all year long to bring you some of the best music around,” they said in a joint statement. “We’ve rounded up talented artists, crafters and food vendors. So, get ready to sit back and relax, sing along, get a few good laughs and maybe shed a tear or two.”

Anne Hills is the honorary director.

“Selecting musicians ... actually begins on the last day of the festival (Sunday) when we select an honorary director from

among the current year's musicians,” said Norm Cook, one of the organizers. “We look for someone who understands the kind of festival we try to create. That person is the first booked artist for the following year.”

The honorary director then suggests two or three others not on the radar of the organizing committee.

“We’ll choose one of them, and if they’re available, interested and affordable, we’ve got two artists,” Cook said.

From there, organizers select six artists for the evening concerts and a few others for daytime shows only.

“Committee members submit names of solo artists and bands that they know,” Cook said. “We’ll listen to their music and debate each one. Eventually, we’ll have a list that we think will make a great festival. We look for a weirdly eclectic mix of musicians – men, women, solo artists and bands; folk musicians, blues, jazz, bluegrass, classical,

pop, dance music, string bands and anything else we run across.

“It’s the eclectic mix that sets us apart from many other festivals.”

The list is given to the directors who contact the artists, check availability and affordability, and fill the schedule with a mix that’s unique.

A pair of evening concerts are scheduled in the air-conditioned theater.

Pat Wiley and John Wilson will be masters of ceremonies Aug. 7. Performing will be Tom Pease; Ellis, Cohen and Ellis; Hills; and Steve March-Torme.

March-Torme is the master of ceremonies Aug. 8. Playing that night will be Wiley and Wilson, Ilene Weiss, Patty and Craig, and Art Stevenson and High Water.

There are three outdoor venues during the day featuring musicians, crafters and food vendors. Test out your own voice with an open mic all day Aug. 8 in the food tent.

The evening concert performers will also play at these venues and will be joined by Door County Sound, Anything You Want, Wattle and Daub, Schwenke and Srubas, Cigar Box Scott, Pinolio, Dayshawn Taylor, and Brenda Belongia.

The theater comfortably holds 250 for the evening concerts. There are about 500 people attending the festival each day.

“Many audience members are local; others come from across Wisconsin and neighboring states. A few will come from farther away,” Cook said. “Many come back year after year, greeting the friends they’ve made. A few have been coming since the first year.”

He said there are many reasons audience members return year after year.

“We’re the only week-end-long folk music festival in the area (there’s one in La Crosse and another in Marquette Michigan),” Cook said. “We’re small enough for it to be an intimate musical experience and big enough to attract regional and national artists. The artists come for the week-end, not just for a single set, so the audience has a chance to really get to meet them.

“The Mielke Park setting is a perfect site for this kind of festival – beautifully wooded and big enough for multiple outdoor stages for daytime programs, and small enough to be easily maneuverable.”

Cook said artists often ask to return as well, knowing the festival doesn’t feature any artist more than two years in a row.

“Some tell us it’s their favorite small festival – friendly staff, friendly appreciative audience, incredible site,” he said. “And they all mention how much they enjoy spending the weekend with other musicians. They comment on the high quality of the artists we get and how much they appreciate working with artists they’ve never met before, some in completely different musical genres. Some have even returned as audience members, driving from several states away.”

The festival tradition of a quilt raffle is back with this year’s quilt created by Jennifer Tagliapietra, Clintonville.

“This year’s quilt is my take on the Star Pop II pattern by Emily Dennis,” she said. “This uses the Sawtooth design.

‘THIS IS NOT YOUR FATHER’S BICYCLE’

E-bikes, scooters combine efficiency with danger

Electric bikes and scooters have changed how we get around, whether for a daily commute, riding the trails or hauling cargo.

Modern e-bikes have transformed from heavy, clunky novelties into sleek, high-tech and efficient machines. The change is similar to the classic General Motors’ rebranding of the Oldsmobile cars in the late 1980s.

The new e-bikes and e-scooters also bring confusion and the increasing possibility of injury.

“What are these things?” asked Randy Wiessinger, Bureau of Transportation Safety, at the July 21 Shawano County Highway Safety Commission meeting. “It’s the hottest topic.”

According to the Shawano Police Department, Class 1 e-bikes provide pedal assistance and stop assisting once the rider reaches 20 mph. Class 2 e-bikes can be powered by a throttle without pedaling and also have a maximum speed of 20 mph. Class 3 e-bikes provide pedal assistance up to 28 mph, but riders must be at least 16 years old and the bicycle must be equipped with a speedometer.

“We have received complaints about e-bikes,

e-motos and e-scooters traveling at excessive speeds in residential neighborhoods and city parks,” Chief Mike Musolff said. “We have not moved forward with banning these devices in the parks at this point in the year, although it remains an option for future consideration.”

Under Wisconsin law, e-bikes must have fully operable pedals, a motor rated at no more than 750 watts and a manufacturer-applied

class label identifying the bicycle as a Class 1, 2, or 3 e-bike. Riders who operate compliant e-bikes do not need a driver’s license, registration or insurance.

E-bike riders are expected to follow the same rules of the road as traditional bicyclists. These include obeying traffic signals, yielding when required and avoiding reckless behavior such as weaving in and out of traffic.

Not following the rules

can lead to accidents.

“I heard about a reported collision involving a scooter and a child, possibly at Franklin Park or Naberhood Park, following Thursday at Franklin,” Musolff said. “My understanding is that the child was transported to the hospital.”

On June 16, police responded to a crash involving an e-scooter and a car.

“The crash at McDonald’s involved a vehicle exiting the restaurant and

an e-scooter traveling at a relatively high speed on the sidewalk,” Musolff said. “The vehicle was exiting slowly when the collision occurred. The scooter rider was transported to the hospital.”

A 2024 U.S. Consumer Product Safety Commission report said e-bike injuries doubled every year from 2017 to 2022.

Officials also warn riders against modifying e-bikes in ways that push them beyond legal limits. E-bikes capable of speeds greater than 28 mph, motors exceeding 750 watts or bikes altered to remove pedals or bypass factory speed controls may be considered motor vehicles under Wisconsin law and could be subject to additional regulations.

Local law enforcement are also seeing increased use of e-motos, electric dirt-bike-style devices that lack pedals and are not legal for use on public roads, sidewalks, or multi-use trails.

“If it goes over 20 mph by power of an electric motor, it is not an e-anything,” Wiessinger said. “It is a motorcycle. E-motos, e-scooters, a bunch of them go 50 mph, obviously they can’t be registered as a motorcycle, so they’re illegally operating on the roadway.”

“The biggest thing we’re seeing right now is e-motos. They’re basically like ... a minibike. They go 50-60 mph, but they have no pedals. Those are e-motos. By definition, they’re motorcycles, but they can’t be licensed or registered as a motorcycle, so they’re illegal to operate anywhere except on your own private property, but people are buying them left and right.”

Change made to roadside markings

Width of white lines won’t be altered on Shawano County roads

Anyone cruising down state Highway 29 at 70 mph (or even at slower speeds due to construction efforts) probably hasn’t realized the width of the white lines on the side of the road has changed.

Tony Kemnitz, of the Wisconsin Department of Transportation,

briefly discussed the change at the July 21 meeting of the Shawano County Highway Safety Commission.

“Paint lines have gone from 4 inches to 6 inches,” he said. “We’ve done that on all the state highways; however, on county highways, they’re still allowed to go to 4 inches.”

Many counties have opted to stay at 4 inches of county roads due to the cost.

“We’re staying with 4 inches except for certain ones that line with state roads,” said Grant Bystol, Shawano County highway commissioner. “Bottom line is it’s 50% more product. A lot more money.”

Kemnitz and Randy Wiessinger, Bureau of Transportation Safety, said they understood the reasoning behind the county’s decision, while Kemnitz said there is a known safety benefit going to wider lines.

“Wider lines and pavement markings, there’s evidence to show that that’ll slow people down,” Wiessinger said. “The perception (is that) the lane is narrower, so narrower lanes, the slower people tend to drive.”

Bystol said if the Shawano County made the switch to wider lines, it would cost an additional \$150,000.

Pulaski School District makes summer fun

Summer school offerings provide academic help, also cater to students' interests

On a Thursday in early July, more than 1,000 kids flooded the halls of Pulaski Community Middle School. Heaps of backpacks were piled in corners of classrooms and hallways. Bikes crowded the racks outside. At lunchtime, lines of children snaked around the building as they waited for hamburgers.

Summer school is a phrase usually wielded as a threat to keep students on task in the classroom.

Not in Pulaski. For six weeks each summer, the middle school transforms into the place to be, instead of a punishment.

More than 2,600 kids – 68% of the school district's enrollment – sign up for summer classes ranging from knitting and cooking to swimming lessons and science experiments. Students who need extra academic help get it, but the focus is on exploring new interests, spending less time on screens and nurturing children's creative sides in a way classwork doesn't always encourage. At a time when affordable child care can be hard to find, the free program has become a lifeline for the community. Signing up for classes is as competitive as queuing to buy Bruno Mars tickets, staff said – the most popular classes fill up in minutes.

"You get to see a lot of kids from other schools that you don't get to see normally," sixth grader Xiomara Lloyd said as she strung beads to add to the stack of bracelets on her wrist, each adorned with her nickname, "Xio." "I love it."

The classes help students build a positive association with school, explore new hobbies, get offline and into the real world – and, of course, learn.

"There's a lot of anxiety and different things as soon as they get close to those (school) doors, because now they're asked to do a lot of things that are difficult for them to do," said Pulaski Area Community Education director Mark Heck, who leads the summer school. "But when we can have them come in and have great success and really enjoy it, that's a win."

Different type of learning

Walking through the halls is like stepping between different worlds.

In one classroom, students dressed in Halloween costumes have a dance party. In another, students take turns using American Sign Language to describe emotions. Upstairs, students cook pizza from scratch in a home economics classroom. And in the

gymnasium, shrieks and shouts echo as kids play an intense game of dodgeball.

The chaos is organized – every classroom has at least two adults, and kids wear a badge printed with their name and their schedule, so adults know where they belong if they get lost.

"Summer school is stuff that you learn new, like swimming floats, or you learn how to make diamond art, or even make hearts made out of clay ... Summer school lets you have fun in the summer, if you don't know what to do at your house," said elementary student Ava Lentz.

It's not all fun and games. Those behind in classes or on tests take reading and math classes designed to catch them up. Several teachers also host tutoring sessions.

Generally, the classes take a more creative approach. That includes a science class where kids gleefully partake in a series of science experiments – on that Thursday, they combined soda and Pop Rocks and watched the fizzy reaction.

"It's really great learning, but it might not be exactly what they're learning during the school year, where (educators are) worried about standards, and worried about the tests that they're going to be getting kids ready for, and things like that," Heck said. "All of those things are very important, but during the summertime we can do a little different type of learning."

That philosophy has guided the program for two decades.

When Pulaski leaders launched the summer school 22 years ago, it was a small program consisting of one or two classes

at several schools, because the state would only fund a few hours a day.

Busy parents begged for a full-day program. Not long after Pulaski schools started offering afternoon programming at a cost, the state's rules changed. Now, schools can get funding for eligible programs all day, all summer long. So Heck dreamed of something bigger.

"I just had this idea in my head that was going, 'I think we could do something a lot better than this.' ... I want to make a program where your kids say, 'No, I want to go to summer school,'" he said.

Nowadays, they do. Kids beg to sign up to be where their friends are. About 68% of the district's 3,800 students will enroll in at least one summer school course. Signing up for classes is "an Olympic sport," staff say. Parents take off work to refresh the computer. They post to Facebook the night before registration, wishing each other luck. The best classes fill up in minutes.

It takes a village

Keeping such a beehive summer school running smoothly takes a village, but in the tight-knit community, it works.

The district employs roughly 130 teachers, 25 classroom aides, various high school and college students and other community members to keep over 2,500 students busy.

"When we hire our teachers ... The first thing I say is, if you weren't here right now, what would you be doing?" Heck said.

Those answers often become classes. For example, a local farmer teaches kids about horses, even bringing in equestrians as guest speakers and taking kids to

visit the farm animals. Two food service workers teach students how to cook. A hobby fisherman took students to different ponds in the area during a previously offered course.

Running such a major operation has also brought challenges. It was tough getting all of the departments – transportation, food, academics – on board, but that's much easier to do in a small district like Pulaski, Heck said.

Ironically, another major challenge is child care.

Many educators have young children who are too young to attend summer school but still need care during the workday. Without viable child care, they couldn't commit to working in the warmer months.

The district's solution: One classroom is transformed into a "babysitting room," where fellow teachers and aspiring early childhood educators change diapers, make bottles and keep a handful of babies entertained.

The program has become a workforce pipeline,

too. Heck estimates about 15 young adults who first worked summer school have since returned as full-time educators either in Pulaski or in neighboring districts.

A lifesaver

Affordable child care has become increasingly difficult to find, and securing spots in summer camps is notoriously competitive. For that reason, the free summer school that turns away no one has become a lifeline for local families.

Parent and Pulaski Area Chamber of Commerce Executive Director Stacey Von Busch said her kids have participated in the camp for years, calling its affordability a "lifesaver."

"To have something like this in our community, where we don't have to drive 30 minutes to get our kids to (other camps), is huge," she said.

The district provides bus transportation for students who need it, and thanks to a federal grant, children can eat breakfast and lunch at school.

While by law the school must be tuition-free, the district may charge modest fees for supplies, such as beads for making bracelets or yarn for knitting and crocheting. Course fees range between \$0 and \$40 for each two-week term.

The school is funded by the state – Wisconsin schools can receive funding for summer school classes that meet certain academic requirements. Rather than paying schools a flat amount for each student, the state bases funding on the total instructional time students attend. Therefore, Heck is on a mission to keep enrollment high, as more students involved equals more funding.

That includes everyone. Parents of children with disabilities often struggle more to find summer schools and camps that serve them, Heck said. He didn't want that to be the case in Pulaski.

Many of the district's special education employees staff a classroom dedicated to children with disabilities. That includes those who require federally mandated "extended school year instruction," an individualized academic program meant to stop students from regressing over break.

"I look forward to this every year," said special education teacher Tessa Badtke. "You just get to know them in such a different way, because there's not this academic pressure like at school, so you can just build these relationships."

Then, Badtke said, students have a better school year. Heck agreed.

"What's the win out of it for us? We got our kids to walk through the school doors and actually not be angry and upset when they came in," Heck said. "They're coming in and they're happy. Our hope is maybe next year, when they come back in the fall, they're coming in and they're saying, 'I'll give it a chance.'"

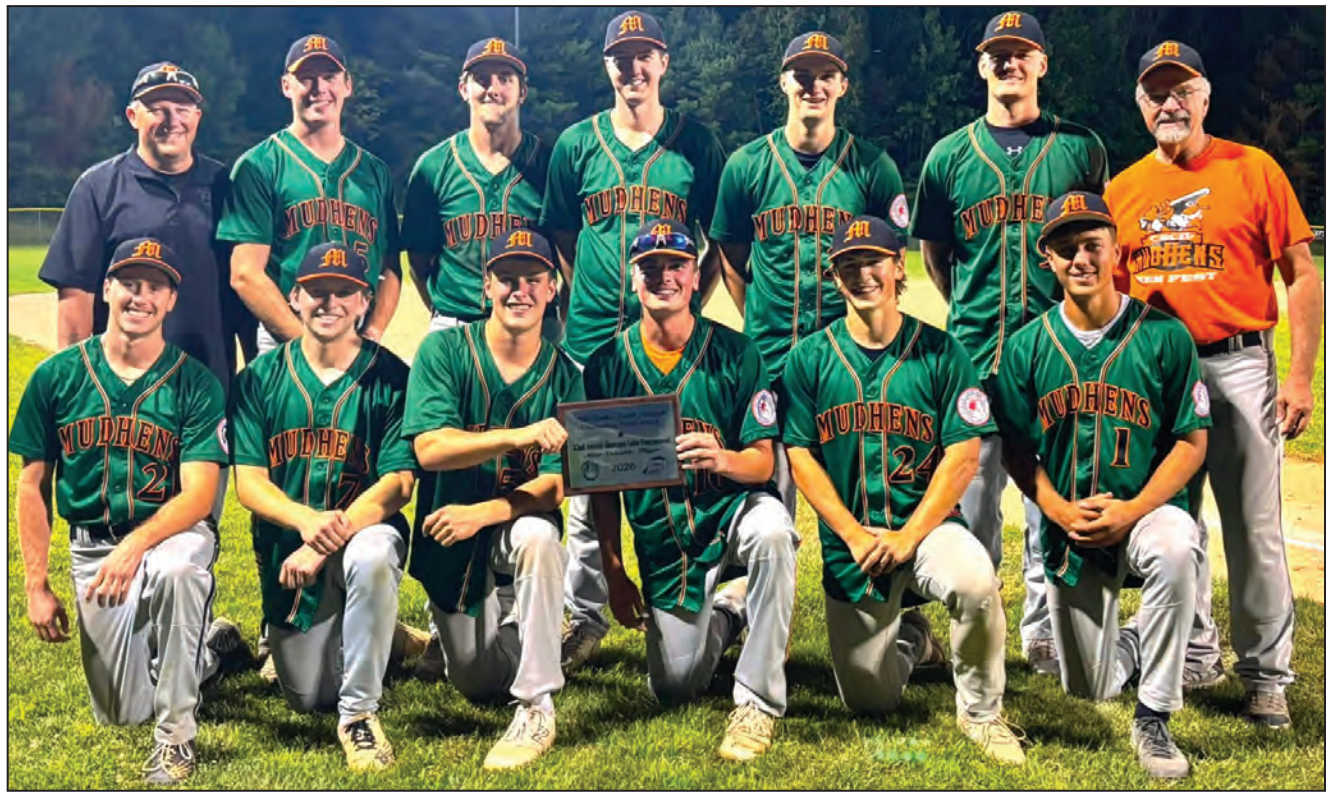

Bees buzzing at Hobby Honey Farm

Honey, beeswax used to create a variety of products for people to use

In rural Shawano County, the bees are busy making honey at John and Lorraine Ballbach's Hobby Honey Farm in Gresham.

However, their farm offers more than raw honey.

In addition to selling local raw and creamed honey, the Ballbachs also sell their own beeswax products which include tea lights, votive cups and candles as well as beeswax bars.

Beeswax bars can be used as a lubricant, a sealant, used for cutting boards and for cabinetry – even for ease of opening windows and drawers.

“My customers have taught me how many uses they come up with for beeswax bars,” said Lorraine Ballbach. “They use it to season cast iron pans and bowstrings for their bows, and to lubricate guitar strings.”

Bees make the wax, gorging themselves with honey, extracting the wax out of their abdomen. The wax is then scraped out of the frames, and Lorraine Ballbach melts it, pouring it into 5-cup mold trays.

“We keep bees throughout the state of Wisconsin and Upper Michigan for specialty honeys. We have 24 Michigan hives we tend,” said John Ballbach.

Bees carry pollen back to the hive and produce honey. Each source reflects the flavor from where it came. Some come from the buckwheat plant, others from the basswood tree and still others from wild flowers.

All the honeys at the farm are labeled and named after the source.

For example, Starthistle is from the thistle plant. It's a light-brown, caramel-tasting honey, velvety and smooth. Summer Blend is a conventional honey and what the bees put in the box from spring to fall. Buckwheat honey is black and has a syrupy, molasses taste with 20 times the antioxidants of any light honey. Honey from basswood has a stronger flavor, with a light mint taste.

The honeys are stored separately in

water-jacketed stainless steel tanks, with the water kept at 90 degrees.

“Otherwise, sitting long enough, raw honey will granulate,” said John Ballbach.

The family has downsized to 100 hives this year from approximately 230 because of health issues and age.

“My dad used to run 650 hives here in addition to 40 head of beef cattle and work the land well into his 70s,” said John Ballbach. “We grew up in southern Wisconsin near Port Washington and bought this property in 1989. He brought the bees with him. He was a migrant beekeeper, spending winters in Florida

and summers in Wisconsin, packing the bees up in a semi and taking them with him.”

Since there is a lot of misinformation on the internet, John Ballbach stresses getting correct information first-hand from a seasoned beekeeper if anyone has a notion to start keeping bees.

“Ninety percent of the stuff out there is false. I tell people what not to do, and they do it and they wonder why it didn't work out even though they saw it on YouTube,” said John Ballbach.

After marrying, the Ballbachs only had one hive. In 2008, Lorraine Ballbach quit working because of health issues.

After making a list of things she could do, she discovered one was making honey. For one year, they researched the ins and outs of selling raw honey.

“The next year we got 25 more hives, and it just kept going up from there,” said Lorraine Ballbach.

The Ballbachs don't have any helpers on the honey farm.

“It takes dedication. You can't let the bee stings bother you; you gotta love the bees,” said John Ballbach. “You can read all the books you want, but there's no learning like hands-on experience.”

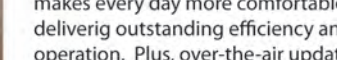

wash the nectar out of the flowers. Those trees start blooming around the Fourth of July, and if the conditions are favorable, the bees can fill a 10-pound box in a day.

“It started out slow, but it’s shaping up well this year. The rains have been excellent for maintaining sweet and Dutch clover. A huge crop all came at once. The sweet clover is exploding everywhere. This year, everything is ready at the same time,” said John Ballbach.

The Ballbachs take a small observation hive along to their farmers markets – encased in clear plastic – so customers can see inside the hive and observe the bees at work. They also use it for teaching 4-H groups or schools that ask the couple to come and speak.

If the bees need to make heat, they’ll consume honey and shiver to contain heat, keeping the brood warm – between 92 and 95 degrees. If it gets too hot, they’ll haul water into the open cells and fan it so it evaporates to cool.

“We work hard to provide a good product. Quality is a big thing,” said Lorraine Ballbach. “For example, I test all my candles before I sell them. I expect quality from others, so I want to offer a quality product. Every year, I think of something new to sell.”

Sales are conducted directly on farm located at W9790 Thurner Lane, Gresham, and also at area farmers markets. For more information, like them on Facebook at John and Lorraine’s Hobby Honey Farm.

Enjoy flavor of homegrown herbs throughout the year

Add homegrown flavor to any meal with garden fresh herbs that will elevate any dish. Continue enjoying them well past the end of the season by preserving favorites to use in winter meals.

Snip a few leaves or leaf-covered stems as needed for cooking or garnishing a favorite dish throughout the growing season. Adjust the quantity of herbs used to allow for variations in flavor intensity and preference. In general, two to three times more fresh herbs are needed than dried, except for rosemary, which has an equally strong flavor, fresh or dried. For example, if the recipe calls for one teaspoon of dried thyme, use one tablespoon (three teaspoons) of fresh thyme leaves.

kitchen counter and cold-tolerant herbs, like parsley and cilantro, in the refrigerator. Wrap thicker-leaved herbs, like sage and thyme, in a paper towel set inside a plastic bag and place in a warmer section of the fridge.

Keep harvesting throughout the growing season to encourage new growth for future harvests. Just leave enough foliage to maintain plant growth. Harvest as much as 50-75% from established annual herbs and one-third of perennial herbs at a time.

Freeze sprigs, whole leaves or chopped clean herbs on a cookie sheet. Pack clean diced herbs in ice cube trays and fill the empty spaces with water. These are great for use in soups and stews. Store the frozen herbs and ice cubes in an airtight container or baggie in the freezer.

Dry herbs by bundling several stems together, secure them with a rubber band, and use a spring-type clothespin to hang them in a warm, dry place to dry out. A drying rack

can be made from an old embroidery hoop, string, and S hooks.

Get creative and use some herbs to make a fragrant edible wreath. Use fresh herbs that are flexible and easier to shape into a wreath. They will dry in place and can be harvested as needed.

Speed up the drying process in the microwave. Place herbs on a paper plate and cover it with a paper towel. Start with one to two minutes on high. Repeat for 30 seconds as needed until the herbs are brittle. Store dried herbs in an airtight plastic or glass jar.

Share extra fresh and dried herbs with family and friends. They make great hostess and holiday gifts.

Fields' request for new judge approved

A request to change judges in the case of Lawrence Fields, a Seymour man who faces child sex assault charges in Shawano County, was granted July 16.

Fields had previously appeared before Shawano-Menominee County Circuit Court Judge Katherine Sloma in Branch I, but he was assigned to Judge William Kussel Jr. in Branch II. As a result, his arraignment, which was originally to take place July 20, has been rescheduled for 1:30 p.m. Aug. 3.

Fields, 55, faces one count of first-degree child sex assault with a victim younger than 13 and one count of exposing genitals or intimate parts to a child.

The criminal complaint alleges that Fields touched the 6-year-old victim around Labor Day at a home on County Road Y in the Town of Belle Plaine. The victim's mother said she asked Fields, her uncle, to watch the victim while she went to Clintonville to clean a house. The mother, who said she was gone

about 90 minutes that day, said Fields is one of the few relatives still speaking to her, and he'd watched the victim on previous occasions.

While away, Fields allegedly touched the victim around her breasts, buttocks and private parts, according to the complaint. When Fields allegedly exposed his genitals, the victim became scared and ran outside, coming back inside later, at which point Fields allegedly told the child that she could not tell anyone about what happened.

The home had two cameras, but one was off because the mother did not turn it on via her cellphone, and the other was disconnected, but the mother told a deputy neither she nor her daughter had disconnected the camera.

Two days later, a Shawano County Sheriff's Department detective interviewed the victim and found her to be credible. A monitored phone call was made to Fields after that, according to the complaint, where he denied any sexual contact or exposure but offered to help pay for any counseling for the victim.

appearance of a conflict of interest when the presiding officer used procedural authority to prevent public discussion of his own official actions,” she wrote.

Her letter and three others were read into the minutes of the meeting.

As public comment and the reading of letters drew to a close, Kautza officially nominated Pollock, and the nomination was made and seconded.

“We have a good candidate, nothing controversial,” Kautza said. “It’s time to get away from this nonsense that went on last year and move forward.”

Pollock, who sat with the supervisors and not the audience members even before he was nominated, addressed the board.

“Since I had time and did want to learn more about the county rather than just the Township of Almon, I thought this would be a good opportunity,” he said.

Gretzinger said he would oppose Pollock’s appointment.

“This is nothing against Mr. Pollock, but I’m going to have a no vote just

because of the process,” he said. “I would hope my other supervisors step up and do the right thing.”

Mallmann agreed. “My biggest problem

is the process of how this happened,” he said. “The board did not even have

an opportunity to consider (Steffen), and exactly what you said in the meeting Mr. Chair, that this is supposed to be a nonpartisan position. You made it a personal and partisan decision not to allow him to take the open district seat. It’s not fair to District 27, and it’s certainly not fair to Mr. Steffen. I disagree with the whole process that’s happening here.”

Miller also noted his opposition.

“My concern again ... is of the chairman repeatedly boo-hooing in the media about this nonsense, about this drama, about everything here,” he said. “You created the drama. What you see from us is disagreement. It is our right to disagree with things that are said. It is everybody’s right to disagree with me, and I respect that. You don’t. You do not respect

our right to disagree with you. You call it drama.”

Bill Switalla, who made the motion to appoint Pollock, spoke in favor of Kautza’s desire to keep the board nonpartisan.

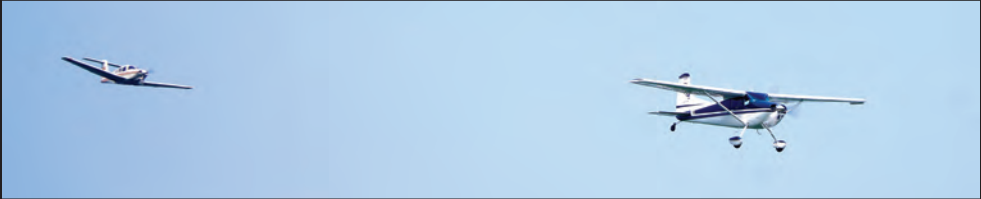
“I stand behind Tom, because every time the Republican Party has come and attacked our board, they stood in front and said they were here from the Republican Party,” he said.

For his part, Switalla has been a Democratic candidate for the State Assembly four times in the past decade.

“We don’t need that drama here,” Kautza said, and after Pollock was confirmed, added “Congratulations, Steve. You are the new board member, and hopefully, we’re done with the drama.”

NOTICE OF THE BOARD OF REVIEW FOR THE CITY OF SHAWANO

NOTICE IS HEREBY GIVEN that the Board of Review for the City of Shawano, Shawano County, shall hold its first meeting on **September 22, 2026, from 2:00 p.m. to 4:00 p.m.** at Shawano City Hall, 127 S Sawyer St., Shawano, WI 54166.

Please be advised of the following requirements to appear before the board of review and procedural requirements if appearing before the board:

- No person shall be allowed to appear before the board of review, to testify to the board by telephone, or to contest the amount of any assessment of real or personal property if the person has refused a reasonable written request by certified mail of the assessor to view such property.
- After the first meeting of the board of review and before the board’s final adjournment, no person who is scheduled to appear before the board of review may contact or provide information to a member of the board about the person’s objection, except at a session of the board. Open Book shall occur no less than 7-days prior to the board of review.
- The board of review may not hear an objection to the amount or valuation of property unless, at least 48 hours before the board’s first scheduled meeting, the objector provides to the board’s clerk written or oral notice of an intent to file an objection, except that upon a showing of good cause and the submission of a written objection, the board shall waive that requirement during the first 2 hours of the board’s first scheduled meeting, and the board may waive that requirement up to the end of the 5th day of the session or up to the end of the final day of the session if the session is less than 5 days with proof of extraordinary circumstances for failure to meet the 48-hour notice requirement and failure to appear before the board of review during the first 2 hours of the first scheduled meeting.
- Objections to the amount or valuation of property shall first be made in writing and filed with the clerk of the board of review within the first 2 hours of the board’s first scheduled meeting, except that, upon evidence of extraordinary circumstances, the board may waive that requirement up to the end of the 5th day of the session or up to the end of the final day of the session if the session is less than 5 days. The board may require objections to the amount or valuation of property to be submitted on forms approved by the Department of Revenue, and the board shall require that any forms include stated valuations of the property in question. Persons who own land and improvements to that land may object to the aggregate valuation of that land and improvements to that land, but no person who owns land and improvements to that land may object only to the valuation of that land or only to the valuation of improvements to that land. No person may be allowed in any action or proceeding to question the amount or valuation of property unless the written objection has been filed and that person in good faith presented evidence to the board in support of the objections and made full disclosure before the board, under oath, of all that person’s property liable to assessment in the district and the value of that property. The requirement that objections be in writing may be waived by express action of the board.
- When appearing before the board of review, the objecting person shall specify in writing the person’s estimate of the value of the land and improvements that are the subject of the person’s objection and specify the information that the person used to arrive at the estimate.
- No person may appear before the board of review, testify to the board by telephone, or object to a valuation if the valuation was made by the assessor or the objector using the income method of valuation, unless the person supplies the assessor with all the information about income and expenses, as specified in the assessor’s manual under s. 73.03 (2a), Wis. Stats., that the assessor requests. The City of Shawano has an ordinance for the confidentiality of information about income and expenses that is provided to the assessor under this paragraph, which provides exceptions for persons using information in the discharge of duties imposed by law or the duties of their officer or by order of a court. The information that is provided under this paragraph, unless a court determines that it is inaccurate, is not subject to the right of inspection and copying under s. 19.35 (1), Wis. Stats.
- The board shall hear upon oath, by telephone, all ill or disabled persons who present to the board a letter from a physician, surgeon, or osteopath that confirms their illness or disability. No other person may testify by telephone unless the Board, in its discretion, has determined to grant a property owner’s or their representative’s request to testify under oath by telephone or written statement.
- No person may appear before the board of review, testify to the board by telephone, or contest the amount of any assessment unless, at least 48 hours before the first meeting of the board, or at least 48 hours before the objection is heard if the objection is allowed under s.70.47 (3) (a), Wis. Stats., that person provides to the clerk of the board of review notice as to whether the person will ask for the removal of a member of the board of review and, if so, which member, and provides a reasonable estimate of the length of time the hearing will take.
- Completed Objection Forms are to be filed with the City Clerk’s office, 127 S Sawyer St, Shawano, WI 54166 by **2:00 PM, Sunday, September 20, 2026**.
