

Deerhunters donate \$5,000 to historical society

The Wittenberg Area Historical Society has received a \$5,000 donation from the Wisconsin Deerhunters, Inc. Witt-Birn Chapter to help support the renovation of the society's newly acquired Heritage Center.

The donation will be used toward the ongoing renovation and improvements needed to transform the building into a space dedicated to preserving and sharing the history of the Wittenberg area and its surrounding communities.

Children should stay home from school if ill

As students return to the classroom, parents can expect their children to encounter plenty of germs.

Children average more than two to three colds each year, according to the American Lung Association, making it important for families to know when a child should stay home from school and when it is safe to return.

While many mild illnesses can be managed with appropriate rest and fluids, some symptoms signal that a child should remain out of school to recover and reduce the risk of spreading illness to classmates and staff. According to Ashley Schuelke, a nurse practitioner with Aspirus Family Medicine, children should stay home if they have a fever, vomiting, diarrhea, nausea or are simply too sick to participate in learning.

Not every symptom requires missing class. Mild cold symptoms alone are not necessarily a reason

for a child to stay home if they feel well enough to participate in school activities.

"It is important to keep a sick child home from school to prevent the spread to other classmates and staff at the school," Schuelke said.

Children can typically return to school when they are feeling well enough to participate in learning and have been fever-free for at least 24 hours without the use of fever-reducing medications.

Parents should contact a health care provider if symptoms worsen, if a child has difficulty breathing or if there are concerns about dehydration, Schuelke said.

"For the back-to-school season, parents should trust their instincts, monitor symptoms and, when in doubt, contact their health care provider," she said.

Sheriff to swap out command vehicle

Department will use trailer formerly confiscated as evidence

A 20-foot-long enclosed trailer once confiscated as evidence from a crime will soon be used as the new mobile command vehicle for the Shawano County Sheriff's Department.

The public safety committee voted Sept. 2 to authorize the disposal or sale of the existing Winnebago RV and replace it with the trailer.

"That was obtained on a grant (in 2004)," Lt. Chris Madle said of the RV. "Recently we obtained a 20-foot enclosed trailer. During an investigation, we were never able to prove ownership of said trailer. Proper procedures and steps were done to determine who the trailer belonged to, and we got official confirmation to dispose of the trailer as evidence and use as department use."

Proceeds from the sale of the existing unit will be added to the county's vehicle replacement fund. Then, the new trailer would be added to the list of vehicles to be replaced on a regular basis.

"We have most of the computer and server equipment, being that it's already in the RV camper," Madle said of the pending makeover of the trailer. "We would just do most of the work in-house,

use budget money that we have from different budgets for equipment and supplies, build some desks on the inside of it and do what we need to do as far as the electrical work."

He said the RV is rarely used, but it has served its purpose for the past 20-plus years.

"We pay a lot more now every year to maintain the thing, and it's not really used for a heck of a lot," he said.

Sheriff George Lenzner agreed.

"I think the upkeep in the future is going to be a lot cheaper, too," he said. "It's similar to what we did with the dive van before we went to the trailer, because we were putting so much money every year to keep these old vehicles running. It comes to the point, 'Is it really worth it?' There's very little to no upkeep in a trailer."

Once operational, the trailer will be hauled behind a truck. Madle said a maintenance vehicle would be used to haul the trailer this year. Next year, when a new emergency management truck is purchased, that will be used to haul the trailer.

Madle said a truck with a trailer is much easier to drive around than the Winnebago.

Emergency management grant comes through

An emergency management grant of about \$40,000 for Shawano County finally appears to be on its way.

Shawano County Sheriff Lt. Chris Madle, also the county's emergency management director, told the public safety committee Sept. 2 the application for the Emergency Management Performance Grant was received the

previous week.

"This year's grant for 2025, they just sent out the application last week finally," he said. "I would normally get this application in October 2025 for this year's, but the 2026 application just came through from the state last week."

He said he will complete the application and file it by the end of September deadline.

"We've got a little bit of work to do to make sure

everything still gets done, because, of course, the state still wants you to have all the work done for the grant by the end of the year even though they only gave you three months to do it," Madle said.

He said he expects about a 5% increase in the grant.

However, due to the uncertainty surrounding the grant, it is not included in the county's proposed budget for next year.

Shawano looks at humane society plan

Officials concerned about immediate request for money

Shawano city officials were scratching their heads at a proposal from the Shawano County Humane Society asking for more money to fund its operations or risk losing services in the coming year.

A notice from the humane society was sent out earlier in the summer to municipalities from Pam Nowak, the society's executive director, and Dusty Martzke, president for the board of directors. The notice is asking for municipalities to help the humane society in one of two ways.

The first option is for municipalities to pay \$2.50 for each resident within their borders, based on the most recent official numbers from the U.S. Census. The city of Shawano, having 9,251 residents as of the census, would be contributing \$23,127.50 per year.

The second option would seek \$500 for every stray dog or cat, or for every dog or cat with a litter, apprehended within municipal boundaries, which would be more challenging for local governments to budget. Municipalities would be billed quarterly under this option.

For any municipalities that don't choose from the two, the third option will be that the humane society will no longer accept stray dogs or cats from those that do not contribute, according to the notice. The humane society has set a deadline of Nov. 1 to return contracts.

The first option seems to be most fiscally responsible in City Administrator Eddie Sheppard's view, because it's a fixed amount, but to be asked for this much money suddenly makes it difficult to figure out how to make it happen. He noted the city's levy limit, set by the state, is only increasing by \$48,000, and the humane society's demand would take up half that amount.

"When this came out, there was significant pushback," Sheppard said, noting that he plans to attend at least one of the humane society's informational meetings to iron out all the details.

"It's been a pretty big topic in the municipal world, especially with the clerks (who manage municipal budgets)."

In total, the humane society found homes for 1,109 animals in 2025, a mix of stray and surrendered animals. However, during the same year, the humane society only received \$17,335.41 through the state's statutory apportionment for dog license fees. The rest of the costs have been funded to this point by private donors, community supporters, businesses and foundations.

"They're telling the communities: 'This is what it's going to cost to subsidize the operation or else we're not going to serve you,'" Sheppard said.

Some strays have been found in the city that came from surrounding towns, according to Sheppard, and the same is true in reverse, so it brings into question how much the city of Shawano should actually pay for what the humane society provides. Given that revenue limits keep municipalities from hiking taxes willy-nilly, he said it could be a hardship for the city.

"If it moves forward as proposed, it would be an unforeseen budgetary expense," Sheppard said. "I have a lot of questions about how, on the back end, we understand where these animals come from."

According to City Clerk Lesley Nemetz, the city's apportionment to the humane society for this year was \$1,200, a fraction of what the society is asking for now. She noted that the society's second option was feasible for the city.

"You have zero control of what your end-game amount is, because it doesn't matter if John brings it in or the chief's CSOs (community services officer) brings it in; if it's a city animal, we'd get charged \$500," Nemetz said.

The humane society operates at an average cost of about \$57,000 monthly. In 2025, the humane society took in 578 stray dogs and cats, but only 141 were reclaimed by owners during a five-day hold period. That left the remainder in the care

of the humane society, which has to assume responsibility for rehabilitation and medical care.

The humane society had to spend \$349,600 to care for stray animals in 2025, coming to about \$800 per stray. Among the expenses were housing and daily care, spaying and neutering, rabies and other core vaccinations, microchipping, any needed medical treatment, emergency veterinary care, adoption preparation and placement, as well as behavioral rehabilitation when needed.

Sheppard said he hoped the humane society would allow some wiggle room and allow the proposal to be implemented in phases instead of demanding the city come up with the money this year. He added that other municipalities in Shawano County are seeing decreases to the levy limit, so they have less money to adhere to what the society wants.

"I think they just think it's something we can pass along, and we'll just increase this," Sheppard said. "We can't, because we have a hard cap. When we start getting more of these agreements, all of a sudden the entirety of all these agreements we're supporting outside of our own ability to generate revenue; it causes me concern, and it's problematic."

Alderman Jack Young recommended that the humane society look at more flexible options, such as getting city assistance with fundraising.

"That's a way to help them in a way that doesn't tie our hands," Young said.

The proposal was only up for discussion, so no action was taken by the committee.

Mayor Bruce Milavitz expressed concerns about the humane society's expenses, noting that the local shelter also accepts animals from outside the county, mainly from shelters that practice euthanasia, and takes in animals after disasters like hurricanes, fires and floods.

"Sometimes the no-kill shelters will contact the kill shelters and take in 20 or 30 animals and move them from community to community," Milavitz said.

Changes coming to ambulance service agreement

The city of Shawano's agreement with Shawano Ambulance Service is changing its terms after 33 years of providing medical transport for local residents. The changes are coming at the request of Pat Trinko, the service's executive director. In a letter to City Clerk Lesley Nemetz, Trinko noted the agreement only has a few adjustments that need to be made at the recommendation of the ambulance service's attorney. One of the changes was requiring a 90-day notice of either side to issue a notice of nonrenewal. Previously, the time period was 60 days. Another change was to the amount of compensation the ambulance service receives. The

agreement had originally a set annual amount, which was \$36,840 in 1993, that needed to be paid in quarterly installments. Now, the city will need to pay a per capita rate using the Wisconsin Department of Administration Demographic Services Center's final population estimate, which is usually released no later than Oct. 10 of the year preceding the contract term. The new agreement also strikes out requirements for corporate seals and multiple witnesses, as such practice with contracts have become less prevalent. The agreement was presented Sept. 4 to the Shawano Finance Committee for discussion only, as the final agreement is expected to come later this year.

Bonduel, Oconto Falls win in Packerland

Suring puts up big numbers in third victory

If the Packerland Conference is going to be like the opener, fans of the Bonduel and Oconto Falls football teams can count on a successful season.

Bonduel handed Kewaunee a 28-22 loss Sept. 4 in the conference opener for both teams, while the Panthers opened Packerland play with a 26-7 home win over Oconto in the Battle of Highway 22 game.

All seven of the game's touchdowns came in the first half.

The Storm scored twice in the final three minutes of the first half to cut the lead to six points. Bosdeck connected with Mason Kovacs on a 17-yard pass that made it 28-15, and Dane Harrell returned a mishandled punt snap 45 yards on the final play of the first half that also turned out to be the final score of the game.

Kewaunee had a chance to tie or take the lead late in the game, as the Storm reached the Bonduel 15-yard line, but Bosdeck's pass on fourth down with 15 seconds to go fell incomplete.

Bonduel had a pair of 100-yard rushers, as Moesch led the way with 159 yards on 13 carries, and Malachi Gray added 125 on 11 rushes.

Bonduel's passing wasn't a factor in the game, as Quinn Wesenberg completed two of seven attempts for 16 yards.

Bosdeck completed 15 of 18 passes for 114 yards, including six completions to Kovacs for 72 yards. Blake Temme led Kewaunee rushers with 87 yards in 18 carries.

Bonduel improved to 3-0, and the Storm fell to 1-2.

The Panthers improved to 2-1 overall with a win over the Blue Devils at ST

Cannon Farm offers natural products

From meats to jams, farmer offers a lot in farm store

From meat to vegetables, everything sold on the Cannon Family Farm is all-natural and homegrown, farm to table.

Born and raised appreciating a farming background, owner Sheldon Cannon stresses the importance of knowing where food comes from. Raising steers, geese, ducks, roosters, chickens, pigs, rabbits and goats, he is kept busy offering healthy, clean food.

"Everything we grow here is free of hormones, chemicals or antibiotics, is locally grown and 100% all natural," said Cannon. "Eggs in the store selling for 99 cents a dozen might have been sitting in a warehouse for months on end until they get to the shelf for sale. Here, we have fresh-laid eggs," he said. "We bring a hog in to butcher, and processing takes days instead of weeks to get it back."

Also on the farm — offered in a self-serve capacity — are canned jellies and jams, farm-fresh chicken and duck eggs and homemade bird suet. Additionally, a variety of vegetables such as sweet corn, tomatoes, onions and peppers are for sale.

Presented as well are a variety of homemade beef-tallow lotions with new scents: watermelon, rum cedar, jasmine, lotus, chamomile, English lavender and unscented.

Tallow is an all-natural way to moisturize skin. Because it closely matches the oils skin already produces, tallow absorbs easily. It functions as an effective occlusive — an air- and water-tight covering — which creates a natural, breathable barrier that locks in moisture and protects skin from environmental stressors.

At their store, they sell homegrown, individually packaged beef, pork, whole roasting chickens as well as chicken feet.

"Chicken feet are good for making homemade soup stock," said Cannon.

"We also sell our meat in halves or quarters, depending on what the customer wants."

Future endeavors include offering meat goats for sale, as well as rabbit meat. Both goats and rabbits are entered at the Shawano County Fair through Bonduel 4-H.

Joining the other animals, a horse is soon to arrive at the farm. Currently, a pasture is being prepared.

Sunflowers are grown on the farm and are sold whole, with the customers either picking themselves or Cannon cuts them. Upon request, sunflower bouquets are fashioned onsite.

Growing pumpkins for a little over four years on an approximately 2-acre pumpkin patch, that product is ready for harvest.

"This fall we'll be busy selling pumpkins. We've got a pretty good crop coming in this year," said Cannon. "We also sell pancake mix — pumpkin spice or plain. There's nothing like a fluffy pancake with maple syrup and a hot coffee or hot chocolate on a chilly fall morning."

Sheldon Cannon's sons, Trenton, 11, and Robert, 5, are learning the trade early.

"My boys take animals to the fair,

so they do the grunt work to get them ready," he said.

Along with physically helping on the farm, Cannon's friend handles the social media aspect, posting information on Facebook to help get the word out. Custom T-shirts and tumblers — using a special printer and heat press — are also available for sale upon order.

"I admit I'm old-school," said Cannon. "I grew up with a paper and pencil, and that's how it works. I'm a low-tech man in a high-tech world. As a kid, I didn't do video games; I worked hands-on in the soil."

Growing up with farming and working on farms and other occupations, Cannon graduated from the Bonduel School District and has been in this

Horrific images of 9-11 still vivid 25 years later

To say 9-11 was a seminal moment in American history is a huge understatement. Most people of school age in 2001 can tell you exactly where they were that day. Though it's 25 years since it happened, the events are seared into my memory as they must be in yours.

Sept. 11, 2001, started like nearly every other day in my busy life. I got ready and picked up a colleague who rode with me to school. We were close friends who shared the happenings in our lives during the pleasant 15-minute drive from Appleton to Riverview Middle School in downtown Kaukauna.

Classes had been in session for only a week; we were still adjusting to the routine. She pointed out how blue the sky was as we got out of the car and bemoaned the fact that we had to be inside on such a beautiful mid-September Tuesday.

I carried my teaching satchel filled with compositions written by my seventh-grade language arts students. Some of the papers needed grading, and I was determined to get it done during my third hour preparation time. I preferred doing this task at school where I could close the door to Room 209 and give their assignments my full attention.

As it happened, 209 shared a side doorway to 207, where my colleague, Gene Hardesty, taught social studies. Gene was a wonderful guy — a gentleman, devoted teacher and hard-working team member. A Navy veteran officer, he certainly didn't fit my ill-informed stereotype of a sailor, all bluster, tattoos and profanity. (My apologies. Now I know better.)

Close to finishing the task before my next class, I was at my desk when I heard unfamiliar sounds emanating from his classroom. I surmised that his students were watching a PBS special. Suddenly, his classroom erupted. The hubbub escalated, which was as unusual as his unexpected appearance at my desk.

Obviously upset, Gene had left his classroom via the common door, something he'd never done before.

"They're attacking us," he said with tears in his eyes. "I need help."

I knew full well not to ask what was wrong and hurriedly followed him. Was this a classroom mutiny? If so, what would I, or should I, do? I was relieved when we entered his classroom.

The kids were just sitting at their desks when a student in the back of the room pointed at the TV and yelled,

"Look, Mrs. Marsh. Look!" I did and was puzzled.

My first impression was that the kids were reacting to a harrowing air combat film. "What's the big deal?" I thought. Gene saw my confusion and explained that a jetliner had struck the North Tower of the World Trade Center in New York.

Mired in disbelief, I watched as the moment of impact was replayed. Then we were all in shock as new images of the South Tower being struck flashed across the screen.

When told that the Pentagon had also been hit, I knew Gene was right. This was no tragic accident. It was terrorism. That wasn't all. In an ensuing act of incredible heroism, all passengers aboard Flight 93 were killed when it crashed in a Pennsylvania field. Their courage prevented a fourth attack intended to take out our entire

government in Washington.

It requires a lot for seventh graders to walk quietly through hallways during change of classes and even more for them to calmly take their seats. I remember how silent and still they were, walking like robots into my classroom, obviously as shell-shocked as I was. My training and decades of experience had not prepared me for this.

Realizing the moment demanded something extraordinary, I dug deep. The class plan I'd written on the chalkboard was not going to cut it.

"I've made a decision," I said in a subdued and soothing voice. "I think we need to talk this through. I'm sure you have questions and concerns. I want to hear from all of you, one at a time. If you prefer to pass when I call on you, that's OK."

It was amazing. I felt privileged to be allowed into

their private space for those critical moments.

"Are they going to attack us too?" one asked.

Another said, "I'm thinking about kids who went to school today and won't have parents when they get home."

A usually self-assured girl admitted, "I feel so helpless. I hate it when that happens."

A big and brawny farm kid asked, "Do you think the Army will take me if I lie about my age?"

I answered each one from the heart, and many parents thanked me later for providing comfort for their children on that terrible day.

"It worked both ways," I replied. "Both ways."

area his whole life.

"I bought this 4-acre piece with the buildings, because I just wanted to be my own boss," said Cannon. "I'd always worked for others."

At this time, Cannon Family Farm does not bring their products to farmers markets but may consider it in the future. For now, repeat customers are supportive and faithful, and they understand Cannon offers a good, wholesome product.

"I like promoting the natural foods versus stuff you get in the grocery stores. I was raised on eating clean, and I want to share that natural product with others," said Cannon.

At one point, Cannon was a volunteer firefighter for five years. Growing up with his whole family involved in firefighting and emergency medicine as well as farming, he has a propensity to help people.

"We're not getting rich by any means. We spend hours tending to all the animals and vegetable gardens, but I like helping people and standing by my product," said Cannon. "This is a lifestyle that I'm passionate about. We know where the food comes from. We consume and can what we grow and sell the rest."

Prepare landscape for change of seasons

As summer comes to an end, it's time to prepare landscapes for fall and winter. Proper fall care helps increase plants' winter survival, supports pollinators and promotes the overall health, longevity and beauty of a landscape.

Continue watering as needed. This is especially important for new plantings, evergreens and moisture-loving plants; but don't overlook established trees. Drought stress makes plants, even established ones, more susceptible to life-threatening insects and disease.

Remove weeds in gardens and mixed borders. Cooler temperatures and a shorter to-do list make it easier to squeeze in more time for this task. Eliminating weeds now means fewer weeds to pull next year.

Don't pack away the mower just yet. Keep cutting the lawn as long as it keeps growing. Mow over fall leaves and leave them and grass clippings on the lawn. The short clippings and quarter-size leaf pieces add nutrients and organic matter to the soil. Just make a second pass with the mower, if needed, to cut the leaves down in size.

Put some of the fall leaves to work in gardens as a mulch. They insulate plant roots from temperature extremes, help suppress weeds, conserve moisture and improve the soil as they decompose. Leaves also provide insulation and winter protection for a variety of beneficial insects, toads and frogs.

Start a compost pile by mixing fall leaves with other landscape trimmings. Don't add invasive plants, aggressive weeds or those gone to seed. Leave insect- and disease-infested or chemically

treated plant debris out of the pile. Don't add fat, meat and other animal products that can attract rodents. Moisten and occasionally turn the pile to speed up the process. Soon it will be a wonderful soil conditioner to put back into the landscape.

Let healthy perennials stand for winter. Many provide motion, form and texture to the winter garden. This subtle winter beauty may not be as colorful as your summer garden, but it adds interest to what may be an otherwise drab winter landscape.

The standing perennials also support songbirds and beneficial insects. Seed heads of many perennials attract seed-eating songbirds, adding color and motion throughout the winter. They also provide winter homes and shelter for beneficial insects that pollinate plants, help manage insect pests and more.

Remove diseased plant debris and those infested with plant-damaging insects. Removing these from the garden reduces the source of future infestations which means healthier plants with less pest management required. Local municipalities can provide guidance on disposing of pest-infested plant debris.

Wait for several hard frosts when cutting perennials back in the fall. This allows the plant to maximize energy produced and store it in the roots for healthy growth next spring. Make the cut 2 to 3 inches above the ground to avoid damaging the crown of the plant.

Protect plants and gardens susceptible to animal damage. A cylinder of hardware cloth at least 4 feet high sunk several inches into the ground can reduce the risk of rabbit, deer and vole damage.

A fence 5 feet tall around small gardens, 8 feet by 13 feet or smaller, with a secure gate can reduce the risk of most critter damage.

If fencing isn't a practical option, consider using repellent. Applying repellent before animals begin feeding provides the greatest success. Look for rain- and snow-resistant repellent, allowing gardeners to reapply less often.

Once fall landscape chores are complete, take time to clean, repair, sharpen and store tools for the winter and winterize the lawn mower. Move granular landscape care products to a dry place and liquids to a frost-free location. Store them

in a secure location away from pets and children.

Take advantage of the often-cooler fall days to prepare gardens for winter. Time spent now can help reduce winter damage and save time as the next garden season begins.

Door County monument educates about Menominee

Monuments help us remember. They educate visitors about the past, acknowledging that the society we're all a part of is built upon the foundation of those who preceded us.

On Sept. 13, the Greater Escarpment Organization of Door County will host "a soft opening and dedication of the first four educational interpretive panels at Escarpment Park in Northern Door County." Among the panels being honored is one titled "Omāeqnomenēw-ahkiheh: In the Land of the Menominee."

My late Mohican friend, Larry Madden, used to say that he spoke to local historical societies because "Scandinavians need to know that the story of Door County didn't begin when Odin set them down on the land. It begins with Menominee people."

Madden passed last November, but his legacy of honoring and perpetuating Native American culture endures. That includes his lifelong friendship with Nancy Goss.

Goss is now the president of GEODC, and she stated that her role is, "bringing the right people together for the right reasons after an idea is created and letting them shine."

Goss helped spearhead a campaign that drew funding from the Town of Liberty Grove, the Wisconsin Coastal Management Program and the Door County

Community Investment Fund.

"We also fundraise through 'escarpment related' tours and educational speakers, and we appear at local festivals and markets to keep our name and mission in the public," Goss said. "We have received a few significant monetary contributions from local angels."

According to Goss, the mission of GEODC is, "Education, education, and education. Our mission demands we use every educational tool available to raise awareness of the geological, historical, cultural,

environmental and economic significance of the Niagara Escarpment in Door County."

The idea for the Menominee panel came from Goss. Madden had made Goss aware that Menominee people held the land first, but she noticed that the public acknowledgements of Door County's original inhabitants excluded them.

"The historical society across the road from us has, for years, held programs exclusively on the Potawatomi as the first Native Americans on the Peninsula. I kind of took issue with that as somewhat misleading," Goss said.

Goss explained that she wanted the story to be told by the

actual living descendants instead of AI or a non-Native historian, but she was having trouble making inroads until she spoke to Madden.

"One afternoon, when I was near where he lived, I stopped in for a routine visit," she said. "That's where the real progress began. Larry opened doors for me that had been heretofore closed. We traveled to the Menominee community where he introduced me to President Chris Caldwell, Historic Preservation Officer Dave Grignon and you, Dr. Winn."

Through these introductions, GEODC found its advisers for educating Escarpment Park visitors.

My involvement led to Goss being connected with the Menominee Clans Committee, whose work is housed on the college's website. The finished panel features the words and images of the site's late creators, James Frechette Jr. and Mike Hoffman.

Hoffman's widow, Karen Ann Hoffman, is one of the website's caretakers, who both advised on the panel and gave permission for it to feature printed QR codes linking to the site.

"This signage, with its link to the Menominee Place Names Map on the Menominee Clans Story website, brings a fuller, richer understanding of the landscape on which all stand. It uniquely brings thousands of years of history and culture into the palm of our hands," Hoffman said.

Caldwell added his approval, stating, "Door County is part of the Menominee ancestral homelands, and as Menominee people, we are charged with caring for it. This sign will help visitors realize our continuing commitment to land stewardship and cultural preservation through the work being done at CMN."

The Escarpment Park installation will also celebrate the installation of panels titled "Ancient Forests," "Sculpted by Ice and Water" and "Underground Passages."

"To the rest of the stakeholders, the Menominee panel represents a totally factual and beautifully completed educational representation of a history and culture that, I believe, does not have enough representation," Goss said. "Many of our local museums focus on 'early settlers' – German, Scandinavian, Belgian, Icelandic. Yes, they settled here; however, the Native Americans were truly the first."

Monuments help us remember, and beginning Sept. 13, visitors to Escarpment Park will be informed that they are standing on a piece of the Menominee ancestral homelands. 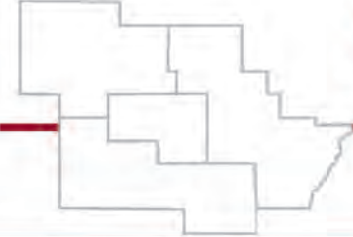

Signed and sealed: Can they deliver?

Pressure on leadership after losing last 5 games

The Green Bay Packers are running it back. After collapsing in the Wild Card round a season ago against the Chicago Bears, team President Ed Policy decided to extend the contracts of head coach Matt LaFleur and general manager Brian Gutekunst.

Now, the pressure is on to win and prove Policy right.

The Packers looked like a team poised to compete for a Super Bowl when they were 9-3-1, ahead by two scores against the eventual one-seed in the AFC, Denver Broncos.

The season changed dramatically from there. Zach Tom (now Zach Bako-Bewele) and Micah Parsons were both lost for the season with significant knee injuries. The Packers collapsed at Denver and did not win another game the rest of the year. Now, they need to figure out a way to win without Parsons for at least the first month of the season.

What's the biggest key to that? Winning within the division.

play, the Packers rebounded to a respectable 4-2 last year. They easily could have been 6-0 had it not been for kicking away a game in Chicago and not trying to win against Minnesota in the final week of the season.

How are they going to navigate the first month of the season without

Parsons with just one division game on the schedule? That could shape how the rest of their season goes.

The New York Jets and Atlanta Falcons could be two of the worst teams in football this year. Green Bay faces them after a Week 1 date in Minnesota.

Tampa Bay follows

October includes home games against Chicago, Dallas and Carolina sandwiched around a road date with the Lions.

The good news is that Parsons should be back to full capacity by some point during the aforementioned stretch. The

2026 opening day roster raises more questions than answers

The NFL season is upon us, which leads us to look around NFL rosters and wonder who is new to the team and how they'll help their teams reach the next step.

In Green Bay, most of those new players for the 2026 season are rookies with an added twist.

When the Packers' season ended, they were

missing who were arguably three of their four best players.

Zach Bako-Bewele, Micah Parsons and Tucker Kraft all missed at least most of December and the team's 31-27 playoff loss to the Chicago Bears.

Those three will be back on the field at some point this season, with two of them potentially as soon as Week 1.

How are those players going to perform?

Brandon Cisse

Cisse was the team's second-round pick, and the highest investment the team has made in a cornerback since they drafted Eric Stokes in the first round of the 2021 draft.

Cisse was far and away Green Bay's best defensive back during training camp. The Packers are typically a team that slow plays their rookies but appear to be ready to feed their second-round pick to the wolves

as soon as Week 1.

Chris McClellan

Speaking of rookies likely to be slow played, third-round pick Chris McClellan could certainly apply here. McClellan had a good training camp, but he's caught at what is arguably the deepest position on the roster. The Packers kept seven

era had run its course during a funereal press conference that he gave in the aftermath of the Wild Card loss to the Bears.

Usually, when a coach has reached the end of his tenure, it's obvious. The end of Mike McCarthy's tenure in Green Bay, for example, was obvious.

Perhaps LaFleur will prove his critics wrong and help the Packers rebound, and prove worthy of the mission to bring the Packers back to Super Bowl glory. With the way last season ended, color me skeptical.

There is an easy path to seeing LaFleur rebounding. He's been one of the winningest coaches since taking the job in Green Bay in 2019. The bigger question is whether he has enough to work with

in key spots.

The aforementioned problems on the offensive line and at cornerback are not going anywhere.

For all the handwringing during the offseason about Keisean Nixon, he's still starting. The alleged upgrade from him is a rookie who has flashed but is still a rookie.

Can a defense make stops without quality cornerback play? Relying on Parsons to cover up some of the major warts in the secondary is likely foolish in a season where he's returning from injury. As great as Parsons is, he cannot do it all alone, and was often asked to do so a season ago.

On the offensive line, the Packers have stability at two positions, and they're both players who

are playing new positions.

Jordan Morgan's natural position is left tackle, but he's starting there primarily for the first time in his pro career. Sean Rhyan moved to center last season and will be the pivot man for the offensive line this season.

The rest of the group has been a mess throughout training camp. Aaron Banks has struggled with knee tendinitis. Zach Bako-Bewele still has uncertainty surrounding his status.

The starter at right guard is Jacob Monk. Monk has one start in two seasons, and it came in last year's regular season finale against Minnesota.

The Packers have plenty of strengths. Jordan Love gives them a puncher's chance in every game.

defensive tackles following training camp. McClellan could be someone who plays at nose tackle or moves around the defensive line. That would be McClellan's best bet to finding his way onto the field early.

Dani Dennis-Sutton

Dennis-Sutton may have been the most exciting of all Green Bay's draft choices, because it still feels wrong that he was available at the end of the fourth round when Green Bay picked him.

Dennis-Sutton did not make his preseason debut until the final game of the preseason, but he did not waste any time making an impression, recording a sack on his seventh snap of the preseason. He created havoc in the backfield for most of the night and looked like a man among boys.

That is a positive development in a game like that one, because Dennis-Sutton is not going to be facing backup offensive linemen anymore. He'll be one of Green Bay's rotational edge rushers early in the season while they wait for Parsons to return. While Parsons is on the mend, however, Dennis-Sutton will have a chance to win a job as the first guy off the bench once Parsons is back in

the lineup.

Jager Burton

Much like Evan Dietrich-Smith or JC Tretter, Jager Burton has worked his way into the team's primary swingman on the interior of the offensive line. Burton is the primary backup at center, so he'll find his way into the lineup if Sean Rhyan were to miss time with an injury. Before that, however, he could find himself filling in as early as Week 1 at left guard.

Aaron Banks has been struggling with a knee injury throughout the offseason, and the Packers are unsure if he'll be able to play a full game. If he can't, Burton is the next man up.

Trey Smack

Smack was one of the biggest stories of the draft because of the move the Packers made to get him. He also became the biggest story of the offseason, because he was money in the bank during games.

Smack did not miss a kick in exhibition play. He made multiple kicks of more than 50 yards. The Packers were preaching patience with their rookie kicker as he struggled early in the spring, but Smack has proven them right over his first big audition. His next test will be

making a kick in a game that matters.

The Packers have given away far too many points in big games in recent years. They have either had a kick blocked or missed a kick in every playoff game since 2021. That's a big reason why Smack was brought to Green Bay.

Tucker Kraft

Kraft has checked every box this offseason and says he'll be active for a full workload against the Minnesota Vikings. The only thing that is worth monitoring with Kraft is his contract situation. Kraft still does not have a new contract in place, with his current deal set

to expire at the end of the 2026 season.

The Packers and Kraft have both insisted that getting a deal done is a top priority for them.

On the field? Kraft is their best offensive player and looked excellent during training camp. He should be someone that Love and LaFleur can both rely on when the offense hits a lull.

Micah Parsons

Parsons is one of the biggest variables of the season. He's currently on the PUP list, which knocks him out for the first four games of the season. His practice window, however, opens after the second game of the season. If

Parsons starts practicing after two games, he could be back in limited capacity as soon as Week 5 against the Chicago Bears. It's also possible that he continues to rehab beyond the month of October.

There's no real timetable that has been given at this point, but Parsons is eager to return and will be pushing to return to play as soon as he can.

Zach Bako-Bewele

Of the three injured returners, Bako-Bewele's return appears to be the one that is the most uncertain. He could play in Week 1. He could have to rotate out of the lineup with Anthony Belton.

Everything is unclear at

the moment, which gives the Packers even more instability with the rest of their offensive line.

In a perfect world, the Packers want to build around their two offensive tackles with Bako-Bewele on the right and Morgan on the left. Green Bay's offense is significantly better when Bako-Bewele is on the field, so they need him to play and play up to his previous standard.

Josh Jacobs

Most teams hope the offseason can end on a good note, but things ended on a sour note in Green Bay. Jacobs was placed on the commissioner's exempt list due to two charges that were filed against him.

Jacobs' availability is unknown at this point. The league is reviewing his case and will likely levy some discipline against him. The Packers, to this point, have given no indication they're going to release him.

Behind Jacobs, the run game is pretty inexperienced. Marshawn Lloyd is talented but has been unavailable. Chris Brooks and Kaleb Johnson have limited to no experience in Green Bay.

The lack of stability in the run game could cause Matt LaFleur to put more of a burden on Jordan Love's shoulders until the day that Jacobs returns.

Learn safety with the use of airguns

Mentor hunting is ideal for pre-teen hunters

I grew up with guns, and from an early age, learned to handle BB and pellet guns before moving up to real firearms like .22 rifles and .410-gauge shotguns. There's an entry in my baby book that I shot a house sparrow at the tender age of 3 with my trusty Red Ryder BB gun (with assistance holding that now prized possession from my older brother, Brian).

My younger brother, Brent, also learned to shoot with airguns, and we thinned the starling population on the edge of Fulton, Illinois, our hometown, most nights at dusk with our beloved pellet guns.

One of my classmates, a brilliant kid with a straight-A average, was never allowed to have any pellet guns until he reached his 16th birthday. His parents didn't hunt or shoot, and it goes without saying that Jim was a maniac with his first gun, waiving the muzzle at us as we constantly scolded him. Brent and I learned safe gun handling from our father and Brian. Hunter education was just starting in Illinois in the early 1970s, and Brent and I were grandfathered in

for hunting licenses.

You don't learn gun safety from osmosis or some instinct that suddenly tingles and kicks in on your 12th or 16th birthday. It's best learned hands-on from experienced hunters, whether family or

strangers.

That's why I've taught hunter safety for decades, including 13 years in Iowa and 20 in Wisconsin.

Kids lucky enough to be raised in hunting families get the itch to join the fun very early. Some kids have

to seek out an uncle, cousin, neighbor or other experienced hunter on their own for both training and a place to hunt. And airguns are excellent training tools that can help them learn safe gun handling and shooting skills.

As most of us fans of "A Christmas Story" know, a BB gun can "shoot your eye out" (I had a junior high history teacher who had a glass eye because of a BB gun mishap), but the relatively low power of said airgun offers a margin

of safety when a youngster has a misstep. A high-powered rifle that launches a bullet 3 to 5 miles or a shotgun that creates a 73-caliber hole in plywood is far less forgiving.

I should note that some of today's airguns are not your father's or grandfather's Daisys and Crosmans.

PCP (pre-charged pneumatics) in bores as large as .50 caliber can take down big game, including deer, bears and Cape buffalo. Break-barrel pellet guns up to .30 caliber can produce enough energy to take down small and medium-sized game up to coyotes. Air guns are now legal for deer in Wisconsin (if you hunt with one for deer, contact me because I'd love to do a story).

The National Rifle Association, the world's oldest firearms safety organization, offers six tips on teaching new shooters with airguns.

One big advantage in using a BB or pellet gun for youth training is the lack of recoil and noise common with hunting firearms. No ear protection is needed for airguns (eye protection is a must). Kids can develop flinching from the start with a firearm, so it's easier to teach shooting fundamentals (trigger squeeze, breathing control, shooting positions) without the shoulder-rocking explosions.

Learning to shoot with iron sights is always a good idea, especially because most young eyes are sharp and clear. But

Get ready for fall hunting seasons

The Wisconsin Department of Natural Resources reminds hunters to prepare for the opening of several hunting seasons in September. New this fall, the DNR published an online version of the hunting regulations, including a drop-down filter that can help people navigate to the info they need faster. It can be viewed at <https://dnr.wisconsin.gov/topic/Hunt/regulations/OnlineHuntingRegulations>.

There are six dates throughout September when seasons open. Hunters are encouraged to double-check season dates and that they have acquired all necessary licenses and stamps before going out for a hunt.

Opening on Sept. 1 were seasons for the common gallinule, early Canada goose, early teal, mourning dove, rail and snipe.

Opening on Sept. 9 was bear season in Zones A, B, C, D, E and F with aid of bait and all other legal methods not using dogs.

Opening on Sept. 12 will be seasons for cottontail rabbit (Northern Zone), deer (archery and crossbow), ruffed grouse (Zone A), squirrels (gray and fox) and turkey.

Coming up Sept. 16 is opening day for regular goose (Northern and Southern zones) and bear (Zones A, B, D with the aid of dogs, the aid of bait and all other legal methods).

Youth waterfowl and woodcock seasons open Sept. 19, and duck season (Northern Zone) opens Sept. 26.

The DNR also reminds hunters of mobile-friendly online resources, including hunting regulations, season dates, hunting hours and more, available

on the DNR's Hunting webpage. Hunters can find information on species population levels and hunting opportunities on the DNR's fall hunting forecasts.

A list of public lands open to hunting is available using the Public Access Lands webpage.

The Fields and Forest Lands Interactive Game Bird Hunting Tool provides hunters information on managed dove fields, stocked pheasant properties, as well as habitat for hunting ruffed grouse and woodcock.

As a reminder, anyone born on or after Jan. 1, 1973, must have a hunter education certification to purchase a hunting license unless hunting under the Mentored Hunting Law.

a low-cost scope can be mounted on many air rifles, getting kids ready for the same sighting advantage on their first deer rifles.

Hunter safety instructor Bob Bohardt, of Shawano, says some parents want to start their kids in a class too soon. While the Wisconsin Department of Natural Resources does not have a minimum age to take an in-person or online hunter education class, the reading level of materials is designed for someone 12 or older, he noted.

“How much time do you spend on one kid?” he said, explaining that kids age 8-10 may struggle to even hold a firearm and may be enrolled just because a parent wants them to take it. “How do you stop this?”

Bohardt, 74, will mark his 40th year as a DNR

certified instructor next year. He helped start in-person hunter ed classes in Shawano, Gresham, Bonduel, Bowler and Tigerton, but these days, he helps lead the one-day internet field classes (a hands-on class after students take an online course) with the help of his granddaughter, Stephanie Popelka, also of Shawano. Bohardt is also a longtime delegate for the Wisconsin Conservation Congress for Shawano County.

When he visited his grandma’s place as a boy, he sometimes shot pellet guns but for the most part learned firearms safety with a bolt-action .410 shotgun.

The state’s mentor hunting program is ideal for young hunters not ready to take a class. The law says any mentee must be within arm’s length of the mentor. Bohardt liked the old version of the law that required the mentor and child to share a firearm, but now each can

have their own gun. There is no maximum age to be a mentee, other than those born before Jan. 1, 1973. You must be at least 18 and a hunter ed graduate to be a mentor.

Another great way for youngsters to learn firearms safety is to shoot trap. Bohardt is involved in that, too, helping start a Youth Trap League at Shawano Gun Club that involves students in grades 6-12 from Shawano, Wolf River Lutheran, Bonduel, Marion and Tigerton schools. The league sees about 80 kids in spring and up to 60 in fall, all learning the responsible way to enjoy a shooting sport that will get them ready for the woods.

Special seasons for youths offer chance to hunt

Special youth hunting weekends for wild turkey, white-tailed deer and waterfowl allow youngsters to hunt and gain experience without competing against adults. These youth hunting events are scheduled one weekend before the regular hunting season and are open to residents and non-residents 15 and younger.

All youth hunters must have successfully completed a hunter education program or participated in the mentored hunt program.

Hunters must hold the required valid licenses, stamps and permits for the species they intend to pursue. An adult 18 or older must accompany the youth hunter.

An adult cannot attend more than two youth hunters at one time. Only one youth hunter can follow the mentor hunting program if the adult is

attending to more than one youth hunter.

Youth hunters may hunt deer with a gun in all deer management units except state park and non-quota units. A gun deer hunting license is required if hunting with a firearm.

The bag limit is one buck per gun deer harvest authorization, plus additional antlerless deer per antlerless deer harvest authorization valid for the deer management unit that the youth hunter will be hunting.

Youth hunters with an archer or crossbow license may continue to hunt with a bow or crossbow during the archery and crossbow season, which runs concurrently with the youth gun deer hunt. All other hunting regulations apply.

This year’s youth deer hunt will be Oct. 10-11.

Youth hunters ages 15 and younger may hunt deer with a gun, bow or

crossbow in all deer management units, except Menominee County or in state parks.

Because the archery and crossbow seasons run concurrently with the youth gun deer hunt, youth hunters who possess an archer or crossbow license may also continue to hunt deer with a bow or crossbow.

Both resident and non-resident youth hunters are eligible to participate.

Again, youths must be accompanied by an adult 18 or older. The adult does not have to be a licensed hunter or a hunter education graduate to accompany one or two youths who are at least 12 and have completed a hunter education course.

Adults accompanying youth hunters may not hunt deer with a firearm during the youth hunt, but may possess a bow, crossbow or gun to hunt for a

game species that is open at that time, including deer with a bow or crossbow only.

An adult may not accompany more than two

youth hunters during the youth gun deer hunt at any given time.

For all youth hunters 11 and younger, or youth hunters 12-15 who do not

possess a hunter education certificate, and who possess a gun deer hunting license:

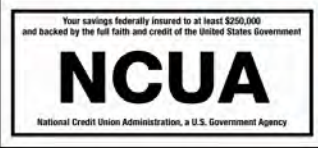

Watch for power lines when preparing for hunt

I could barely sleep last night. I kept thinking about the big buck Dad saw on the trail cam last week. My alarm went off way too early, but I didn't even care – I was already wide awake. I threw on my warmest gear, grabbed my backpack and tip-toed out the door like a ninja so I wouldn't wake my little sister.

It was a cool, crisp morning. My boots crunched with every step as we walked to the stand, and my breath made little clouds in the cold air. Dad gave me a thumbs-up before he walked to his stand nearby, and Grandpa and I climbed in his.

Now I'm sitting here, watching the woods wake up.

The sunrise is turning the sky orange and pink, and it's so quiet I can hear my own heartbeat. Then – crunch. I freeze. Something's moving. My hands grip the rifle tighter. Could it be him? The big one?

I hold my breath and wait. I nudged Grandpa to show him that the buck was coming. "Can I shoot?" Before Grandpa could even answer, I had my barrel out the deer blind window and waited for the perfect shot. Boom!

"Grandpa, I got him."

Now came the hard part, waiting. After 30 minutes, Grandpa said that we could finally walk over to the deer.

There it was, a nice 7 pointer.

As hunting season approaches, excitement builds for time outdoors. I'd like to share these safety tips with you before you head into the woods. My mom works at OEC and has shared them with me.

Power lines and utility

equipment are often out of sight – and out of mind – especially in wooded or rural areas.

Ignoring them can lead to serious injuries or even death.

Keep these tips in mind to stay safe and avoid costly or dangerous incidents:

- Scout the area. Before hunting, take time to scout your area during daylight. Look for power lines, poles and electrical equipment. Note their locations to avoid them later.

- Power safely. If you're using a portable electrical generator on your hunting trip, don't use it

inside a cabin or RV, or in a confined area. Make sure it's used outside where there is plenty of ventilation.

- Avoid aiming toward power lines or equipment. Never fire near or toward poles, lines, substations or transformers. A stray bullet could knock down a line, interrupt power or create a deadly hazard.

- Keep your distance. Always stay at least 10 feet away from overhead lines, poles and other electrical infrastructure when setting up or taking down tree stands.

- Never climb a utility pole. Even if it looks like the perfect vantage point, don't do it. Poles carry high-voltage lines, and climbing them can be deadly.

- Don't use utility poles for support. Tree stands or blinds should never be attached to or supported by power poles or electrical equipment.

Know the danger of downed lines. If you come across a downed power line or damaged electrical equipment, stay at least 50 feet away, even if it doesn't appear to be live.

Power lines can still carry

electricity when on the ground, posing a risk of shock or electrocution.

Call 911 or your utility right away to help prevent a dangerous situation.

Whether you're a seasoned hunter or heading out for the first time, staying aware of your surroundings could save your life.

- Hunters must be "mentored" by an adult who is within arm's reach at all times during the hunt.

- Qualified adult mentors must be at least 18 and have the youth's parents' or guardians' permission to mentor the youth hunter.

- Mentors must possess a valid Wisconsin hunting license for the current hunting season. The type

of hunting license does not matter unless the mentor will be hunting other game. When hunting on land the mentor owns or occupies, a mentor is exempt from the hunting license requirement if not hunting, or if only hunting rabbits, squirrel, raccoon, fox, coyote, beaver or unprotected species.

- Qualified adult mentors may only mentor one

youth hunter whose age is 11 and under, or who has not completed hunter education, at any given time.

- Adults accompanying youth hunters may not hunt deer with a firearm during the youth hunt, but may possess a bow, crossbow or gun to hunt for a game species that is open for them to hunt at that time, including deer with a bow or crossbow only.

Early goose season opened Sept. 1

Regular goose seasons open in different zones in September and October

There are still a few days left in the early goose season.

The season opened Sept. 1 and runs through Sept. 15.

The early goose season has an increased daily bag limit of five Canada geese and is uniformly regulated across Wisconsin.

The regular goose season will open in the Northern and Southern Goose Zones on Sept. 16. The Mississippi River Goose

Zone will open Oct. 3.

The 2026 population estimate for Wisconsin-breeding Canada geese is slightly lower than the 5-year population estimate.

While afield, goose hunters must carry either an electronic or physical copy of their small game license, early Canada goose permit, Harvest Information Program (HIP) registration, as well as proof of purchase of a state waterfowl stamp and federal

Duck Stamp at all times.

Acceptable methods of proof include a paper copy, a DNR-approved PDF displayed on a mobile device or a Go Wild Conservation Card, along with a Wisconsin driver's license.

Young hunters need serious tools for the woods

The saddest thing I can imagine is a kid without a pocketknife.

Next in line on my Sad List would be a young hunter in the woods without a decent hunting knife (or two or three).

Growing up in the non-PC world of the 1960s and 1970s, I carried a pocket-knife everywhere, including school. What self-respecting Cub Scout or Webelo would be caught without his multiblade Scout knife?

Sacrilege. Nobody cared, least of all teachers. Kids, don't try this now.

Once you are in the timber, it's time to check and re-check that glorious blade your parent, grandpa, uncle or other hunting companion bought you. Whether you opted for a solid single-blade locking folder or a stealthy, gleaming sheath knife (leather sheath, please), it doesn't matter. You will eventually own and carry both.

I love guns, but I have a passion for knives. Once you start carrying one, you'll wonder why you ever lived without them. Did you ever try slicing bread with a table knife? Cut a piece of twine with a dull scissors? Not too sharp, eh? Well, let's get with the program and evolve to the tool-using stage.

Parents will have to judge the maturity of their kids, as always, but in general, when you give kids a little responsibility, they seem to appreciate your confidence in them and take their newfound freedom seriously. Kids with toy guns learn what real guns can do at the shooting range, and the same holds true of knives.

A sharp knife can slice a finger but can also field dress and skin a rabbit, squirrel or deer. Start a kid with a small blade and when they grow in maturity, they can graduate to a hunting blade.

It's been said that a sharp knife is safer than a dull one, because it cuts what needs to be cut without slipping, but I am terrible at sharpening knives. Today we have replaceable-blade knives made by Havalon called the Piranta line, which offer scalpel-sharp blades you toss instead of sharpening. Genius.

These are an option for older kids, but not a great idea for the grade-schoolers because an early mistake could become a long-lasting one. The Havalon blog is packed with great hunting and knife information for all ages at <https://blog.havalon.com>.

I prefer an American-made blade, but most trusted brands like Gerber, Buck, Kershaw and SOG offer both U.S.-made and foreign options to hit certain price points. One of my new favorites is Bear and Son, with most of its reasonably-priced blades made in Alabama. On a recent trip to Myrtle Beach, we made the mandatory stop in Sevierville, Tennessee for a 90-minute waltz through three stories of blades at world's largest knife store, AKA Smokey Mountain Knife Works.

Many were Bear and Son blades. You can get a lot of knife from them for \$30-\$80.

Carbon-steel blades are easier to sharpen than stainless steel, but most hunters opt for the latter because they are rust-resistant (if you leave them in a leather sheath

too long, they will start to rust).

Keep your knives clean (blood will etch steel) and lightly oiled.

Plan to spend at least \$30 on a solid sheath knife and at least \$40 on a folder. The latter are easier to carry in a pack or pocket, but when it comes time to clean your knife, it's much harder to get the viscera out of the folding knife's nooks and crannies. That's why you need both.

Local sporting goods stores like Dunham's, Fleet Farm, Scheels and Cabela's/Bass Pro Shops are full of decent hunting knife choices. You can also go the online route (adults have to order knives) for a larger selection. Boker, Cold Steel, Morakniv and Helle (the last two mostly Finnish Puukko designs) are other favorites of mine. Some of these border on works of art, but for hunting, rugged utility is its own beauty.

Choose a blade shape that best fits the job. I prefer a strong tanto point for general carry, a 3- to 5-inch blade is handy for most cutting tasks.

Now that we have a blade or two for field-dressing, skinning and general cutting, let's look at a few other must-haves for young hunters:

- A comfy seat. Youth hunters get wiggly and cold. Comfort is key to their success (just like us grown-ups). A plastic bucket won't cut it. A nice folding stool with a backrest is good but a heavy-duty hunting seat with a silent swivel is even better.
- A soft pad. A

ThermoSeat or other cushion (even a boat cushion or old throw pillow) offers OK sitting on the ground or a bucket and adds an extra layer of cush for the tush on any chair.

A great flashlight. Most lights today are super-bright LED bulbs. Rechargeable ones are OK but seem to go dead when you need them most. A headlamp is even better

if you are carrying lots of gear (waterfowl or deer hunters, or me).

A small folding or pelvic bone saw. The folding saw is great for trimming bigger limbs for shooting lanes. An alternative to the pelvic bone saw is a small hatchet, but this adds more weight to your backpack.

A pruning shears. The greatest hunting tool next

to the knife, a decent pruning shears will cut through grass and small limbs silently, and also works great for cutting joints when cleaning squirrels or rabbits, as well as turkey legs.

Take advantage of Navarino Wildlife Area for fall hunting

Navarino Wildlife Area is part of the Lower Wolf River Bottomlands Natural Resources Area and can be found in southern Shawano and northeast Waupaca counties. The property includes more than 15,000 acres of state-owned land and the largest parcel within the Lower Wolf River Bottomlands Natural Resources Area.

The wildlife area is comprised of sandy uplands and ridges with marshy depressions. Habitat types include open fields, swamp conifer, lowland scrub, bog, bottomland hardwoods, pine plantations, and an aspen and oak forest. The West Branch of the Shioc River and the Wolf River run through the property.

Navarino Wildlife Area is seven miles south of Shawano. Ample parking opportunities are located throughout the property on the following roads: McDonald, South Townline, Lessor-Navarino, Birch and state Highway 156, County Road K,

Two Creek, Wildlife and Swamp Road.

There are two improved boat launches on the property (River Road and Highway 156), three designated carry-in sites (Zeuske Road, Steucks Road and Highway 156) and several other undeveloped access points to the Wolf River, Shioc River, tributaries and flowages.

The nature center maintains hiking, snowshoe and groomed ski trails along with picnic areas, restrooms, a parking lot, a shelter and a cabin to accommodate program participants.

Navarino Wildlife Area is managed to provide opportunities for public hunting, trapping, fishing and other outdoor recreation while protecting the qualities of the unique native communities and associated species found on the property.

The large acreage contains significant occurrences of several natural communities, including floodplain forest, sedge

meadow, emergent marsh and dry-mesic forest.

Management includes the maintenance of continuous, extensive floodplain communities and a hydrologic connection between the river and off-channel aquatic habitats. Flowage management, with periodic drawdowns, is used

to maintain and improve the emergent marsh and open-water wetland types.

Bottomland hardwoods are maintained by favoring silver maple and swamp white oak while retaining other native trees and understory species. The aspen cover type is maintained through coppice

cutting at rotation age to regenerate the type. Quality red oak sites are managed through shelterwood harvests that are timed to coincide with good acorn crops.

Grassland and shrub-carr wetlands are maintained and improved through mowing and

prescribed fire. Sedge meadow is maintained or restored where feasible.

Farming agreements are used to maintain a mosaic of agricultural land. Populations of invasive species are controlled or eliminated by cutting, pulling, burning, herbicide treatment and biocontrol.

Peshtigo Brook Wildlife Area offers rustic hunting, trapping opportunities

Peshtigo Brook Wildlife Area is a 2,373-acre property in Oconto County, with about two-thirds of the property making up the Peshtigo Brook Meadow and Woods State Natural Area.

This area has extensive, unique native sedge meadows interspersed with dry oak, pine and aspen forests. It provides excellent remote hunting, trapping and wildlife-viewing recreation.

The property is north of Suring and south of state Highway 64. Take Hawthorn Road from Pipeline Road to a parking area on the property's southwest corner. A single parking lot is provided. Remote country recreation skills are a must for the limited development of this property.

State ownership of the property began in 1953, with the original management directed toward waterfowls and sharp-tailed grouses. With changes in hydrology and the succession of land cover, management has shifted to an emphasis on wildlife and the unique sedge meadow community.

improve habitat for wildlife dependent on early successional forest types. Prescribed burns to control brush in the sedge meadows are conducted periodically. Oak wilt containment measures have been utilized here. Timber stand improvement plans, and treatments for invasive species treatments are planned for the future.

The road system is maintained for management activities but is not currently open to vehicular traffic. Plans include improving access and parking through agreements with the town and county.

This property is managed in collaboration with the Bureau of Natural Heritage Conservation.
